

## We Must Know Our Racial Past

**The Study of Languages.** Historically, investigation regarding the origins of the white, Aryan or Indo-European peoples has been confined to methods and time frames consistent with and constrained by Biblical interpretations in the book of Genesis. This confined all discussion of the subject to no earlier than 2350 B.C. or about 1,656 years after the Biblical story of the creation, when the families of Noah disembarked from the ark and set out to populate the world. Consequently most of the early attempts to set the historical record straight involved speculative interpretations of ancient classical texts, as well as politically motivated fabrications of medieval monks. It was not until the development of the science of linguistics that racial studies moved from the realm of myth and guesswork to the scientific arena of fact.

The progress from savagery to civilization is intimately bound up with the advance of abstract thinking, which has enabled the world's civilized peoples to rise above the chaos of animal sensations and to fashion an ordered cosmos. The growth of reasoning in turn goes hand in hand with the development of language. Words, after all, are the very seeds of thought. It follows that a common language not only implies a common mental outlook among its speakers, but to a large extent also reflects the general progress of a race as it moves from animalism to savagery, from savagery to barbarism and finally from barbarism to civilization. Philology, the study of languages, may therefore claim a place among the historical disciplines, so far as it is able to trace and interpret the progress of early civilizations.

The close relationships between some European languages had been explored as early as the beginning of the 17th century. In 1767 a member of both the Royal Society and the Society of Antiquaries, James Parsons, did some research on the most ancient peoples of Europe and Asia. Through a comparison of linguistically similar elements contained in different languages he was able to offer a guide to the relative affinity these groups shared and to their distant origins. He concluded that the languages of Europe, Iran and India were all derived from a common linguistic ancestor. Parsons can well be credited with the independent discovery of what we now call the Indo-European language family.

After Parsons' discovery, and in 1796, William Jones, then Chief Justice of India and a scholar in linguistics, proposed that Sanskrit, Gothic and Celtic languages as well as old Persian belonged to the same family. It was not, however, until the beginning of the 19th century that the development of comparative philology allowed us to arrive at the concept of a linguistic affinity unfathered by

Noah. Modern studies have revealed a commonality among the languages of ancient white peoples stretching from the Atlantic to India. This suggests a single source or ancestry that was the precursor to the Indo-European, a language that has been termed Proto-Indo-European. Archaeological evidence shows that the Proto-Indo-European peoples and, by extension their vocabulary, appeared on the scene in Neolithic times, an appearance not coincidentally corresponding to the first widespread domestication of animals. Irrespective of the advancements made through the study of language similarities, this line of study was limited because the occupation of Europe by Indo-Europeans invariably predates the written historical record.

**Archaeological Evidence and Radiocarbon Dating.** We know that the study of race is a multidisciplinary field. It draws upon Linguistics, but also from History, Anthropology, Archaeology, Biology and other fields of expertise. One of the least likely of scientific fields, yet in retrospect one of the most important to the discovery of the origins of peoples, was that of Atomic Physics, a study with which, until comparatively recently, archaeologists were unfamiliar.

In 1949, Willard F. Libby opened a door to the past which egalitarian Marxism never succeeded in closing—a scientific method of dating using radiocarbon or carbon-14.

Now with Colin Renfrew's advancements in radiocarbon techniques we know with certainty that European cultures are of greater antiquity than previously supposed. The megalithic tombs of Western Europe, we now know, are older than the Pyramids, which were once thought to have preceded them. Indeed they rank as the earliest stone monuments in the world. The "Newgrange" tomb in Ireland has been dated to 3350 B.C. and a tomb in Brittany to an astounding 4300 B.C. We also know that early metal-using cultures of Europe antedate both Troy and the Bronze Age Aegean, from which they were presumed to have derived. Through microscopic analysis Alexander Marshack has taken the European time line even further back. He postulates an advanced time-based and time-factoring culture, capable of advanced thought processes and astronomical measurements thousands of years before it was deemed possible.

The origins of our culture become less important when we realize that the creators of culture, notwithstanding their specific geographic origins, were biologically the self-same people as we. That is, a generally dolichocranial, invariably tall and unquestionable white race. The darkening and coarseness of many peoples currently seen in the Middle East and India are reflective of inbreeding with

more primitive peoples over a period of several thousand years. It is not a mirror of their physical appearance at the time of their cultural zenith. Even in ancient Hittite inscriptions our people were referred to as *Hari*, the blond people. Indeed there is substantial evidence to indicate that this very down-breeding led directly to the decline and dissolution of these once proud and advanced civilizations. The practice of incest among the Vanar, a people of Nordic and Germanic mythology, and among the "God Kings" of Egypt may well have been an attempt to protect the bloodlines against such degeneration.

**Natural Selection.** White, Aryan, Indo-European peoples have inhabited the European continent at least since the Early Bronze Age, perhaps as far back as 7,000 years ago or even longer. For all intents and purposes they were identical to the modern Caucasian. The white race is unmistakably the child of the earth of his European homeland.

Some 100,000 years ago the ancestors of our race may have migrated to their current cold and stressful Eurasian climates. There the harsh and unforgiving landscape influenced the temperament, as well as the creativity, of these ancient ancestral people. The harsher climates selected for larger brains, more forward planning, a longer time horizon, greater family stability and increased longevity, with concomitant reductions in sex hormones, speed of maturation, reproductive fertility and aggressiveness. This latter feature, whatever its negative effects, is a blessed necessity for complex cultural development.

Other humanoid subraces adopted different survival mechanisms. The Negro developed greater bone density, a higher percentage of "quick-twitch" muscle fiber, higher levels of testosterone, faster rates of growth to sexual maturation and higher rates of reproductivity. In a strictly evolutionary sense, there is no right or wrong way in which nature acts to ensure the survival of a given species—only successes and failures. In this respect both the Negroid and the white can be said to be on more or less equal terms. *Survival is one thing, civilization is another.* Evidence from a variety of scientific fields demonstrates that the beginnings of our race and the beginnings and maintenance of civilization are irreconcilably linked.

**Ancient Journeys.** In ancient times our people expanded from their Eurasian homeland and mastered all of Europe. The Indo-Europeans brought their culture to the icy North and storm-tossed western lands of the continent. To the south our ancestors ventured to the limits of the Sahara and Africa's Atlas Mountains, where to this day pale Bedouins, relatively unpolluted by Arabia's now swarthy multitudes, still move to the seasonal pulse of nature. To the east, we went through the Khyber Pass and along the timeless old "silk road." Auburn and red-headed people have recently been found in remote areas of China where previous history dictated they were never supposed to have been.

Similar interest is provoked by a white ruling class among the population of the Incas who were identified to Pizarro as being the *viracochas* "a divine race of white

men with beards." Thor Heyerdahl's seminal study of Easter Island shed light upon a white race which once inhabited eastern Polynesia. Here a people called the *oho-tea* are said by the native populations to have been a race which in "olden times had white skin, red hair and blue eyes." According to Heyerdahl's studies they were eliminated in a final war by the more primitive yet more numerous *Hanau momoko* people, the descendants of whom now are the sole inhabitants of the sorry little island.

From Kashmir to Mysore in the western provinces of India our race's influence prevailed and established cultures that were old before the annals of recorded time. The caste system was introduced into India by our Aryan cousins millennia ago in a failed attempt at maintaining racial integrity. The Sanskrit word for caste, *varna*, means color. Even today, after the infusion of ancient Aryan blood so many centuries ago, we still find the occasional blue-eyed Brahman (the highest caste) conversing in a language whose Aryan roots weave the story of our greatness back through the mists of time.

**An American Beginning: An American End.** In ancient North America the impact of our race was similarly felt. A 9,300-year-old Caucasian male was found on the banks of the Columbia River in Washington State, the so-called "Columbia River Man." As in so many other areas of the world where the thought police rule and news is suppressed and twisted, information of white achievement has been suppressed. If it checks out, Columbia River Man would revise everything we thought we knew about early man in the Americas. In the light of these and similar findings it is now considered possible that the earliest waves of humans coming across the Bering land bridge were not

the ancestors of the people we now call Native Americans. Many of the traces left behind by these early trekkers display markedly Caucasian features. It is possible, perhaps even probable, given the historical precedents from around the globe, that they were the victims of genocide perpetrated by the proto-Indians.

We continue to find that our race's travels in Paleolithic times were more extensive and wondrous than previously imagined. Wherever we went we brought with us our unique gift—civilization. These early pioneering cultures have now fallen into ruin. With the decline of the spark of white creativity, no one was left to build. Once

prosperous cities have now decayed, along with the sad monuments to nearly forgotten achievements. Will this also be the fate of our civilization? In spite of our self-deluded retreat from responsibility, we still continue to hold sway over the ever shrinking remnants of a civilized world that is still the envy of backward peoples everywhere. Whites must remember that without the continuation and the survival of their race, not only their culture, but all high civilization may end and a dark pall of ignorance will settle on the earth.

## Is It Time to de-Holocaust Jewish History?

Professor Robert Faurisson once remarked that the Holocaust has become a civic religion for Jews. Anyone who needs further proof of that statement should read *The Seventh Million* by Israeli journalist Tom Segev. In rich detail Segev shows how the Holocaust, the alleged "gassing" of six million Jews, has expanded from a wartime event at first downplayed by Zionists to a daily obsession.

The first section of Segev's work covers much the same territory as Lenni Brenner's *Zionism in the Age of the Dictators* or Edwin Black's *The Transfer Agreement*. Segev asserts that the main interest of Zionist leaders was the foundation of the Jewish state, not saving Jews in Europe or elsewhere. In the immediate postwar years, Holocaust "survivors" were far from being coddled by the Israeli state-in-the-making. They were loudly criticized by sabras (Jews born in Palestine) for letting themselves be led like "lambs to the slaughter." Had they emigrated to Palestine before the war they would have been saved. Consequently the Holocaust not merely proved the validity of Zionism; it was implicitly blamed on the "survivors."


In *The Seventh Million*, Segev deftly exposes the internal contradictions of Israeli society. The Zionist emigrants from Hitler's Germany were the objects of unremitting hostility. They were accused of possessing the innate German respect for authority that characterized the Nazis. Their Yiddish publications were considered a linguistic corruption of the official Hebrew. All in all, life for German Jews under Zionism was not an easy one.

One of the major issues facing Israel in the 1950s was the decision to reestablish relations with Germany. The issue, as can be surmised, was an emotional one. In many heated debates Ben-Gurion advocated the establishment of ties with Germany in order to strengthen Israel economically and militarily. The reparations agreements, it is important to note, did not compensate Jews for six million murdered relatives. Rather they were intended to compensate Jews, whether they lived in Israel or not, for wrongfully confiscated property. In time reparations also came to include compensation for career interruptions or diminished earning capacity.

Nahum Goldmann of the World Jewish Congress first cannily agreed to relatively small initial sums in exchange for ever expanding payments down through the years. Segev diligently explores the vast claims racket that grew out of the agreements. Viewing most of the claimants as cheats, Germans meticulously checked the dates and details of the applications. This early bureaucratic revisionism surprised many Jews who had been looking for "easy money."

The two most significant parts of *The Seventh Million* are the accounts of the Kastner and Eichmann trials. The former was triggered by a pamphlet written by Malchiel Grunewald accusing Dr. Rudolf Kastner, an official of the Mapai government, of having collaborated with the Nazis during the war. An official of the Jewish

Agency in Hungary and involved in the notorious "trucks-for-Jews" deal, Kastner allegedly went out of his way to save the lives of his Jewish friends while shipping the rest of the Chosen off to Auschwitz.

The Kastner trial was a disaster for Ben-Gurion and the Mapai Party. It established what had been common knowledge among the leaders, but not to the man in the street, namely the Zionist policy of saving the few and sacrificing the many. The legal proceedings were based on the fallacious assumption that the Jews who remained in Europe had in fact been exterminated. The Kastner trial gave Menahem Begin and his Herut Party their first real opportunity to break the power of the Socialist and Labor politicians. The verdict of the trial court supported Grunewald's charges against Kastner.

The kidnapping of Adolf Eichmann was Ben-Gurion's chance to correct the damage caused by the Kastner trial. Throughout the proceedings Gideon Hausner, the prosecutor, strove to show how heroically the Jews had resisted the Holocaust. Eichmann, the defendant, was an almost irrelevant figure. The trial completely failed to establish his role as an architect of mass murder. It did allow Ben-Gurion and Mapai members to claim that Jews and their leaders had not been "Kastners" during the war.

It was the Eichmann trial which made the Holocaust a permanent fixture of the Israeli conscience. Almost all Israeli educational courses on the Six Million date from that time. Today the Holocaust is big business in Israel, as it is all over the world. Israelis are taught to delve deeply into the "meaning" of the Holocaust and reach the inevitable conclusion that only unquestioning support of Israel and its policies can prevent a similar tragedy from occurring. It is this conclusion that Segev challenges. Although no revisionist, he correctly understands that the nationalist inter-

pretation of the Six Million story is wrong. He agrees with Professor Yehuda Elkana, who wrote a widely read newspaper article, "For Forgetting":

I see no greater danger to the future of Israel than the fact that the Holocaust has been instilled methodically into the consciousness of the Israeli public, including that very large part that did not endure the Holocaust, as well as the generation of children that has been born and grown up here. For the first time I understand the seriousness of what we have done, when for decades we have sent every child in Israel to visit Yad Vashem over and over again. What did we expect tender children to do with this experience? Our minds, even hearts, closed, without interpretation, we have proclaimed "Remember!" What for? What is a child supposed to do with these memories? For a great many of them, the horror pictures were likely to be interpreted as a call for hatred. "Remember" could be interpreted as a call for long-standing, blind hatred. It may well be that the world at large will remember. I am not sure of that, but in any case that is not our concern. Each nation, including Germany, will decide for itself, in the context of its own considerations, whether it wishes to remember. We, on the other hand, must forget. I do not see any more important political educational stance for the country's leaders than to stand up for life, to give oneself over to the construction of our future—and not to deal, morning and evening, with symbols, ceremonies and lessons of the Holocaust. The role of historical remembrance must be uprooted from our lives.

And that, in so many words, is what author Segev calls the task of *The Seventh Million*.

In the fall of 1964, I was in Advanced Infantry Training at Ft. Gordon (GA). My training company was 75% black. Among these tribesmen was the most vicious and brutal "human being" I ever encountered. In addition to taking in great numbers of Africans and forcing young white males into close proximity with them, the army was bending over backwards to accommodate Negro draftees. All a black had to do was holler "racism" and every white officer and senior non-com in sight would dash for cover.

I saw violent blacks who should have been serving life sentences in prison commit acts of savagery I can never forget. After a brief investigation, the African suspect would walk out of the orderly room, ivory teeth gleaming and head for his "punishment"—sweeping out the barracks.

In one such incident, I saw a black biped, having cracked the skull of a white draftee, come out chuckling and "high-fivin'" after a short interview with the gutless C.O. He was restricted to barracks for

a week. The white victim was still in intensive care when I left three weeks later. The investigating officers had bought the African's obvious lie that the white, half his size, had attacked him.

I remembered the name of this animal, mainly because I had never heard it before and have not heard it since. Not, that is, until I turned to last September's "Primate Watch" in *Instauration*. An item revealed that a 15-year-old black murderer was named Cabbagestalk! I was hardly surprised to find this name associated with violence. Since the young Cabbagestalk lives in a Pennsylvania town not too far from Philadelphia, I feel sure he is the spawn of that other savage primitive Uncle Saul forced me to associate with at Ft. Gordon so long ago.

# Conspiracies, Then and Now

In the America of the 1950s and 1960s, it was not uncommon, on meeting a fellow right-winger, to come to touch on—better put, to dwell on—what we called in those times the Communist menace. Nor was it less common, after sundry Bolshevik atrocities and terrifying threats had passed in review, for one of us to play the trump card in civilized humanity's case for the prosecution: "Communism's a conspiracy, you know." So we knew—or thought we knew.

It's almost a decade since the U.S.S.R., well, not exactly collapsed, but began to slough off its Soviet skin. Only a few diehards, even on the right, seem willing to maintain that this is all a carefully contrived deception to lull us to our doom. Nor is it widely claimed, even in the remotest stands of Birchdom, that whatever beast is aborning or slouching is worse, or could be worse, than Lenin's, Stalin's, Brezhnev's Russia.

More than 30 years after the late Revilo Oliver debunked conclusively the right-wing delusion that some malevolent and seemingly omnipotent combination was to blame for all the right wing's and all the white man's woes, communism may be moribund, but conspiracy—The Conspiracy!—lives on.

Consult the booklist of nearly any "patriotic" publisher. Three years short of the millennium the same hodgepodes of Gothic romance, arabesque invention, baroque exaggeration, Victorian consternation—all calculated to make your maiden auntie and 10,000 right-wingers swoon—vend and wend their way among our kind.

Freemasons? Rosicrucians? Illuminati? Banksters? Bilderbergers? CFR? Skull and Bones? Club of Rome! A diller, a dollar, a thousand Rhodes scholars!

Run even part way through the profusion of plotters and complotters that "experts" in "conspiriology"—as many of them like to call their "science"—have at their fingertips and the names begin to have a nonsensical, but vaguely comforting ring, somewhat like the London church-bell rhymes of fond remembrance from childhood.

What then is wrong with a little conspiracy theory? First, as Professor Oliver argued in his magisterial *Conspiracy or Degeneracy*, it doesn't adequately describe reality, aside from failing to explain the workings of politics and history.

It is noteworthy that the very word conspiracy is a legalism, denoting a secret plan to carry out a crime. Conspiriologists have converted this legal formulation into a moral one, whereby all the doings of designated "conspirators" become evil. (Note that often enough the "conspiracies" or their elements—e.g., the institution of the Rhodes scholarships—are seldom crimes by law).

The malign afflatus of conspiracy quickly overwhelms its individual crimes, real or imagined. Soon enough a Manichaeian (Magian in Spengler's sense) spirit infuses the conspiracy hunters, the most fervent of whom may discover in the workings of the Federal Reserve or the Order of Demolay the direct and continuing work of the Evil One himself.

This is not to argue—any more than Oliver did—that conspiracies don't occur. Leaving aside the innumerable criminal and sometimes not-so-criminal arrangements that delight American prosecutors' hearts (and wishing sadly in passing that some of our rambunctious and misguided activists had known the practical consequences of their own "conspiracies"), plots to overthrow governments, to topple dynasties, even found new nations have been a staple of history.

The authors of England's Glorious Revolution, and our own, were just as conspiratorial as those who

masterminded France's and Russia's upheavals. But try to find a patriot who'd call Washington and Jefferson "conspirators." His contemporaries, however, weren't afraid to call the Sage of Monticello conspirator, revolutionary or worse. Yale College President Timothy Dwight stumped the country accusing Jefferson of being an Illuminatus.

This sort of historical embarrassment is common enough for the current crop of conspirologists. Their politics are generally populist. They scorn "elites." But the conspiracy literature they feast on is often absolutist; often stalwartly Papist—logically as out of place at gun shows and right-wing conclaves where it's sold as its sellers would be if they sat behind their tables in the costumes of the Ancien Regime.

"But, ah," some argue, "conspiracy makes good propaganda. Certainly it sells. When all the names of defunct cabals are gotten through, at bottom lurks, invariably—the Jew!"

Is the possibility of conjuring up from all the gimcrack apparatus of conspiriology the Eternal Jew—*Judeus ex machina*, if you will—enough to make it all worthwhile? Once more following Revilo Oliver, I say no. Conspiracy mongers invariably treat the Jewish problem in one of two ways: they either overrate and overdamn the Jews and their influence or, timorously, they leave them out altogether.

As Oliver, in his learned prescience, foresaw over three decades ago, Aryan objectivity and ingenuity has begun to devise, under the rubric of sociobiology, the first synthesis of which was broached by Professor E.O. Wilson, theories that explain the Jews and their behavior. One such, Professor Kevin Macdonald's *A People That Shall Dwell Alone: Judaism As an Evolutionary Group Strategy* (Praeger, Westport, CT, 1994), is easily worth the price of all the anti-Semitic conspiracy pamphlets combined.

A book like the above brings the Jewish problem within the province of biology, within the same precincts as

the racial problems which perturb the American social order. Here let us note how seldom the conspiracy screeds even so much as glance at race. The fall of the Knights Templar, the introduction of the metric system, the symbols on the reverse of a dollar bill—these are deemed far more important than the history, say, of how America's immigration policy was turned topsy-turvy in the 1960s.

Most Instaurionists aren't conspiracy buffs. The editor has wisely seen to that. But on the wide and woolly right conspiracy theories rule.

Thirty years after Oliver's *Conspiracy or Degeneracy*, nearly a decade after our "victory" over the Soviet, not even the publicly proclaimed intent to turn America into a Third World nation—and the effects of that transformation day by day, year by year, decade by decade—the awful truth is transformed, transvested, gussied up in conspiratorialist drag. Then, and only then, the cobwebs fall from glazed eyes. The patriots smile, they understand: "Oh, you mean the New World Order! It's a conspiracy, you know."

## Tarzan Spoke for His Creator

Ivan Hild in his piece on kid fiction (Sept. 1996) mistakenly referred to Edgar Rice Burroughs (1875-1950) as an Englishman. Dead wrong! Burroughs was born in Chicago, the son of a Confederate veteran. He was successively a soldier, business executive, gold miner, cowboy, storekeeper and policeman before turning to writing.

An ardent Anglophile before and during WWI, Burroughs readily ingested all the anti-German propaganda churned out by the Establishment press. This was reflected in books he wrote at the time—*The Land That Time Forgot* and especially *Tarzan the Untamed*. The latter work was so virulently anti-German that copies of it were included in the symbolic book-burning day staged by Germany's National Socialist government in 1933.

While Burroughs depicted the Negro realistically and often humorously, he painted Jews with the same brush. One of the most hilarious scenes in his novels occurs in *Tarzan and the Golden Lion*. A portly, avaricious Chosenite named Adolph Bluber, a member of a jungle safari headed by Tarzan, is at one point treed by a charging lion. Anxiously sur-

veying the scene from his precarious perch, Bluber wails, "Safe mein life, Mistah Tarzan, und I giff you five pounds!"

Burroughs' experiences with Hollywood moguls were none too pleasant. There were Tarzan films in the silent era, but with the advent of talkies, Burroughs wanted his famous character portrayed as he had depicted him in his novels—as a cultured and athletic mixture of English Lord and Jungle Superman. MGM producer Sol Lesser had other ideas. He cast Johnny

Weismuller as a hulking dimwitted savage whose vocabulary mainly consisted of grunting, "Me Tarzan, You Jane" and "Umgawa!"

In Burroughs' novels Tarzan was married to Jane, had a natural son and lived on estates in Africa and England. In Lesser's flicks the unmarried couple lived in a treehouse. Unable to produce a child of their own, they eventually adopted a son.

Burroughs was so disgusted with Lesser's celluloid perversions that he formed his own film company in 1935 to pro-

duce a Tarzan series starring Bruce Bennett, who portrayed Burroughs' character precisely as depicted in the novels.

Burroughs trenchantly satirized the Hollywood scene, especially in *Tarzan and the Lion Man*, in which a film actress is given the lines: "In Hollywood we all try to be something we're not, but we only succeed in becoming something we ought not to be."


*Tarzan and the Lion Man*, reflecting the author's disillusion with the movie industry, was about a film being shot on location in Africa, where the cast encounters Tarzan. Both fascinated and repelled by the antics of the movie crew, Tarzan decides to see Hollywood firsthand for himself. His subsequent adventures there

bring his already low opinion of moviedom to its nadir. Fed up with Tinseltown, as he is checking out of his hotel, he has just one question for the desk clerk: "What is the shortest route to Africa?"

# The Life and Death of Harlem

Encompassing roughly 3½-square miles in upper Manhattan, Harlem lies north of Central Park between 110th and 155th Streets (some expansionists would say from 96th to 160th), from the Hudson River to the Harlem River. Since Manhattan was settled from the southern tip to the northern tip (even today the narrow, oblique-angled streets of lower Manhattan are reminiscent of a village), Harlem, blighted as it is now, was one of the last regions of Manhattan to succumb to the urban development juggernaut.

Originally named in 1658 by Peter Stuyvesant in honor of Haarlem in the Netherlands, today's massive ghetto was once a rural village. In 1831 the Harlem Railroad, the first in the city, connected lower Manhattan to the "outlying villages." Currently there are few reminders of this era. To get an idea of what "goin' uptown" meant in the pre-Negro days, the tourist in New York might consider visiting the Morris-Jumel Mansion, an elegant Georgian edifice at West 160th Street (the highest point in Manhattan), that was built in 1765 and restored in 1910. The area is known as Washington Heights because the Mansion served as George Washington's headquarters after he was defeated in the Battle of Long Island. Passing from Colonel Roger Morris to a French merchant named Jumel, the home deserves another footnote in history because Jumel's widow married Aaron Burr, who killed Alexander Hamilton in a duel on the other side of the Hudson River in Hoboken. History buffs will also find much of interest at the Graveyard of American Heroes, between 153rd and 155th Streets. The largest cemetery in Manhattan, it serves as the final resting place of many prominent Americans, including artist-ornithologist John James Audubon and Clement Clark Moore, who wrote *'Twas the Night Before Christmas*. Columbia University, Riverside Church, the Cathedral of St. John the Divine and Grant's Tomb are all encompassed within the bounds of Harlem, whose emergence as a Negro stronghold did not occur until the early years of the 20th century.

As development spread north up the island, Harlem's bucolic existence was doomed. The subways and elevated trains (built with Rothschild money\*) made commuting and "remote" housing developments feasible. In the 19th century successive waves of immigrants washed over Harlem: first Irish and Germans, later Italians and Jews.

\*It is worth noting that in 1902 the head of the Interborough Rapid Transit (better known as the IRT) Construction Company was one August Belmont II—presumably a descendant of the August Belmont, the Rothschild agent who provided financial support to the North during the Civil War.

Harlem was not intended to be a dumping ground for the "wretched refuse." Some developers envisioned it as an upper-middle-class bedroom community. Brand new elevator apartment houses, many equipped with servants' quarters, went up. Neo-Georgian and Italian Renaissance homes were erected at St. Nicholas Place, while a group of 116 Brownstones (10-16 rooms each) were built on

138th and 139th street in 1891. The architect was Stanford White, whose name looms large in the annals of New York architecture, not just because of the many prominent buildings he designed but because he was murdered in Madison Square Garden by the cuckolded husband of famed showgirl Evelyn Nesbit, White's mistress.

Like other building booms, the one in Harlem in the Gay Nineties gave birth to scores of get-rich-quick dreams and schemes. Promoters and speculators, worried about missing the boat, went overboard and the boom went bust. Money dried up and foreclosures began. Harlem property owners were forced to slash rents, making the apartments particularly attractive to the dusky newcomers who were moving up from the rural South. A number of Negroes even became real estate agents. The stately homes were occupied by middle-class blacks. The neighborhood eventually became known as Striver's Row.

Of course, Negroes had long been present in New York—since 1683. Development pushed them northwards

into fringe areas. Prior to the blackening of Harlem, Negroes resided in one West Side neighborhood nicknamed San Juan Hill to commemorate the numerous interracial battles fought there. It was the influx of migrants and the financial panic of 1904 that created the Harlem we know today.

Then, as now, damming the black flood into an urban neighborhood was impossible. Several white organizations tried to hold the line (easier to do in those pre-civil rights days), but to no avail. "We are approaching a crisis," warned John G. Taylor of the Harlem Property Owners Improvement Corporation in 1913. "It is a question of whether the white man or the Negro will rule Harlem." The answer was not long in coming. Harlem's population grew from 10,000 in 1914 to more than 200,000 overwhelmingly black residents by 1930.

During the 20s, Harlem became the place to go for whites who wanted to be "out on the tiles." Speakeasies proliferated with Prohibition. Nightclubs swarmed with white patrons. Bar-hoppers could visit Connie's Inn, the Lenox Club, Barron's, the Nest Club, Jimmy's Chicken Shack, the Golden Gate, the Renaissance Ballroom, the Savoy Ballroom (home of Ella Fitzgerald), Small's Paradise or the Lafayette and Apollo Theaters. Many clubs were owned by white gangsters. Best known was the Cotton Club, which had a whites-only policy. Though the thrill of slumming was what attracted most whites, the so-called

Harlem Renaissance added a certain pseudo-intellectual respectability to trips uptown.

By the time the Great Depression settled in, Harlem was no longer a favored destination. Without white money, Harlem ceased to be a going concern. Black resentment made trips to Harlem risky for palefaces. During the 50s, East Harlem became known as Spanish Harlem owing to throngs of Puerto Ricans who ousted the Italians. Despite postwar prosperity, ever more civil rights laws and government largesse—federal, state and local—Harlem's decline continued through the 60s and continues up to the present.

True to form for a Negro enclave, Harlem today contains more than 400 churches and more than 6,000 abandoned apartments—tops in the city and eight times the quantity in second-ranked Brooklyn, a much larger area.

If you're planning a trip to New York, you can view Harlem from the safety of a tour bus or you can "Take the A Train," from the tune of the same name. Cab drivers are reluctant to go there. Shopping on 125th Street, Harlem's main drag, is not recommended for the lightly complected. If you do go, be sure to look for the Tree of Hope at 131st street and 7th Avenue. A plaque marks the site where tap dancer Bill "Bojangles" Robinson planted it.

You won't see a tree, however. Only a stump remains.

## Mister Virtue

In a country awash with con men, knaves, and rogues, it would be difficult to find a more obnoxious specimen than William J. Bennett. Bill or "Bull," as some of his knowledgeable associates call him, has made a career out of crafty trimming, while at the same time perfecting the time-honored political skill of shoving ice picks into the kidneys of those honorable, decent men who have the courage to stand up for the American people in their battle against the liberal-minority coalition. A close look at this creature is useful, if for no other reason than to point out the congenital warts common to most examples of the bovine clan of "neoconservative" phonies.

Bennett plopped to earth in what Time magazine called a "combative" neighborhood of Brooklyn. It is safe to say that he was raised in a social and cultural ambiance that was anything but normal. While many fine folks have been born and raised in New York City, many more have come through the experience permanently warped by an early and crippling exposure to a rancid, heavily Jewish, minority-oriented ambiance. Their values, to say nothing of their virtues, either never developed or never recovered. It is clear from Bennett's career that he is a person of little character—and what there is of it is bad.

In theory Bennett is a well-educated person, having a bachelor of arts degrees in philosophy from Williams College, a Ph.D. from the University of Texas and a law degree from Harvard. Very impressive, indeed, a little too impressive in some respects. A typical northeastern egg-head intellectual, a breed that the average American knows all too well and loathes for good reason, Bennett for all his "conservative" chatter is a chummy pal of the liberal clique that has all but wrecked the country.

I looked in vain for Bennett's record of military service. It must be there somewhere, as he was 21 in 1965, when the big drafts for the Vietnam War started. Perhaps his induction letter somehow didn't catch up with him as he drifted from Williams to the University of Texas to Harvard. Maybe I just didn't dig deep enough. It is entirely possible that he is a decorated war hero—or a chicken hawk.

Bennett has had a high-flying political career, first as Secretary of Education and Chairman of the National Endowment for the Humanities in the Reagan administration, then as Director of the Office of National Drug Control Policy under Bush. He is now a co-director of Empower America, a paid drone at the Heritage Foundation and an editor of the National Review. Introspective Majority members remember Bennett for four infamous acts, each of which describes his true nature.

The first was the incredibly vicious smear campaign waged in 1981 by Bennett, George Will and the rest of the

Neocon Mafia against the appointment of the distinguished scholar, Dr. M.E. Bradford, as Director of the National Endowment for the Humanities. A brilliant, deeply conservative Southern traditionalist, Bradford was rightly seen as a grave threat to liberal, Jewish and minority efforts to erase the history and culture of the American Majority and replace it with the now familiar multicultural mishmash. This struggle, little noticed outside conservative intellectual circles, unmasked the Neoconservative Fifth Columnists in the camp of Ronald Reagan and was the opening shot in the conflict that resulted in a complete

and irrevocable split in the so-called "conservative movement." It ended any chance that the Reagan Administration would rise above mere hucksterism and jingoism, and make a serious stab at national renewal. Chosenite neocons won this battle, but the Pat Buchanan campaign of 1996 warned them that they are fated to lose the war. Dolts such as Bennett have apparently spent too much time in college classes taught by the likes of Laurence Tribe and Allen Dershowitz and not enough time studying demographics. Whether Beltway neocons like it or not, there is going to be a Majority revolt in this country that will be largely dominated by Southerners and their Western allies.

The second major deceitful act of Bennett, cravenly abetted by then President George Bush, was his push to ban *soi-disant* "assault weapons," while he Drug Czar. Working hand-in-glove with gun control fanatics from such sinister groups as Handgun Control, Inc., Bennett preposterously claimed that the availability of semi-automatic rifles was a significant factor in the inability of Federal, state, and local law enforcement organizations to

get a handle on the drug problem. Bennett resorted to the old, tired trick of trotting out a line of paunchy, weeping, politicized cops, eager to pin their lack of success in controlling crime on a supposed "firepower advantage" enjoyed by black street hoodlums.

All this was and is poppycock. Semi-automatic military caliber shoulder weapons have been used in an infinitesimal number of violent crimes. The use of such weapons against police officers can be counted on two hands. More cops are killed by kitchen knives and baseball bats than by AR-15s. Frankly I have had my fill of uniformed incompetents (almost all of whom long ago ceased to be bona fide street police officers) telling me that I should not have the means to defend myself. They proclaim to all the world that they can't do their jobs and then want to disarm the rest of us. Hooyey!

The motive behind the liberals' drive to disarm the citizenry is motivated by stark fear. They have guilty consciences as a result of their unceasing war on the American people and are terrified of the day of reckoning. Moreover they are crazy enough to think that they will avoid their fate by banning guns. Ho, ho, ho! The 2,000 Chinese machine-guns seized by Customs recently should be a wake-up call. There are plenty more where they came from. If the BATF bully boys steal every gun in the country, we will have no problem getting replacements. Recall how ineffective Bennett was at sealing the borders against drug smugglers. Almost anything can be smuggled. Gun-running is an ancient art.

The truth of the matter is that Bennett was an absolute disaster as the nation's Drug Czar. Unable to reduce the flow of drugs to America's children, he focused on what he foolishly considered an easier target—law-abiding gun owners (90% of whom are Republicans). This is the sort of mistake to be expected from a punk raised in Brooklyn. He probably doesn't know a barrel from a buttstock. His diddling around in gun control was partly responsible for Bush's defeat in 1992.

As far as narcotics trafficking is concerned, Bennett's term in office coincided with a virtual meltdown on the streets of America's cities. The ugly fact is that the man is a babblers, not a doer.

The third misadventure of Bennett was when he and Jack Kemp, a frequent sidekick, stuck their noses into the California initiative on restricting welfare and other benefits to illegal immigrants. Making a dramatic flight to Los Angeles at the eleventh hour, the only effect of their effort was to show beyond a shadow of a doubt that nobody in California knew who the dilettantish pols were or cared. The initiative passed easily. When Californians, harassed beyond endurance by floods of greasy illegals, finally realized who Bennett and Kemp were and what they had come to California for, the reaction was one of cold anger. Bennett and his pansy football player buddy slinked back to Washington with their tails between their legs.

That Bennett was arrogant enough to meddle in California politics was bad enough. It was compounded by his

implied defense of illegal immigrants. Californians have seen enough of them not to be taken in by any of Bennett's Ellis Island baloney. The really appalling element was their total lack of political savvy. Bennett was so stone deaf and out of touch that he didn't even feel the political earthquake rumbling around him.

The fourth and latest chapter in the Bill Bennett story is his disgraceful role in undermining the 1996 Buchanan presidential campaign. Bennett and Bill Kristol were the two persons most responsible for the near-criminal media piranha attack on Pat. Listen to a TV interview with Bennett shortly after Buchanan faltered following his win in New Hampshire.

Fat, rumped and with the usual pompous, vulgar sneer on his face, Bennett pontificated that Buchanan supporters could either "toe the line" or go somewhere else. The line, of course, is the pathetic neocon line he has been peddling for years.

Bennett is perhaps best known for his book, *The Book of Virtues: A Treasury of Great Moral Stories*. Most of the stories are fine because Bennett didn't write them. What jumps out of the book is what is not there. In this 832-page book intended to be used as a guide for teaching virtue and morality to American children, Bennett manages to avoid including even one poem, story or anecdote from a Southern source (Washington and Jefferson excepted). Robert E. Lee, probably the finest Christian gentleman ever to grace the Western Hemisphere, is ignored. Ditto for Stonewall Jackson and Jefferson Davis. Not one story about the South, the region of the country most known for its folklore, proverbs and storytelling. Plenty of pages are devoted to Jewish Bible tales, Holocaust stories and so on. Needless to say, St. Martin has his page.

Bennett has made a mint off other people's work. Maybe I can put together a similar opus and then retire to the Bahamas! I'll title it *The Book of Horribles*. I'll fill it full of liberal wisdom gleaned from Newsweek, Time, the Washington Post and the New York Times, making sure that the authors are dead and I am safely beyond the reach of copyright laws.

Proof that Bennett is a shameless poseur was provided by Time magazine (June 17, 1996), which contained short articles on the "25 Most Influential Americans." Bennett, one of them, is an "Advocate of Traditional Values" and an icon of pimply, pasty-faced College Republican nerds. He appears alongside such heavyweights as Martha Stewart, who tells you how to fold your napkins, Al Gore, the Buddhist Temple money-raiser, Oprah Winfrey, former streetwalker, and Robert Redford, noted Hollywood nitwit, once quoted as saying, "I don't feel like a blond person; I have always felt like a dark-haired person."

Bennett's days as "an influential person" are numbered. It may be true that people did come up to him in airports and urged him to run for President. People with shaved heads walk up to me and ask me to buy flowers and incense.

Bill Bennett is a scam artist, a floater who has latched

on to the "virtue and values" act. The depth of his sincerity is shown by his half-hearted attacks on dirty movies and rap lyrics. You won't ever find him preaching against the Jewish-dominated materialist culture that spawns this mental junk food. He is a middle-of-the-roader. # The Third Millennium Has Already Started


Most Westerners are aware that our system of dating is based on counting the years since (or before) the birth of Jesus. For example, 1997 signifies that Jesus was supposedly born 1,997 years ago. But few people realize that the author of this system of dating, known as the Christian Era or Common Era, miscalculated the birth of Christ by four to six years. Technically the Third Millennium has already started.

In ancient times it was customary to associate a year with some unusual or dramatic event, such as "the year of the great flood." Except for the people who lived through it and remembered the actual event, such identification was useless. A somewhat more regulated system designated the year with a king or chieftain, such as "in the third year of the reign of Jehoshaphat" or "in the twenty-second year of the reign of Manasseh." Years are so listed in the Bible. But neither system made for a uniform worldwide chronology.

Marcus Terentius Varro was a Roman who lived before the Roman Empire was established and while Rome was still ruled by elected consuls and a Senate. Varro decided it would make sense to number the years from the date the city of Rome was founded. He studied Roman history assiduously and counted the lists of legendary kings and consuls who were said to have ruled the city. Eventually he determined a year for the founding of the city, named it the Year One and numbered all succeeding years from that "birth date." This system of dating is called the "Roman Era." When Roman writers numbered the years in this fashion, they commonly added the initials A.U.C., which stood for *Anno Urbis Conditae*, Latin for

"in the year of the founding of the city." Varro died in 726 A.U.C., at the age of 89.

In Christian times the Catholic Church did not think that the founding of Rome, which had been pagan for the first 1,000 years of its existence, was the proper way to mark the flow of time. Popes believed that the birth of Christ was the central event of history and urged that the year of his birth be adopted as the basic reference point.



The problem encountered by early Christian fathers with dating time from Jesus's birth was that the year was uncertain. The Bible does not count years according to the Roman system. It does, however, give some guidance. Around 525 A.D. (*Anno Domini*, "the year of the Lord") a monk named Dionysius Exiguus attempted to calculate the year of Christ's birth.

According to the Gospel of Luke, Jesus's birth was said to have occurred

when Emperor Augustus ordered that the population of the Roman Empire be taxed. Luke goes on to say, "And this taxing was first made when Cyrenius was governor of Syria." (Cyrenius was in charge of Roman military affairs in Syria and Judea on two occasions, 747-749 A.U.C. and 759-762 A.U.C.)

The Gospel of Matthew states that Herod ruled over Judea at the time of Christ's birth. Herod ruled from 716-749 A.U.C.

The only years Augustus, Cyrenius and Herod were concurrently in office was during 747-749 A.U.C. If the New Testament is to be believed, Christ had to be born during these years.

Dionysius Exiguus came up with the figure 753 A.U.C. for the birth of Jesus, a date accepted by the Christian world. That his figure was four to six years off was not recognized until later. By this time so many people had used and were using the incorrect dating that it was impossible to change it. Ironically some editions of the Bible have attempted to rectify the miscalculation by stating that Christ was born in the year 4 B.C.

As a result of Dionysius Exiguus's uncorrected error, the American Declaration of Independence was not signed 1,776 years after Christ's birth, but rather in 1772, 1771 or 1770. Come January 2000 there will be much hoopla about the start of the Third Millennium. Clinton's slogan while running for a second term was that he wanted to "build a bridge" to the new century. Strictly speaking, however, the new century started during Clinton's first term.

# New Albany Declaration

All the natural world is based on loyalty to hearth and kin. Yet, in the West, historical regard for the integrity of distinct peoples and cultures is being submerged in a multicultural "melting pot." It will, if carried to its logical conclusion, overwhelm peoples of European descent. By subverting natural affinities, those in power commit the crime of genocide against Western peoples. It is the natural right of all peoples to seek their own survival and safety. Given the pace at which changes are unfolding, it has become necessary to seek political solutions hitherto unthinkable: the irrevocable separation of threatened peoples from governing bodies that no longer further their safety and well-being.

No distinct people is more threatened than the European derived peoples who constitute the American South. In 1861, the U.S. government waged a war of destruction and annihilation against the Southern people, a war provoked in part by abolitionists, who agitated ceaselessly for destruction of Southern whites by military force and armed servile insurrection. This call for their own murder met the only response any sane people could possibly make. The Southern people fought back, surrendering only when the weight of the invader became more than life itself could bear. While the factors influencing the political climate have changed in the intervening century, nevertheless it is self-evident that Lincoln's war of aggression against people of his own blood and for the benefit of those of another descent, is now being reenacted throughout the West.

By such means are a proud and brave people brought to ruin. Indeed, the situation today is far worse because it afflicts all of the West. Nowhere in the civilized world is there sanctuary from the dissolutive multicultural tendencies inflicted in 1865 only on the South. If we are to survive, this spiritual malignancy cannot stand. We, the Southern people, are resolved that, whatever the risks to ourselves, we must take those steps necessary to secure the existence of our people and a future for our children. Therefore, in the 131st year of our physical and spiritual occupation by the United States Government, we, the unreconstructed Southern people, do proclaim the following:

## I. Natural Rights of a Free People

1. That we are a Christian people of Northwest European descent, with predominately Anglo Celtic institutions, traditions, culture and heritage; wherever we may abide, we are bound by blood, loyalty and sentiment to the American South, comprising Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Maryland, Mississippi, Missouri, North Carolina, Oklahoma, South Carolina, Tennessee, Texas and Virginia.

2. That our historical and cultural identity was forged over a 400-year period of exploration, settlement and endeavor that created our distinct character, dialects, folkways, values and civilization. The War for Southern Independence was the crucible that transformed us into a people with a single purpose and destiny.

3. That we have an unalienable right to self-determination and to continued existence as a distinct people. These unalienable rights were bought with the courage, tenacity and sacrifice of ancestors who fought and died in the War for Southern Independence, the American Revolution and in every American conflict where the call of duty beckoned.

4. That the ideals of liberty and sovereignty undergirding America's founding were in large measure given voice by the genius and resolve of Southern statesmen. The transcendent principles they embraced and codified in the Virginia Declaration of Rights, the Declaration of Independence and the Bill of Rights have served as an enduring inspiration to all people who aspire to self-government.

5. That no power on earth is morally justified in depriving our people or our posterity of safety, independence or substance. To this end, separation and independent nationhood are morally just measures for securing the safety of a free people.

## II. Dispossession of the Southern People

6. That the hallowed battlefields and cemeteries of 1861-65 bear silent witness to the destruction wrought by the U.S. government in league with Northern financial interests and social radicals for the purpose of subjugating and obliterating the Southern people, to wit: abolition, aggression, conquest, disenfranchisement, reconstruction and amalgamation.

7. That during the military occupation called Reconstruction, the South endured destructive physical, economic and social depredations by carpetbaggers, scalawags and freedmen. Reconstruction ended not because of federal benevolence, but by the indomitable resistance of the Southern people to their own dispossession, despite which the federal government continued its policy of economic exploitation until WWII, keeping much of the South in unrelieved poverty.

8. That we, as well as all Americans of European descent, are suffering a second, more terrible reconstruction, one that began in the late 1940s with the schism in the Democratic Party over the "Civil Rights" plank, that then escalated with the *Brown* school desegregation decision of 1954 and achieved dominance with the 1964 Civil Rights Act and the 1965 Voting Rights Act.

9. That the moral and societal dissolution engendered by this Second Reconstruction was thrust on us through propaganda, deceit and force of arms by adherents of the Marxist, universalist ideology known as liberalism, an ideology alien to the Southern people, contrary to God's laws, and destructive of all who are deceived by it.

10. That the tidal wave of Third World immigration unleashed during this Second Reconstruction imperils not only our right of self-government but our continued biological existence, as indeed it imperils all Western peoples.

11. That in furtherance of the illusion of a multicultural "Tower of Babel," an unholy alliance of government, media and, regrettably, Christian churches in error are directing a relentless campaign of slander and abasement against our institutions, traditions, symbols and history through destructive laws, dishonest reporting and teaching of false universalist doctrines.

12. That the assertion of equality among races, sexes and moral belief systems is contradicted by every shred of natural evidence. As a people, we condemn interracial unions because they are destroying our society and our people's very existence.

13. That much of the subjugation of the Southern people has been fostered by weak or inept Southern leaders who, due to venality, cowardice or lack of vision, refuse to confront the hard choices needed to preserve our heritage and our children's future.

### III. The Southern Creed

14. That as Southerners, we affirm our faith in and devotion to God, Family and Country and to the traditions that have sustained our people for uncounted generations; Southern ideals of honor, chivalry, courage and discipline are timeless virtues, unchanged by the decadence of the modern age. While respecting freedom of conscience, we are a Christian people with Christian institutions.

15. That we believe equality is the sworn enemy of liberty. We recognize a natural, hierarchical social order and adhere to a political system in which the best members of society are enabled to rise to positions of leadership and civic duty.

16. That the agrarian origin of the Southern people confers a deep affection for nature and for the land. Responsible stewardship over nature's bounty has ever been the duty of all Southerners.

17. That we respect traditional social norms defining the role of the family, the relationships between men and women, and the ideals of Southern Manhood and Southern Womanhood.

18. That we have a long and distinguished martial tradition that precludes soldierly participation by women or other races.

19. That kindred folk who marry into Southern families and adopt Southern ideals and traditions may become naturalized Southerners. We welcome kindred folk who, without benefit of family ties, adopt the Southern way of life. Conversely, Southern nativity alone does not confer Southern nationality.

20. That while maintaining the integrity of Southerners as a distinct people and culture, we seek renewed fraternal ties with kindred peoples and friendly relations with all people of goodwill.

### IV. Resolve for Self-Determination

21. That we shall never accept the defeat of the Confederacy, the subjugation of our people, nor the eradication of our symbols as the final judgment of history, nor shall we accept alien domination of Southern churches, schools, media, commerce, industry, government or, through these institutions, alien control of Southern life.

22. That defense and preservation of Southern symbols, monuments, relics and history are sacred charges to every Southerner. In defense of this heritage no honorable retreat or compromise is possible.

23. That the Confederate Battle Flag is the banner of the Southern people and stands preeminent as the most powerful symbol of liberty and Southern nationhood in a constellation of venerable Southern symbols. *Dixie* is the anthem of that nation. We will stand when it is played and sing it with boldness and pride.

24. That those who love the South are committed to the health and prosperity of its people, the rejuvenation of its culture, the unbiased recording of its history, and the lifting of occupation and control of the South by non-Southerners.


25. That we pledge "our lives, our fortunes and our sacred honor" to the creation of a secure homeland for our people and a future for our children. We shall use all moral means, consistent with the right of self-preservation, to achieve that end.

That true Southerners, like our unreconstructed Confederate ancestors, have an abiding faith in Providence and the rightness of the Southern Cause, and that we do affirm that faith by adherence to the principles of this Declaration.

### Norway Women Join the Cause

Zip 411 (Backtalk, Feb. 1997) thinks that I believe in "Let women have it both ways feminism." Not at all. My "Feminism Unmasked" article (Backtalk, Nov. 1996) was an attempt to describe what is wrong with feminism from the perspective of racial survival. The ideological strain of feminism I described is sometimes known as "gender feminism," a quasi-Marxist ideology based on gender rather than class. Other ideologies which might be called "feminist" don't concern me if they aren't racially harmful. Written by a doctoral student at the University of Oslo, it analyzed the large increase in female participation in what it called "extreme-right" groups, which have gone from being virtually all male in 1990 to one-third female today, with the percentage of women continuing to rise. Ten new women's groups have started in the last two years alone, with the recruits generally starting to participate on or about age 15. The report says that "action and excitement" attracts young women to these groups and that they give women the chance to "combine something feminine with something masculine." The phenomenon is described as part of a "neo-feminism which is definitely on the way back."

I have heard similar reports of greatly increased participation by young women in racially oriented groups. Scandinavia is in the lead. Neo-feminist or not, these women aren't joining simply to look pretty and provide girlfriends for the male members of the group. They are active participants. No doubt they are more aggressive and less submissive than were their mothers who stood by and mouthed liberal platitudes while nonwhites poured into Europe. Should these young women be discouraged on the grounds that they are "feminists" and therefore wrong? I think not. St. Paul may have called for women to be submissive, but this aspect of Christianity certainly is not upheld by our race. ## Short-Lived Idea




Democratic Senator Dianne Feinstein in her 1994 election victory.

When the judge cut him off after a rambling, tearful speech about his sexually abused childhood, Kostner said he wanted to die in the electric chair, a decision he quickly amended. **Bleeding Heart Attorneys**

Jewish shysters Michael Hausfeld and Daniel Berger are the brains behind the financial and legal assault on Texaco, which has agreed to pay \$171.1 million to more than 1,300 Negro employees, plus an across-the-board 11% pay raise. A large hunk of this money, as much as perhaps \$29 million, will go into the bulging bank accounts of Hausfeld and Berger, whose hearts bleed for the minorities that have made them multimillionaires. Hausfeld is currently pursuing a class action suit (pro bono, he says) on behalf of some Holocaust survivors against Swiss banks. In some cases Chosenites don't have to pay for legal services that would bankrupt non-Jews.

**Safe in Israel**

Yosef Lifsh, the Jewish driver of the car that ran into and killed a seven-year-old black kid, thereby triggering a race riot in Brooklyn six years ago, is living happily in Israel. The black who killed an Australian-Jewish rabbi caught in the riots has been convicted in a federal trial for civil rights violation after being acquitted in a state murder trial. "Why," asked Carmel Cato, the father of the convicted black youth, "hasn't the driver of the car been brought to justice?" Bystanders said the car was going 50 m.p.h. in a 25 m.p.h. zone. The answer is that a grand jury failed to indict Lifsh and, since he is in Israel, he cannot be served. Israel was set up to be a nation for Jews fleeing persecution worldwide. It is also becoming a safe house for Jewish criminals fleeing the scene of their crimes.

**Criminalizing Speech**

It has always been the contention of this magazine that civil rights is not the chief motivation for civil rights groups. What these groups are really interested in is the transfer of all political and economic power into the hands of nonwhite minorities, with an assist from Jews. A recent ordinance passed by the City Council of Cleveland hints of things to come. Say a bad word about a minority member in the workplace and you can get a fine of \$1,000 and up to six months in jail. *Auf Wiedersehen* the First Amendment.



A gaggle of young black goons (15 to 20 strong) attacked two young whites who were leaving an Edison (NJ) bowling alley at 1:30 a.m. One was hospitalized with severe head, eye and nose injuries. Doctors worked around the clock to save his sight. Another young white was hospitalized a few days earlier with a broken jaw caused by a Nunchaku, a martial arts wooden club, wielded by black primates who ripped off his ear, leaving him permanently deaf. There was nothing about the black-on-white crimes in the national media which was saturated in the last week of March with reports of an attack by white youths on a young Chicago black.

On behalf of three fired black employees the Jewish law firm of **Beldock, Levine and Hoffman** is suing the government agency that operates the Statue of Liberty for \$900,000. Carefully coached by their team of shysters who hope to get a huge slice of the settlement, the blacks complained they had been subjected to a "racially hostile environment" before they lost their jobs. Lady Liberty hostile to the "wretched refuse"! Emma would be scandalized.

The state of Washington has formally taken custody of two pickaninnies, aged one and two, whose black father threw them out of a third-story window in Tacoma. It was a 36-foot drop, but both toddlers suffered only minor injuries.

An even more unfatherly black father in Dallas, angry at the noise his three-year-old, James Thornton III, was making during a televised Dallas Cowboys game, beat him to death.

Leading candidates in the Democratic primary for this year's race for Manhattan Borough president: City Councilman **Antonio Pagan**, a self-advertised Hispanic homo; City Councilwoman **Virginia Fields**, a black; State Senator **David Paterson**, a black who is legally blind; City Councilman **Adam Clayton Powell IV**, half-Puerto Rican and half-black; State Assemblywoman **Deborah Glick**, a lesbian Jewess.

The murder of white women by black males is becoming so routine it hardly rates more than local new coverage. One of the latest crimes of this genre occurred some weeks ago in the San Francisco Bay Area. The body of Sherry Anne Downing of Mountain View (CA), an attractive blonde, was found stuffed in the trunk of

her 1974 Mercedes. Arrested and charged with the murder was **Wendell Bigelow**, 41, her black boyfriend, a relationship which she had been frantically trying to end.

**Reverend Willie Wilson**, D.C. Mayor **Marion Barry's** pastor, says Jesus was a "blue-collar worker [who] lived in the ghetto." He regrets that Christ is a white in most people's minds. "The image of Jesus is for [sic] white supremacy, and makes black people hate themselves."

**Gennifer Flowers**, Clinton's longest reigning mistress (12 years), has started a semi-porn model live interview program on the Internet, which she calls "Presidential Quality Cybersex." Models squirm and wiggle at the online users' commands.

After a white school teacher, Lisa Scuddy, 28, was shot and killed outside a Miami fast food establishment, the media described the murderer as a white. A day or two later newsmen reversed themselves and allowed that the murderer was a black.

**Autumn Jackson** is out on bail after her attempt to extort \$40 million in hush money from her alleged father, **Bill Cosby**. After some ill-considered posturing, Cosby admitted that because he did have sex with her mother "there is a possibility" she is his illegitimate daughter.

Philadelphia drug lord **Richard Ramos** was able to elude police for 18 months, courtesy of the dextrous digits of plastic surgeon **Dr. José Castillo**, a fellow Hispanic who changed Ramos' fingerprints, altered the crook's face, sucked off some of his avoirdupois and removed a few of his tell-tale facial scars. In February, Castillo was convicted of obstruction of justice and conspiring to harbor a fugitive.

Amid great editorial fanfare in The Nation, the Oliver Stone of magazines, snobbish British journalist **Christopher Hitchens** announced that his mother was a Jewess and that he himself was married to one.

Reuters News Agency asserts that **Steven Hoffenberg** pulled off the biggest swindle in U.S. history by selling \$450 million of fraudulent notes and bonds to more than 3,000 individuals, companies, trust funds and pension plans. Hoffenberg, one of those Jewish entrepreneurs who prefers to steal their way to riches,

got 20 years and was ordered to repay \$476 million in restitution. The super-scammer once owned the New York Post, which is now the possession of **Rupert Murdoch** and, if he keeps it, will almost certainly be part of the inheritance of his daughter, who is married to a Nigerian.

Teresa Ortez, 36, who once toiled for Outlaw Biker magazine, sued her boss, publisher Casey Exton, for sexual harassment and won \$19,000. Exton's real name is **Harvey Shapiro**. Where are they not?

For threatening to kill Joy Silverman's 14-year-old daughter unless mother came up with \$20,000, New York State's top judge, **Sol Wachtler**, a married man who preferred Joy to his wife, spent 15 months in the hoosegow. Out on the town once again, the learned jurist will get a rumored six-figure advance for a book about his travails. Believe it or not, the adulterous stalker-extortionist was once considered seriously for the Supreme Court.

On top of the \$95 million that Disney CEO **Michael Eisner** gave to ethnic cousin **Michael Ovitz** for a year's "work" as his second in command, Disney shareholders approved a 10-year pay package for Eisner that will net him between \$400 to \$775 million. These carrion make more in one year than Walt, the source of their undeserved wealth, made in his lifetime.

**Harvey Golub**, chairman and CEO of **American Express**, has picked **Kenneth Chenault** to be president. The black is being groomed to take over the company when Golub retires in seven years at age 65. A decade ago American Express had 25% of the charge-card market. Today, in spite of or perhaps because of Chenault, it has less than 17%. The only other corporate giant with a black president, **Richard Parsons**, is **Time Warner**, which, like American Express, has a Jewish CEO.

When racial slurs were attached to rocks thrown at the home of a Negro family in Coatesville (PA), blacks and liberals yowled racism. The rock thrower, it turned out, was the family's 14-year-old son who wanted to stir up a racial ruckus. A similar hoax was staged at the Waynesboro (VA) high school when a black student wrote forbidden words on the blackboard, knowing it would provoke violence in and out of the classroom.

The **Ford and Rockefeller Foundations** are the two biggest bankrollers of **MALDEF**, a virulent Hispanic racist organization.

The Office of Special Investigations has a staff of 29 and a \$3 million annual budget for conducting witch-hunts against alleged Nazis or WWII "death camp" personnel. Since the 1970s some 103 suspects have been apprehended. O.S.I.'s latest "catch" was Ferenc Koreh, 87, who was deported to Hungary. Rabbi Abraham Cooper of the hateful Simon Wiesenthal hate group pulled out of his hat the number of 10,000 for Nazis who have supposedly sneaked in to the U.S. The U.S. government itself maintains a watch list of 60,000.

Rate per 100,000 of offenders committing murder and non-negligent manslaughter in 1994: Black males 32.1; white males 3.7.

Every day 16 kids in the U.S. are killed by gunfire. Every few seconds 1 child is reported abused or neglected.

Some 5 million illegals resided in the U.S. in 1996. To try to control this border-hopping horde—an impossible task—was a prime reason for increasing the annual INS budget to \$3.1 billion. More than half of the "undocumented" come from Mexico. 40% of the illegals are hunkered down in California.

Newsweek reported 2 million wives are battered each year. Time arbitrarily doubled this figure to 4 million.

Immigration accounted for 11% of U.S. population growth in 1970; 39% in 1990.

2 minority hacks, William Goldman and Joe Eszterhas, are paid as much as \$3 million per screenplay. For "polishing" plays written by others, they get as much as \$250,000 per week. A couple of generations ago their families probably didn't know a word of English.

The Pasadena (CA) playhouse lost 1,000 subscribers when it put on 2 "black plays" early this year. One was about Jackie Robinson breaking the color barrier in baseball; the other featured a black disco group, whose dialog often lapses into Ebonics. The third play, a white play if it can be so described, was *Equus*, in which a boy blinds horses to expiate his stints of lovemaking with a girl in the stables.

Nearly 100 college newspapers have reported the theft of 400 or more copies

of a single issue. Biggest heist was the 24,000 copies of the Daily Californian (U.C., Berkeley) by a black gang displeased by the paper's support of Proposition 209, the initiative opposed to affirmative action that is now tied up in the courts. Second biggest haul was 14,000 copies of the University of Pennsylvania student newspaper by 60 Negro students.

As many as 180,000 of the 1 million people who became U.S. citizens last year had criminal records.

O.J. Simpson has signed 19 contracts since he killed his peroxide blonde and breast-enhanced ex-wife and her Jewish "friend." One deal for \$1 million included photos of O.J. shedding crocodile tears as he stood beside Nicole's grave.

9% of the U.S. Army infantry is black, though the army as a whole is 30% black. One reporter inspecting an infantry platoon of 52 men counted only 2 black faces. Are blacks not to be trusted in the frontlines? Many black visages are visible in office jobs.

A recent Harris Poll reported that only 51% of the respondents thought the media get the facts straight. 84% said the government should require the balanced reporting of issues.

A healthy high culture can only arise from the culture of a homogeneous people. When the elite is racially and culturally different from the people at large we have the monstrosity known as television—an-around-the-clock schism of the soul.


One small bright spot flashes occasionally in the darkness of the TV landscape. Bigtime Television, the three networks, has been losing its audience—from 73.5% of viewers in 1986 to 50.5% last year. This doesn't necessarily mean that the viewers' taste is improving. Cable and satellites often churn out programs that are even worse than the worst CBS, NBC and ABC can offer. But the fall-off does show a certain dissatisfaction with network TV offerings. How can what effuses from the boob tube be improved? One way is for what is good to get better ratings than what is bad. This means that the Howard Sterns, Roseannes and Geraldos must become history.

Dan Rather, with some justification, called Tom Brokaw's news program, "news lite," though the reason for such an outburst was probably sour grapes. Another reason why Dan is miffed is that his minority-tilted news—a little more minority-tilted than the other two minority-tilted network news—isn't drawing the number of viewers it did in the past. 

# Notes from the Sceptred Isle—John Nobull

In America, Majority activists may be American nationalists, in that they believe in the preservation of the union. I am more inclined to support those in states like Montana, Texas, and Alaska who would like to break away, those in California who would like to divide the state into two parts or the core states of the South which would like to establish a Southern coalition. It seems to me that separation would offer the best chance of survival for white Americans. It would also weaken the Washington administration which dominates Europe, allowing no NATO command to be in the hands of any European and constantly working against European interests.

The situation in the British Isles is no less complicated. The existence of an Irish Republic, which contains 26 of the 32 counties in Ireland, acts as a strong destabilising factor in the six northern counties, especially now that the Irish Republic is doing much better economically with the help of German money. Tony Blair who, if the polls are correct, will be the next British Prime Minister, is offering the Scots a chance to have a referendum. If the vote is favourable, they will then have a second referendum for or against a Scottish parliament. At the same time, Blair wants to trample on the immemorial rights of the originally Scandinavian-settled Isle of Man and Channel Isles. The Isle of Man has a parliament, the Tynwald, which was founded in the 9th century, before the Icelandic Allthing. The rights of the Channel Islands were established before the Norman conquest.

In Northern Ireland the unionists are under no illusion about the long-term desire of the British political parties to sell them down the river. Churchill was ready to sacrifice them during WWII in order to gain control of the Irish ports. Presbyterians are split about celebrating the 1898 rebellion against England, in which they took the lead. While the Church of Ireland element is inclined to compromise over the status of the North, the working class, mainly Presbyterian, is solidly against any compromise. These workers have learnt a lot about terrorism from the IRA. Prince Charles recently shook the hands of some of the young Protestant paramilitary leaders, which will stand him in good stead. But the Northern unionists, like the IRA, have been bitten by the multiracial bug. What is more disgusting than Pakistanis marching in the regalia of the Orange order?

The United Kingdom is just that, a kingdom not a united nation. So it is now breaking up into ethnostates. In due course, English nationalism will intensify in its reaction to England's need to subsidise Scotland and Wales, without any say as to how they should be governed.

At the union of the crowns of England and Scotland in 1603 a Scottish king became King of England. This led to a union of the two parliaments in 1707 under Queen Anne. The Scots wanted to participate in the development of the English empire. Much poorer than the English, they were all the more land-hungry. They also played a disproportionate part in opening up new territory. Simon Fraser, who discovered the Fraser River in Canada, was the son of an American Scottish Tory.

The results of British immigration are evident in the place names of Ontario. Until 1914, the best land had English and German place-names, because only the English and Germans had enough capital to buy it. (In 1914 the German place-names were

replaced by English ones, e.g., Berlin became Kitchener). The Scottish place-names are found further out towards the Canadian Shield. The Irish, who arrived after the famine, took the poor, if beautiful, land actually on the Shield, which they later mostly abandoned.

Even today the Scots have their own system of law (based on Roman law imported from Holland and France). The Stone of Scone on which their ancient kings were crowned has been returned. They may very well vote for their own parliament, which would not be incompatible with a unified crown.

Dr. Stephen Dorrell, the left-wing Conservative Secretary of Health, said that if a Scottish Parliament were created, it could be abolished by a future Conservative government. That would be very stupid indeed. The long-suffering Scots would have to fight. I certainly shall not be encouraging any young members of my family to go up and deprive them of their parliament. The Falklands were different. The settlers constituted the only purely British community left in the world. A Welsh assembly also strikes me as a very good idea. The Welsh have their own language, a great literature and a strong interest in music. But I don't see why the English should continue to subsidise a very different people with a predilection for wasteful socialism.

Years ago, I was sightseeing in the German region of Dithmarschen, in Angeln, the area allegedly deserted by the Angles when they went to England. The big houses with their deeply thatched roofs reminded me irresistibly of East Anglia, where I spent part of my boyhood. Here's another reason why fighting against Germany does not appeal to me. All too often nationalism divides similar people and tries to unite very dissimilar ones. I am perfectly happy to be part of a united kingdom including the Scots, with all the virtues they are known to possess, but I would object most strongly to a homogenised republic in which I had to regard Glaswegians as fellow citizens. Nor am I just talking about the Roman Catholic Irish element in Glasgow. I am also talking about the vicious little native Marxists who must surely represent some aboriginal subrace—little rats eager to open your face with a sharpened bicycle chain

When David Niven got his commission in the British Army, he asked to be transferred to any regiment except the Highland Light Infantry (in effect, a Glasgow regiment). Disobligingly the War Office sent him there. In time, he grew to like his Scottish buddies, as did George Macdonald Fraser of *Flashman* fame. I find that hard to believe. In the German town of Lüneburg after the war, the illiterate little poison dwarfs from Glasgow used to attack civilians, six or seven of them against one, a hatred inspired by comic strips published by Jews, in which the Germans were always the baddies. In due course, the dwarfs had to be suppressed by club-wielding English soldiers. No one died, though there were many cases of concussion, I am happy to say.

Back in the early 1980s there was a football match in Glasgow between Rangers (Protestants) and Celtics (Catholics). One group of supporters in the higher stands urinated on the others below them. The ones below mounted a mass attack. The upper stand collapsed and 81 people were killed. It's the kind of thing that happens in South America, where the referee has to exit by an underground passage.



# Report from the Darkening Tip

*Feb. 1:* In a stunning political move President Mandela named Prince Mangosuthu Buthelezi, chief of the Zulus and an opponent of the African National Congress, as Acting President during his absence for three days to attend the World Economic Forum in Switzerland.

*Feb. 2:* Last November the City Council of Johannesburg sent out accounts for electricity used by blacks in Johannesburg. The total amount was \$344,595. Only \$277 was paid!

*Feb. 6:* At least one person was shot dead and 14 policemen and scores of rioters engaged in gunfights on the streets of Johannesburg's Coloured suburbs.

*Feb. 8:* By far the majority of the many recently reported rapes have been by black men on white women.

*Feb. 9:* The Afrikaans Sunday paper, Rapport, has warned that so many Afrikaners have lost confidence in the new political dispensation that the National Party, which governed and dominated South Africa for decades, has now only 13% of voter support.

*Feb. 11:* Whites still own some 80% of the land in South Africa, while comprising only 13% of the population.

*Feb. 12:* Up to 20% of the members of the South African Defence Force will shortly receive package deals when they resign.

*Feb. 13:* Criticism that the National Party has "sold out" its Afrikaner constituency is on the increase and could lead to a split in the party. In academic circles F.W. de Klerk is to a large extent regarded as having lost out (or sold out) to the A.N.C.

*Feb. 15:* On his trip to South Africa, which produced no meaningful results, Vice President Gore took along wife Tipper, two of his children and 380—Washington aides, bureaucrats and factotums.

*Feb. 16:* Only about a quarter of the more than one million civil service posts are still held by whites. The situation is so serious that de Klerk is being referred to as "a lame duck" by the press that staunchly supported him in the past.


*Feb. 21:* Some \$60 billion is expected to flow out of the country when exchange controls are abolished, according to Dr. Chris Stals, President of the Reserve Bank.

*Feb. 25:* Mrs. Mary Metcalfe, Gauteng (Johannesburg, Pretoria and Witwatersrand) member of the executive

board for education, has declared that it is the responsibility of all schools in Gauteng to arrange as soon as possible a program to accommodate all pupils with AIDS.

*Feb. 27:* The Conservative Party has announced that it would continue with plans to establish self-protection units at white schools to protect pupils from racial violence. A party spokesman said there had been incidents of racial conflict at school levels which ranged from assault to rape: "It is ironical that the core of the problem is being ignored and attempts are made to present the facts in such a way that it appears as if Afrikaner children are the instigators of the unrest."

*Feb. 28:* Most South African whites now admit that it will never be possible for any political force to create a unitary state out of this diverse population.

**Canada.** In some ways Canada does not pander as cravingly to its Jewish population as does the U.S. Only one man has been tried for war crimes and he was acquitted. As the N.Y. Times reported, "Charges against three others were eventually dropped." Only two persons have been deported—one to Holland, another to Germany. In many respects, however, Canada and Canadians grovel even lower to Jews than do U.S. mediocrats and politicians.

Take the case of Paul Fromm, the Ontario schoolteacher who has long been the target of the Canadian B'nai B'rith's intense privacy-intruding scrutiny. Following a 25-year exemplary career as a teacher, Fromm was informed in February by the Peel Regional School Board that his contract was terminated.

In Canada increasingly at issue is what an educator thinks in his spare time. From the James Keegstra case to this current miscarriage of justice, the definition of what Jews will tolerate in classrooms is narrowing. Last year a part-time homosexual prostitute and full-time teacher hit the headlines. Since there was no evidence of any thought crime, B'nai B'rith and the Canadian Jewish Congress issued no fatwa and the man remained in situ.

A few years ago Fromm was disciplined for his "white supremacist" and "anti-Semitic" associations and advised to mend his ways. Forbidden to teach malleable adolescent minds, he was transferred to an adult education facility. Despite his repeated efforts, the authorities would not or could not clarify precisely what sins he had committed.

Responding to nebulous allegations of "shadowy associations" Fromm's lawyer, Doug Christie, produced meticulously documented evidence that accusations against his client had been cooked up by Communist Party fossils. Leader of the anti-Fromm crusade is tireless "worker" David Lethbridge, an instructor in psychology, a confessed Red and a devout passenger on the anti-racist gravy train. (Don't let that old Anglo name fool you.) Christie also presented irrefutable evidence that B'nai B'rith remains intimately involved with local minority activists, who themselves belong to a genuine terrorist organization.

Though it was a classic case of "Don't confuse me with the facts," the Peel Board finally bit the anti-Majority bullet and sacked Fromm. The ostensible reason was that he had once said a few words at

the funeral of the late Revilo Oliver, the University of Illinois professor who raised the study of anti-Semitism to a high level of scholarship.

As it stands, Fromm has been fired outright—no financial settlement, no benefit package, no income. Since he has filed an appeal, a strong show of support for Fromm could well affect its outcome. A defender of Fromm, Doug Collins, who writes a column in British Columbia's North Shore News that is redolent of H.L. Mencken and Westbrook Pegler at their best, has been summoned by a nosy, noisy, noxious group, the B.C. Human Rights Commission, to answer a complaint by the Canadian Jewish Congress, a racist cabal dedicated to the proposition that no word critical of Jewry should ever appear in any Canadian periodical or be heard on any Canadian radio or TV station. Collins' "crime" was amending the title of the movie, *Schindler's List*, to *Swindler's List*. On and off in his columnistic musings Collins has intimated that the Holocaust has been hyped to the gills.

What all this amounts to is a stern warning to film reviewers not to be too critical of any film having to do with Jews and Jewish causes, a "regulation" which gives such movies a headstart at the box office, since negative comments must be muted. We all know Jews control Hollywood. Now we are learning they want to fix the boundaries of film reviewing.

The chairman of the B.C. Human Rights Commission is mischling Mary-Woo Sims, one of Canada's most Amazonish lesbians. Since the North Shore News has already had to spend some \$52,000 in preparing for its defense and the defense of columnist Collins, it might behoove some well-heeled Instaurationists to send a few bucks to the North Shore News Defense Fund, 1139 Lonsdale Ave., North Vancouver, V7M 2H4, Canada.

Dr. F.A. Wigmore, a reputable Canadian surgeon, served in an overseas Canadian hospital unit during and after WWII. Wigmore recounts that when

homo could have painted the *Mona Lisa* so lovingly. Mozart is not popular with the papacy because he promoted the cause of Masonry. To be on the safe side the currency will stick to bridges, church windows, buildings and other impersonal objects.

**Britain.** In the old days one of the many pluses of religion, among its many defects, was the moral boost it gave to human behavior. No more. Church of England Reverend John Papworth recently pronounced ex cathedra that it was no sin to shoplift articles from Britain's largest department stores and retailers. The divine was circumspect enough, however, to draw the line on stealing from small merchants.

Adrian Targett, a schoolteacher who lives in the town of Cheddar, has some of the mitochondrial DNA of 9,000-year-old Cheddar Man, whose remains were discovered in 1903 in a cave only half a mile away from Targett's residence. The DNA of Cheddar Man was obtained from a molar tooth.

Double jeopardy, becoming a fixture of American justice, is now eating at the foundations of Britain's legal institutions. Five young white males were suspects in the killing of a black in London four years ago. Charges against two of them were dismissed for lack of evidence. The other three, brought to trial, were acquitted. Britain's liberal-minority coalition, however, was not willing to call it quits. Last February the five were ordered to appear before a reconvened coroner's jury which found them guilty of "unlawful killing." A few days later the Daily Mail came out with a front-page story condemning the five whites as murderers and displaying their pictures. Primed by the resurrected investigation and media fuss, the black youth's family, taking a cue from the second O.J. Simpson trial, is planning to institute civil proceedings against the accused.


A black doctor, Patrick Ngosa, originally from Zambia, plied his Hippocratic trade in Britain for eight months after learning that he had picked up the HIV virus from an infected sleeping partner. A massive search is currently underway to identify the 1,752 patients the doctor may have treated while he was keeping his own disease secret.

*From a subscriber.* In a recently released 1995 VCR tape, "The Truth Shall Prevail," David Irving estimates that at most half a million Jews died from all causes in WWII. Those the historian refers to as "the traditional enemy" have inflated this total by an order of magnitude. Irving further points out that the words "Holocaust" and "genocide" are marketing ploys used by the compassion industry to acquire big bucks and global power.

Irving suggests replacing the word "genocide" with "innocentocide" to define the killing, not just of Jews, but of innocents on all sides. How this neologism sits with Holocaust doctrinaires can well be imagined.

In the same tape Irving explains that recent documentary evidence from Russian archives reveals a total of only about 65,000 deaths at Auschwitz during its entire operation, most due to natural causes (especially typhus). Only a tiny fraction of deaths could be ascribed to deliberate extermination programs (which Irving admits did happen).

#### Sweden.

**France.** Although 58% of French think their country has too many Arabs, a recent government proposal to put more effective controls on immigration has brought gangs of intellectuals out in the street to storm and rail against the politicians who support the cutback. One hundred thousand of these *Intellos*, as they

are called, demanded no tampering whatsoever with immigration laws. Needless to say the urban marchers were largely unsupported by country folk. The leaders of the demonstration—writers, filmmakers, cartoonists—were never identified as Jews, though, as in all such manifestations, the Chosenites are invariably on center stage.

Le libre Journal ran a full-page article comparing attempts to revise the Gospels with laws criminalizing even the slightest revision of the Holocaust canon. Paradoxically, Bible revisionists are protected by law, while any revision of the Six Million hoax is forbidden by law.

In a new French bestseller, *Roman d'un président*, Jean-Marie Le Pen, replying to questions by two reporters, is quoted as saying President Chirac lost the presidential election of 1988 because he refused to solicit Front National votes. To keep his "respectability" and perhaps in exchange for a packet of francs, Chirac was willing to turn his back on Le Pen and allow Mitterrand to win the presidency. The reporters then went on to say that Le Pen considered Chirac to be a hostage of Jewry.

All the above, said Le Pen, was a bare-faced lie. He has filed suit against the book's publisher. In the midst of the furore, Le Monde, the N.Y. Times of France, published a 1986 statement of the B'nai B'rith indicating that France's two conservative parties promised not to have anything to do with the Front National. Other engagements undertaken by the conservatives have never been revealed.

The ongoing campaign against Le Pen has reached the point where some of his enemies have actually called for his assassination. The left-wing paper, Liberation, reprinted a "Wanted Dead or Alive" poster that portrayed Le Pen as a Western-style bank robber. Another left-wing newspaper editorialized that his assassination would be most welcome. A TV personality suggested that someone "put out" Le Pen's "good eye." He lost the other fighting Algerian separatists.

**Switzerland.** A preliminary report on the question of looted Nazi gold was not good news to the Jewish-led army of financial ferrets. U.S. researchers could find no proof that the melted-down jewelry of Holocaust victims, along with their dental fillings, was ever received and stored by Swiss banks. Nonetheless the investigators will keep on investigating until they find—or invent—some proof that the Swiss banks connived with Nazis to



filch the wealth—the enormous wealth—of a tiny fraction of the European population. No attempt, of course, is being made to find the wealth seized by Jewish commissars in the Soviet Union in the course of the Communists' massive confiscations. Surely some of this bountiful booty must have found its way into various Swiss banks.

Instead of the Jewish billions the World Jewish Congress claims have been squirreled away in Swiss banks, an ombudsman has turned up only \$1.3 million, of which a mere \$9,000 belonged to five Jewish account holders. Interestingly the all-out Jewish assault on Switzerland has forced a significant part of the population to take a piercing look at Jewry and the whys and wherefores of anti-Semitism. Swiss government officials have been flooded with letters critical of the Jewish shakedown—letters in which for the first time the writers gave their names and addresses.

**Germany.** Three huge wooden spears, six to seven feet in length, have been unearthed in Germany. Archaeologists determined they are 400,000 years old. Man, or early proto-man, has been around much longer than anyone previously believed.

"Multicultural" Germany is more than a little disappointed in the behavior of its increasingly mixed population. In 1938, when all the people were Germans, a total of 355,665 crimes were reported. In the new "diversified" Germany of 1996, the count was an incredible 7 million crimes. In 1938 there were 468 murders, in 1996, 3,928; in 1938, 903 cases of rape, in 1996, 6,200; in 1938, 502 robberies, in 1996, 63,470. Heil democracy!

**Czechoslovakia.** Auschwitz had a symphony orchestra. Now it turns out that Terezin, a German-run concentration camp in Czechoslovakia, had a gaggle of would-be gourmet cooks, who experimented with all kinds of fancy recipes, which have been published in a bestseller, *In Memory's Kitchen, A Legacy from the Women of Terezin*. Instructions for preparing game, sweet cakes and other delicacies for elaborate Jewish family feasts are scattered throughout the cookbook. Not exactly the kind of opus you'd expect from people who themselves were supposedly scheduled to be thrown into ovens.

**Romania.** Having finally rid themselves of Communist (paleo and neo) leadership in the last parliamentary elections, Romanians are now examining past national and religious traditions to determine their suitability for incorporation in the new Romania. The recent visit of ex-King Michael met a mixed reception. In the city of Timisoara, where the anti-Communist revolution first broke out in 1989, the Legion of St. Michael the Archangel (the Iron Guard) has been gaining popularity among university students. The Legion is an uncompromising Christian organization, founded and led by Corneliu Zelea Codreanu until he was murdered in 1938. Legion members have been ruthlessly persecuted, imprisoned and murdered by Romanian governments ever since. The official logo of the Legion is "For a Christian Europe." It is opposed not only to any return to communism but to one-world capitalism as well.

**Russia.** *From a subscriber.* Analysis of the new Russian establishment (bankers, media moguls, politicians and industrialists) reveals total corruption, favoritism and Jewish control of the media and finance. Young crooks and sharpsters have replaced the equally inept and aged Communist nomenklatura.

The government, through the office of Deputy Prime Minister Alfred Kokh, 35, simply assigns most of the previously state-owned oil and industrial enterprises to hand-picked youthful CEOs. As personal friends of Yeltsin and in gratitude for the government's generosity, they return the favor in the form of financial support for the current government. Mikhail Khodorkovsky, 33, former head of the Communist Youth League, has been given 80% control of Russia's second largest oil company.

Media control has gradually fallen into the hands of two Russian Jews, Vladimir Gusinsky and Boris Berezovsky. The latter, also a member of the Russian Security Council, previously admitted he had dual Israeli-Russian citizenship. Gusinsky founded the Most Bank; Berezovsky has multiple bank interests. General Lebed, the most popular candidate for high office, now finds himself partially frozen out of media coverage. Deputy Prime Minister Yakov Urinson and Minister of Finance Aleksandr Livshits (both Jews) preside over economic and financial matters, while Deputy Prime Minister Anatoly Kulikov, the "top cop," is officially responsible

for policing economic and tax crimes—an impossible job.

Fortunes are being made by the privileged few. Billions of dollars flow into Russia from the West and billions flow back out again for safekeeping in Swiss and other banks. Meanwhile the armed forces, the scientific and academic community and working people in general have to wait months to get their paychecks.

**Israel.** The greatest problem facing present-day Israel is the seemingly irreconcilable dichotomy between secular and Orthodox Jews. Although most of the new immigrants (*olim*) are secular Soviet Jews, the fanatically religious Orthodox generally have more children. Their fervor equals that of the followers of Iran's ayatollahs. In the past 20 years special military units called *yeshivot hesder*, designed specially for nationalist-religious soldiers, have grown enormously. There are now 20 such units, each with 3,000 to 4,000 religious Zionist soldiers. The graves of Baruch Goldstein, who murdered 29 Arab worshippers in Hebron, and Yigal Amir, who murdered Prime Minister Rabin, are venerated. Israeli women who fail to observe traditional religious rites, dress and behavior are scorned and even attacked by their more observant fellow citizens. The country is now so divided that a civil war cannot be ruled out. Aggravating the situation is the increasing strength and control of the Russian-Jewish Mafia which in recent years has invested some \$4 billion in Israel through fictitious firms that deposit large sums in Israel's notoriously "liberal" banks.

A heart attack felled billionaire Shaul Eisenberg in Beijing in March. He had his own Boeing 727 complete with gold fittings. His mansion in Tel Aviv has one wall sheeted with gold. Eisenberg was heavily implicated in arms sales to China, some of which violated U.S. agreements with Israel. Considering the wealth of Eisenberg and other Israeli magnates, U.S. citizens have the right to ask why they should give Israelis \$3 billion-plus a year, particularly when so many American citizens' incomes are on or below the poverty line.

**Australia.** *From a subscriber.* I read with amazement the following quote from Dennis Shanahan in Rupert Murdoch's flagship newspaper, *The Weekend Australian* (April 5-6, 1997): "[T]he power of Jewish financial contributions to Liberal coffers has a legendary and almost mythical impact on the Liberal (and Labor) psyche."



### Secessionist Texans

Lawmakers are increasingly worried about a militia-type group that calls itself the Republic of Texas. Some members, supposedly armed, have taken to the hills. Located near Fort Davis, ROT claims that the government is preparing a Waco-type assault against its membership. The outfit's leader, a firebrand named Richard McLaren, who has already served some jail time, has been warned by a federal judge that if he persists in his errant ways and ignores various judicial commands, he is destined to spend a lot more time behind bars. The organization insists that the state of Texas was illegally annexed to the U.S. and is legally an independent nation.

### Silence Reigned

A Majority member who works for the Social Security Administration in Washington asked the following question at a meeting for Social Security employees last year:

Why should my boss. . . who makes several times my salary, have an officially recognized organization to represent him [Black Affairs Advisory Council] simply because of his race, while I am denied the same benefit for the same reason? Don't you know this is against the law? Don't you know this is wrong?

No one at the meeting chose to answer.

If eugenics is not restored to its rightful place in the sun, mankind, or at least that part of mankind huddled in the white world, will soon retrogress to the primeval slime from which it once emerged.

### Butz Keeps Buzzing

Arthur Butz, the Northwestern University professor of engineering, still manages to support and promote his anti-Holocaust views from his perch on the Internet. The mere thought of Butz's web site drives Jewish organizations and individuals up the wall. One such individual is Sheldon Epstein, a part-time lecturer on engineering design at Northwestern, who took it upon himself to devote some of his classroom time to denouncing Butz.
