"The majority of people do not learn bigotry at home, but in the streets and schools," he expounded. Martinez didn't seem to be hurting in any real way. Although he says he has received death threats, he has a book on the market, *Brotherhood of Blood*, and his story will come out in a television documentary in 1991.

The giant video screens near the stage made it possible to see close-ups without binoculars and the special laser effects were infinitely better than the rinky-dink opaque projector light-shows of the hippie era.

In January, I attended the East Coast Horror Movie Fan Convention in Manhattan. Fabulous! Everything a white racist with feelings of suppressed rage could hope for! I even got to shake hands with Leatherface of The Texas Chainsaw Massacre. What a jolly fellow! The fans were mostly white males in their teens and twenties. ## The New York Times Invents a Jew

Though Jews are only a drop in the world's demographic bucket, their population is increasing day by day -- at least in the ranks of celebrities. Take Bertolt Brecht. If you read the New York Times (May 6, 1990), you would discover he is Jewish.

### Vandalism Is Reported at Brecht's Gravesite

EAST BERLIN, May 5 (AP) — The graves of Bertolt Brecht and his wife have been vandalized and smeared with anti-Semitic slogans, the official East German press agency said today.

The agency said vandals painted slogans like "Jews Out" on the graves of Brecht and his wife, Helene Weigel, and on the walls of the East Berlin cemetery. The report did not say when the vandalism took place.

Brecht, a Jew and a Marxist, fled the

Nazis and lived in the Netherlands and the United States before settling in East Germany in 1948. He directed the state-supported Berliner Ensemble.

His plays included "Threepenny Opera" (1928), with music by Kurt Weill, and "Mother Courage and Her Children" (1941). He died in 1956.

Reports of anti-Semitism and violence by neo-Nazi groups have increased since East Germany's pro-democratic revolution in October.

Though it's pure heresy to contradict the "good, grey Times," as it has been undeservedly called, Brecht was not a Jew. He was the son of a Bavarian Roman Catholic father and a Lutheran mother. Since he was an atheist, he could hardly be accused of being a convert. So why did the Associated Press and the New York Times list this talented poet and playwright (Mother Courage, The Caucasian Chalk Circle, Galileo, the libretto of The Three Penny Opera) as a Jew? Because he palled around and collaborated with Jews, even married one? Who else could you pal around with if you were an anti-Nazi German playwright?

Brecht was transformed into a Jew to add some sentimental oomph to the alleged neo-Nazi activity in Berlin. Vandalized graves of non-Jews don't have the necrophilic appeal of vandalized Jewish graves. If a grave is desecrated by a swastika, then the contemporary media storyline dictates that the dead person must have been a Jew. If he isn't, make him one. Never neglect to play the anti-Semitic card. The Holocaust must never be forgotten. The Israelis must get their annual payola.

Back in the 1920s and 30s, the Times "underreported" the famines in the Soviet Union in order not to dilute world Jewry's crypto-affection for the Bolsheviks. In the 1940s, the Times blamed the Katyn massacre on the Nazis and waited almost half a century to take back this horrendous howler. War crimes trials sent several Germans to the gallows for crimes that Stalin cooked up in his campaign to wipe out the Polish officer corps -- all without a peep from the Ochs-Sulzberger mediocrats.

Nevertheless, the New York Times, which reads as if it were edited by Baron Münchhausen, continues to be the U.S. newspaper of record.



# EQUALITY AND FELON REHABILITATION

**A**MONG CRIMINAL JUSTICE experts, there are two major schools of thought on why perpetrators commit crime: classical (nurture-produced criminality) and positivist (nature-produced criminality). Until recently, the classical school was dominant in this country.

## Classical School

The classical school emerged in the middle of the 18th century. Its principal author was Italian economist Cesare Beccaria (1738-1794), who was strongly influenced by French writers like Montesquieu, Rousseau and Voltaire. A single work by Beccaria constitutes the manifesto of the classical school of criminology. *Dei Delitti e della Pene (On Crime and Punishment)*, published in 1764, is essentially a plea for reform of the judicial and penal systems, characterized at the time by secret accusations, extensive use of torture, harsh penalties for trivial offenses, mixing with politics and the extreme arbitrariness by judges in levying punishments.

According to Beccaria, humans are fundamentally rational and hedonistic. They possess free will and base much of their behavior on their calculation of expected pain or pleasure. To avoid the chaos resulting from total individual freedom, humans essentially enter a contract in which they relinquish to legal systems part of their liberty in exchange for security. But men and women are basically self-serving. Given the opportunity, they will enhance their own position at the expense of other humans. Consequently, the role of the state is to reduce these acts of selfishness, which often degenerate into outright crimes. Beccaria wrote:

It is better to prevent crimes than to punish them. This is the ultimate end of every good legislation, which, to use the general term for assessing the goods and evils of life, is the art of leading men to the greatest possible happiness or to the least possible unhappiness.

To this end, Beccaria argued that laws should be clear, simple and directed against only the types of behavior clearly endangering the social order. While compliance with laws should be rewarded, individuals must be convinced that punishment for crime will be certain and prompt, and that the pain inflicted will outweigh the pleasure derived from the lawbreaking.

Beccaria perceived human beings as equals. Having never lived in a multiracial or multicultural society, when he referred to humans, he had in mind his Italian countrymen and the few other Europeans he had encountered. Because rationality was a human characteristic, Beccaria saw all men and women as equal before the law and accepted literally the proposition that the punishment should fit the crime.

It was not until the early 1900s that Beccaria's theory of punishment was amended to include the proposition that all people are born equal and that the sole cause of deviance rests with socioeconomic deprivation. The apostle of this theory in the U.S. was Franz Boas, born in Germany in 1858 of radical socialist Jewish parents. Since his education included no study of anthropology, how he got his Ph.D. is something of a mystery. Nevertheless, in 1899 he became professor of anthropology at Columbia University, which at the time had a 40% Jewish student body.

During his nearly 40 years at Columbia, Boas expounded his doctrine of social or "cultural" anthropology. Social anthropology breaks with physical anthropology (and also with all past

wisdom on the subject) in teaching that so-called racial differences were primarily due to environment rather than to inherited influences.

Selected pupils of Boas, given an aura of authority with Ph.D. degrees, were placed at the head of anthropology departments in leading universities. They soon became the favorite anthropologists of press, radio and, later, television, all of which freely disseminated their pronouncements and refused a hearing to the few social scientists who dared challenge their anti-hereditarian dogma. The Boas school must bear a large share of the responsibility for forcing virtually the entire academic and intellectual life of the U.S. (and much of the political, economic, religious and social life as well) to accept equalitarianism as the gospel truth.

Because they assert criminality is the product of socioeconomic conditions, adherents of the classical school claim that criminal elements can be changed by rehabilitation. Although the term was never conclusively defined, rehabilitation as a penal ethic emerged in the early 20th century as an alternative to the long-established punishment model. In the post-WWII period, rehabilitation became a totem of the criminal justice system. In 1949, the U.S. Supreme Court, in *Williams v. New York*, observed that "Reformation and rehabilitation of offenders have become important goals in criminal jurisprudence."

The 1966 Manual of Correctional Standards, published by the American Bar Association, promoted rehabilitation as the appropriate basis for sentencing and correctional philosophy:

Punishment as retribution belongs to a penal philosophy that is archaic and discredited by history . . . Penologists in the U.S. today are generally agreed that the prison serves most effectively for the protection of society against crimes when its major emphasis is on rehabilitation. They accept this as a fact that no longer needs to be debated.

During the decades that the classical school reigned over the criminal justice system, the crime rate increased much faster than the rate of population growth. Moreover, the recidivism rate of felons also continued to increase unabated during this period.

Beginning in the late 1960s, with crime escalating to new heights, scholars and criminal justice officials began to question the efficiency, if not the desirability, of the rehabilitation model. In *The Public Interest* (Spring 1974), Robert Martinson asked, with regard to rehabilitation, "What works?" He answered his own question in a now often repeated statement: "With few and isolated exceptions, the rehabilitative efforts that have been reported so far had no appreciable effect on recidivism."

By the end of the 1970s, the vast bulk of research criticized the effectiveness of the classical school's rehabilitation programs for criminal offenders. Today, the emphasis in sentencing and penal philosophy has shifted from rehab and parole to punishment and just deserts. In 1984, a Senate Judiciary Committee report buried rehabilitation:

Recent studies suggest this approach [rehabilitation] has failed, and most sentencing judges as well as the Parole Commission agree . . . We know too little about human behavior to be able to rehabilitate individuals on a routine basis or even to determine accurately whether or when a particular prisoner has been rehabilitated.

During the late 1970s and the early 1980s, many states, includ-

ing California, and the federal government changed their sentencing laws to emphasize just deserts and to deemphasize rehabilitation. As one commentator put it, "Retribution has returned to criminal justice. Rehabilitation is being passed over like a meal that did not digest well."

Nevertheless, the many equalitarian successors of Professor Boas have not given up their championship of rehab. Some argue that it was never fully or effectively implemented. Rehabilitation critics dismiss such arguments as more wishful thinking than wisdom.

Other than the apparent falsity of the theory, why was rehab "officially" abandoned? According to most writers, part of the reason has to do with basic changes in societal norms. Francis Allen, in *The Decline of the Rehabilitative Ideal: Penal Policy and Social Purpose*, asserts that the rehabilitative ethic can flourish only if a culture accepts two key assumptions: (1) a strong and widespread belief in the malleability of human character and behavior; (2) a consensus of values as to what it means to be rehabilitated. According to Allen, neither assumption is accepted in contemporary American culture. Allen and other writers also point to our culture's irreverence and the loss of faith in the capacity of institutions and the government to change individuals or achieve social goals.

### The Positivist School

Cesare Lombroso (1835-1909) has been described as "one of the best known and possibly one of the least well understood figures in criminology." He pursued the cause of behavior by applying scientific methods to the study of individuals, and is considered the founder of the positivist school.

Lombroso's most important book, *L'Uomo delinquente (The Criminal Man)*, first published in Italy in 1876, contained his doctrine of evolutionary atavism. Criminals were seen as distinct types of humans who could be distinguished from noncriminals by certain physical traits. These traits did not cause criminal behavior, but served to identify persons who were out of step with the evolutionary scheme. Such persons were considered to be closer to apes or to early primitive humans -- throwbacks (atavists) to an earlier stage in human development.

A physician trained in psychiatry and biology, Lombroso was aware of the recent works of Charles Darwin, whose theory of evolution linked modern humans with a nonhuman past. It is a trait of the classical school to attack Lombroso solely on the basis of his theory that criminals can be detected by their physical traits,

yet this concept represents only a small portion of his voluminous work and does not take into account later modifications in his thinking.

Lombroso's most famous students, Enrico Ferri (1856-1929) and Raffaello Garofalo (1852-1934), broke away decisively from concentrating exclusively on physical features. Ferri suggested five types of criminals: (1) insane criminals who acted as a result of mental infirmity; (2) born criminals, "whose anti-human conduct is the inevitable effect of an indefinite series of hereditary influences which accumulate in the course of generations"; (3) habitual criminals who show in an indistinct way, if at all, the marks of the born criminal, and act through moral weakness, especially when under the influence of a corrupt environment; (4) criminals of passion who act under the impulse of sporadic emotional binges during otherwise moral lives; (5) occasional criminals who have not received from nature an active tendency towards crime but have fallen into it, goaded by the temptation incident to their personal conditions or physical and social environment.

Garofalo disagreed with Ferri on many counts, but not upon the hereditary nature of crime. He suggested a theory of moral degeneracy that resulted from retrogressive selection and cause man

to lose the better qualities which he had acquired by secular evolution, and has led him back to the same degree of inferiority whence he had slowly risen. This retrogressive selection is due to the mating of the weakest and most unfit . . . Thus are formed demoralized and outcast families whose interbreeding in time produces a true race of inferior quality.

### Present and Future Research

The present-day just deserts model of criminal sentencing is neither purely classical nor purely positivist. No attempt is made under this model to determine what causes criminality and how to combat these causes. Instead, once a crime is committed and a perpetrator convicted, a harsh sentence is imposed to incapacitate the criminal.

Due to decades of nearly total control over research grants and publication avenues by the equalitarian school, positivist theorists have all but totally abandoned research. Little or no attempt has been made to understand the sexual and racial disparities among crime perpetrators.\* The few positivists who are conducting research are proponents of the predictive deterrence or selective incapacitation theory. They argue that sentencing and punishment should be based on neither the rehabilitation nor the just deserts model, but rather on a model that seeks to predict at the time of their first offense which offenders are more likely to engage in serious crime, and to incarcerate such offenders for long periods of time, irrespective of their crime.

While pointedly avoiding sexual and racial disparities, some researchers today are conducting twin studies to determine which traits are biological and which are environmental. This research has confirmed the conclusion of Francis Galton in 1875 that the "history of [twins] affords a means of distinguishing between the effects of tendencies received at birth and those that were imposed by the circumstances of their lives, in other words between the effects of nature and nurture." A few studies of identical twins reared apart have revealed criminal tendencies in the siblings, even though they were brought up in entirely different home and parental environments. If it should stand up, this line of research is bound to raise new interest in the positivist theory of crime.

\* According to the Justice Department, 96.6% of those who commit major crimes are male. A black is 7.5 times as likely as a white to commit a felony; a Hispanic 4.5 times. Recidivism studies show that 50% of male felons are imprisoned for a second or subsequent offense, compared to 36% of the females. The recidivism rate for whites, including Hispanics, is 45%, compared to 56% for blacks.

## THE WASP MYSTIQUE

**E**VERY NATION RIDICULES other nations," wrote Schopenhauer, "and all are right." The philosopher's generous, territorially based sentiment is difficult to realize in a multi-ethnic nation like modern America, where who-gets-to-ridicule-whom establishes the current racial pecking order.

A critic for the Los Angeles Daily News recently spoke of "WASPs, the latest discovery in the movies' non-stop search for idiots and villains." "Latest discovery," of course, is typical Hollywood hype. Journalists were busy dissecting the WASP-bashing phenomenon by the mid-1970s. The very same West Coast critic, John H. Richardson, describes the movie, *Clara's Heart*, starring Whoopi Goldberg, as

a Jamaican housekeeper who comes to a WASP plantation to try to save the white people from themselves.

The adult WASPs are beyond hope -- they've been psychoanalyzed and yuppified to the point that they're virtually zombies. But by singing reggae and exposing him to poor people, Ms. Goldberg manages to save their young boy.

It sounds very contemporary, but there is an episode of the early 1950s TV comedy, *Beulah*, in which the too-wholesome, all-American family's Negro maid, played by Ethel Waters, redeems their blond boy by teaching him all the latest moves in shuckin' and jivin'.

Richardson, however, is right to observe, "Lately, WASP-kicking has taken on a new urgency, becoming a trend so vast it's almost unnoticeable." One of many new books with the theme is *The WASP Mystique* (Primus, 1987), written by Italian-American psychiatrist Richard C. Robertiello and WASP-American psychology student Diana Hoguet. In many ways a shallow, even stupid work, *The WASP Mystique* deserves a closer look for the light it sheds on the often muddled Italian-American mind.

ethnic whine."

Robertiello finds several grave flaws in the WASPs. He says that the WASP lives his life as a symbol, without "ever becoming a real person." The emphasis is on adjustment to and affiliation with the WASP social group (defined here in class as well as ethnic terms) rather than on individual achievement and self-realization. "Transcendent for upper-class WASPs is the necessity to assure themselves of a moral and behavioral superiority, 'holier than thou,' and to avoid shame and humiliation." The *WASP Mystique* in-

cludes "a heavy emphasis on suppression of overt expression of feelings and an attitude of distance and moral superiority." WASP graciousness is nice in a way, but finally reduces to a "formula for dealing with people." The result: "No emotional damage . . . No upset, but not completely alive either." The corporate WASP is a "team player" with a low-key personality. The public position of the upper-class WASP is "to eschew prejudice, to denounce it as unfair and indeed immoral . . . WASPs are extremely cautious about overt expressions of prejudice." Of course, in the safe precincts of their homes and clubs, things are otherwise. WASPs express their prejudice by "veiled contempt and shunning," with "a knowing smile and a wink." Mr. WASP doesn't "join up with the Ku Klux Klan or the American Nazi Party," yet "the result is far more invidious."

WASPs self-protectively avoid coming into conflict with their often unaware feelings of prejudice by avoiding the objects of their prejudice. They try not to dirty their hands or their psyches.

WASP guilt is thus diminished -- for many of these people remain liberals -- but at the cost of "inhibitions and frustrations."

Robertiello devotes several chapters to describing the lives of some of his disturbed WASP patients, whom he misrepresents as being almost typical of the breed. (A book like this by a WASP shrink describing his "typical Jewish patients" would have the ADL demanding his medical license.) "Don," a Cleveland WASP, is a man still in his forties who goes months at a time without making a single sexual move toward his wife. His sister is heavily into drugs, his mother is a martyr type, and so on.

It is hardly remarkable that many of Robertiello's WASP patients present caricatures of the WASP character. Yet instead of recognizing that he is seeing one end of a normal distribution curve, the notably unscientific Robertiello has begun to see disturbed personalities wherever he sees WASPs, and readily attaches labels like "rigid," "repressed" and "bland clone" to practically the whole lot. He concedes the existence of healthy WASPs in the traditional mode, but makes it appear as if they are a minority.

The two main messages of *The WASP Mystique* are: (1) non-WASPs should not try to think and act like WASPs; (2) WASPs should strive to think and act less and less like WASPs. Replete with fascinating case histories of so-called "self-hating Jews" and "self-hating Italians" who tried to pass as WASPs, Robertiello's book attempts to show how psychoanalysis helped return them to ethnic authenticity.

Robertiello comes close to the truth at one point, when he says, "By nature and presumed necessity he [the WASP] is conservative, a self-preservationist rather than a self-fulfiller." The WASP, he complains, invokes euphemisms like "quality of the area, zoning laws, overdevelopment . . ."

WASPs caught in a decaying multi-ethnic environment try to preserve their traditional liberal ways while politely distancing themselves from their genetically and culturally threatening "equals." This produces what Robertiello calls the WASP "holier than thou" syndrome. But instead of trying to understand what is really going on here, he retreats into the sort of psychobabble which is used to mask basic realities -- calling the syndrome, among other things, a "reaction formation."

It is simply too painful for a man like Robertiello to accept some



of the tragic truths of American history (or even of ancient Roman history), so he resorts to Ellis Island kindergarten tales. His defensive mindset is revealed only too plainly in passages like this:

It was, of course, mostly the English -- and lower-class English -- who first settled in America. Some of the aristocracy did go South, but they were a small minority. It's not so surprising that having been at or near the bottom of their own social structure, the English settlers now saw an opportunity to set themselves up on top, being the first to get here.

Ellsworth Huntington, the great Yale geographer, demonstrated in many of his books that America's New England Yankee settlers were a rigidly selected lot of extraordinary intelligence, character and drive. Robertiello can be forgiven for not knowing this because the old Yankee type is almost extinct, and books like Huntington's have been driven from the marketplace.

As for the bizarre notion that the early Americans, feeling their inferiority, "saw an opportunity" to bring in foreigners and "set themselves up on top," Van Wyck Brooks's *The Flowering of New England* (1936) paints a more accurate picture:

All of [the Bostonians] lived and moved, walked and spoke as if their little town were a holy city . . . . For this there were certain reasons. Boston was only a regional capital, but a Boston man could say to himself, quite truly, that it was much more a capital than either New York or Philadelphia; for the people were more homogeneous. A visitor from New York, observing the crowd in the streets, exclaimed, "Why all these people are of one race. They behave like members of one family, whereas with us a crowd is an assembly of all the nations upon earth." As one of the results of this homogeneity, the institutions of the town and country had a greater similarity than in other regions -- a fact that was full of meaning for the future. It favoured the growth of the region in all its parts. For, while Boston attracted the master-minds and took them away from the smaller towns, it rendered them more active and efficient; and, precisely because of this concentration of powers, it was able to send forth influences that were beneficial to the rural districts.

In a population wholly derived from England, one counted the foreigners [in Cambridge] on a single hand: two Scotch gardeners, a hair-cutter of nebulous antecedents, one Irishman, the master of a spade. And the Irishmen knew his Latin, like everyone else . . . . The janitor of the newly-established Law School was a notable spouter of Virgil.

In all New England, as late as 1840, there were, as Brooks says, only a handful of people of non-English stock. As racially similar as the Irish were, their different code of values brought the total disruption of Boston-area ways in the decades of mass immigration that followed. The Yankee birthrate plummeted, the well-to-do WASPs lost much of their old community-mindedness, class antagonisms flared and, by the 1890s, the New England which had flourished for more than 200 years was extinct, as Rudyard Kipling and other English visitors recognized to their grief.

Part of Robertiello's problem may be that he has never come fully to grips with the reality and nature of Nordic racism. Writing about the extreme difficulty which an ethnic outsider experiences in "crashing" WASP society, even when he has all the "right" attitudes, Robertiello concludes: "Attitude, it seems, cannot be bought; it must be inherited."

What he means, of course, is not attitude but *appearance*. An Italian who looks like Robert Redford (a few do exist), and also has "WASP attitudes," is accepted as a WASP, even if all four of his grandparents were ethnic. A Jew who looks like Leslie Howard or Paul Newman encounters few assimilation problems (if he cares to assimilate), and so on across the appearance scale. The so-called "self-hating Jews" are generally ones with a definite physical resemblance to the American Majority. Had they been Woody Allen types, they would never have tried to pass. Indeed, many of

the would-be "passers" had emotional problems which originated partly in the circumstance that some family members had much more of a minority look than others.

Racial biology is the hidden, unspoken theme throughout Robertiello's book -- as it is in nearly all of the shallow, WASP-bashing books which have grown like weeds in the late 20th century. In one place, he lists (accurately) 39 WASP virtues and 20 WASP vices, and says, "Other ethnic groups would have very different lists." He means, of course, some other ethnic groups. The Scandinavians, being Nordics, have a list similar to that of WASPs. Yet only once, on page 56, does Robertiello suggest a biological basis for such similarities of character. In denouncing the WASP (actually, the broadly Nordic) "virtue" of high pain threshold, he writes: "If it's actually physiological, so be it." It is indeed a fact that the light-eyed tend to have a higher pain threshold than the dark-eyed.

A few of Robertiello's criticisms score direct hits. Like Peter Schrag, in *The Decline of the WASP* (1971), he correctly accuses WASPs of having become chained to their WASPdom. He chides WASPs for not "making waves," perhaps forgetting that when they do make waves, "white ethnics" are often furious. In the 1920s, the powerful KKK was strongest not in Alabama, but in New Jersey, Florida, northern New England, Indiana and Oregon. Most of that Klan activity involved Old Stock Americans who were upset about all the Italians, French Canadians and other "white ethnics" who were pouring into their Norman Rockwell towns from the big cities. Robertiello speaks favorably of "anger, passion and other feelings that allow intimacy and closeness." Doesn't he know that with Nordics, those feelings often lead to *separation*?

Naïveté may not be the answer to all of Robertiello's mistakes. He alludes to a wave of "WASP takeovers of corporations," insists that Levine and Boesky have copied WASP ways, says junk bonds and "greenmail" are part of the corporate WASP "motto," and accuses WASPs of miscasting Jews as the financial exploiters. For Robertiello, WASPs are *always* the "insiders," even in a field like psychoanalysis. At a time when ethnotherapy is winning wide praise, Robertiello might perhaps have mustered some sympathy for a WASP lady who was frustrated because she couldn't locate a shrink of her own ethnic and class background. After all, he admits, he once led a group session where a woman expressed anti-Semitism only to learn that the other nine patients in the group were all Jews! Of this WASP lady, he writes: "A paradox, that she of all people should feel shut out . . . ."

All in all, however, Robertiello's is a moderate book, compared to other off-the-wall racial tomes. At bottom, the author is basically friendly toward his benighted WASPs, even while saying things like "we've only just begun to fight [for ethnic liberation]," and calling the present moment a "juncture in social transition." (Rome, too, was "in transition" for a long, long time to get where it ended up!)

One always comes away from these confused authors -- Robertiello, Schrag, Leo (Dr. Hug) Buscaglia -- feeling that a few candid words from some true-blue Nordic, and a few informed books, would perform wonders of enlightenment and blast away mountains of envy, frustration and ad hoc history. The ethnics who dabble in comparative raciology, while denying the existence of any such thing, are basically perceptive, well-meaning sorts, and can scarcely be blamed when half the country is vaguely conspiring to spare their feelings.

# THE ETERNALLY CONTENTIOUS ARMENIANS

**A**FTER A MASSACRE of Armenians in Baku in 1905, a Western journalist named J.D. Henry tried to plumb the deaths of mutual hatred in the Azerbaijani capital. "I unhesitatingly declare that no one can put forward a theory that will be universally accepted as true," he concluded. "Baku is the hotbed of wild theories, misrepresentations and lies."

The current fighting between Armenians and Azerbaijanis has centered around the ethnically Armenian enclave of Karabakh [Karabagh] within Azerbaijan. One reason why it is so heavily Armenian today is because of the massacres of 1918, vividly described in a British army field report.

24 October. Since the Pact of Batum the Armenians of the regions of Erivan, Karabagh and Nakhchivan have perpetrated every form of torment and cruelty on the general Muslim people of Burja and Kizah; in particular the Armenians have effectively annihilated the entire Muslim population of Erivan and Karabagh forcing by massacre, pillage and flame, wholesale flight. To date thousands of Muslim families have streamed in penury and want to the region of Kars where they are perishing.

The Armenians, to be sure, have often been history's victims themselves. The Armenian Soviet Republic of today contains only 11,500 square miles, whereas the historically Armenian region of eastern Anatolia (Turkey) covered an additional 57,000 square miles. The Armenians, a Christian Indo-European people with surprisingly close links to the Crusaders and other Western groups, occupied the Missouri-sized area for about 2,600 years before their deportation during WWI. The present inhabitants, the Seljuk Turks, arrived as recently as the eleventh century. Germans who bemoan the recent severance of their eastern territories can possibly grasp the Armenians' anguish at losing more than 80% of their ancestral lands at a single stroke. It is true that the Turks had gradually become the majority group in many areas prior to the expulsion, but perhaps white Westerners can also empathize with fellow victims of "demographic imperialism."

One thing about today's Armenians which wins them few popularity contests is their status as a verbal, urbanized ethnic diaspora with marked tendencies toward self-righteousness. Sound familiar? It is noteworthy that the largest concentration of Armenians in the New World, some 200,000, just happens to be found in greater Los Angeles -- clustered around Hollywood and Glendale, no less. It is also significant that the Armenians of the dispersion have bullied and often bombed both Turkish diplomats and Western scholars who dared to deny that Turkey sought their extermination during the grim years of expulsion.

Like the Holocaust revisionists, the Turkish spokesmen never deny that many atrocities were committed against wholly innocent Armenians of the day. But as the Turks delve further into the complexities of the period, the Armenians often turn nasty and try to end the debate. In the present struggle with Azerbaijan, thoughtful Westerners have again been disturbed to see the Armenians exploiting their sizeable presence in many of our larger cities by forcing a one-sided view of things.

The United States Senate, to its considerable credit, recently rejected Sen. Robert Dole's resolution designating April 24, 1990, as "a national day of remembrance of the 75th anniversary of the Armenian genocide of 1915-1923." Last October, however, the same body was less perspicacious when it adopted a resolution which strongly favored the Armenian side in the present Soviet

strife. A group of 23 representatives of the Azerbaijani news media immediately protested with a letter to the New York Times (Oct. 13), which set the record straight (or at least "straighter," as the aforementioned J.D. Henry would have said, despairingly):

We can only assume that a shortage of information explains that the Senate, discussing the humanitarian aspects of events in Sumgait that resulted in the deaths of 26 Armenians and 6 Azerbaijanis, did not find the words to express regret for the lives of 57 Azerbaijanis who died in similar events in Armenia. The Senate also did not note that in Armenia, where 200,000 Azerbaijanis lived before February 1988, not one remains, all driven out, left without shelter and means for survival, some killed.

The resolution, which was also deplored by Pravda, had been introduced by Sen. Claiborne Pell (D-RI), chairman of the Senate Foreign Relations Committee. In November, Pell was at it again, introducing another pro-Armenian resolution which also faulted Moscow's handling of the Transcaucasian ethnic clashes. The Soviet Foreign Ministry summoned the American ambassador to protest this "brazen and unwarranted" meddling in a "purely internal" Soviet affair, which violated "the most elementary norms" of international conduct.

## Different Peoples, Different Truths

Though the world heard plenty about the vicious killings of several dozen Armenians in Baku and Sumgait, it heard next to nothing about what lay behind the violence. A wire service report (Jan. 18, 1990) partly confirmed the plaint of the Azerbaijani journalists by noting that the homes of the Armenian refugees from Baku had "in most cases . . . been immediately occupied by some of the estimated 200,000 Azerbaijanis who had streamed into the republic" following their dispossession in Armenia. The press report continued:

By most accounts, the core of the recent uprising was the seething community of Azerbaijani refugees, more than 130,000 of whom reportedly settled in slum and squatter districts in Baku.

The newcomers, mostly peasant farmers and goat herders, were said to have changed the character of the city, a sprawling oil port on the Caspian Sea that prided itself on being cosmopolitan. Jobless and hopeless, they spent their days bitterly retelling stories of atrocities suffered at the hands of Armenians.

"Baku is not really Baku anymore," said one lifelong resident . . . "It has become a city of refugees . . . And everything else, the whole mood of the city, has been lowered to their level."

Gorbachev fans may have forgotten (if they ever knew) that a charismatic Azerbaijani named Geidar A. Aliyev nearly became the Soviet Union's first Moslem leader before Gorby's forces prevailed. The tall, trim Aliyev faded quickly from view after a heart attack in 1987. Last January, fully recovered, he returned to Moscow to present the world media with the Azerbaijani side of recent events.

"If we want to talk about pogroms," said Aliyev, "pogroms started two years ago. In Nagorno-Karabakh, they started killing Azerbaijanis and expelling them from their homes and their lands. And that was done by extremists of Armenian nationality."

Many people in the Soviet Transcaucasus are nursing a conspiracy theory, according to which the Russian imperialists have set the little nationalities at one another's throats to justify sending in

tanks and reestablishing strong, Moscow-oriented administrations. The idea is hardly a new one. The so-called Armenian-Tatar conflict of 1905-07, which involved the same two groups, is still widely believed to have been kindled by Russian Czarist officials pushing an expansionist policy of divide and conquer.

Russian reporters have had a hard time covering the latest round in the ancient feud, as groups of Armenians and Azerbaijanis alike have been beaten, shot at and threatened them for "distorting the truth." Victor F. Gorlenko, a deputy editor at Pravda, stated (Jan. 19, 1990), "Everyone is always trying to sell you their story and it's very difficult to distinguish the truth. In a situation like this, the truth of what is happening is different to different people." Gorlenko noted that only Slavic and Jewish reporters are now being assigned to the story. "Absolutely no Turks or Armenians, so there's no question of our objectivity."

Reporter Galina Sidorova of the Soviet magazine, *New Times*, analyzed the hot-blooded temperament at work:

When you go down to that region, even when there aren't all-out hostilities, people are always trying to figure out where your sympathies lie. And if, for example, Azerbaijanis hear that you've just come from an Armenian village, they often won't even speak to you because you just listened to the other side. But people are apparently so riled up now, they don't even ask you what side you're on, they just beat [you].

Tensions are greater still between the Armenians and their neighbors to the west, the Turks of the Republic of Turkey. During the early 1980s, an international bombing campaign killed Turkish representatives in many countries, as young Armenians vented their rage at Ankara's refusal to admit to a deliberate campaign of genocide in the years 1915-23. The most remarkable thing about this Armenian terrorism, according to the *Wall Street Journal* (Aug. 9, 12 and 16, 1983), was "the apparently widespread tolerance such violence has won among a basically conservative, middle-class community" (i.e., the Armenian Americans).

After the Armenian bomb-throwers quieted down in the late 1980s, the Turkish government announced that it was opening its entire archives from the expulsion era to all qualified scholars. "We will accept whatever reality emerges from the Ottoman archives," declared Prime Minister Turgut Ozal at a news conference, which produced only skepticism in the Armenian scholarly community. Prof. Richard Hovannisian of UCLA said it would be "naïve to believe that a government that has been so active in denial" of any genocide would make available any truly damaging papers.

The Turks reiterated their belief that no such papers existed. True, there had been a Decree of Deportation in 1915, but the infamous "Talat pasha telegram," ordering the extermination of the Armenians, which was first circulated in France by one Aram Andonian, had long since been proven a forgery. A key Western voice against them, added the Turks, had been that of the American ambassador, Henry Morgenthau Sr., who only listened to rumors and made no personal investigations, never even venturing beyond Istanbul. Like much of the Western diplomatic community, Morgenthau was an ardent Turkophobe, dedicated to dismembering a crumbling Ottoman Empire, out of whose ashes he hoped would come the Phoenix of Israel.

For their side of the story, Turkish Americans still recommend an essay called "The Turkish Tragedy," which liberal educator and philosopher John Dewey wrote for the *New Republic* (Nov. 12, 1928). Turks also point to the "war crimes trial" held by the Allies in the wake of WWI against several Ottoman leaders. After two years in detention, they were all released with no charges filed and no evidence produced.

The official Turkish position is that, in lands under the Turks' rule, somewhere between 300,000 and 600,000 Christian Ar-

menians died from all causes during the period in question. The Christian Greeks also lost hundreds of thousands, while the Muslim majority lost perhaps 2.2 million. Each of these groups suffered mostly from typhus, typhoid, cholera and starvation, rather than from bullets and bayonets. Parts of eastern Anatolia had no crops during three years of total upheaval. The Armenian figure of 1.5 million victims of a deliberate extermination policy is way out of line, say the Turks, who are fully supported by reputable scholars like Justin McCarthy, a professor of Middle Eastern history and demography at the University of Louisville. The Armenian lobby, taking a back seat to the Jews, has been unable to get McCarthy or people like him fired -- or to punish journalists like Colman McCarthy of the *Washington Post* (no relation), who has likewise championed the Turkish position.

### Dole's Folly

The senior senator from Kansas has shown a flash of courage lately with his verbal skirmishes with the Israeli lobby. In the case of Armenia, however, he threw oil on a simmering fire by proposing to make April 24 a national day of remembrance of the genocide inflicted by the Turks on the Armenians. The leader of the opposition to the bill, Sen. Robert Byrd (D-WV), observed, "Not one of 100 senators has the facts on which to make a careful, deliberate, objective judgment." As the resolution's co-sponsors dwindled from 60 to 46 in the face of fierce lobbying by Turkey and American arms contractors, Dole offered compromise wording which made less direct reference to genocide. Byrd defeated that too -- but only after four days of heated debate on the Senate floor climaxed months of jockeying behind the scenes. Sen. Alan Simpson (R-WY) called it "the greatest lobbying campaign I've experienced in a long while." A Senate aide called it "one of the slimiest campaigns I've seen in eight years on Capitol Hill. It's created a real international mess."

Something good, however, may have emerged from the slime. It is quite possible that Senator Dole's recent gestures in support of trimming aid to Israel were motivated at least in part by his moralistic fervor in behalf of the Armenian cause. Always a big Holocaust booster, Dole was profoundly dismayed last year when the Israeli lobby went to bat against his Armenian resolution. As *Washington Jewish Week* reported last Oct. 26,

Prominent Jewish lobbyists took the lead last week in fighting a Senate initiative to commemorate the Turkish massacre of Armenians . . . .

Some of the high profile lobbyists against the bill on behalf of the Turkish government are also leading figures in the Washington Jewish community: Morris Amitay . . . Richard Perle . . . Douglas Feith . . . .

Israeli journalists reported this week that the Israeli government asked American Jewish organizations to fight the measure . . . .

"Shameful" was the headline of a subsequent editorial in the same paper, which decried the "lack of moral vision" shown by Jews like Sen. Howard Metzenbaum (D-OH) in "whitewashing" the Turks. Such behavior continued an old pattern. Indeed, the Israeli government once tried to halt a major international conference on genocide, which was held in Tel Aviv, on the ground that Armenians were among the featured speakers!

One might have expected Jews to take the lead in decrying the "Armenian Holocaust," unless, that is, their jealous god doesn't want any Holocaust to take precedence over *The Holocaust*. Yet it seems there are several thousand Jews living in Turkey whose interests must be considered. Besides, Ankara maintains friendly relations with Israel. So the Israelis say they must support Turkey by keeping the Armenian wailers in line.

Fair enough. But how can the Jews remain angry with all those decent Western diplomats of the thirties who tried to maintain

good relations with the Third Reich?

Dole has been widely accused of offering his Armenian resolution solely because a kindly Armenian surgeon in Chicago once patched up his WWII wounds. Though his motives are surely broader than that, Dole shot himself in the foot with an error-filled "justification" of the bill.

He began by reciting the phoniest of phony Hitler quotes -- "Who, after all, speaks today of the annihilation of the Armenians?" -- which he insisted was uttered "as [Hitler] prepared to unleash the Holocaust on Nazi Germany." (How Der Führer must have hated those Nazis!)

After calling America "the world leader on human rights," Dole, who comes from the state which is going wild over the Eisenhower Centennial this year, suggested "you can't erase a genocide" -- shocking news to the millions of surviving victims of history's forgotten massacres.

Dole then proceeded to call Elie Wiesel "the world's authority on the Nazi Holocaust," and falsely asserted that the Allies'

post-WWI "war crimes trials" had found Ottoman officials "guilty of exterminating the Armenian nation."

The senator criticized the Turkish lobby for having "teamed up to keep us from even debating the resolution" -- which seemed to conflict with his follow-up: "But look at the ensuing Senate debate -- we won on the merits. Not one of our opponents was able to refute the volumes of evidence we offered on the Senate floor: chilling newspaper accounts of the genocide and official Ottoman documents that clearly revealed the murderous intent of its Armenian action."

Sheer folly! sighs Prof. Justin McCarthy. The official orders recently unearthed from the Ottoman archives were remarkably humane. War was almost constant in the region from 1912 to 1922, as were plague and famine. On some occasions, it was the Armenians and Greeks who massacred Turks.

That kind of talk may one day get the speaker a bomb in his lap. Too many Armenians, like too many Jews, have taken to wearing their victimhood like a holy mantle of righteousness.

## Gaseous Lucubrations

• That article about Fred Leuchter and the executioner's art in the February issue of Atlantic brought a hostile response from the New York ADL. Author Susan Lehman, who would have been crucified if she hadn't been Jewish, replied, "In my many hours of conversation with Frederick Leuchter, *The Leuchter Report* was never mentioned, and I was unaware of Leuchter's activities with respect to Holocaust 'revisionism' . . . I am grateful to the Anti-Defamation League for bringing these disturbing facts to my attention and to that of Atlantic readers."

• Gassing was in the news in San Francisco in April when it was reported that emissions from San Quentin's modern gas chamber pose a threat to fish and birds in the vicinity. Bob Cleek, an attorney who once was a prison guard, says it was

common knowledge that both cyanide gas and sulfuric acid, once leaked into the air and water outside the gas chamber, killed wildlife in the area. When capital punishment was commonplace, [Cleek] says, a special detail of prisoners was assigned to clear the prison rooftops of dead sea gulls.

Not true, said a prison spokesman, in response to columnist Peter Anderson's inquiry. Yet toxicologist Pat Holmes of the Bay Area Air Quality Management District told Anderson: "Someone from San Quentin inquired last week about the need for a permit. My understanding is that the prison was going to send us data on how much cyanide they use, in order for us to do a risk assessment analysis."

As Fred Leuchter and other experts have

pointed out in sworn testimony, the alleged German gas chambers were far flimsier and riskier than anything ever used in the U.S. If San Quentin's ultra-tight chambers killed gulls on the roof, there is all the more reason to believe Auschwitz's would have killed every person within half a mile.

• Five members of the Confederate Hammerheads, a Skinhead group in Dallas, were given terms ranging from 4 to 9 years for scheming to put cyanide gas into the air conditioning system of the local Temple Shalom "in memory of the Holocaust." (Overlooked in all the Skinhead publicity is the fact that many Skins in Portland (OR), Los Angeles and other cities have been shot and brutally beaten by non-whites on the basis of their appearance while going about their daily business.)

• An old family name in parts of the American South is Gassaway. Perhaps the ADL should investigate.

• Thousands of teenagers from 36 countries staged a torchlight parade at Auschwitz in April. Elie Wiesel came to the podium and perorated: "Years and years ago I saw -- I cannot tell you what I saw. I'm afraid that if I told you we would all wake up in tears and would not be able to stop. I see a young girl . . ." He stopped -- "apparently unable to continue," as the Associated Press put it -- and theatrically fled the dais.

• An important point raised at both of Ernst Zündel's historic trials in Toronto was whatever became of the ashes of the alleged millions of cremated victims at places like Auschwitz? Whenever historical revisionists managed to obtain answers to the question and announced their intention to

start digging, they were quickly told: wait a minute, that's only a "symbolic location" of the ashes. Those curious about where the *real* ashes went, got an answer of sorts in the Philadelphia Inquirer (April 23). Survivor Isabella Leitner says that at the time of the liberation in 1945 there were "shrieks of joy" and "hysteria":

I have never since heard sounds like those we uttered . . . The sheer force of it must have scattered the ashes of Auschwitz to every corner of the universe.

Why not? Science demands consistency, and this fits in perfectly with the death camp physics of survivors like Elie Wiesel.

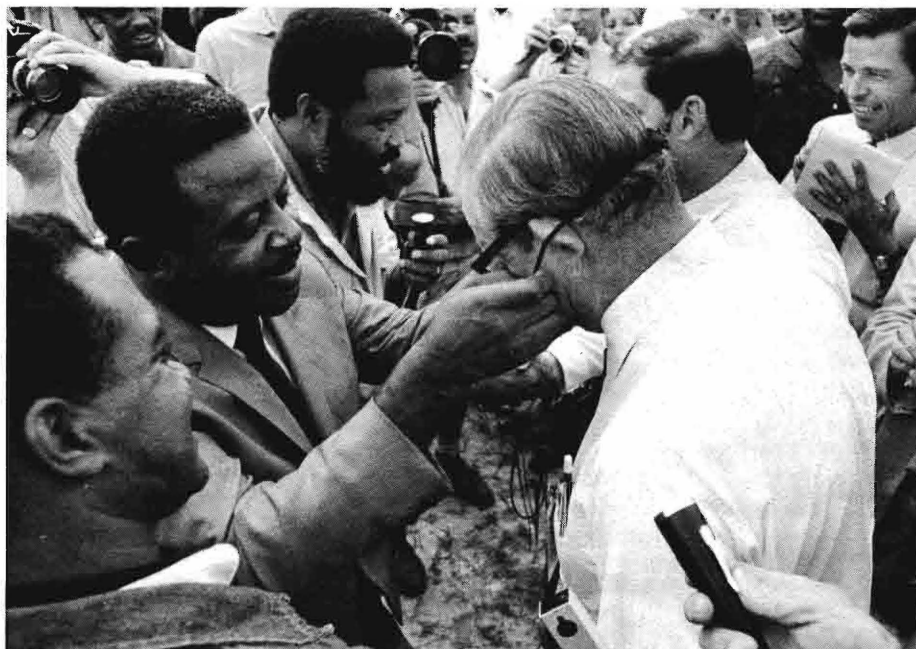

## Five O'Clock Refugees

*They are called Washington's "50-mile liberals" because they travel that far each day, from home to government office to spare their wives and children the implications of the social policies which they espouse.*

Gentle Arthur, an economist who may have picked up his indifference to race by studying too long in Sweden, parks his VW camper beside a 200-year-old farmhouse in the horsey Maryland countryside. Even out there, Arthur's four boys have learned the art of procuring recreational dope.

Inscrutable Jerry cut his leftist teeth at the University of Michigan back in Vietnam War days, and still favors a scraggly beard, possibly to divert attention from his balding pate. When not seeking domestic bliss in the settled calm of a Victorian-era Baltimore suburb, Jerry follows the East Coast auto racing circuit or shares dope with a mind-scrambled teenage son.

Bumbling Bobby, a rotund son of the Ivy League and the American Good Life, hangs his hat in Reston (VA), a planned community which, as he can't stress too often, was planned to be (tokenly) integrated. But the tokens multiplied, as did the crime rate.

Captain Bud, a weekend sailor, escapes the consequences of a lifetime in the service of liberalism by hightailing it for Annapolis (MD) each week night. The genteel capital of the Old Line State, once a quiet place, today offers mostly the synthetic colonial atmosphere of a busy hotel cocktail lounge. The town's plentiful Negroes are fast abandoning their Southern manners as they "rediscover their blackness."

Integration needs lawyers and bureaucrats aplenty to crank it up and keep it purring, yet hardly 10% of the 50-mile liberals still believe in what they are doing.

## Aesthetically Propped

Jewish clothes designer Richard Sylvan Seltzer, who prefers to be known as plain "Mr. Blackwell" and won't give his age, which is certainly over 60, went into cosmetic surgery a few weeks ago and came out with a new \$20,000 face. His cheekbones were enlarged, his eyes were "restored" (whatever that means), some silicone from an earlier "facial sculpturing" was removed and a previously remodeled

nose was "reglued."

Few black women have Seltzer's kind of money, but more and more of them are going in for nose "touch-ups" (meaning narrowing the nostrils). What they're trying to do is to look more like whites, though Pearlman Hicks, a plastic surgeon, explains it as a desire for "features that are more in proportion to each other." Hicks warns that if too much work is done on a broad nose, it may come out looking like Michael Jackson's, which he deems "very unnatural."

Blacks have a problem with cosmetic surgery because many have a troublesome genetic trait which causes cuts and wounds to heal with raised scars. Some "brothers" and "sisters" are also cursed with hypo- or hyperpigmentation, different amounts of pigment in different body areas. Scars may have a noticeably different color than the surrounding skin. This can often be corrected with melanin stimulation for pale spots and bleaching medication for dark patches.

Blacks do have one cosmetic advantage. Their skin takes sunbathing better and it is more elastic than white skin. That's why blacks seem to age more slowly than less colorful folk.

If this face-fixing craze continues at its present rate, in a century or so everybody on earth will look like a WASP at the very moment WASPs will have almost become almost extinct.

## The Black Look

For decades, many American Negroes have tried to "look" white. If you leaf through mass-market publications aimed at blacks, you'll find that they are still crammed with ads for hair straighteners and skin lighteners. The "Black is Beautiful" spin has had mixed success at best.

In sad contrast, the acquisition of Negro features is growing in popularity among young American whites. Males are wearing Jamaican dreadlocks, "fade" haircuts and flashy gold medallions. Impressionable white females get silicon injections to fatten their lips, while blacks, like Michael Jackson, shell out wads of cash to thin theirs. Even black speech is "in." From morn to night Madison Avenue mainstreams ghetto slang into television spots.

"I call it the darkening of White America," says Charles Thomas, professor of urban studies at the University of California at San Diego. "What we are seeing is white people being totally engulfed in black lifestyle and behavioral patterns. It started with music. Now you see it in fashion, religion

and expression."

Always available to air a Negro point of view, Alvin Poussaint, a Harvard associate professor of psychiatry, notes, "The stigma has been removed from features that were Negroid . . . like thick lips . . . We're seeing a freeing up of style, just like there was a freeing up of sexuality in the 1970s." In the parlance of the black Harvard don, "free up" has become a synonym for "debase."

American whites aren't the only ones who are going ape. Lena Williams, who monitors the fashion scene, reports that "Around the world a universal standard of beauty is emerging, projecting a multiracial mix."

All of this must be comforting to mashers, trashers and slashers of Western civility, those who rejoice as the last barriers to "racial unity" are being swept away. Surely, the unpropping of the Aesthetic Prop indicates that the dawning of a "Brave New World" cannot be far in the future.

## Gory Stories

It's hard to believe anything written in sensational news sheets like the Sun (owned by mediocrat Rupert Murdoch) and the Weekly World News (put out by some other press lord). But two recent items are worth repeating, if only for their sardonic humor. The Sun (May 22, 1990) reported that a tribe of Amazon cannibals is being decimated by AIDS, after one of its more voracious members ate 32-year-old Gaston LeFron, a French interior decorator. LeFron, a certified homo who was a member of a fag tour group, strayed too far into the jungle and was killed by a poisoned dart. After a tribal chief ate the French pansy, AIDS spread like wildfire through the local jungle. In the cannibals' list of priorities, human meat comes first, sex second. "[AIDS] is now a full-fledged epidemic," stated Dr. Afonso Texeira, an anthropologist who watches the doings of Amazon Indians for the Brazilian Ministry of Health.

The Weekly World News (May 29, 1990) came out with an equally unsettling whopper about cannibalism. Now jailed without bail in Buenos Aires is Teresa Ventura, an Indio in Latin American terminology, who, despondent after her husband left her, "murdered her children in cold blood, cooked them and ate them." Reported the WWN without batting an eye, only one of her brood of six, a six-year-old boy, was not on mom's menu.

A more credible dispatch, from the Zambia Bureau of the Associated Press (May 15, 1990) informed its newspapers that local

African tribal chiefs have banned the traditional custom of widows and widowers copulating with close relations of their deceased spouses. This so-called "cleansing" ritual has been responsible for the spread of AIDS in large parts of Zambia and was particularly inappropos when the husband or wife died of the lethal disease.

## Black Musical Apartheid

Dionne Warwick is furious because a white singer was given a "black man's award." George Michael edged out Michael Jackson for Favorite Male Vocalist in the Soul/Rhythm & Blues category at the 1989 American Music (Grammy) Awards. Though Warwick has already won five Grammys, she will not be appeased. "It's like a slap in the face," she fumed. "To give that award to a white man . . . is absurd."

Another black entertainment giant agrees. Don Cornelius, producer of TV's *Soul Train*, says giving George Michael the award "changes the meaning of the word 'soul.'" He had tried to get around the problem by starting the "Soul Train Music Awards." No whites allowed.

If the Grand Ole Opry tried to keep Negro Charlie Pride or Hispanic Johnny Rodriguez from "mixing it up" in their country music shows, Dionne Warwick would probably be blocking the entrances with the first picketers.

## Congressional Burial Service

A short article in the *Jewish Sentinel* (Chicago, May 10) said more about the reality of American political life in the late 20th century than all the political science texts in the Harvard Graduate School. "According to recent news reports," it began, "congressional Iran-Contra [scandal] investigators discovered but kept secret a diversion to Israeli intelligence of more than \$1 million in proceeds from the Reagan administration's sale of arms to Iran."

The *Sentinel's* source was an article in the *New York Times Magazine* by Seymour Hersh, who reported that the senators agreed before the Iran-Contra hearings began that they would "avoid seeking impeachment unless it seemed Reagan had been fully aware of the diversion of arms sale money to the Nicaraguan Contra rebels."

On the one hand, the Senate believes that a U.S. president who hushes up the diversion of money to an anti-Communist guerrilla army should be kicked out of office. On the other, the very senators and

congressmen who are prepared to do the impeaching are themselves, with all due deliberation, covering up a diversion of precisely the same funds to a Zionist intelligence agency.

Members of the Senate and House investigating committees learned before the hearings began that Gen. Richard Secord and his partner, Albert Hakim, had diverted more than \$1 million of the "Iran-Contra money" to Amiram Nir, an Israeli official. Nevertheless, "the transfer was not mentioned in the panels' joint report in November 1987."

It's kind of like dropping an A-bomb on Damascus but reporting only the tear gassing of a local synagogue.

## Zero-Tolerance Blacks

Gerald Turner, a 16-year-old white junior at Opelika High School in Alabama, wrote a letter to the editor of the school paper calling Martin Luther King Jr. "a great man [but] I just can't see [him as] some kind of god," as an article in the previous issue had implied. "Why don't we celebrate Harriet Tubman's birthday?" asked Turner. "She started the civil rights movement, not Rev. King! He just tried to finish it. Why aren't we out for Lincoln's birthday? He gave blacks most of their rights."

The newspaper was distributed during lunch hour. The tension hit the school cafeteria's roof. Hundreds of black students refused to attend afternoon classes. Turner, after receiving threats, stayed home the next day. Fights broke out among football players at the half-black school. Opelika's leading black townsman rushed to the school to "mediate" and called for a new black studies course. The white principal, Don Roberts, promised to offer a new course in black history, in what the *Montgomery Advertiser* described as an "immediate concession." Saying he disagreed with Turner's letter, Roberts waffled:

It was not, in my opinion, a derogatory letter, although now I can see that it was certainly more offensive than I had expected . . . I think I overestimated the tolerance of the students at this point.

One recent editorial in the student paper described arch-terrorist Nelson Mandela as "the Moses of South Africa," which provoked no discernible or audible white reaction. When another editorial advocated keeping the Confederate flag flying above Alabama's state Capitol dome, overly nervous school officials wondered if the black students would burn down half of Opelika in their indignation. Luckily, they must have run out of matches.

## The Genius of Black Engineering

Malcolm Jamal Warner is known to millions as "Theo," one of *The Cosby Show* kids. A sometime host of NBC's *Friday Night Videos*, he has written (or had ghost-written) a book called *Theo and Me*. Last Jan. 12, Warner wrote (or had ghosted) an article in a special King Holiday supplement to the *Washington Times*, which paid tribute to black "genius." It had all the usual rhetorical trappings: "African civilization . . . existed long before the 'civilization' of Europe . . . while Europeans were wearing their animal skins, [Africans had long] been wearing silks . . . The Europeans had no knowledge of weaving or sewing . . ."

What made Warner's piece a collector's item in the field of African hype was his lecture on the pyramids:

Our African ancestors were way ahead of their contemporaries in Europe . . . The pyramid is tangible proof that our African ancestors in Egypt had a vast knowledge of geography long before Europe came into existence. To build the pyramid, our ancestors had to know where the exact center of the earth was. The base of the pyramid is located in the exact center of the earth's land mass, which means that its architects had to have already known not only that the earth was round, they had to have already known how much land there was in all the directions from where they were standing!

Amen!

## Dummy President

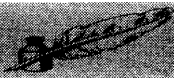

She had New York City in an uproar for months. Of course, the story was phony from syllable one. The only rape was Tawana's rape of the truth.

Now the U.S. is blessed with a new Tawana, a black 18-year-old student at Emory University in Atlanta. Sabrina Collins was in a "state of shock" after racial slurs and threats were plastered on the wall of her dorm room, so "shocked" she had to be taken to the hospital and couldn't speak for almost a week. The last word about the case is that the Georgia Bureau of Investigation is now convinced she had done all the dirty work herself.

Sabrina was smart enough to know that all any minority member has to do to get in the news these days is to find a swastika or hear a racial slur and shout "racism." The media will immediately give the victim a big play with reams of front-page stories and editorials denouncing white racists and calling for tougher "hate laws."

It's taken for granted, of course, that some bigoted white was responsible for the crime. Weeks will pass before it occurs to anyone that the real culprit might be the alleged victim. Since the facts never quite catch up with the non-facts, many people will go to their final resting place believing that the Brawleys and the Collinses were on the level.

## All About Eve

It's both a modern and an ancient mystery. Who was that (Black African) woman whose 200,000-year-old DNA was found substantially intact by Berkeley anthropologists somewhere in the bush country of Botswana? Was she, as the Berkeleyites theorize, everyone's First Mother? Or merely an early version of that well-developed strain of African humanoid informally known to the white taxpayer as *Homo wel-farus*?

On the answer lie the hopes and fears of racists on both sides of the artist's palette. Whites proud of their racial achievements have long cherished a belief in mankind's origin that assumes relatively simultaneous beginnings in many places throughout the world. According to this paleo-anthropological thesis, the white race evolved separately from others. Afro-racists, anxious to

blur a lamentable trail of cultural failure blazed by endless generations of their forebears, have grasped the Berkeley Theory of Common Origin as a drowning man stretches for a life ring. The reason? With the Common Origin notion is packaged a diminishment of white man's last, vital line of cultural defense against racial swamping -- his sense of uniqueness. Break that, the nonwhites theorize, and the country club is theirs.

Rev. Farrakhan recently took the argument a step further, claiming that the DNA theory proves that blacks, having evolved first, are actually the superior race. More credible observers believe that the Mother Eve argument for lineal development of all mankind implies that whites, having evolved later, have evolved further. Perhaps the argument, shrouded in the mists of time, can never be resolved by science. If so, all we've got to go on are our own empirical observations and a healthy dose of common sense. To that end we faithfully present, without editing, the words of three blacks calling in to a TV talk discussion (WHMM-TV, Washington, April 11, 1990) on the DNA problem:

If we'ze all comes from de same genes,  
how comes we'ze blacks be so different?

I'h believe dat de Lawd make man, and  
he make woman from man's rib.

I'h understand dat German scientists is  
havin' trouble breedin' Petunias 'cause  
of der Nazi history.

To cap the discussion, one white liberal came forth with these words:

Whether or not man actually did spr-  
ing from the same origin, I think that it  
would be profoundly good that we all  
adopt the DNA theory for the love it is  
bound to create!

## Savage Attack

Negro Illinois Congressman Gus Savage, flush from a primary victory over a black opponent, has been making things uncomfortable for his fellow Democrats, who count on black votes and Jewish campaign contributions to control both Houses.

Savage, whose reelection next November will be a shoo-in, said it was "very dangerous" that most of his Democratic primary opponent's money came from the American Israel Public Affairs Committee. The Hon. Mr. Savage observed,

A group that lobbies for the foreign  
policy or the population of a foreign na-

tion [and] then takes that issue into a congressional district such as mine [all black] and tries to make the election determined by where a candidate stands on that issue is a disgrace.

He went on to say that AIPAC cared not a whit about issues affecting his district and had "targeted" him because he opposes the huge amount of U.S. aid sent to Israel every year. Instead, Savage wants many more dollars sent to Africa.

Despite savage attacks against Savage in the national media, the Congressman did not retract his statements concerning AIPAC. Nor do his black supporters seem to care that he has been loudly accused of engaging in "group libel." Savage's experience dramatically contrasts with that of another Illinois congressman who came under fire from the Israel lobby. Republican Paul Findley's rural white constituents failed to reelect him after he was singled out for defeat by Jewish interests. Illinois Senator Charles Percy suffered a similar fate when wealthy out-of-state Jews financed the campaign of his Democratic opponent, Paul (give the Zionists the key to the U.S. Treasury) Simon.

Savage was only weakly denounced by the two black bigshots who personally campaigned for him: Majority Whip William Gray III of Philadelphia and Congressman Charles Rangel of New York. He was never criticized by Jesse Jackson, whose silence put the party into a pretty pickle. The Demo flacks had had a field day blaming the GOP for David Duke, who ran as a Republican for the Louisiana State Legislature. Since they now have a racist within their own ranks, they are having to eat their words.

## Breslin's Brannigan

When a white male editor at Long Guyland's Newsday called a black editor a "nigger" two years ago, he was fired. When Morton Downey Jr. was just a nobody in talk radio in Sacramento (CA), he was canned for calling a listener a "chink," even though he said it was all right because he was married to an Asian. But when Newsday's star columnist, Jimmy Breslin, called a young Korean-American reporter at the paper's Queens bureau a "yellow cur," a "slant-eyed ----," and so on, he got off with a media drubbing and an apology. Breslin, after all, has built his reputation on championing the little guy and the ethnic underdog.

Breslin couldn't leave well enough alone and promptly called up Howard Stern's infantile "shock radio" show to exchange jokes about his nephew's approaching marriage to a Korean. For that, he was suspended without pay for all of two weeks.

Columnist Eleanor Randolph of the Washington Post thought the most telling thing Breslin said in his original newsroom outburst was, "I can't stand people who don't know their place."

"He can't?" asked Randolph. He's been getting filthy rich all these years for "writing about the little people battling . . . the establishment."

It's hard not to rally to Breslin's defense when people like Helen Zia of the Asian-American Journalists Association call him a "hate-filled bigot" and demand his head. It's easy to turn a deaf ear when the likes of New York Gov. Mario Cuomo jump into the fray and salute Breslin as "a champion of open-mindedness."

## Milken's Judge

We wondered about Kimba Wood, the 40-year-old lady judge who will pronounce sentence this October on convicted felon, Michael Milken, the biggest financial flimflam artist in the history of crime. Her first name sounded a little suspicious, but she wasn't black. Kimba was a town in Australia, whose name had appealed to her mother. Born in Port Townsend (WA) into a military family, green-eyed Judge Wood was that rare exception -- a WASP solon in New York City. But it was she who approved the plea bargain which removed all but six of the 98 felony charges against Milken and all charges against his brother.

Will Wood be as lenient when she sends Milken to jail? He could get 25 years, but it's expected he will only get five. At least he will not be sentenced by a Jewish judge, who might harbor some feelings of kosherhood for a racial cousin.

All the illusions about Wood, however, were shattered by her bio in the New York Observer (May 14, 1990), a weekly Zoo City fishwrap owned by the left-wing Jewish millionaire Arthur Carter, who also owns The Nation, a rag mag that has a yen for the old pre-Gorby, post-Czarist Russia. Judge Wood is a Democrat, sad to say. Sadder to say, she is the spouse of Michael Kramer, a Jewish writer who keeps the fires of minority racism burning in Time and several other organs of disinformation. What's more, she has borne Mike a half-Jewish son, now four. What's still more, in her chambers hangs an inscription in Hebrew: "Justice, Justice, Thou Shalt Pursue."

We no longer wonder.

## Racists Run Rutgers?

Given the temper of the times and the low state of "hire" education in America, it came as a severe but pleasant cultural shock when the 105-member English De-

partment at Rutgers refused to grant tenure to visiting professor Amiri Baraka, more familiarly known as Leroi Jones.

Baraka/Jones came to Rutgers two years ago, after taking leave of a full professorship at the Stony Brook campus of the State University of New York, where the black poetaster also served as director of the African Studies Program. He remains editor of The Black Nation, a journal of "African-American thought." Although Leroi extolled Black Nationalism, in his Baraka incarnation he embraced Marxism as his revolutionary ideology of choice.

At Rutgers, only full professors vote for full professorships and tenure requires a two-thirds majority. Baraka admitted to the New York Times that he doesn't really know why his colleagues voted against him. But these doubts did not discourage the angry black academician from telling 250 student supporters that his appointment was blocked by what he called

Europolitan elitists and white supremacists . . . . The power of these Ivy League Goebbels can flaunt, dismiss, intimidate and defraud the popular will. We must unmask these powerful Klansmen. These enemies of academic freedom, people's democracy and Pan American culture must not be allowed to prevail. Their intellectual presence makes a stink across the campus like the corpses of rotting Nazis.

It is not likely that this is the last we will hear of the matter. Further protests and legal action can be expected. We will try to keep abreast. But, for the moment, we can commend those professors who had the integrity not to take the easy way out and rubber-stamp this crazy Negro's nomination.

## Fudging the Crime Stats

In no area of the media is deception and obfuscation more apparent than in the reporting of crime statistics. One recent UPI press release was headlined, "Blacks Suffer Most from Crime," when the meat of the story should have been that half of all crimes that blacks commit are committed against whites. Going on for paragraph after paragraph about blacks being disproportionately raped, robbed and murdered, in comparison to the rest of the U.S. population, the UPI report finally admitted that 15% of all rapes, robberies and assaults by a single person were committed by blacks on whites. But no figure was given as to the total number of such crimes.

The fact is that there were 140,000 cases of rape, 872,000 robberies and 3.5 million

assaults in the U.S. in 1988, according to a Justice Department report. That comes to a grand total of 4,713,000. Taking 15% of this number (4,713,000 x 0.15), we arrive at a figure of 706,950. That's the number of violent crimes committed in one year by blacks against whites. Doesn't that astonishing news deserve a little more emphasis than the UPI report gave it? Many newspaper editors cut the story before it even mentioned black-on-white crime.

As for white-on-black crime, it represents 2% of the violent crimes listed above. Multiplying 4,713,000 by .02 produces the figure of 94,260. So blacks, despite being only 13% or so of the population, commit 7 times more violent crimes against whites who still comprise about 75% of Americans, than whites commit against them.

## The Coddled and the Bullied

Campus Report, the monthly newsletter of Reed Irvine's Accuracy in Academia, printed a thoughtful letter in April from Lawrence D. Swickard of Mountain View (CA). "I was not militant nor political" in my college years from 1973 to 1978, recalled Swickard, "just a traditional, God-fearing young man who did not accept all their drivel."

Certain professors, especially in my major, history, singled the few conservative students out for mocking, derisive name-calling, taunting, and interrogation in front of the class to draw out their "ignorant" beliefs. Of course, they played with our grades as well.

These profs were certainly not on Swickard's side. Just as certainly, philosophy professor Al Gini of Loyola University in Chicago was on the side of the black student whom he called "nigger" during a "civil rights" lecture last winter. Gini did not mock her, taunt her or interrogate her. Yet he very nearly lost his job over that one word, while Loyola went through months of rallies and news conferences, which ended only when the administration surrendered to a list of demands ranging from new furniture for the Black Cultural Center to increased recruiting of black faculty. It's hard to see how the latter concession will be met, since, as dean of faculties James Wisner told the Chicago Tribune (April 15), Loyola *already* had a policy of hiring every "qualified" black professor who was available, whether or not any opening existed!





# WASPISHLY YOURS

**O**REGON'S TWO MOST influential state leaders are Neal Goldschmidt and Vera Katz. Ron Wyden is one of "our" representatives in Congress. After African-Americans go wilding, the media urges forgive-

ness because such behavior is an excusable reaction to white racism. What about the whites who have been driven to desperate acts by racial persecution? The Anti-Defamation League and the FBI hound them relentlessly. White-haters like Jesse Jackson and Tony Brown are given hours of exposure on TV. Imagine David Duke getting 10 or 12 uninterrupted hours on C-SPAN to present his views, or Tom Metzger being given a regular half-hour program on PBS.

The Anti-Defamation League routinely suppresses opposition to Jewish views and goals. It once sent a circular (Dec. 13, 1933) urging newspapers and periodicals not to review or otherwise publicize Madison Grant's *Conquest of a Continent*, a magisterial work challenging the wisdom of unlimited immigration. "We are interested in stifling the sale of this book," wrote Richard Gutstadt -- "interested" being a warning, like a snake's rattle. Despite the ADL's long record of censorship, Ralph Blumenthal, an ADL honcho, says the group is merely a "fraternal and philanthropic organization."

Get real, Ralph. The ADL is a hate group, and not just hateful of free expression. For decades this gang has been harassing, suing and subverting white preservationists while turning a blind eye on the antiwhite doings of minorities and Communists.

Would the ADL challenge unlimited migration by Moslems or Mexicans into Israel? Would *The Oregonian* run pages of news and views favoring Open Borders for the Zionist state and praise pop philosopher Ben Wattenberg, who is ecstatic about America's prospects of becoming the world's first "universal nation"? Most Americans want the alien inundation ended. A democratic government obeys the majority's will. An occupation government does as it wants.

ZOG wants Open Borders for the U.S. as yet another means for maintaining Zionist power. A continuous flood of dirt-poor Third Worlders dilutes the majority's political might, while eroding its economic base. Two-thirds of all this planet's migrants are streaming into the Land of the Freebies and running up astronomical bills. # Notes from the Sceptred Isle - John Nobull

Under the heading, "Racial Bias Shown In U.S. Sentencing," the Guardian (Feb. 19, 1990) refers to a report "compiled by a Washington-based pressure group and endorsed by the U.S. Justice Department." The report states that nearly 1 in 4 American black males in their twenties is in jail, on parole or on probation. It compares the 610,000 young blacks enmeshed in the U.S. criminal justice system to the 436,000 enrolled in colleges of higher education. The prison rate for young Hispanic males is 1 in 10; for young white males, 1 in 29. Marc Mauer, author of the report, claims it's all due to poverty, the growing number of one-parent families, the crack epidemic in the inner cities and discriminatory sentencing.

The surfeit of black criminals is actually much worse because, as the U.S. News and World Report made clear (July 31, 1989), only a tiny proportion of the criminals is brought to book, and fewer still get sent to gaol. But Mauer's explanation of this state of affairs is inadequate in other respects. American blacks are very much better off than the relatively nonviolent poor in many of the less developed countries. Don't one-parent families result automatically from the determination of black females to qualify for welfare payments? As for the crack epidemic, who promotes it most? Surely the black and Hispanic communities. They foul their own nests.

That leaves us with discriminatory sentencing, which implies a nationwide conspiracy of judges dedicated to frustrating the non-discriminatory intention of the law. It implies that the police deliberately pick on blacks and that prosecuting attorneys are in cahoots with defense attorneys. Who can honestly claim that this is a true picture? How many judges, policemen and lawyers are there in the U.S. (or any other English-speaking country, for that matter) who do not lean over backwards to give blacks the benefit of every doubt?

It is much easier to believe that the blacks' propensity to commit crimes is rooted in their not exactly overactive brains. Forty-odd years of IQ testing by the U.S. Army, supplemented by the research of Arthur Jensen and others, leave no doubt whatever that the blacks have IQs on average 15 to 20 points below the white norm. The few blacks who are more intelligent than the average white do not alter this genetically based difference a jot. As for the Negro's highly reactive nature, one need only hear Negro music or look at black African culture for proof. Frustrated, in a society stratified by genes, he naturally takes to violent crime and any drug which offers quick satisfaction.

The "solution" implied by Mauer and his black supporters lies in yet more handouts to the black community and in sentencing proportionate to black numbers in the population as a whole. That would mean many more black criminals prowling around in the streets committing many more crimes with impunity. The inhabitants of the no-go areas of the inner cities would increase their operations in the white suburbs.

My message is that white flight is not enough. We must learn to help each other, congregate in white areas and shut out the minorities -- especially the Jews who fund the anti-discrimination organisations and have a stranglehold on the legislative process and the media. I think the best way forward lies not so much in overt anti-Semitism, though I deeply admire anyone who has the

guts to face up to the Jews openly, but in demands for law and order coupled with full and heartfelt support for all causes which favour the interests of the Majority.

In a single generation, crime in Britain has increased seven fold, with a 40% increase in violent and sexual assaults in the last decade. Despite a steep decline in the numbers of the age group mostly likely to violate women, rape reports have doubled since 1984, though it is believed that three-quarters of the victims don't notify the police. The disheartening statistics were discussed on the BBC Radio 4 programme, "The World at One," but not one member of the panel of "experts" mentioned immigration or race.



Opinion formers are fond of referring to the Anglican Church as "decent." By any normal standards, the behaviour of many Anglican clergymen is highly indecent. Instances of such behaviour are frequently reported in the newspapers, but what the mediocrats mean by "decent" is a tendency to emote vaguely about problems instead of solving them. By this definition the Anglican Church is indeed "decent."

A big fuss has been made about the execution by the Iraqi regime of the journalist Farzad Bazoft. The charge was spying for Israel, and there may well have been something in it. Bazoft was frequently referred to in the press as "British," a designation given anyone who holds a passport from an island which is now generally recognised as a dumping ground for undesirables.

What we did not realise until M.P. Terry Dicks brought it out was that Bazoft was already a criminal. Dicks asked in Parliament why Bazoft was not "booted out" after he blackmailed a Northampton building society into giving him £475 (\$765) by pretending he had planted a bomb. He was not sent back to his native Iran "because he might be in danger" there. Instead, he was allowed to remain in Britain, obtain a British passport and become a Middle East correspondent for the liberal Sunday Observer. Donald Treford, editor of that egregious newspaper, was predictably outraged by Dicks' daring to refer to Bazoft's criminal past (Daily Telegraph, March 17, 1990).

We may be grateful to the Daily Telegraph for printing news that other papers wish to conceal or fear to print. For instance, Ronnie Kray, the Jewish leader of the London underworld, who is in Broadmoor prison for hanging up his victims and torturing them to death with a cattle prod, was reported (Feb. 12, 1990) to have been allowed to cohabit with boy prostitutes introduced into the prison by friends who had bribed the male nurses. When we realise that these boys are often drugged and forced into this kind of life by organised syndicates, we get some idea of the corruption rampant in the New Britain.

The New Scientist (Feb. 17, 1990) said that zoos were no longer breeding to preserve species, but subspecies. Siberian and Bengal tigers exhibit profound differences. Crossing them would eventually destroy both animals. The article said that mixing tigers or any other animal subspecies was no better than exterminating them. Nothing was said about the danger of mixing human subspecies.

The New York State Board of Regents, which determines state education policy, is expected to approve a new "Curriculum of Inclusion" requiring all of the world's major cultures to be treated as equals in American history courses. The report on the proposed curriculum, released last July, warned that today's minority youngsters are being psychically damaged by cultural icons like *Amos 'n' Andy*, Charlie Chan, the Frito Bandito and Tonto (of *Lone Ranger* fame). Columnist David Rossie was among the few who asked how many kids these days have even heard of *Amos 'n' Andy* (Binghamton Press and Sun-Bulletin, Oct. 30-31, 1989).

It's actually sensitive white children who need to learn more about Thomas Edison and Alexander Graham Bell if they are to overcome the grotesque TV stereotyping to which their race is now subjected. Few of them realize that Roseanne Barr is actually a Jewess. Most white kids, taking her to be a fat white slob, shudder at the mere sight of her, just as sensitive black kids once shuddered before the infinitely less crude "Mama" character on *Amos 'n' Andy*.

And then there's the Bundy family on *Married... with Children* (Fox network). Created by Ron Leavitt and Michael G. Moyer, this series tries to make crudity an art form. According to Alan Pell Crawford (Reason, Dec. 1989):

Within perhaps three minutes of this episode... there were, in rapid succession, references to pimple squeezing, nose picking, bra stuffing, armpit sniffing, constipation, masturbation, and group sex. None of these jokes were especially clever, but they were about what one would expect from the Bundys who are, after all, crude people for whom such references may well represent the very *ne plus ultra* of hilarity.

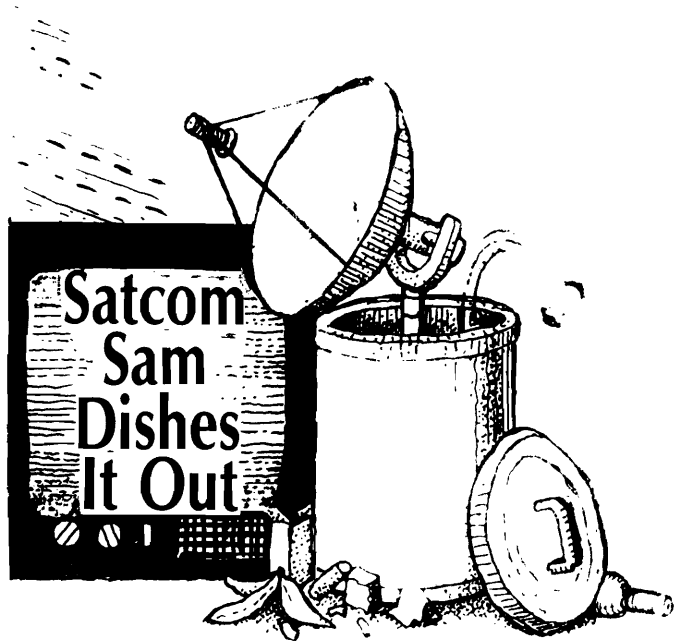
"Not the Huxtables" was the review's headline, in reference to the elegant black family which has ruled the airwaves for some time now. Despite all, Crawford found the Bundys almost refreshing because most other sitcoms these days "are so inordinately preachy that the laughs exist almost solely to support whatever moral the writers are trying to get across."

The Huxtables -- at once suave, witty, preachy and totally untrue to life -- are watched each week by tens of millions. *Amos 'n' Andy* is available only on hard-to-come-by video tapes. Yet Christopher Columbus and Benjamin Franklin will now be shoved aside in the history textbooks of New York State to make way for the likes of Ernest E. Just (1883-1941) -- you know, the mulatto marine biologist famous for having "studied egg development."

*CBS notes:* David Burke, the president of CBS News, who took the heat for the Andy Rooney screw-up, is still hanging on to his job. The man chiefly responsible for the fiasco was Laurence Tisch, the Jewish billionaire whip-cracker at CBS, who has his hand in every nitpicking matter that affects the network. Certainly, he had the final say on the Rooney affair. Yet somehow, the media hardly ever mentioned his name and put all the blame on Burke.

As an illustration of how Tisch operates, "after *60 Minutes* ran a negative story in 1988 on Israeli fundraising in the U.S., a subject dear to Tisch's heart, he angrily confronted Don Hewitt, the program's executive producer, at a party. 'Nobody could believe it -- Tisch just went ballistic,' says a CBS news-division employee. Hewitt turned on his heel and left



the affair rather than engage in a public shouting match with his boss. But news of the incident quickly bounced around [Black Rock, the CBS HQ]." The gory details can be found in "Has Larry Tisch Lost His Touch?" (Fortune, Feb. 26, 1990).

Burke, it should be remembered, came to CBS well recommended. For some years he was on the payroll of the Kennedys, first as an assistant to JFK, then as a speechwriter for Senator Ted. Burke was a member of that select group of bigshots hastily summoned to Hyannis Port to help Fat Face cover up the drowning of Mary Jo.

When Dan Rather visited Baltimore recently to take part in a student anti-drug assembly, he characterized the legalization of drugs as a "well-thought-through and interesting idea," though he did have some serious reservations about it. Dan speaks from experience, since he has admitted shooting up with heroin and imbibing LSD. "I've tried everything," Dan asserted, though he confessed he had never smoked marijuana "in this country."

*From Zip 329:* After clicking through the transponders on Satellite TV a few weeks ago, I was about to give up and go to bed, when my eye fell on a three-star listing on BRAVO (F3/04), *Moscow Does Not Believe in Tears*, a movie made in Russia and dubbed in English. I don't usually like to watch dubbed foreign movies, but this one was done so expertly that I often forgot the original dialog wasn't written in English. The main character gets pregnant while young and innocent and is left to raise her baby by herself. Later, she rises to the top of the Moscow apparatchik heap, meets old lover who had abandoned her years earlier, meets true love, and so on. Obviously not an original theme, but placing the characters in Moscow and the scenic Russian countryside somehow endowed the film with an aura of freshness. Best of all, the movie lasted 2½ hours with no commercials.

Jews have so far managed to keep the American television audience from seeing *Voices from Gaza*, a highly praised documentary in which 15 Palestinians give their side of the butchery going on in Israeli-occupied territories. The hour-long program has been aired in England, Canada, New Zealand and Japan, but PBS won't touch it. The network's executives say "the time is not right," meaning they don't want to go through a repetition of what happened when they put on *Days of Rage*, that other rare program that, for once, let Americans see and hear the misery and suffering of the Palestinian people.

*Satcom Sal* expostulates: The insipid promo of *Bagdad Cafe* on CBS last March -- "In the Mojave stands an oasis of laughter. The food's lousy, but the comedy's four star." -- doesn't tell the half of it. Why would an actress of Jean Stapleton's stature join such a coarse, inane production? What the promo failed to mention was that Whoopi Goldberg is greatly concerned that her daughter's boyfriend is a white "biker" type. All this I gleaned from the last ten minutes or so of the show (I had tuned in late).

*Sugar & Spice*, which followed *Bagdad Cafe* on CBS, is even more childish. It's about two black sisters played by Loretta Devine and Vickilyn (how else would you spell it?) Reynolds. I shut the TV off just after the faggy midget had minced through a scene. When will we rebel!?

A few years ago, I wrote about a *60 Minutes* segment on which Mike Wallace had interviewed two people, Ricardo, a black with an IQ of 67, and Donna, a white with an IQ of 64, in a home for the mentally retarded. They had fallen in love and wanted to marry. Mike, unlike his customary antagonistic and belligerent self, was in a mood of playful civility -- an attitude he'd never adopt toward mentally sound WASPs. In a tone generally reserved for an 8-year-old who had just discovered that one of the girls in the third grade had a crush on him, Mike scrunched his eyes, gently squeezed both of the dimwitted lovers on the forearm and bantered, "C'mon now, level with me! Will there be . . . babies?" Dull eyes brightened and loose lips shaped themselves into smiles. "Yes, indeedy!"

Well, in April Mike brought us up to date on this gripping if sluggish drama. The twosome had married, and in 1986 Donna became pregnant. After an agonizing attempt by two doctors to explain the meaning of amniocentesis, during which she would burst into sobs each time she was asked, "Do you understand?", the procedure was performed. The tests indicated the fetus was normal. Asked whether the pregnancy should have been allowed to run full term, a beaming (surprisingly old) social worker said she was "delighted" and that, despite their being subnormal, here were two people who "cared about each other." Ain't love grand!

The baby boy, Ricky (we were treated to delivery-room coverage of the last few minutes of his birth), weighed in at 2 lbs., 11 oz. Because he was so small, he had to remain in the hospital until he had gained weight and would no longer need intensive care, a sojourn that cost the city's taxpayers \$25,000.

Donna at first cherished the tiny infant, but later became confused and impatient. When she finally took him home, she had extreme difficulty in following his feeding schedule,

even though she had been persuaded to write it out in her own hand. Social worker: "Donna didn't seem to understand . . . but they are caring parents . . . [who are] overwhelmed." Donna: "I thought it would be easy." Mike Wallace, avuncular and crinkly-eyed: "Like [having] a doll?" Donna: "Yeah." When Ricky was four months old, Donna was barely coping: "My nerves are too bad, but I take it out on Ricardo. He could do more." The marriage began to flounder.

Mike then informed us that "only a very small percent of retarded people are born that way. About 75% of them become that way due to environment." What happens when a "normal" child is brought up by retarded parents? Ricky began at a "special" school at a very young age. He is "ahead" in motor skills, but markedly behind in those of language.

And the punch line! Mike: "Should Donna and Ricardo have had this little boy?" Social Worker: "I cannot say that they shouldn't have. He'll have to show them what he needs." Now, if that doesn't tug at your heartstrings, I don't know what will!!

CBS has scored another triumph. It has told its vast audience that genes don't matter a hoot and, by its complete silence on the important issues of the case, huckstered the idea that interracial marriage and child-bearing are as normal as apple pie.

*From Zip 303*: The Financial News Network (Jan. 6, 1990) broadcast a report on the Zionist "propaganda machine" that keeps American politicians "silent" about American taxpayers' dollars sent to Israel to finance nuclear weapons research and to drop bombs on Palestinian villages.

# Thoughts from the White Tip

IT IS UNDERSTANDABLE that people overseas should have little knowledge of South Africa and its inhabitants. It is less understandable why many of these same people think they know more about this country of mine than the whites who actually live here. Most Americans and Europeans have been persuaded that South African whites are both ignorant and depraved, much like latter-day versions of sheeted Ku Kluxers. But what about the views of prominent white men, even men of genius, born and bred in Europe, who had a long and intimate acquaintance with Africa and substantiate everything local whites have to say? Are their views to be brushed off as so much irrational nonsense? What about the great explorer, Stanley? Though he was damned forever for having dared to fire on natives in self-defence, he not only knew Africa, but actually discovered much of it. No one has ever accused him of lacking mental acuity. Francis Galton is in the same league. It is not generally known that the founder of eugenics, a cousin of Darwin, spent a long time in Africa, initially in the company of the Anglo-Swedish explorer, Charles Andersson, the first white to set foot on the banks of the Okavango River on the border of South-West Africa and Angola. Galton believed that the development of Africa required a mass influx of industrious Chinese, who would eliminate the useless blacks. What about the intrepid explorer, Sir Richard Burton, who was also a renowned orientalist? His opinion of African blacks scandalised the missionary-minded England of his day, as it would now. But, as he could run intellectual rings round any of his bleeding heart opponents, it is difficult to dismiss him as an unbalanced ignoramus.

Those who believe that the opinions of these 19th-century authorities are irrelevant today should be reminded of what the late Dr. Albert Schweitzer had to say in 1961:

I have given my life to try to alleviate the sufferings of Africa. There is something that all white men who have lived here like I must learn and know: that these individuals are a sub-race. They have neither the intellectual, mental or emotional abilities to equate or to share equally with white men in any of the functions of our civilisation . . .

Let white men from anywhere in the world who would come to help Africa, remember that you must continually retain this status: you the master and they the inferior like children that you would help or teach. Never fraternise with them as equals. Never accept them as your social equals or they will devour you.

It is unnecessary to say that these words of the Alsatian medical missionary, theologian, musician and philosopher who wasted his great talents in Equatorial Africa have been given the hush-hush treatment by the Western media.

The unbanning of the African National Congress by F.W. de Klerk came as a surprise to the outside world and to most South Africans themselves. In fact, it is all part of a pattern of decay that began with the death of Verwoerd.



The National Party, which ousted General Smuts and his Union Party, came to power on an apartheid ticket in 1948. The first Nat prime minister, Dr. Malan, was followed by J.G. Strijdom, who was followed in turn by Dr. Verwoerd, the man who spoke for the Builders and not for the Wreckers. Verwoerd was a benign gentleman, not a fire-breathing fanatic. He was as immovable as a rock, and under his rule South Africa prospered as never before. Political innocents might have imagined that Verwoerd's government would have been applauded in Western countries, but peace and plenty in South Africa was exactly what London and Washington did not want. The liberals in Britain and the U.S. sought a different kind of rule altogether and by another kind of people. Sharpeville ("episodic," as Verwoerd correctly described it) came as a godsend to the Western media. Time magazine put a picture of Verwoerd on its cover, a true likeness except that his face was curiously pitted, as if he suffered from some loathsome disease. To make quite sure its readers got the message, Time added a drawing of a barbed-wire concentration camp full of perishing Negroes. All this Western enmity notwithstanding, Verwoerd, like his two predecessors, quietly defied the world to do its worst. Since his brains equaled his will, he had no serious political rivals within the country itself. He could only be removed by murder. So he was killed by a half-breed Greek from Mozambique who was an avid reader of the English-language newspapers. This creature, Tsafendas by name, was not hanged and was not subjected to questioning at his trial because his Jewish psychiatrist testified that he was mad and imagined he was being pursued by a gigantic worm. The Midgard Serpent, mayhap? I recently took steps to ascertain that he was still locked up, as I feared he might possibly be ensconced in a luxury villa in Athens.

Verwoerd was succeeded in 1966 by John Vorster. This was when the rot really set in. After declaring he would follow faithfully in the footsteps of his illustrious predecessor, Vorster slowly veered off in the opposite direction. At first he struck a tough anti-Communist pose, then he waffled. He would describe members of the Frelimo gang in Mozambique as "murderers" one year and praise them for constituting a "stable government" the next. He exerted intense pressure on the Rhodesians to abandon their Unilateral Declaration of Independence because it was "an embarrassment to some of their best friends" -- particularly the Americans, who were incensed at such rebelliousness on the part of a British colony!

In 1970, Vorster made a statement in the South African Parliament which should have been all-revealing.

I do not base my policy on the premise that I think I am better than another person is. Who am I? A creature of God, just as he [the Negro] is. Shall I presume to say that I am better than he is? . . . Nor do I found my policy on the fact that for the present I may perhaps be more learned than he is, for in the long run he may become just as learned as and perhaps more learned than I am . . . There were Coloured states which already had gunpowder when my ancestors were still crawling about in holes . . .

Vorster was sold on the egalitarian dogma and was by no means as learned as he thought he was. How many politicians, though perhaps wielding great power, can be described as learned? Many are barely lettered. Although Vorster was regarded overseas as the very personification of racialism, the truth was completely otherwise.

Vorster was succeeded by P.W. Botha, who nominated himself President, created a President's Council, brought the Indians and Coloureds into Parliament and juggled around artfully in all directions. Eventually he became an egalitarian like Vorster. National Party members in 1974 had to quit the party if they did not agree that "all men are created equal in the sight of God." This was the prelude to his sustained assault upon the conservatism of his own people. It was also in line with Harry Oppenheimer's Anglo-American Corporation's view that economic development alone would bring about an "era of liberalism" which would finally put an end to the country's racial divisions. De Klerk is but putting the

finishing touches to his predecessors' handiwork -- a work which is essentially a process of taking away from productive and stable whites to give to feckless and riotous blacks. (Ironically, Botha, now retired, recently resigned from the National Party, claiming it had betrayed the whites. It was a case of the betrayer complaining about being betrayed.)

De Klerk's "triumph" represents a triumph of the Liberal Lie over reality. A state of near anarchy exists in the country. Legalised institutions are being illegally demolished. The blacks are slaughtering each other every day; the Homelands are exploding; the schools are being abandoned. Meanwhile, De Klerk frantically reshuffles his Cabinet, and the clever-dick capitalists, such as De Beers, hive off most of their interests into new Swiss-based companies before they are nationalised or liquidated.

Compare this political, economic and social etiolation with the prosperity and stability of Verwoerd's South Africa!

The House will take it up later this year.

According to the U.S. Census Bureau, the 1980s witnessed a 70% increase in the Asian population (from 3.8 to 6.5 million), two-thirds due to immigration. The Hispanic population grew by 34% (from 14.8 to 19.9 million), with half the increase stemming from immigration and the other half from high birthrates. Due mainly to its irresponsible sexual habits, the black population grew by almost 13% (up from 26.3 to 30 million). In the same period, the white population went up 6.2% (a figure that includes an unquantified number of "off-whites").

Statehood for Puerto Rico enjoys the strong support of President Bush, who has an Hispanic daughter-in-law. A proposal to permit the question of statehood to come to a vote in Puerto Rico next year has been introduced by Louisiana Senator J. Bennett Johnston. trying to enter Puerto Rico. Other thousands have evaded capture and made it to the U.S. mainland. Perilous waters and sharks are a greater deterrent to illegal migration to Puerto Rico than fear of being intercepted by the INS.

Last October, Emilio Santana Camacho was convicted of operating the largest alien smuggling ring in the Dominican Republic. He charged as much as \$1,000 a head to move illegals to New York. U.S. authorities estimate he smuggled more than 30,000 immigrants into this country.

#

The U.S. Census Bureau has been ordered to make a special effort to find and count "undocumented workers." An accurate count of illegal aliens and the homeless will be an important factor in some states getting a greater share of federal funds and more congressmen. California expects to gain five new congressional seats at the expense of other states that are not as attractive to illegal aliens.

#

Contrary to the claims of Julian Simon, Ben Wattenberg and other Jewish advocates of open borders, Asian "refugees" are not an asset to the U.S. economy. In Stanislaus County (CA), there are some 12,000 refugees, with 6,700 currently on welfare. In San Joaquin County, 24,000 of the 35,000 refugees are getting welfare checks. In Merced County, half of the 11,000 refugees are receiving public assistance.

Aliens, some legal, most illegal, have become a major drain on law enforcement and comprise 20% of the federal prison population. Thousands more are in state, county and local jails. Over 70,000 aliens were arrested on drug charges alone last year. Even worse, the protracted deportation process allows released convicts to commit more crimes while their immigration cases are pending.

Between 1977 and 1984, 35% of those arrested for murder and non-negligent homicide were white, 50% were black. Yet 62% of those executed were white, and 33% black. During the same period, of every 1,000 whites arrested for murder, 16 were sentenced to death, compared to 12 of every 1,000 blacks.

At last count, WAR (White Aryan Resistance) was maintaining 21 telephone message services around the country, while some 30 public access cable TV stations were carrying WAR's affiliated program *Race and Reason*.

The Census Bureau selected minority ad agencies to devise 51 national TV and radio spots in 13 languages and dialects. The bureaucrats also wrote census sermons for minority clergymen and encouraged census rap songs. Whites were studiously overlooked in the nose-counting campaign.

A Los Angeles Times poll taken in Mexico found that 22% of the respondents said it was "very likely" or "fairly likely" that they would be living in the U.S. sometime this year. Just before last Christmas, Bush signed a directive that permits foreigners seeking asylum in the U.S. to give as an excuse their desire to escape what they see as repressive family planning policies in their homelands. This directive is primarily designed to benefit Chinese, but can apply to citizens of any country with population control policies that include forced abortion or sterilization.

In mid-February of this year, Bush also signed into law an amendment to the 1952 McCarran-Walter Immigration Act, part of a \$9.8 billion State Department authorization, which now permits anarchists, Communists and advocates of totalitarianism to freely enter the U.S. The most likely beneficiaries of this bill will be Jews from the crumbling Soviet Empire. This important change in immigration statutes will make it easier for Communist Jews from the USSR, whose Marxist madness nearly destroyed Russia, to move across the Atlantic and accelerate the wrecking process now going on in this country.

**Canada.** The Canadian government ruled in March that Sikh Mounties may wear turbans instead of the traditional broad-rimmed Stetsons with their uniforms. Hundreds of thousands of Canadians signed petitions opposing the change, and polls showed that a majority of their countrymen agreed. Yet Prime Minister Brian Mulroney recklessly declared that Canadians rejecting Mounties in turbans were "as bad as the Ku Klux Klan."

The Sikh religion was founded in India in 1469. Every male Sikh is supposed to practice "the five Ks" by keeping five items on him at all times: a kirpan (sharpened dagger), kesh (uncut hair, which the turban covers up), kanga (holy hair comb), kach (special underwear), and kara (holy bracelet). The human rights professionals in Ottawa ruled that Sikh Mounties may adhere to the five Ks on the job, just as Orthodox Jews may do their own K (kosher) thing. But a member of the Canadian white majority who dared to indulge in the three Ks would be kicked off the force instanter.

The struggle is far from over. The Sikh Mounties are still required to put on helmets in emergencies, but plan to fight that too. The Treaty Indians want the right to wear long braids, and the Rastafarians are insisting on dreadlocks. What's next? Meanwhile, a Conservative party MP from Alberta, Louise Feltham, says, "I have talked to hundreds of Sikhs . . . and they all tell me the same thing: it [the turban] is not a religious item." She didn't say what it was -- a cultural relic? -- but her finding may open the door wider to Canadian whites who want to preserve some of their own non-religious customs.

A subscriber reports. Freedom of speech is slowly evaporating here, as it is in other white countries that have passed "hate laws" to stifle criticism of minorities. But "pin speech," to the great chagrin of liberals and Jews, is on the upswing. Below are a few examples. Unfortunately, drawings had to be used since photos of small lapel pins don't reproduce well.



One lapel pin, perhaps the most infamous, is not illustrated. It has the words, "Who is the majority in Canada?" and portrays a Sikh, an Asian coolie and a spear-

toting black crowding a small, worried-looking white in a business suit. This pin gave the Alberta Human Rights Commission a slight case of apoplexy. Other pins, like the ones shown at lower left, condemn the ruling that allows Sikhs in the RCMP to wear turbans, and raise lib-min blood pressure by going after Prime Minister Brian Mulroney. At the same time, a poster, featuring a Sgt. Kamell Dung in a Mountie uniform modified by a turban, Turkish slippers and a saber, began circulating in Western Canada. Superscribed was the question: "Is this Canadian or does this make you Sikh?"

Herman Bittner of Langton, Alberta, dreamed up the poster. If anyone in Manitoba is caught selling it, he will face criminal charges, according to the province's minister of justice. So much for free speech in Canada! Peter Kouda, a Czech immigrant who lives in Calgary, designed the controversial "Who is the minority?" pin. Bill Hipson, also of Calgary, arranged for the manufacture of the pins, most of which are made in Taiwan. He says he has sold about 30,000 of them at about \$3 (American) each.

**France.** Things were going well for Jean-Marie Le Pen. His Front National was climbing relentlessly in the polls. At last count, he had the support of 15.5% of the French electorate. A curb on immigration, the biggest plank in his platform, was right on with most Frenchmen. French Jewry, which was leading the fight against Le Pen in the media, was getting a battering because of the zooming Arab crime rate in France and the Israeli crime rate against Palestinians on the West Bank and Gaza. The one fly in the ointment was Le Pen's upcoming trial for making a supposedly anti-Semitic pun. He juxtaposed the name of a leading French politician with Holocaust crematoria.

Yes, things were going well, all too well. Something had to be done -- and it was! The media bang was heard round the world. Thirty-four Jewish graves were opened in Carpentras in southern France. One corpse, buried a month earlier, had been exhumed and impaled on the tip of an umbrella.

France went bonkers. Some 80,000 Jews and Jewish fellow travelers hit the streets in Paris. François Mitterrand *lui-même* led the procession, the first time any French presi-

dent had participated in a public demonstration since WWII.

Le Pen was blamed for everything. Several prominent Jews, including the half-Jewish Interior Minister Pierre Joxe, subtly recommended Le Pen's assassination. All the major newspapers made it quite plain that the vandalism had been pulled off by Front National members or manic anti-Semites associated in one way or another with the Front.

A dozen or so skinheads or neo-Nazis were picked up in an all-points dragnet, but had to be released for lack of evidence. In a previous incident, a month before the graveyard gambol, three Arabs and a European had climbed over Carpentras's high cemetery wall, one of them having broken his leg in the process. The major media did not see fit to print this interesting piece of news, nor did the press and TV see fit to mention that the Jewish widow of the impaled dead man was a Front National sympathizer. Some North African Jews in France are actually members of Le Pen's party because of the rough treatment they received by Arabs before they made it to France.

It is glaringly obvious that no Front National member or anti-Semite in his right mind would desecrate a Jewish cemetery. Nothing would benefit the cause of Jews, liberals and leftists more. It had to be one of those "staged events" over which the media can wring out every last red drop of heartache for the victims. There is also the possibility that Mossad was in on the racial scam in order to scare more Jews into emigrating to Israel. If so, it was quite effective. Two thousand of the Chosen sought permission to emigrate to the Zionist state in the week following the Carpentras affair.

*Cui bono?* was the justifiable cry of Le Pen. "Who profited?" If the culprits are not found -- and they seldom are in such perpetrations of Machiavellian cointel -- it will depend on the level of sophistication of French voters as to whether what went on in a Jewish cemetery will be a mortal blow to Le Pen or whether he will ride out the storm as he has ridden out many others in the past.

Because the crime was not solved, he had a harder time at his trial. He lost and was fined. Meanwhile, his enemies went to work on a specifically anti-Le Pen law which denies public office for five years to anyone found guilty of a hate crime. The French Assembly passed it. It is now in the hands of the Senate.

The grave of Le Pen's right-hand man, Jean-Pierre Stirbois, has been vandalized twice since his mysterious death in an auto accident a few years ago. Mitterrand stayed home, and so did the screaming heads of various Jewish, liberal and Communist



rent-a-mobs.

Two Israeli Jews were found guilty in early May of desecrating 250 Jewish graves in Haifa with graffiti blaring, "Burn the Jews." The desecrators explained they wanted to get Jews mad enough to attack local Arabs. The French media hardly raised an eyebrow.

A long, long way from Carpentras, and only a few days after the event that caused all the tumult and shouting, more than 100 headstones were overturned in a College Park (GA) cemetery. Since this was not a Jewish graveyard, it only rated an eight-line story in the Atlanta Journal and Constitution.

\* \* \*

The Carpentras caper gave added impetus to the inquisition against French skeptics of the Holocaust. Bernard Notin, a professor of economics at the University of Lyon, who dared to challenge some of the details of the gas chamber story, has been the target of the university's council of administration, which asked the Minister of Education to ban him from teaching any courses at the next session.

Although he has successfully weathered six physical assaults, one of them almost fatal, Professor Robert Faurisson, also a member of the University of Lyon faculty, has received no pity from his superiors. He has been permanently relieved of his position -- an unheard of act in the French educational system -- and put out to pasture in the correspondence course department of the education ministry.

The Socialist Party's recent appalling performance of its Rennes Congress and the urgent public call by Chirac about the immigration problem, plus Prime Minister Rocard's "appel" for a general meeting of all the political forces to discuss the immigration question, plus the sinking Communist Party, sound to the French as a kind of S.O.S. from a foundering ship.

\* \* \*

A formidable repression is on the way, based on a sharpened reconstruction of the Plevin Act of 1972. It will be the task of the courts to decide if any public expression (oral or written) is actually racist or will possibly lead to racist behavior. The latest victim of France's present "hate laws" is Monseigneur Lefebvre, the Traditionalist Catholic bishop, an octogenarian of irreproachable morals and high culture. A strong but quiet man of total "desintéressement."

**Germany.** In all the Sturm und Drang about German unification, the fate of the East German Soviet puppet state and the consequent streaming of tens of thousands of East Germans out of their Marxist miasma into the cultural wasteland of West Germany (crime, drugs, pornography, hate laws and the rest of democracy's cultural baggage), little has been heard of a much larger German ingathering -- the Germans arriving from the other East Bloc countries, no longer under Soviet political control (though all still play host to huge numbers of Soviet troops).

The ingathering started in 1944-46, at the point of Soviet bayonets, when 12 million Germans from traditional German territories or territories acquired in the Hitler-Soviet pact and its military aftermath poured into the shattered Third Reich, losing 2 million along the way. These and later arrivals, refugees from Transylvania and Romania and German enclaves in Hungary, Czechoslovakia, Poland and even in the Soviet Union, have done much to compensate for the declining German birthrate and hold the population steady at 61 million. These refugees also brought with them a bent for right-wing politics, since most had been through hell and had personally experienced the results of Marxist Leninism, a cultish credo which many left-wing German eggheads continue to hold in high repute.

There are still 3.5 million ethnic Germans scattered throughout the Soviet Union and Eastern Europe. Two million are in the USSR, hundreds of thousands in south and central Asia, where they were sent by Stalin after the Nazi attack. About a million more are in western Poland in the former German provinces of Pomerania and Silesia. The remainder can be found in Yugoslavia, Hungary, Czechoslovakia and Germany's lost province of East Prussia.

Last year, 377,000 ethnic German refugees arrived in West Germany. That's 30,000 more than the influx from East Germany, indicating that more Germans are leaving Russia than Jews. Unfortunately, not all the migration into Germany consists of Germans. Eighteen thousand East Europeans, mostly Romanians and Bulgarians, have arrived in East Germany in recent months, along with 20,000 Poles and thousands of Italians. They are joining tens of thousands of Vietnamese, Ghanians and Mozambicans, who were brought in years ago by the Communist government to do the menial work that is beneath the dignity of the native proles.

\* \* \*

Holocaust blackmailers have now managed to get their claws on East Germany and Austria, after bleeding West Germany of some 80 billion marks (\$48 billion) in reparations over the years. The Austrian government tentatively agreed in February to pay 300 million schillings (\$24 million) over a five-year period to various Jewish organizations outside Austria. The economic basket case of East Germany promised Edgar Bronfman, head of the World Jewish Congress, about \$100 million. But then when the East German Communist government fell apart, East Germany reneged, much to the despair of the Jewish booze magnate. At last report, the new non-Communist government was making noises about some kind of *Wiedergutmachung*, while probably waiting to drop the whole problem into the lap of the West Germans on the day of unification. One difficulty in paying Jews reparations is that the money doesn't always go where it's supposed to. The latest audit of the estate of Werner Nachmann, who headed the Central Council of Jews in West Germany, showed 210 million schillings (\$168 million), which he was supposed to hand out to "survivors," went into his own pocket.

Another old Jew, Karl Marx, was in the news when Chancellor Kohl of West Germany asked his Parliament for money to maintain and renovate the Marxist's grave in London. One would think that, at the very moment Marxism has been collapsing all over Eastern Europe, a capitalist head of a capitalist government would not ask his Parliament for money to fix up and maintain the Communist founding father's grave. For reasons well known to Instauration, that is just what Chancellor Kohl has done. It's always good politics to butter up to Jews, left-wing or right. It guarantees a better press.

\* \* \*

The Commonwealth Club of San Francisco will include a stop at Oberammergau in its European tour package this summer. Predictably, the 20,000-member club has come under raking fire from the Anti-Defamation League for patronizing the "anti-Semitic" passion play in that Lederhosen and Dirndl Bavarian town. The ADL hoped to stage an "informational briefing" for all those attending the play, but had to settle for providing the tour group with literature on why Jews dislike Oberammergau and all its works. One of the sticking points is Matthew 27:25, which asserts that after Pontius Pilate washed his hands of responsibility for Jesus' execution, "the whole people said in reply, His blood be upon us and upon our children."

Actually, the inclusion of that revelatory



verse was narrowly approved by a 11-9 vote of the text committee for the Oberammergau play -- with the proviso that a five-page commentary defusing it be inserted in the literature which tourists purchase to follow the plot of the day-long drama. In this and other respects, the 1990 performance will be virtually a philo-Semitic parody of its predecessors from 1634 to 1984. A few of the changes:

- The Jewish merchants whom Jesus chased from the temple will no longer bear any telltale physical characteristics.

- Pontius Pilate, portrayed as a noble, rather compassionate Roman for 350 years, will suddenly become a brutal, unsympathetic creature.

- Judas Iscariot, a coldly mercenary figure enticed by 30 pieces of silver, will become a "confused" idealist who loses his faith in Jesus.

- There will no longer be "good guys" and "bad guys," suggested by light and dark clothing, but a fairly harmonious, like-thinking Jewish community. Jesus' identity as a regular Jew will be stressed repeatedly, and the Jewish high priests will no longer have horns, a medieval convention.

Unlike Oberammergau, which stages its show every 10 years (1984 was a special anniversary), the passion plays in places like Eureka Springs (AR) and Spearfish (SD) generally draw large crowds each summer. The Holy Family Passion Play in Union City (NJ) has been watered down even more than its Bavarian counterpart, if that is possible. Since Gerald L.K. Smith was once the guiding light at Eureka Springs, it will likely be the last holdout for a more credible dramatization of what the Jews did to Jesus.

\* \* \*

The Paris daily, *Le Figaro*, reported (April 5) that Poland's Lech Walesa had threatened a united Germany with annihilation in an interview published a day earlier in the Dutch weekly, *Elsevier*. Walesa allegedly said he had "every reason to be preoccupied" with German reunification, and added:

I do not even shrink from a statement that is not going to make me popular in Germany: if the Germans destabilize Europe anew, in some way or other, then partition will no longer have to be resorted to, but that country will have to be erased from the map, pure and simple. East and West have at their disposal the advanced technology necessary to carry this verdict out.

Rather harsh language coming from a recipient of the Nobel Peace Prize. Or, considering that Menahem Begin was likewise honored, perhaps rather predictable. If Walesa would try reading a book once (he says he never does), he might learn that

Poles have also scored pretty high in history's blood and iron department.

\* \* \*

David Irving, ignominiously run out of so many German-speaking towns in his day, finally got the triumphant reception he deserved in Dresden on Feb. 13. The city's cultural director invited him to speak and made available the largest meeting hall in the Palace of Culture. Posters announcing his appearance were everywhere. The city's dignitaries were on hand, and East German TV did an interview, which was well received.

As Irving approached the stage, the entire audience of more than 1,000 rose to give him a standing ovation. Speaking in perfect German, the British historian recounted Churchill's plans for bombing German cities from the mid-1930s, and contrasted them with Hitler's prolonged resistance to the idea of hitting civilian targets.

The figure of 35,000 dead at Dresden was "Allied propaganda," Irving charged. He could prove 135,000 deaths from his own research, and the city had a list of 480,000 victims. Churchill, Irving charged, had selected the time and place in order to "fry the refugees from Breslau" (the prime minister's words). As large numbers of burn victims fled toward Chemnitz, Churchill ordered "Bomber" Harris and his men to fry them again. For this sort of thing and a plan concocted (but happily not executed) to drench many German cities with poison gas, Winnie was awarded the prestigious Karls Preis by the West German government.

Irving concluded his historic oration with this rouser: "Ladies and gentlemen, survivors of the holocaust of Dresden, this holocaust really happened. That of the Jews at Auschwitz was invented." Afterwards, a panel discussed the findings of the 1988 Leuchter Report, which scientifically and methodically reduces the gas chamber story to a fairy tale.

**Poland.** Anyone in the market for hate crimes? Listen to this spleen.

The Warsaw ghetto was destroyed under the eyes of the bishops of the Catholic Church. All the murderers of Auschwitz were baptized Christians. The camp must be described as the bankruptcy of Christianity.

These hateful words, which would have sent the speaker to a jail cell in several Western countries, were spoken by Ben Chorim, a prominent Jewish publicist who resides in Tel Aviv.

Speaking of hate, what about these polemics? Are they actionable?

Ye serpents, ye generation of vipers, how can ye escape the damnation of hell?

Ye are of your father the devil . . . .

Ye Blind guides . . . . Hypocrites!

Give not that which is holy unto the dogs, neither cast your pearls before the swine . . . .

These words were spoken some time ago by another Jew (though historian Arnold Toynbee says he belonged to a family of forcibly converted Galileans). Whatever he was, he did have his kinder and gentler moments, which is probably not the case with Ben Chorim, who is more of an Old Testament type.

**Lithuania.** As the dramatic events of spring unfolded in the largest Baltic republic, world Jewry kept demanding center stage for its own concerns. "All people of good will rejoice in the new birth of freedom [in Eastern Europe]" began an article by John Rothmann in the *San Francisco Examiner* (April 23). But! There is almost always a "but" attached to Jewish disquisitions on events in Eastern Europe. Rothmann's "but" concerning the situation in Lithuania subtly proposed a linkage between recognition of Baltic rights and the Balts' readiness to rewrite their history from a Judeocentric perspective. The Lithuanians have tried to explain that they also suffered greatly, and that some (perhaps much) of that suffering was directly at Jewish hands. Balts, however, don't have the clout or the verbal agility to make their ideas lodge permanently in the brains of the powers that shape our destiny.

Some of the demands for linkage have been quite blunt. The Jewish Telegraph Agency carried a story in May that began:

Israelis of Lithuanian origin are demanding that Lithuania acknowledge its role during the Holocaust before it asks world support for its declaration of independence . . . .

Lithuania is trying to rewrite Lithuanian history of that era, according to Dr. Abba Gefen, chairman of the Organization of Israelis of Lithuanian Origin . . . .

The organization is protesting specifically against turning [a] site of Holocaust atrocities in Kovno [Kaunas] into a museum of Stalin's terror . . . .

More than 46,000 Jews were murdered in Lithuania in 1941, most of them by Lithuanians . . . .

Here is a classic case of the Jews blackmailing a nation by withholding their powerful media support unless the Jewish interpretation of controversial events is accepted.

Joel Litewka, an American Jew who recently went on a "cultural mission" to Lithuania, told *Washington Jewish Week*,



"Everybody remembers what the Lithuanians did. From this point of view, you have to be against independence."

The Spotlight reported that President Bush was about to impose economic sanctions on the Soviet Union because of Lithuania, but changed his mind on April 25 after consulting with the Israelis, who were convinced that Gorbachev would respond by cutting off Jewish emigration. As Vytautas Landsbergis, the embattled Lithuanian president, asks: "Can the freedom of one group of people be sold for the freedom of another? What then is the idea of freedom?"

**Soviet Union.** Oceans of ink are being spilled over the "new pogroms" of Russia, when not one Jew has yet bitten the dust. Russian military officers are being slaughtered by the score, but very few know about it. Reuters did carry one story in March, quoting the London-based Jane's newsletter, that 59 Soviet officers from the rank of lieutenant to general were murdered in 1989, compared to only two in 1988 and one in 1987. Since nearly all high-ranking Soviet officers are Russians from the heartland, Jane's suggested that ethnic hostility was the chief cause of death.

\* \* \*

Five of Russia's major nationalist groups formed an alliance in March under the leadership of Evgeny Pashkin, head of the Christian Patriotic Union. The "most virulent" of the five is said to be the Pamyat (Memory) Union for Ethnically Proportional Representation, one of the factions into which Pamyat is said to have split. This group is so "virulent" that it wants the same rights for ethnic Russians (the Soviet "Silent Majority") that Moscow has handed out to all the loudmouthed minorities. The umbrella group of the new coalition is to be called the People's Russian Orthodox Movement. It flies a "swastika-like" flag featuring a black cross in a yellow circle.

\* \* \*

The last of the bloody old Bolsheviks is 97-year-old Lazar Kaganovich, who now lives in a Moscow apartment and seldom dares show his face on the street. On Feb. 14, the Moscow daily, *Vechernaya Moskva*, printed an open letter from five leading public figures in the Ukraine, daring Kaganovich to come out and visit one of the killing sites for which he was indirectly, if not directly, responsible. The five offered to pay Lazar's way to Bikovnya, outside Kiev, where mass graves from the 1930s were

uncovered after Gorbachev came to power in 1985.

"We residents of Kiev do not have the slightest doubt that you are quite familiar with the settlement of Bikovnya," began the letter.

Your stooges here tried like thieves in the night to hide the traces of the crimes committed on your orders . . . You and Molotov . . . were [among] the organizers of the unprecedented genocide -- the carefully planned murder of 7 to 9 million Ukrainian peasants . . .

In a significantly un-not anti-Semitic tone, the letter added, "It is not up to us to pass judgment upon you, a 97-year-old man, who is . . . on the point of appearing before God."

\* \* \*

"Video uprisings" have occurred in a number of stores around the city of Yaroslavl. Until recently, VCRs were available only to the Communist Party elite or on the black market at prices like \$6,400. When 158 VCRs arrived at one store recently, hundreds of citizens camped out for days on end. Some went on a hunger strike to emphasize their demands that affirmative action for apparatchiks be buried with the dictatorship of the proletariat.

\* \* \*

For the keenest insight possible into why the Jews fear recent developments in Russia, one has only to obtain a copy of the *New Republic* (Feb. 5). It contains two major articles by Jewish writers which go into considerable detail about the wave of anti-Jewish thinking now sweeping through Russia. The first is an overview of the situation by Walter Laqueur, featuring an "analysis" of 20th-century Russian-Jewish relations which can only be described as intellectually corrupt. To wit:

Why the sudden preoccupation with the crimes committed by the Bolsheviks against the Russian peasantry and other classes in the 1920s? Surely the confrontation with current problems is even more important; and it is not a little strange to make Sverdlov, Trotsky and Zinoviev responsible for policies carried out many years after their deaths by Stalin, Molotov, Zhdanov and Voroshilov.

Laqueur is quite familiar with Solzhenitsyn's *Gulag Archipelago*, and the extensive evidence therein that the genocide began under Lenin and his original circle of Jew-

ish Bolshies. He also surely knows of Zinoviev's famous demands that the Russian bourgeoisie be "drowned in rivers of blood." The sudden preoccupation with the past comes because a 70-year terror has only now been lifted, as Laqueur well understands.

More important is Liah Greenfeld's review of *Russophobia*, a book by the noted mathematician, Igor Shafarevich, and published last year by the Union of the Russian People. The Jews are already treating it as one of the classics in the 3,000-year history of "anti-Semitism" -- with the difference being that they are handling the author with a modicum of respect. Greenfeld observes that he was a founding member of the Committee on the Defense of Human Rights in the USSR. *Russophobia*, according to Greenfeld, is "an expression of an important part of the Russian intellectual elite, of some of the movers and shakers behind the contemporary transformation of Russian society."

From the wailing and gnashing of kosher teeth in the New Republic, it is obvious that an important book has seen the light of day (after circulating in samizdat form for a decade). Shafarevich forthrightly tackles the problem posed by those who do not wish the Russian people and their culture well -- and he looks with special care to their motives. At the root of Jewish hatred for Russia, which has had such disastrous consequences in this century, he finds not so much internationalism as something much older and deeper -- Jewish nationalism. Pursuing this problem leads him to many striking, Instaurion-like insights:

In his studies of the French Revolution, made early in this century, Augustin Cochin identified a social or spiritual stratum which he called the "Little People," an elite which lives apart from the experience of the majority, and, in Shafarevich's phrase, often behaves as an "anti-people." The Russophobic Jewish exile G. Pomeranz is a contemporary example of this rootless intelligentsia. Pomeranz insists, "the place of intelligentsia is always in between destinations . . . Spiritually all contemporary intellectuals belong to a diaspora." In the present Soviet context, writes Shafarevich, this mindset leads to an unjust obsession with the problems of minority groups. "In the area of nationalities, the fate of Crimean Tatars enjoys more attention than the fate of Ukrainians, and the fate of Ukrainians more than that of Russians."

On the Jews, Shafarevich is always emphatic:

There is only one nation of whose concerns we hear almost every day. Jewish national emotions shake both our country and the whole world, influencing disarmament talks, trade policy and [the]

international connections of scientists . . . . The "Jewish Question" has acquired an incomprehensible power over the minds of people, eclipsing the problems of [all other groups] . . . .

In their long history, the Jews never exerted so disproportionate an influence on the fate of a nation as in Russia during and after the Communist Revolution. The result was the biggest, most protracted disaster in human history. But now, for a second time, they are reaching a pinnacle of power. Americans especially, warns Shaferevich, must begin to heed the grim lessons of the Russian-Jewish interface.

Anti-Semitism is quite consciously wielded as a super-weapon by the Jews. The idea is to replace logic and information with emotions, even to the point of mass hysteria. And the formula usually works. A "deeply rooted, internalized inhibition" is deliberately created in the breast of each Gentile intellectual, according to which "any thought that somewhere in some period [the] actions of some Jews harmed other peoples -- even any objective study which does not from the start rule out such [a] possibility -- is considered reactionary, not intellectual enough, impure." The Jews, in short, have propagandized themselves into a race of angels.

In reality, however, Jews are quick to use the misfortunes of others to their own advantage. Indeed, the "thought that political turmoil may serve as an instrument for the achievement of national goals is not foreign to the Jewish consciousness."

Ordinarily, when Jewish writers criticize a work of anti-Semitism, they point out its "mistakes" each step of the way. Greenfield's review is unusual in that it allows Shaferevich to develop his ideas for several pages before the reviewer finally steps in and says, "Okay, my goy friend, far enough!" From that point on, it's mostly unflattering comparisons with medieval Jew-baiters and Alfred Rosenberg. But, for a strange interlude, this reader at least was left wondering if the impossible was happening and some influential Jews were seeing the disastrous errors of their ways. (No doubt more Jewish readers were feeling a tad disturbed.) Even at the end of the article, there is a strange note of ambiguity, as Greenfield quotes from Shaferevich's paean to "the People," which closes his book:

A People is one of the most wonderful phenomena and enigmas of our Earth . . . . Belonging to one's People makes a man partake in History, in the mysteries of the past and the future . . . . [Through it] he can sense . . . the significance and higher meaning of the earthly existence of humanity and his role in it . . . . We have said what the People gives to man. Man, for his part, creates forces which strengthen the People and secure its ex-

istence . . . . When this two-tiered process decomposes, the same thing that happens in nature occurs: the habitat turns into a dead desert, and the man dies with it . . . . This is the end to which the "Little People," constantly trying to destroy everything that supports the existence of "Big People," pushes us. Therefore the creation of the weapons of spiritual defense against it is a question of national self-defense.

**Israel.** King Hussein of Jordan was in international waters in the Gulf of Aqaba on April 28 when an Israeli naval boat opened fire on his royal yacht. According to the Israeli newspaper, Haaretz, the utterly unprovoked attack came from weapons mounted on the deck, "not just shots from a pistol." As Hussein's clearly marked yacht headed for Saudi Arabian waters, the Israeli naval vessel "tailgated" it, while continuing to shoot. The Israeli government later insisted that it was nothing more than a routine "weapons check," and refused to apologize to the incensed Jordanians.

\* \* \*

King Hussein will have some even wilder Jews on his western border if the independent "State of Judea" is ever realized. Michael Ben-Horin, a former activist with Rabbi Meir Kahane's banned Kach party, is the self-proclaimed president of Judea, and vows to take up arms against all comers should Israel ever agree to grant autonomy to the Palestinians of the West Bank. Ben-Horin, who has made Kahane "Judea's" honorary ambassador to the United States, says he has 600 followers who "won't allow stone throwing. We would deport every stone thrower . . . . To save one Jewish life, I am in favor of deporting them all."

\* \* \*

Rabbi Kahane is said to be raising funds for the "State of Judea" in the U.S. these days. One should not assume that this is merely some crackpot idea of a few extremists. Kahane first made headlines in the early 1970s with his Jewish Defense League campaign of terror against the Soviet Union. The JDL bombed and shot at Soviet facilities in the U.S. until, as author Robert I. Friedman puts it, "the U.S. government was compelled to make the free immigration of Soviet Jews a top priority" (Washington Post, April 22, 1990). (Does this mean that a few Klan bombers could "compel" Washington to make an end to Third World immigration a "top priority"?) Friedman has written a book, called *The False Prophet: Rabbi Meir Kahane -- From FBI Informant to Knesset Member*, which shows that "the JDL's guerrilla war against the Soviet Union was orchestrated by right-wing Mossad officers led by . . . Yitzhak

Shamir." Kahane is currently on trial in Israel, which apparently doesn't preclude stints of fund-raising in Zoo City. He is charged with inciting attacks on Arabs. Only 20 years ago, he was meeting in Manhattan with a covert emissary from Shamir. Kahane has never been the "lone operator" he is cracked up to be.

\* \* \*

On May 7, two major human rights groups released reports deploring the "inhuman conditions" in Israel. The Geneva-based Defense of Children International described how Palestinian kids are jammed into cells and often beaten in the prison located within Jerusalem's so-called "Russian Compound." On one visit, the Swiss found 39 bruised children packed into a cell with 12 beds. Incredibly, all this transpired in the very building which houses the Israeli Supreme Court. (Could this be another odd example of what the critic Leslie Fiedler means when he advises his fellow Jews to "go high-low every time"?)

Also in May, Felicia Langer announced she was closing down her law office after 24 years. The defender of 5,000 Palestinians said that Israeli "travesties of justice" had made the presence of a lawyer "totally useless."

\* \* \*

When Colombian authorities raided the ranch of drug lord José Rodríguez Gacha last winter, they discovered hundreds of Uzis and other Israeli weapons. Investigators subsequently determined that, in November 1988, supposed "representatives" of the government of Antigua, a tiny Caribbean nation, went to Tel Aviv with a request to purchase the arms. Directing the fraudulent transaction were two Israelis, Maurice R. Sarfati and Yair G. Klein; bank-rolling it was the New York branch of Bank Hapoalim. The job of Antiguan front men was to convey the guns from Israel to Colombia. Bogotá officials have issued an arrest warrant for Klein, who is now in Israel. Sarfati is being sought by the U.S. because his "produce company" in Antigua defaulted on \$1.3 million in loans from Uncle Sam. A Senate investigations subcommittee insists that it is carefully examining the entire Israeli-Colombian connection.

\* \* \*

Friedrich Nietzsche wrote that the Jews "voluntarily and out of the most profound prudence of self-preservation, take sides with all the interests of decadence -- not as mastered by them, but because they divine a power in these interests with which one could prevail against 'the world' " (*The Antichrist*, chapter 24). Someone forgot to tell Galia Albin, an Israeli publisher, that



Jews are supposed to peddle smut to the goyim, not pollute their own homes with it. When Ms. Albin started an Israeli Hebrew-language edition of Penthouse magazine last year, plenty of locals started buying it. But advertisers shunned the venture, and it failed after eight months. "It's one big hypocrisy. One big double standard," Ms. Albin complained. "What can I say? It's a Jewish state."

\* \* \*

When Norway sold Israel 21 metric tons of heavy water in 1959, the contract gave it inspection rights to ensure that the isotope would be used only in the operation of nuclear reactors, not for weapons purposes. After Israel consistently refused to let in Norwegian inspectors, the two countries eventually hammered out an agreement which calls for half (10.5 tons) of the liquid to be shipped back to Norway.

Gary Milhollin, a nuclear expert in Washington, told the Wall Street Journal (April 30), "This is the first time that a nuclear supplier has neglected to enforce an inspection pledge." Even though heavy water is lost over time, Milhollin believes the Israelis may still have up to 8 tons left from the initial 21-ton shipment.

\* \* \*

The Israelis sighed with relief when Norwegian ambassador Torleiv Anda went home last year after five years on the job. Anda got into trouble several years ago by candidly noting that the Nazi occupiers of Norway never mistreated the locals as badly as the Israelis treat the Palestinians.

**Iraq.** Back in March, at about the same time Farzad Bazoft, a young Iranian reporter employed by Britain's Observer newspaper, was hanged in Baghdad as an "Israeli spy," a second contributor to the Observer, Alan George, was writing a detailed article for a London-based current affairs magazine called *The Middle East*. George's article linked Dr. Gerald Bull, a Canadian-born arms designer and dealer, to the regime of Saddam Hussein in Iraq. Bull's firm, the Brussels-based Space Research Corporation (SRC), is a world leader in long-range, high-caliber artillery. Within days of the appearance of George's article, Bull was assassinated by a professional hit man outside his fashionable Brussels apartment. The equivalent of about \$19,000 was found in his pockets. The victim's son, Michel Bull, who is also general manager of SRC, blamed the March 22 slaying in part on the article, provoking its author to say, "It's ridiculous, of course, to think that

some reporter is going to have more information than that which is available to the combined forces of Western intelligence agencies and Israel."

Two senior reporters with the *Spotlight* in Washington (DC) later spoke with a senior official at the U.S. Justice Department, who noted the FBI had learned that the Israeli secret service had tracked Bull from Washington to New York and then aboard a transatlantic flight to Brussels. A Pentagon investigator told the *Spotlight* (May 14), "You can bet no one will be indicted for killing Dr. Bull. When the Mossad eliminates an adversary, it can count on the protection of the most powerful fixers in Washington." The *Spotlight* article recounted the cases of retired U.S. Army Col. Robert Bayard, drug informant Barry Seal and other Americans who seem to have had fatal "dates" with Mossad agents.

Gerald Bull was unquestionably the most remarkable person in this group. A volatile man who was too busy to take safety precautions, Bull was called by Christopher Foss, military editor of *Jane's Defence Weekly* in London, "perhaps the greatest gun designer of the century." Just last year, "weapons experts and arms buyers who attended a military trade fair in Baghdad were astounded by one of the latest state-of-the-art achievements of Bull's design team: a 203mm field gun with a planned range of 50 kilometers, double that of the most powerful Soviet-made heavy howitzer used in the Middle East." (*Ottawa Citizen*, March 31)

Shortly before his death, Bull informed his son that Mossad was after him (*Ottawa Citizen*, April 3). Bull had worked with the Israeli government in the 1970s, and his other clients included China, Yugoslavia, Austria and Spain. Indeed, following his death, Israeli Brig. Gen. Avraham Bar-David noted that Bull had helped his country to greatly increase the range of its artillery. In 1980, Bull was convicted in Vermont of smuggling arms to South Africa and jailed for six months. Armscor, the South African government armaments company, had purchased an advanced 155mm howitzer. Following his release, he relocated his company from Quebec to Europe, opening offices in four countries.

The "Iraqi connection" began to hit the headlines of Western newspapers early this spring. On March 28, officials at London's Heathrow Airport seized a shipment of U.S. capacitors bound for Iraq. The electronic components have been called nuclear detonators or "triggers" by some. On the evening of April 10, customs inspectors on the Teesport docks in Middlesbrough, Eng-

land, seized eight enormous sections of reinforced steel tubing that were to be loaded on the *MV Gur Mariner*, a Bermuda-registered freighter bound for Iraq. The manufacturer, Sheffield Forgemasters, agreed with Baghdad that the cylinders were a kind of precision piping for the Iraqi oil industry. Henry Dodds of *Jane's Defence Weekly* said he wasn't sure what the tubes were for, but the British government insisted they were part of a 140-ton "super-cannon" intended to hurl two-ton chemical or nuclear projectiles at targets like Israel and Iran. Significantly, it was Bull's SRC firm which mediated the contract between Sheffield Forgemasters and the Iraqi Ministry of Trade. The *London Telegraph* also linked Bull to the seizure of the alleged nuclear "triggers" two weeks earlier.

The latter part of April was dominated by Israeli-generated hysteria about Iraqi President Saddam Hussein's alleged threats to "burn half of Israel" with chemical weapons. Usually overlooked in the affair was the purely defensive nature of Hussein's threat: if you bomb us, then we'll bomb you. Also overlooked was the fact that the International Atomic Energy Agency (IAEA), based in Vienna, had routinely inspected all of Iraq's nuclear power facilities in early April and found nothing amiss. The same agency has never been allowed to make inspections in Israel, where, according to most experts, nuclear energy is to no small degree a façade for nuclear weaponry.

On May 8, Saddam Hussein again denied that Iraq is making nuclear weapons. The capacitors seized at Heathrow in March were intended solely for laser research at Baghdad's Technological University. Hussein produced an example of the American-made device, alongside two copies which he said were Iraqi-made. They were not intended as nuclear "triggers," he insisted. Whatever its prospects for developing a nuclear arsenal, Iraq is known to have the most advanced military industry in the Arab world, including chemical weapons it has used against its own Kurdish minority.

Belgium's *Le Soir* magazine has written of "this huge gun, of a caliber never before seen in military history." Iraq calls the allegations "baseless and sheer lies." The British Labour Party has tried to make political hay of the issue, alternately accusing the Tories either of being duped or of conniving with the Iraqis to circumvent the British arms embargo. Sheffield Forgemasters forlornly points out that British officials were present at every stage in the deal, with customs even clearing the first 44 of 52 component parts for shipment.

As for SRC, Michel Bull announced in late April that the firm would be dissolved.



## Tyndall Turned Back

The Annual Convention of the Populist Party was held in Winston-Salem (NC) in late May. The featured speaker was to have been John Tyndall, head of the British National Party, a veteran right-winger and nationalist who has been fighting the good fight for the white race against overwhelming odds and oddballs for nigh unto 30 years.

Tyndall's plane landed in Charlotte (NC) on time on Saturday, but when the passengers came through the arrival gate, he was not among them. At first, the airline personnel at the airport denied he had been on the plane. But when Populist Party members sent to welcome him insisted that he was a passenger, the airline people, after lying for two hours, admitted the fact.

So where was he? What had happened? Well, the worst had happened. Tyndall had been stopped by immigration officials after he had deplaned and kept in a dungeon-like cellar underneath the airport. When the Populist Party group finally found out about it, they insisted on seeing him. The request was refused, and the INS threatened to arrest anyone, including a Populist lawyer, who tried to come down and see him. Tyndall arrived at 2:55 in the afternoon. A few hours later, he was clandestinely put on a return flight for London.

Several days before Tyndall's arrival, a seedy Marxist minority totalitarian lobby, the Center for Democratic Renewal, put out a press release announcing it was going to prevent the Brit from addressing the Populist Party Convention. Apparently, the group has close connections with the State Department and the INS, which obediently deferred to its wishes and closed the door on Tyndall.

This is one more example of muffling free speech by a gang publicly (and hypocritically) committed to free speech. That the U.S. Government can cave into these miserable censors is an abomination. Members of the Populist Party, which does not have the biggest treasury in the world, had to pay for the expensive round-trip air flight of a speaker who was not allowed to speak. In late May, Nelson Mandela, a professional terrorist, was welcomed into the U.S. with open arms.

## Boycotting the Holocaust

It is often said that Israel's ruling party is looking for a way to torpedo the "peace process." They may recently have found the perfect solution: accuse the PLO of being "revisionist" in regard to the Holocaust, thereby making any dialogue with Arafat impossible. Elie Wiesel says that those "who believe the Holocaust never happened" are "the most vicious of anti-Semites," who "kill the victims for a second time." An official PLO weekly magazine, published in Nicosia, has called the German gas chambers "the Lie of the 20th century" in a series of articles. Rabbi Marvin Hier of the Simon Wiesenthal Center wasted no time urging the Bush administration to cut off all contact with PLO leaders.

Holocaust denial is also a hot topic in Illinois, which recently became the first state to require instruction (indoctrination) in the subject in all public schools. An intrepid couple in the Chicago suburb of Winnetka withdrew their daughter from an eighth-grade English class where Elie Wiesel's fantasy novel, *Night*, was being taught as history. Safet and Ingeborg Sarich went a step further and mailed 6,000 letters explaining their action to educators, politicians, journalists and parents across the country. Safet Sarich is the son of immigrants from Yugoslavia and has always had doubts about the Holocaust. "The Eastern European mentality is something else," he told a Chicago Tribune reporter (May 8). "You've got peasants with wild imaginations, even in times of peace.

Rumors and stories, you know." He was familiar with similar tales from wartime Yugoslavia, which he found to be exaggerated. Ingeborg Sarich came with her mother and brother from Germany in 1957. Her father, a civilian, had died in a Siberian gulag during WWII. Even if Wiesel's stories were true, she says, "I wouldn't give a book like this to a 13-year-old."

My daughter knows the German people. She's been there. Now she's told by her teacher that the Germans took babies by their feet and slammed their heads against a wall and split them open like watermelons. Those are not nice pictures. I don't believe you should scare children like that.

When Holocaust studies became mandatory in Illinois public schools, the Sariches obtained a copy of Arthur Butz's *The Hoax of the 20th Century* and were won over by its logic. "When you delve into [Wiesel's *Night*]," says Sarich, "you see the gross inconsistencies . . . the highly questionable testimony . . . He is part of the huge propaganda machinery."

Those planning Holocaust boycotts of their own will be encouraged by the Sariches' story. Everyone at school continued to treat their daughter, Sanya, normally. Though he didn't change too many minds on the Holocaust, Safet Sarich says, "From the vibes I'm getting, virtually everyone agrees with my objection to the law." All but Gov. James R. Thompson, perhaps, who told a recent Holocaust luncheon that he "takes great pride" in the fact his state alone requires schools to teach "the lessons of the Holocaust."

## Nibbling at Israel

Jews still ridicule George McGovern for going into a kosher delicatessen at the height of his 1972 presidential campaign and ordering a pastrami on white with mayonnaise. They never quite trusted George, as they never quite trusted Jimmy Carter -- too small-town goyish. Now they're saying their "never-fail Jewish radar" was right all along. On March 18, McGovern had an article in the Boston Globe urging the U.S. to cut *all* aid to Israel unless it promptly begins negotiations with the PLO. McGovern wrote, "I now assert my firm belief that Arafat is the kind of man both Israel and the United States will find to be a reliable and reasonable negotiator."

Senator Bob Dole has been another cause of Jewish fretting of late (Stirrings, May). However, the canny Kansas pol has been careful to maintain close personal ties with leading Zionists like Canadian billionaire Albert Reichmann and New York investor Zev Wolfson (Wall Street Journal, May 1). For doing so, Dole received a (conditional) stamp of approval from New Jersey developer Sydney Sussman. "As a United States Senator," Sussman allowed to the Journal, "[Dole] has the right to question [the level of aid to Israel], and I see nothing wrong with that."

On March 22, the Senate passed a resolution recognizing Jerusalem as the capital of Israel. Senator Dole had entertained hopes of rescinding it, but surrendered in mid-April under heavy fire from his Republican colleagues. On April 24, the House voted 378-34 to join the Senate action. A militant Middle Eastern Moslem group responded with a threat that "every American . . . in Islamic countries or outside will be considered a target."

In May, the Senate approved \$400 million in guaranteed housing loans for Soviet Jews arriving in Israel, even as Prime Minister Yitzhak Shamir was pushing ahead with plans for new illegal settlements on the West Bank. Concurrently, the Congressional Black Caucus backed off from its proposal to slice a little aid to Israel and divert it to Africa and the Caribbean. Instead, the blacks worked out a deal with the Jewish lobby which calls for increasing foreign aid to just about everybody.



## Mecham on the Rebound

At least nine candidates have announced for the Arizona governorship -- five Republicans and four Democrats. Most national attention has been focused on Evan Mecham, the populist who was elected governor in November 1986 and impeached in April 1988. Some observers are viewing Mecham's level of support as a rough indication of the people's opposition to the King holiday. This is way off the mark. A recent poll gave Mecham 16% in the crowded Republican field, while other polls indicate that more than 80% of Arizonans want the King holiday put to a popular vote, where it would go down by probably a two-to-one margin. Opposition to the King holiday is clearly Mecham's winningest issue, and he (and other candidates around the country) would do very well to milk it.

Mecham's campaign headquarters in Glendale were torched or firebombed on May 2 and again on May 3, but damage was slight. His greatest worry, however, is a camorra of plutocrats who call themselves the Phoenix 40. The fatcats act as if their one big fear in life is that the 1993 Super Bowl, scheduled to be played in Phoenix, will be moved to another state.

Arizona's unelected governor, Rose Mofford, signed legislation on May 16 which creates a paid King holiday and restores the paid Columbus holiday, which a similar King bill last year had ended. The idea is to draw angry Italian Americans away from the anti-King camp while forcing the anti-Kingers to gather, within 90 days, the vast number of signatures needed to call a statewide referendum. Mecham predicts the names will be collected "within 30 days" this time around.

## Simmering Selma

The white-dominated Selma (AL) city council succumbed to black pressure when it named a black man as interim superintendent of its troubled school system. To make matters worse, James Carter had been the top aide of Norward Roussell, the black superintendent whose contract was not renewed last December, prompting Selma's five black councilmen to walk out and start the daily demonstrations. It's almost certain that Carter will follow Roussell's campaign of cutting back on "academic tracking" (Instauration, May, p. 18).

Rose Sanders, a Harvard-trained attorney and one of Selma's foremost black militants, warned that she and her supporters would "take action" if a white were named to the post. Civil disobedience has tied the city in knots all year. "We have an utter dictatorship in Selma today," says Sanders, who calls overworked City Attorney Henry Pitts a "little Himmler" who comes from a "racist family," and charges Mayor Joe Smitherman and his aides with using "Gestapo tactics." Smitherman one day told the black noisemakers outside City Hall that "before this whole thing is over" they'd be "calling me master" and he'd be bringing them a "truckload of watermelons." The mayor says any such remarks were made purely "in jest."

At one point, some of the protestors, jailed briefly for disobeying a court injunction not to disrupt city business, were told they could go home. Instead, they insisted on hanging around and launching a hunger strike. Smitherman correctly called it another publicity stunt. Readers of the Montgomery Advertiser were regaled with headlines like: "Three protestors remain in Selma jail; one falls victim to a 'Big Mac attack.'"

Zoo City has its Sharpton, Mason and Maddox. In Selma, the cast of characters includes:

- Ron Peoples, head of the protest group and dean of students at Selma University -- despite his conviction on felony theft

charges nine years ago. Peoples recently applied for the restoration of his voting rights, which were jeopardized anew by his recent arrest on charges of attempting to steal a video camera from an officer who was taping the demonstrations.

- County Commissioner Albert Turner, of nearby Perry County, indicted by a federal grand jury on voter fraud charges not long ago, then acquitted by a "Black Belt" jury. Turner likens the Selma struggle to Nelson Mandela's fight against apartheid.

- Donald ("Can't Recall") Smiley, who always pleads mental fatigue when pressed by City Attorney Pitts. "Who put it there?" asked Pitts of a city-owned video camera found in the back of Smiley's truck. "The film fairy?" Answered Smiley, "Can't recall."

- Almost the entire youth services office of Dallas County. Said Mayor Smitherman: "It seems we don't have a youth services office anymore in this county because all of them are involved in the demonstrations at the expense of taxpayers."

Race is on everyone's mind at the Selma courthouse. A white police sergeant, Anita Barlow, was asked about the testimony of several defendants who said Smitherman had told them they could remain inside City Hall after closing time, even though he had just ordered them to leave. Black defense attorney J.L. Chestnut asked Sgt. Barlow incredulously: "Do you often get orders not to enforce the law?"

"Yes, when it comes to black people," she replied.

Judge Leslie Johnson candidly admitted one day that he brought a "white man's mentality" to court with him. Defense attorney Chestnut, who heads Alabama's largest black law firm, later cited the reference in a motion asking Johnson to recuse himself from the case: "There is a white man's mentality and a black man's mentality. The judge himself used that term first, not us." City Attorney Pitts observed: "I'm a little perplexed about what it means. If he means a white man's mentality will not allow people to go out in the streets to create anarchy, that's a pretty good definition."

A shadowy group called the Info-Education Committee has emerged on the white side of the controversy, with a leaflet asking, "Do White Children Have Any Rights As They Attend Public Schools?" It advised Selma's white students to "have no social contact with blacks," and warned: "WHITE GIRLS TAKE NOTE. If a black lays a hand on you, scream loud and clear. Don't be bashful. It could save your life."

## O'Connor Fights Back . . . Momentarily

John Cardinal O'Connor, who has spent much of his tenure in New York bowing or scraping to Jews and making idiotic remarks about exorcism, finally had the gumption to open his mouth and stick up for his own faith and people. The occasion was the illegal occupation by 150 Jews of a 72-room Greek Orthodox hospice in the Christian quarter of Jerusalem. O'Connor called the takeover, which was secretly financed by the Shamir government, "obscene," "shocking" and a "provocation."

Jews, never asleep at the verbal switch, quickly responded. The Cardinal's words were "intemperate and inappropriate," said one rabbinical flack. Rabbi Fabian Schonfeld slyly hinted that the Cardinal was getting anti-Semitic (that will be the day!) and murmured something about the *Protocols of the Elders of Zion*. No Jewish leader went so far as to accuse O'Connor of firing up a new Holocaust. Queens Borough President Claire Schulman raised the old "insensitivity" bugaboo and warned O'Connor against indulging in "buzz words." In a long personal letter to the prelate, Jerusalem Mayor Teddy Kollek wrote he was "deeply offended."

Ironically, the American Jewish Congress went ahead and gave O'Connor the committee's Isaiah Interracial award. The event had been planned for months.

The cardinal told his assembled hosts that he "would die for them but would not lie for them."



## David Duke, "First Domino"

"Pollsters Agog" read a headline in the Washington Times last April about the fortunes of David Duke. They were still agog as May gave way to June. Duke told a USA Today reporter, "Some people with Time magazine told me they thought this would be the most covered Senate race in history."

Bennett Johnston has been in the U.S. Senate for 18 years and his "name recognition" statewide is only 88%. David Duke has been in the state legislature for barely one year and 98% of the people know his name. Some Republicans have been trying to convince the official GOP candidate, Ben Bagert, to drop out of the race so Democrat Johnston will have a better chance of knocking off Duke in round one on October 6.

Mississippi, a state which hugs Louisiana closely, is feeling fresh political breezes from the Duke campaign. Rob Waters, a columnist for the University of Mississippi Daily Mississippian, says he started to take Duke seriously after two friends visited a New Orleans bar during Spring Break:

One of the patrons, slightly ripped and thus a little impetuous, stuck David Duke stickers on their lapels without asking what they thought of Duke. The guy figured he was doing them a favor.

My friend thought it was kind of funny. Then one of them got the inspired idea of wearing the stickers around the French Quarter as a sociological experiment, just to see what people thought of Duke.

Dozens of people, I mean literally dozens, stopped them to say they were also behind Duke. Young people. Lower class. Middle class.

Some people said, thank God a man has the guts to stand up for white people. Other people said Duke is the only politician who isn't afraid to tell the truth. A few said he was a hero . . . . People seemed to admire my friends for having the courage to wear the stickers.

Only one person called my friends bigots . . . .

The "results were scary," wrote Waters, who probably saw his future as a liberal journalist in jeopardy.

David Duke may be the "First Domino" of the Great American Instauration. As this magazine reported in May, the chief sponsor of the (successful) bill to restore the King holiday in Arizona warned that if the state's voters ever had a say in the matter, it would be rejected and then the holiday would "go [down] like dominoes" in the other states. Now that liberty has swept across parts of Europe, American lib-mins suddenly have visions of "dominoes" dancing darkly in their brains. One of David Duke's fellow state legislators, Bo Ackal of New Iberia, is among them. Last March, Ackal told the media,

Duke's being in the race is just polarizing everything along racial lines. It's bad. It's-bad for the state, for all of us. And if he should be elected, other states are going to topple like dominoes. You'll have real racial problems and polarization, all across this country. That's the last thing we need.

The polarization is already there. As Duke keeps telling his wildly enthusiastic crowds, "Blacks have voted in a bloc ever since they could vote. But if whites do it, it's polarizing."

Black state representative Alphonse Jackson of Shreveport says he is "astonished" at the broad range of people who freely approach him to say they dig Duke: lots of young whites, and even some blacks.

Recent polls show Duke doing better than Johnston in northern Louisiana, running even in "Acadiana" (the Cajun southwestern and south-central part of the state), but doing poorly in the south-east, which is greater New Orleans, where the state's blacks and liberals are concentrated. Win or lose, Duke's sure to "raise the consciousness" of millions around the country.

Meanwhile, Duke's opponents are delving deeply into their barrel of dirty tricks:

- A group of black ministers, in announcing their support for Senator Johnston, said that Duke believed Roman Catholics were not entitled to any constitutional rights. Johnston, without swallowing hard, thanked the clergymen for their backing. The ministers' words breathed new life into the old expression, "lying nigger preacher."

- Snitchmaster Thomas Martinez, a convicted felon and ex-counterfeiter, and his two bodyguards have been touring Louisiana with the message "white supremacy is nothing but a cult." Ten years ago, Tom would have been pounding the pavements for Duke. But he found out that stool-pigeoning pays much better.

- Columnist Dick Williams of the Atlanta Journal-Constitution attacked WAGA-TV for letting Duke speak freely about his campaign on a special local program about race. Williams, knowing that few white Atlantans understand the grim realities of life in New York and Chicago (if they did, they would probably try secession again), wrote deceptively, "A Yankee tuning in would have looked for knuckles dragging on the studio floor." Forgoing any attempt to answer Duke's arguments, Williams called him and some supporters in the studio audience "the swamp things."

- Jason Berry, a freelance writer in New Orleans, has gone around the South asserting that Duke's NAAWP News "for years has espoused the Nazi theory of a master race" -- when, in fact, each issue since its inception has devoted a page to showing how the group's platform is more moderate than the NAACP's.

FLASH! Duke scored a brilliant legislative success on May 30 with the passage by the Louisiana House of his bill to outlaw state affirmative action. The Duke bill, which passed 66-26, bans any preferential treatment on the basis of race, religion or sex in business or higher education. The Louisiana Senate is expected to defeat it. If not, Governor Buddy Roemer promises to veto it. Lawyer groups say it is unconstitutional. Whatever happens, Duke has shown himself to be an accomplished legislator.

Sending a clear message of disapproval to the Supreme Court, Duke also helped push a bill through the Louisiana House that would subject anyone attacking a flag-burner to a maximum \$25 fine.

About all the despairing Louisiana media could do was shout "Nazi." Replied Duke, "We've got a civil rights movement of our own going." As for Johnston, "He plays too much tennis with Teddy Kennedy."

## ACLU Gets Its Comeuppance

Back in 1980 the ACLU, which practically has a patent on civil rights, was sued by Newport Beach (CA) police officer Richard T. Long, who claimed *his* civil rights had been violated when he was threatened, slapped around and ordered to leave a public meeting organized by the American Civil Liberties Union and chaired by local ACLU honcho Rees Lloyd. A jury awarded Long \$35,000 from the ACLU, which was promptly paid, and \$46,000 from attorney Lloyd, who appealed. Last April, when the California Supreme Court refused to review the case, Lloyd was also forced to pay up.

### Welcome Snags in the War Crimes Trials

'Twas a stunning defeat for the hounds of the Holocaust. Imre Finta, a onetime captain in the Royal Hungarian Gendarmerie, was found not guilty on all eight counts of war crimes and crimes against humanity by a jury of eight women and four men in Canada's first war crimes trial. Having lost his home in a civil suit, Finta, ailing, broke and 78, had been accused of rounding up 8,617 Jews in Szeged, Hungary, back in 1944, stripping them of their valuables and herding them into boxcars, where some died in transit to Nazi camps.

The prosecution, under the direction of Asian attorney Christopher Amerasinghe, produced 43 witnesses, one of them a "professional," who over the years has testified at more than 50 trials in Europe and the United States. Videotapes and other evidence in Finta's trial were gathered during a horrendously expensive jaunt to Hungary by both the prosecution and defense teams. Two Jewish witnesses were flown in from Australia.

The outcome of the trial was not only a blow to Jewish revanchists in Canada; it was a triumph for attorney Douglas Christie, the indefatigable crusader for free speech, which has been having hard going in Canada in recent years. Christie is also the lawyer for Ernst Zündel, currently out on bail as he awaits a decision on his petition for permission to appeal his nine-month prison sentence to Canada's Supreme Court.

Christie astounded everyone at the Finta trial by refusing to present evidence and witnesses for his client. Having ably cross-examined prosecution witnesses, when it came time to present Finta's side of the case, Christie announced that the defense would rest. In his closing address to the jury, he questioned again and again both the legality and the morality of arresting and charging old men for crimes supposedly committed more than 45 years ago in countries thousands of miles from Canada. In addition to pointing out the confused and often contradictory testimony of the witnesses, he drummed home the theme that the ex post facto (retroactive) laws cooked up to deal with war crimes amounted to a travesty of justice and a perversion of Anglo-Saxon jurisprudence.

As expected, Canadian Jews were horrified at the verdict and demanded that the case be appealed. When Nazi hunter Simon Wiesenthal heard the news, he was "almost speechless," according to a reporter. As for the two other war crimes trials already scheduled in Canada and the 17 others on which state attorneys and investigators are working, their fate is uncertain.

Holocaustism suffered a similar setback in Britain when the House of Lords in a rare show of spunk rejected by 207 to 74 a House of Commons bill which gave a green light to war crimes prosecution. The Lords temporarily dashed the hopes of Jews, who were all geared up to get their pound of flesh from British citizens from Eastern Europe, who may or may not have offered a helping hand to Nazis almost half a century ago. The bill, unfortunately, can be revived in the House of Commons in the next parliamentary session. Until the Lords' action, British legal beagles were preparing to move ahead on three cases, while continuing investigations of 75 other suspects. It is interesting to note that the defenders of Anglo-Saxon law and the opponents of changing the rules of evidence (written into the House of Commons bill) were members of the British upper class, while the lowly M.P.s in the House of Commons were quite willing to trash Britain's long established Bill of Rights to appease Jewish racism.

The witch-hunting safari has also run out of gas, at least for the time being, in Australia. Everything Down Under was set for an in-

quisitional orgy of anti-Nazism. The necessary legislation had been passed by the Australian parliament, and the first victim had been selected. He is Ivan Polyukhovich, 73, a Pole charged with the murder of 24 Jewish men, women and children and with involvement in some way or other in the murder of 850 additional Jews. Polyukhovich, a pensioner who gardens and tends bees in his declining years, has challenged the constitutionality of the legislation, and the Australian High Court will rule on the matter in September. Meanwhile, investigations of suspected Nazis and Nazi sympathizers, both in Australia and Eastern Europe, are being conducted at huge expense to the taxpayers (\$4.2 million spent so far on persecuting Polyukhovich), even though there is a possibility the High Court will throw out the case before it comes to trial.

If it does, Mark Weinberg, Australia's Director of Public Prosecutions, will be sorely disappointed.

Someday, if there is a drop of decency, fairness and courage left in Western politicians and mediocrats, Jewish sniping at Western institutions, especially Western laws, will be brought to a grinding halt. Some day the tables might even be turned and Jews might find themselves in the dock instead of serving as judges, prosecutors and witnesses. Israelis are committing war crimes on a daily basis against the Palestinians — crimes committed not a half-century ago, but here and now on TV in front of millions of eyes.

Israelis can be found in considerable numbers in every Western country, some 400,000 are supposed to be in the United States. Surely this crowd contains at least a few Jews who have committed far more authentic and far more heinous war crimes than septuagenarian or octogenarian Poles, Ukrainians or Balts.

In some ways, war crimes legislation as enacted or proposed in the West is more criminal than the supposed war criminals themselves. When will the targets of Jewish vengeance or their descendants take aim against their oppressors? When will the hunted turn against the hunters?

By attacking the very essence of Western jurisprudence the Jews may eventually succeed in doing away with the very laws that over the years have protected them in their incredible, almost miraculous, ascent to the peaks of financial and political power.

### Holy Survivor

If there ever was a holier-than-thou congressman, he is Tom Lantos, a Holocaust survivor who made it big in California. Lantos manages to get his face on the tube with the regularity supinely accorded to Jewish pols and mediators. As the leader of the congressional investigation of HUD scandals, he has been getting free office space for his privately financed Congressional Human Rights Foundation. Nothing terribly out of the ordinary about that. Congressmen are loaded with freebies from the moment they set foot on the Capitol steps. But in this case the office space was provided by Hill & Knowlton, the public relations firm flacking for Thomas T. Demery, a former federal housing commissioner and one of the HUD people suspected of serious wrongdoing. On May 8, Lantos ruled that his House subcommittee would not question Demery in regard to damaging statements about him in an inspector general's report.

### Nailing Hedda

*What Lisa Knew*, by Joyce Johnson, claims that Hedda Nussbaum was just as responsible for the death of the illegally adopted six-year-old non-Jewish girl as was Joel Steinberg. If she was so opposed to Steinberg's cruelty to her and Lisa, why did she shack up with him for 14 years? "[B]ecause collectors of child pornography never destroy their valuable collections," author Johnson suggests that someday videos will come to light showing Steinberg and Nussbaum beating and buffeting their living sex toy.
