As you say, the dry, warm weather seems to conspire toward the elimination of jobs, in addition to the Indians & the Chinese. Some Washington State forecasters expect a drought this summer, which will adversely affect navigation, irrigation, fishing & hydroelectric power. We would likely experience a bad fire season as well. Before "p.c." jargon, we used to have brushfires, housefires & forest fires, all of which were deemed bad.
