

16 MAR 05. Dear Michael: It was good to receive your letter of MAR 7th & 10th, along with the exhibits. I did not receive the article by Rufus Woods re The Cult of Victimhood, which you said you had included. After making photocopies of your exhibits, I shall return them under separate cover. Thule Publications is no longer in business and their P.O. Box is closed, according to the Post Office. Taylor reveals himself to be a 'paytriot-for-profit'.
