

17 MAY 05. Dear Michael: Many thanks for your letter of April 26th. Please pardon the delay in my reply, for I was out of town from 22 April to 11 May, & I am only now digging into my pile of correspondence. I read a local jewspaper about the "lock-down" at your palacial residence, which is now back to 'normal', I hope. As you say, what sparked the matter is a mystery. FEDZOGUSA is 'poisecuting' JEWSEEEK magazine for alleging that The Koran was being desecrated in Guantanamo as an interrogation ploy against the prisoners. The report was apparently written by a jew, & it sparked deadly rioting in Afghanistan, as well as anti-U.S. demonstrations in other Moslem countries. Word sure travels fast!
