

6 Jewlie 05. Dear Brian: I think we can easily & properly correct the invalid, 19th century pseudo-classification of "race" into geographical areas, such as "Nordic" & "Mediterranean". "Nordic" would have to include Eskimos, Lapps & Finns who are members of the Yellow Race in whole or in part (as are the Finns). A "Mediterranean" would be any person living near the seacoast of the Mediterranean, whose peoples were varied, even when I visited the area in the 1960s. The chief problem with geographical "racial" nomenclature is that people can & do move around, as we see in present-day Europe. They also race-mix, in the case of many. To add to this nonsense about "race", we have such terms as "English", &c. in which the nationality is confused with the territory of the former nationstate. Now, the term, "English", is coming to mean anyone who comes from England, regardless of their biology. Race is biology, that is, genetics. It is not geography, culture or tradition. A Black is still a Black, where ever he is born, wherever he has lived, whatever mode of dress he wears, whatever language he speaks, whatever religion or not he believes, &c. The same applies to Whites & Yellows. A Yellow may be of Chin or Han descent, but he is still a member of the Yellow Race, for they are sub-races or nations of the Yellow Race. Sub-races or nations need not get along for them to be members of the same race, just as brothers of the same parents often quarrel & fight. I see all sorts of emotional attempts to dodge the issue, that race is a state of biology & not a state of mind, which is subject to emotions. It is irrelevant for those who may be mongrels of Black/White/Yellow admixtures to accuse others of being mongrels as well. My impression of the North American population is that most of its denizens are mongrels, chiefly anglo, franco & hispanic mestizos (Eurasians in pseudo-scientific nomenclature). The Rousseauvian rascal, Jefferson, wanted to create a "new" American "race" of mestizos who would not be loyal to England nor to their asiatic nations & tribes. The Jesuits wished to achieve the same adulteration of peoples in Latin America. Our misfortune is that they largely succeeded. There is, in addition, a large Black admixture in the coastal regions of Latin America, along with the addition of Voodoo to Christianity, variously known as Condumblé or Santeria. Race, therefore, is the biological basis for culture, so a mixture of races creates the same confusions in terms of culture, within the indigenous population. The Arab conquest of the Iberian Peninsula imbued its peoples with many Arab characteristics, including genotypes & culture. In Spain, they still say, "Ojalá", which is a corruption of "Insha Allah" ("If Allah wills it.") or ("Would that Allah..."). This is not to say that the population is thoroughly mixed with Arab genes, for it obviously is not (yet), but it shows the biological irrelevance of referring to all denizens of the Iberian Peninsula as "Spaniards". The Basques & Catalans, as well as the Portuguese do not agree on that!

As I & those in current biological science say, race is not place. It is biology, expressed in DNA. Were I ever to have children, I would have my DNA tested for racial content, for the racial designation of "White" on my birth certificate may not have been accurate in terms of present knowledge.

Intelligence or lack thereof, dodges the racial issue. I.Q. testing done in the U.S.A. does show an average of 15 I.Q. points difference between Whites of all social strata & Blacks of

upper, middle & lower classes. Similar studies were done by Eysenck & Jensen in the Caribbean islands, with the same results: around 15 I.Q. points in favor of Whites. Tests were administered to Blacks by Blacks, to Whites by Whites & to mulattos (Black/White mongrels) by mulatto testers. As suspected, the mulattos tested higher than the Blacks, but their problem-solving scores were lower than Blacks or Whites. They appeared to be confused about what should be done to solve a theoretical problem, such as the one I remember: You are in a basement where the water is running into a sink which is overflowing onto the floor. The sink is plugged with a stopper. The drainhole in the basement floor is covered by a lid. There is a mop & bucket by the sink. Question: What do you do first? Answer: Turn off the water! The mongrels exhibit the same behavior as we were warned about in The Bhagavad Gita: "From the corruption of women proceeds the confusion of races; from the confusion of races, the loss of memory; from the loss of memory, the loss of understanding, & from this, all evil." Studies done in Weimar Germany, long before Hitler, correlated racial adulteration with schizophrenia. Jews, who are mongrels, were disproportionately represented amongst the schizophrenics in German asylums. The film, "Erbkrank" (Hereditary Illness) refers. It has been argued that I.Q. tests are culturally biased to favor potential contributions one can make to a Yellow or White society. That is correct, from what I have seen of Black societies in Africa & the Western Hemisphere, for the type of intelligence valued by I.Q. tests is not so valued in Black societies as much as agility & strength. With such social values, a Black I.Q. test would not be required! To the extent that Whites adopt Black social values, they also show signs of "dumbing down". As I said, a racial policy must include a eugenic program, so as to improve (make more viable) the race in question. Naturally, such concepts of a racial nation & racial improvement therein are radical & unpopular for those who suspect they are really mongrels, based on their emotional reactions. If they wish to bash "Nordics", so be it, but they are addressing illusions, not racial reality. Meanwhile their former countries are being invaded, occupied & taken over by peoples who are not English, not French, not Irish, not German, not Portuguese, not Italians, not Greek, &c., but THEY WILL BE, if they are allowed to stay & breed. As a denizen of the Americas, I have seen what denizens of Europe are only beginning to see on the demographic or biopolitical front. That is why I proclaim that Our Race Is Our Nation! for the countries of Europe are no longer "nations", any more than the U.S.A. or Canada is a "nation". One local Brazilian acquaintance assured me that we will remain "Europeans" as long as we use forks, rather than chop-sticks or bare hands. That illustrates how some people can put symbols ahead of substance. Non-White allies, like the "Black Nazi", have an important role to play in AZA, The Anti-Zionist Alliance, but we must understand that being pro-White does not equate with being White, just as anti-White Whites, who are nevertheless White, at least of one generation, remain members & traitors of our race. As time quickly passes, I note how "White" the Afghans & Turks begin to appear, as the American population rapidly browns out. We need to understand that we are undergoing the beginnings of major demographic & economic changes, wherever we live, on a scale much greater than our former Völkerwanderungen of The Ice Age, et al.
