

20 "Jewlie" 05. Dear Tom: Your letter of 7-7-05 was timely & topical, for there are many lessons to be derived from the recent London bombings, if we wish to learn, on behalf of our own survival & our freedom. Your description of the London Underground was vivid, with its evocation of the Victorian era, in which the Underground was built, principally by Irish labor which were treated worse than slaves, since they belonged to no owner & worked cheaper than slaves, who had to be housed & fed. When an Irish laborer dropped dead or was killed by terrible working conditions, he was simply replaced by another Irishman. This occurred in the U.S.A., as well, in the mid-19th century. Black slaves were deemed valuable, since they were possessions who had to be purchased, whereas Irish came for free, & would do hard work more cheaply than Black slaves.

Your mention of the role of subways in The Protocols of Zion, as a means of mining Goy cities, is indeed timely, for such destruction is indeed possible, especially with modern explosives. The kosher connection is also likely, for former Mossadnik, Victor Ostrovsky, wrote in "By Way of Deception" that the Mossad targets Moslems for recruitment. If the jews were warned away from the bombing sites before the blasts, as alleged on the Internet, a Mossad connection is likely, rather than a mere possibility. The jewsmedia made a big thing, however, by announcing the death of a woman named Levy in the bombing. Were more jews killed? The jewsmedia are silent. As we should ask in all "terrorist" incidents, "Cui bono?" It was interesting how a Brit think-tank, Chatham House, linked the London bombings with British presence in Iraq, just as a connection was made between Spain's military presence in Iraq & the Madrid bombings, which resulted in a Spanish withdrawal, after a change of government. Iraq involvement is generally unpopular in so-called democratic countries, so the bombers are playing to the gallery. It has been demonstrated as a valid rule of politics that imperial wars are won in the imperialists' countries, rather than in the imperialists' target countries. This strategy was promoted by "Karl Marx", as I understand, who said that the British Empire could be destroyed from Ireland, which was then under British rule. It has been alleged that the French were made to pull out of Algeria, as well as Indochina by the effects of those colonial wars on the people of France, as purveyed by their newsmedia. There is even less doubt about the effect of the Tet Offensive in Vietnam upon the U.S. public. Despite U.S. military assurances that the North Vietnamese casualties 'proved' they had lost the Tet Offensive, U.S. people saw the powerful photos of U.S. soldiers in combat, & most apparently concluded that the U.S. had lost, despite all the troops dispatched & the years of costly combat. The U.S. pullout from Vietnam occurred in due course & the Vietnam War had been won in the U.S.A., by the North Vietnamese, who weren't even here! Hence, the London bombings may help Brits who dislike their role in Iraq to move as the Spaniards did: kick the pro-war PM, Blair, out & pull the troops out of Iraq's no-win war. But that's only one issue in the current mess!

The real issues are Freedom Through Separation versus Security Through Surveillance, & these issues are apparent worldwide. Britain has practiced both, so we are not addressing a purely theoretical matter. Britain was noted for centuries as a major proponent of separation. Religious fanatics were sent to America & petty criminals to Australia. The results were excellent for the majority of Britons: no civil/religious wars & so little crime that police were unarmed. Personal freedom was increased, for the majority were able to live free of religious tyranny & crime. But, after World War II, the British Empire invaded Britain in the form of non-White immigrants, many of whom were brought in by greedy capitalist pigs to work as 'cheap labor'. The Pakistanies, for example, monopolized jobs in the textile mills & Blacks became fodder for slumlords, who profited from the Blacks' welfare money, as in all countries which pay those in need to breed at public expense. Slumlords & sweatshop owners want lots of impoverished immigrants, whose living costs are paid by the tax-payers. I live in Northern Mexico alias Washington State, so I am well aware of this 'business' in favor of fatcat felons. I have seen the same in Canada & in White-ruled Africa: personal profit at public expense, with demographic disaster as the chief by-product.

All societies practice separation to one degree or another. Criminals are usually separated from non-criminals, if they are caught, & the exercise of freedom of association usually results in racial separation, as we see in the case of White Flight in the U.S.A. Back on the London Underground, train passengers have been terrorized by gangs of Black thugs who often go "steaming" in the Underground, which means mugging train passengers in the cars. More Whites have been killed or injured by Blacks than those who were killed or injured by the Moslem bombers. Yes, the Blacks took longer to achieve the same results, but they did not

use explosives. Besides, their predatory violence was deemed 'fun' & not revenge! As long as there is no separation, every violent minority can hold the majority to ransom with such terror tactics.

This brings up the role of everybody's minority: our governments. When government becomes alien & criminal it often uses the threat of terror by which to inflict tyranny upon the majority. In jew-ruled Russia, The Terror was inflicted by the state itself, with the addition of the alleged Capitalist Threat, so Soviet sheeple were terrorized by domestic & foreign bogeymen. These "Cold War" bogeymen also served to bolster the U.S. military-industrial complex, much as Orwell described in "1984". Although Communists were largely in control of the U.S.A.'s government, much was made of The Communist Menace by way of terrorizing the dumb Goy sheeple, who were herded into illegal "brushfire wars" for the profit & empowerment of U.S. rulers. Thus it is that acts of terrorism ostensibly committed by minorities can serve the predatory interests of our government minority, who wish to squeeze our pockets & our personal freedoms by shouting "Terrorists!" It's a very old trick, but it usually works, if we can learn from history. As we have seen recently, acts of "terrorism" can also herd the sheeple into wars, on behalf of our own tyrants, in the name of "fighting terrorism & tyranny!" The U.S. idea of "democracy" is similar to the Roman idea of "peace:" both are synonymous with graveyards. Instead of Freedom Through Separation, our Zionist Occupation Governments want "Security Through Surveillance". In this case, "security" is synonymous with "tyranny", for it is fraught with snooping & restrictions. "1984" described such a 'surveillance society' as we already have, for the London authorities had the bombers' I.D. & were able to follow their movements on videotapes, as they could with every person in London. The only thing lacking was bag & body-searches, which technology is able to perform at airports, where passengers are searched by devices which scan our bodies through our clothing. Had these devices been deployed in Britain's public transportation system, the bombers would have been identified as soon as they entered the first train station.

So far, surveillance societies ruled by terrorist regimes, like those of Red Russia & the DDR (East Germany) have failed in large part because of the expense of the surveillance & terror apparatus. The cost of running the East German STASI or State Security was exorbitant for such a poor, Soviet Bloc country, just as the gulag empire of the USSR did not pay for itself, even with its deadly, ruthless exploitation of the Goy victims. Paying ½ to guard the other ½ is hardly a paying proposition, as the U.S. is about to discover in its own gulag system. But can modern technology put such a tyranny on a paying basis? Apparently, our rulers think so, or they may not care! In Soviet Canuckistan alias Canada alias China-duh, there are entire buildings allocated for telephone surveillance, with banks of recorders whirring 24-7. Computers save lots of labor in this job, for they can be programmed to signal a real person at the sound of key words, such as "race" or "bomb". If you want to see the alarms go off, just say, "Yeah, my horse really bombed at the race." Now the computers are watching the Internet, so the sheer volume of information may overload the surveillance systems, which require trustworthy analysts to process such data. It is much cheaper to govern free people than it is to imprison everyone, even in minimal quarters, & watch them 24-7. I understand that a U.S. super-max prison cell is more expensive to maintain than a suite of rooms in a first class hotel. For centuries, the Japanese had no prisons. They just killed an offender a.s.a.p., preferably on the spot & in public, with a slash of a samurai sword. Hence, there were no buildings to maintain, nor prisoners to guard & feed, for in crowded Japan, every square inch of land was precious & every grain of rice, likewise. It was insane to PAY anything for incarcerating a criminal, for he was easily & cheaply replaced & rehabilitation was both questionable & costly. The Japanese version of separation was the separation of one's head from his body, so neither deportation nor incarceration were required to separate criminals from society. There is wisdom in that policy, but our ZOG wants slaves who will do the ZOG's bidding, so it will continue to snoop, to terrorize & to incarcerate its subjects: US! The pattern is perfectly clear: the ZOG protects criminals of every stripe, including illegal aliens, while it subjects law-abiding citizens to increased surveillance & restrictions. A point may occur in which slaves are forced to become crooks in order to survive, that is, law-breakers. When legals become illegal, will the ZOG exercise tolerance for them as it now does with illegal aliens & other crooks? Stay tuned!

Ah yes, China looms ever larger in terms of its influence, as well as its population. I just heard that there are reports of peasant protests & riots against industrial pollution of their fields & crops. Will China collapse with the weight of its population & its rampant corruption? I think that is too much to hope for, just as many had hoped that Nazi Germany &

Red Russia would destroy one another without involving anyone else. This failed to take into account the vicious interests of the international jewish banksters, who had paid for their world war with profits bilked from the First World War. One thing leads to another, as they say. When faced with domestic turmoil, what do criminal regimes do? They usually go to war, as the U.S.A. did to escape from the Bankster Depression. China could do the same, especially since the U.S. ZOG seems focussed on Taiwan, rather than North America, which is being bought & invaded by the Chinese. Today, I heard that Chevron has bought Unocal, thus depriving the Chinese of a coveted oil asset. We shall see how China obtains the oil it needs, by other means, as Clausewitz stated. A jew commentator said that U.S. companies want to transfer their factories to China for quick profits, at the expense of U.S. workers, but China's purchase of Maytag would probably mean that the factory would remain in the U.S.A., BECAUSE China wants the brand recognition & the Maytag reputation for its markets overseas. Such a deal! China has muchos zogbucks, so it can easily afford such a loss-leader. I can remember when goods from Japan were deemed cheap & inferior. Within a decade, that reputation changed to one of high-quality & fair prices. Pretty scary, eh kids? As you say, it is not the fault of the Chinese for wanting oil, as the result of their hyper-industrialization. It is really the fault of our own greedy capitalist pigs who must bear the blame for any unintended consequences of their piggish stupidity, although we must bear the burdens of their treason.

Yes, our masters are really only masters of SYMBOLIC WEALTH, not real wealth. The masters of real wealth are those who work the land & the factories thereon, so the land really belongs to those who occupy it, not those who have paper titles to it. As the banksters debase the value of their symbolic wealth, such as zogbucks alias Federal Reserve Notes, their powers become threatened, so they must begin to tread with care in the issuance of their commands, in furtherance of their scams. Their power is revealed in The Protocols of Zion: "Force & Make-Believe." As these banksters lose their force, will they continue to exercise their power with make-believe? How long will the U.S. military might deter China's numbers, when Israel makes our most advanced military technology available to the Chinese?
