

31 AUG 05. Dear Günter: It was great to receive your letter of 23 AUG & THE outstanding enclosures. Many thanks for the information on the jew Booth family. I wondered about the founders of the so-called Salvation Army, who use a goat as their mascot in their publications' editorial columns, as I recall. I wondered what connection a goat would have with a supposedly Christian organization, if that is what it purports to be. Although I've known Salvation Army missionaries, they never mentioned Jesus even once.

Another crypto jew named Wilkes ran London's Hellfire Club, which was frequented by the Freemason, Benjamin Franklin, who was also a philanderer. Apparently, the club made booze & broads available to its members, but not necessarily in that order, along with other unmentioned items (drugs & drag queens?).

Lincoln's assassin, John Wilkes Booth, was not only a jewish actor, along with his brother, but he was apparently a Rothschild agent who was assigned to kill a president who had printed his own legal, constitutional money, instead of borrowing from the jew banksters. It has also been alleged that Lincoln intended to send the Blacks back to Africa, specifically, to Liberia, which had been established for that purpose. Jews did not like that idea, either. This denial of DNA testing also applies to the Lindbergh heirs who refuse to allow the alleged Lindbergh baby's body to be so examined, thus casting considerable doubt that the Lindbergh baby was killed, rather than held hostage. I corresponded years ago with a San Francisco attorney whose Irish name I forget. He was taking two Lindbergh-related cases at once: Bruno Hauptmann's widow & the case of a man who claimed to be the Lindbergh baby. Suddenly, our correspondence ceased, & I learned nothing about these important cases. I believe this occurred in the early 1980s. I only learned from the jewsmedia that Bruno Hauptmann's widow had subsequently died, & nothing about the alleged Lindbergh baby. Were he the real Lindbergh baby, this would show that Hauptmann had been innocent all along, plus the now grown up baby could reveal who'd raised him, & perhaps revealing more jewish involvement than was apparent in the courtroom at Hauptmann's trial.

On the biowarfare front, which includes non-White immigrants as well as exotic diseases, we can certainly look forward to deadly diseases which are new to us, as well as the revival of old ones, such as TB & hepatitis, dengue fever, malaria & a 'diversity' of venereal diseases resistant to treatment & cure, as well as many more. No doubt, Fort Detrick, Maryland, plays an important role in developing disease mutations which are deadly to humans, as they have previously been to animals, including birds. Dr. Douglass of the USA reported that the HIV or AIDS virus appears the same under an electron microscope as the ovine visna virus, which has long been fatal to sheep. In the book, "Deadly Allies", it is reported that the USA & Britain were trying to mutate deadly animal viruses so as to become deadly to humans. Dr. Cantwell, also of the USA, with whom I corresponded, also maintains, with facts, names & dates, that the AIDS virus is man-made & was purposely inoculated into Africa via a World Health Organization smallpox vaccination program. In North America, the AIDS virus was also inoculated into the active homosexual population as an 'experimental' vaccine against hepatitis C. Had AIDS been endemic to Africa, the current die-off of Blacks would have taken place centuries ago, but it appears to have occurred around the time of the WHO smallpox vaccination campaign cited by Dr. Cantwell. Oh, there was another proponent that AIDS was man-made, a Dr. Strecker, who was murdered. On the other hand, crowded places with poor sanitation, like Asia, are centers of disease proliferation.
