Hail D.R.: Jewsradio mentioned that it is the AJWS which is promoting interest in Africa, as well as the importation of Black 'refugees' from Africa, who are dispersed throughout the USA, as were Somalis in Maine. There is a time & place for such activities, but in these times, I can't think of many such places, especially in cities. In any case, I have no zogbucks to spare, one way or the other, but I'd need to know more about such a candidate. The official political process is designed to exclude honest White candidates, whom a single ZOG judge can disqualify, if by a miracle, he is elected. I don't think I am unduly pessimistic, but realistic. Still, if one has the time, money & determination to run as a pro-White candidate, I'd wish him the best of luck.

If words fail to teach & to motivate, then dire events will have to do the job. Further to the Lindbergh Case, a DNA test would reveal the true identity of the badly-decomposed body purported to be the Lindbergh baby.
