

23 OCT 05. Dear Paul: I appreciate the downloads you sent on OCT 19th re jew chicanery & Nazi popularity in post-Soviet Russia. Some suspect that the neo-nationalist Russian regime sympathizes with these mainly young "Nazis", despite Putin's fulsome endorsement of the Holocaust. The formerly Forbidden Fruit of National Socialism may have the same sort of reactionary attraction as bawdy entertainment had for the post-Cromwell British. I suspect that the youth are attracted to NS symbols, parades & uniforms, rather than the substance of nationalism, culturalism & full employment in a thriving economy. I'd call that "Hell's Angels' Nazism"; not reality, but regalia. Russians have never enjoyed the presence of non-White foreigners, nor especially those who receive privileges from the Russian government which are denied to ordinary Russians. I think that Russia must first rebuild itself as a nation, before it wastes its time & resources in a vain attempt to rebuild its former empire. History teaches us that empire-building is the surest way to destroy the nation or nations which try it. As a rather casual observer of Russian affairs, I perceive only that which appears salient in matters of policy: Communist corruption inherited from the former Khazar regime, which is still practiced by the Khazars who remain in Russia, & how they appear to have infected Russians with the nation-destroying disease. Added to this brake on Russian national recovery are the vestiges, large or small, of internationalist imperialism, the Bolshevik extension of Tsarist imperialism. It would seem that Russian National Socialism has many such obstacles on its way to realization, so I wish the real Russians good luck!

Thanks for the download on some jews in the news, in regard to that old jewish tradition, tax-evasion! How odd or 'miraculous' that a change in the Australian sales tax structure would net an entire Khazar fashion family. It reminds me of the tax-dodging Gringo companies in pre-Castro Cuba, which had to sell their properties to the socialist regime for their previously-declared value for tax purposes!
