

19 NOV 05. Dear Günter! Many thanks for your letter of NOV 10th & the great enclosures! I enjoy IMPACT, & it would be much appreciated if I could receive it again. As always, I send out IMPACT promotions to my correspondents, with their address, which I photocopy.

I was indeed taken aback by the nasty, petty personality feuds in 'revisionist' ranks. I wonder if they agree on anything. Do they view one another as competitors for shekels & recognition? If they do deny the Holohoax, then why can't they co-operate in sharing their research, & make it available to the world? I was also wondering why "Ingrid Rimland," as she is currently called, interested in others' alleged sex lives. That's one more mark of the jew to her kosher account. In addition to my letter to Claude, I should have stated my criteria for jewishness at first sight: (1) Looks. (2) Behavior. (3) Attitudes. (4) Job. Does he or she work in trades monopolized by jews, such as self-promotion, rather than products; middleman businesses which merely buy cheap & sell dear; the jewsmedia, including journalism, movies, 'higher education', showbiz: the media of information, education & entertainment, where jews occupy strategic positions, if not outright ownership. Under our present Zionist Occupation Government, political positions invite suspicion that one is jewish, or married to a jew or jewess, or otherwise beholden to jews & their money. Since Claude appears to be ignorant in regard to jewish law, I failed to state that one's mother determines the nationality (jewish nationality) of her offspring. The dumb Goyim had long prattled that Vladimir Ilych Ulyanov alias Lenin was 'not' a jew, but his mother's name was Blank, which is jewish, not Russian. The fact that "Lenin's" father was not a jew, but a Mongolian or Tartar, does not nullify jew law which says he was jewish via his mother. In this regard, those who now claim that Josip Djugashvili alias Stalin was 'not' a jew should check his mother's background. I just heard on NPR jewsradio that a photo collector has his mother's picture in prominent display in his mansion, so there is a 'paper-trail' on "Stalin", also. "Stalin" was married to a jewess & was guided & instructed by his jew father-in-law Kaganovich, who outlived Stalin, & who initiated such policies as starving the Ukrainians in the 1930's forced famine. Jews can be as ruthless with their own kind as they are with Goyim, but when they purge some jews, as did the Stalin regime, they do not cease to be jews themselves. To use a sloppy analogy: Did the Americans who killed one another in the American Civil War cease to be "Americans", whatever that may now mean? Jews have also had their civil wars in Old Testament times, as they allege. (5) Name: If a Russian has a Russian name, that is as it should be, but the original jew bolsheviks adopted Russian names. If, however, a "Russian" has a Yiddish (Yid-Deutsch) name, he is no Russian!

Jews are also distinguished by their behavior of looking out for jewish interests, while Whites are usually distinguished by their failure to look out for White interests. In other words, Cain would be a typical jew & his victim, Abel, would be a typical White. That's why we must snap out of our evil jew-daze, or perish. It's a clear case of "to be or not to be."

I believe that jews have infiltrated revisionism, thanks largely to The Zud, who invited them in: Weber, Cole & quite likely "Rimland", et al. I collaborated with The Zud because I believed he was pro-White, but as I said to Claude, that was merely a phase on his part. The Zud's initial entry into revisionism was to "build a political movement" using the Holohoax as our starting position & the trials were aimed at gaining publicity so as to gain financial support & active members for the "movement." This is what Ernst told me, & his program seemed to be working. But after his second trial & the repeal of the law under which he was tried (the "false news" part of The Canadian Criminal Code), he drastically altered course. No longer did he want to "build a movement", but he alienated all his active supporters in favor of Erbschleichung" or geezer gold, which he also obtained, under false pretenses. It became obvious that The Zud was no longer interested in disproof of the Holohoax, but only in me-me-me, when he said to supporters: "I am the cause!" followed by gimme-gimme-gimme. I note from his propaganda that he emphasizes his personal 'victimhood', to the diminution of the slogan I coined: Truth, Freedom & Justice (for everyone). Now he appears to seek only Freedom for himself & for no one else, while Truth & Justice become irrelevant, & the truth or falsehood of the Holohoax appears to move to his proverbial 'backburner'. That is why I advise that we should await the results of his trial, before we make further statements that The Zud is a revisionist 'hero'. His track record shows his readiness to betray his previous positions, as he did with The White Power Movement, so it would be no surprise if he were to avow the Holohoax, rather than deny it, at his trial. All I can say is, "Beware of The Zud!" There are much worthier people to receive Zudniks' hard-earned shekels than The Zud (who can't receive them) & those who claim to be on HIS side, rather than on the side of Whites.
