

25 NOV 05. Dear Günter! After translating the outstanding Milch Document, I reread some of The Barnes Reviews, including Robert Logan's excellent article on the transition from Yeltsin to Putin. Suddenly, I was struck by the resemblance of today's situation in Russia, with its recent past under the Jew known as Lenin, who pretended to abandon Bolshevism in favor of his N.E.P. or New Economic Policy.
