

10 DEC 05. Dear Shappa: Thanks for your letter of DEC 6th & the Notice re Civil Rights dated NOV 4th, 2005. I wish you good luck in your legal quest for freedom of association!

I also enclose a photocopy of the DTO4 list of religious preferences & the Memorandum of Law Regarding Religion & Literature in D.O.C. It is a mean zoggie thing for them to steal the originals which I returned by 1st Class Mail to their source in your gulag. I hope they arrive this time, ZOG willing!

I am returning your original Notice Pertaining to Civil Rights with this letter, & I have made photocopies thereof, in case your copy is also stolen by your ZOG-gulagniks. If they believe that theft is 'kosher', then it would be great grounds for appealing the cases of all prisoners serving time for theft! Why is one in jail if the jailers are also thieves, in addition to politicians? When is theft not theft, in other words? Theft of legal documents is also obstruction of justice, which I think is deemed a felony. We are sure becoming more & more like Mexico, in terms of general corruption. As you may know, everybody in Mexico avoids the cops, since they are the #1 Bandits! I know corruption at firsthand, for I worked in Mexico, more years than I cared to.

Our current U.S. jurisdiction of ZOG's empire is heading for extremely tough times, so White kids are in extreme danger for themselves & for their eventual offspring, who may not be White! Truth is rarely popular, for those who hear it, don't want to know it, for the knowledge may urge them to act in terms of the truth. On the other hand, many who know the truth behave as if they did not know, & those who most know the truth are on the enemy side!

In your letter, you mention that Aryan Nations is not deemed a separate religious category, but lumped under "Christian", according to Washington's Attorney General. I know that may save the state some shekels, but it is nonsensical to assume that there are no differences amongst Christian sects. Only a space alien would do that, if he recently arrived on this planet. I shall enquire as to the A.G.'s identity & his possible educational background, or hers, as the case may be. I can imagine Presbyterians being mixed with Roman Catholics. Surely, the A.G. must have heard about the bloody Christian conflict in Europe called The 30 Years' War. That resulted when some Christians wanted to unmix themselves from others. I think that any requirement for a believer of one sect to attend the services of another sect violates The U.S. Constitution. It is unnecessary for there to be more than one believer in a ZOG-gulag in order for HIS religion to be respected, as in the example of a jew prisoner who demands kosher food & recognition of his religious holidays, as I understand. It seems unconstitutional to require one to attend alien religious services or none at all, as would apply in your case. In the U.S. Army I had O.D.ed on religion, so I became disgusted with all the officially ZOG-recognized cults. That's why my dogtag reads "No Preference". Obviously, this could be interpreted to mean that I'd gladly attend any or all religious services. I had originally requested that the army show me as "Atheist", but they said "Atheist" was not a category they recognized for issuing dogtags! I was thus officially 'drafted' into all current religions by the U.S. Army! My Rhodesian dogtags read "Aryan", for being White requires one to behave White. Therefore my race & my religion are Aryan. I wonder what the U.S. Army now says, but I won't enlist to find out. We know that it's hard to be Aryan in an Anti-Aryan society, like this one under ZOG, but that's one of life's worthy challenges.

I'll mention your interest in N.P.A., but I don't know when or if I'll hear from him, according to his last letter. He says he is being "Metzgerized", that is, bankrupted by a ZOG civil seizure of all his money & property, as well as forthcoming income. As far as I know, H.A.C. has a new & undisclosed location, "somewhere in The Great White Hopeland". I wish him all the best, & you too.

One of your zoggies sent me a recent notice of non-delivery of an item in German or French, because "foreign language materials" are forbidden to gulag inmates, even when I supplied the translation! The French text, as I recall, was "Merry Christmas" in French, under the magazine name, "Historia", which means "History" in French, Spanish & other languages commonly used. The ZOG publication I received about "Medicare" included many, many other languages, other than English, so your zoggies would have good reason to seize that! How do they KNOW that the English text is a translation of the other paragraphs? That would be a case of ZOG versus ZOG, so it might be fun to try.

This explains why I shall not say OUR RACE IS OUR NATION! in German, for it could give your zoggies an excuse to seize this letter. I close with ORION! That stands for Our Race Is Our Nation! It is an abbreviation in English like WSP or DOC, zoggies, so let's all try to get along. ORION!
