28 JAN 06. Hail John! It was great to receive your letter of 22 JAN. Hey, don't worry about arranging your ideas & questions in some kind of order. That's the advantage of the written word. If the reader doesn't follow the connections in your thoughts, he can always read them again. Nor does it matter how many different subjects you write about. They remain on the page where the reader can find them & consider them. There's only one writer I know of who successfully jumbled his statements. He was a nutty fruitcake, so I won't bother mentioning his name, & he bragged about his "writing style": He would take a page of his writing & cut it, say, down the center from top to bottom, so he'd have ½ of each page of his book, then he'd shuffle them & stick them together, so the poor reader would have ½ of page 1 combined with ½ of page 36, & so on. If anyone could follow his story after that, he'd have to figure out which page was spliced with which & UNDO the crazy author's work! Of course, the reader would have to be crazy to do that. I don't know if you've heard of The Beatnik Era of the 1950s, which led to the Hippie Era of the 1960s. There was such a thing Beatnik poetry, for which one fellow had the formula down pat: Cut up a dictionary & put all the words into a cement mixer. Run it for awhile so the words would be well-mixed,

put all the words into a cement mixer. Run it for awhile so the words would be well-mixed, then stop the machine & pull single words out without reading them. Stick each word on a piece of paper as you take it out of the machine, one word after the other. Once the page is full of stuck-on words, you now have a Beatnik poem! Then you could read it out loud for

people in coffee houses! No wonder the Beatniks aren't around any more.

Let me give you a general idea of the German SS. Their death's head insignia comes from a traditional German insignia assigned to a military unit, such as the Death's Head Hussars. A Hussar was an elite cavalry unit. Other countries also had their Hussars, all of whom were fancilly dressed. World War I German Mackensen was a Hussar, & he had a death's head fancilly dressed. World War I German insignia on his shako, a distinctive Hussar hat. The members of the SS adopted that honored insignia, as well as the two lightning bolts in the form of an SS. The original duty of the SS was the same as the U.S. president's S.S.: the Leader's bodyguards. In German, SS stood for Schutzstaffel or Protection Staff. In the USA, it stands for Secret Service, which, like the German SS, have duties in addition to the protection of The Leader or President. The original SS was called the Allgemeine SS or General SS, which was still the Schutzstaffel, but as the war went on, Himmler wanted his "asphalt soldiers", as they were nicknamed, to play a combat role, so he designated that branch of the SS as the Waffen SS. Waffen means weapon, but it would be more accurate to call them the Combat SS. This branch of the German armed forces received volunteers from many European countries, including Britain & even India! The Ukrainian & Croatian National Armies were also SS divisions, hence "SS" could no longer mean Schutzstaffel. This resulted in the retention of the twin lightning bolts & the death's head insignia, but the "SS" symbol no longer had its original meaning. That's why it was simply know as the Waffen SS. The Allgemeine SS ran concentration camps for civilian prisoners, war production workers, internees & transit persons, including refugees from war zones. Himmler was in charge of those camps, whereas the Wehrmacht, including the Luftwaffe, was in charge of P.O.W. camps for enemy soldiers. The Red Cross regularly inspected all the German-run camps during the war. Some SS-run camps were labor camps, others internment camps, others transit camps, & others mainly for criminals who were put to work. All workers, even if conscripted (drafted) were fed, clothed, housed & PAID for their work. If they say that they were "slaves" because their pay was low, then our military draftees were also "slaves", for their pay was much lower than civilian pay in the USA! The 666 internment camps run by the USA on U.S. territory during World War II served much the same purpose as the German camps. Some internees were like the Japanese, who were interned behind barbed wire for two reasons: (1) Because they weren't trusted & (2) For their own protection against enraged U.S. mobs seeking revenge for Japan's attack on Pearl Harbor. Jewish inmates were most often held in camps for the same reasons. Many of them were evacuated from war zones for their own protection, since they were noncombatants.

Despite Holohoax tales, it WAS NOT A CRIME TO BE A JEW IN THE THIRD REICH! Thousands of German jews fought in the Wehrmacht, & others were high-ranking members of the armed forces, as well as the Nazi Party. Few of them were disloyal to the Third Reich, but many Aryans be-

trayed their Folk, I am sorry to say.

The Holohoax is designed to achieve at least 2 things: (1) Conceal the amount of Nazi-Zionist co-operation before & during World War II & (2) To justify jews' "reparation payments" & jewish crimes committed after the war. The Holohoax is used to 'justify' the jews!

2) invasion & occupation of Palestine in 1948, as well as their genocide against the Arabs. That's a pretty tall order from a lie, but so far, the jews have gotten away with it, because of their domination of western countries, chiefly the USA, which they achieved by controlling our money supply & our media of information, education & entertainment, as they do even more

today. So let me answer your questions in their order of appearance:

The Holohoax-promoters purposely do not define what they mean by "Holocaust". Were SOME jews interned in German camps? Yes, for the war caused lots of movement among civilians. Was there any Nazi order to exterminate jews? No. Were there any gas chambers for killing people in German jurisdiction? No. People were gassed only in American prisons, before, during & after World War II. The Red Cross figured that some 300,000 persons, some of whom were jews, died of all causes in German custody. This would include people in the camps & people being evacuated from the camps, such as those inmates who were fleeing from the Red Army in two German hospital ships, the Wilhelm Gustloff & Cap Arcona. The sinking of these ships by the Reds & the British in the Baltic were the worst maritime disasters in terms of lives lost in the 20th century. These numbers far exceed the numbers of lives lost on The Titanic & the Lusitania. Around 9000 died with the sinking of the Wilhelm Gustloff alone. The death records survived the war. All camp inmates' records are now in The International Tracing Service offices at Arolsen, Germany. The Soviet Union released the Auschwitz death register which recorded a total of 74,000 deaths. 99% of these deaths were from typhus, which killed Germans, Poles, jews & everybody else in the camps. As the war progressed against Germany, their delousing abilities declined disastrously, mainly because of over-crowding & lack of Zyklon B, which was the delousing agent used before the invention of DDT. In the last months of the war, thousands of inmates, as well as Germans, died of disease & malnutrition, which was very similar to the Union P.O.W.s who died in the Confederate P.O.W. camp at Andersonville during the Civil War. U.S. doctor Pinter said that no autopsy revealed anyone dead from "gassing" in any of the German camps, but lots were dead of typhus, dysentery & starvation. The Big Fib of the "Holocaust" began in 1919 with an article in The American Hebrew of October 31, 1919, alleging that "six million jews" were dying of starvation in post World War I Europe. This story was apparently concocted to shake shekels out of the gullible to support Zionist &/or Communist organizations. The Holohoax began in August 1943, when the British were trying to counter the discovery of the Soviet killing of 15,000 Polish officers with bullets in the backs of their heads in Katyn Forest, Russia. The Germans were told of mass graves in the forest & they brought Polish & other international witnesses to view the bodies. I've seen the German film on this subject. The Soviets later made their own film & blamed the massacre of the Poles on the Germans, who were not in that part of the USSR when the massacre took place in 1940! Some of the jew NKVD murderers even bragged of their deed! The British were afraid the Poles might switch sides & join the Germans against the Reds, so the British Foreign Office was told to cook up something to keep the Poles on the British side. The Foreign Office hackwriter cooked up a story that the Germans were rounding up Poles & conducting mass executions at certain sites, including internment camps. In their office memos, one flunky asks how they were executing the Poles, so the typist inserted "gas chambers." When head of British Intelligence, Sir Cavendish-Bentinck, found out, he told them to delete the gas chamber accusation, for it was like the ridiculous propaganda the British had promoted in World War I, which was later discredited! I have enclosed this order with this letter, which I obtained from British Foreign Service archives. Around 1960, the Allies officially changed their lies that "death camps" existed in Germany & Austria, as well as Poland's six camps. Suddenly, the "gas chamber" at Dachau, which was built in 1945 by jewish film director of "Shane", George S. Stevens, "was never used." I've seen the atrocity film which Stevens made for Allied propaganda, which claims that "thousands were gassed in Dachau" At Auschwitz, Poland, there were huge plaques claiming that "4.2 million" people were killed there. As you would guess, that number is quite different from the actual figure of 74,000! As I understand from recent visitors to Auschwitz, the plaques have been officially erased. After 1945, the "Polish victims" of the alleged German extermination camps became jews!

I also believed in the Six Million Swindle, for I had no reason to question it, until I began to study World War II history. I learned that the truth is quite different from the kosher jewsmedia, including the statements of our own ZOG (Zionist Occupation Government). My sources are Allied, Zionist, jewish people & documents from the same sources. I cannot supply you with the Nuremberg Military Tribunal & International Military Tribunal transcripts, which I've read, for they exist in many volumes, but I can supply quite a few good sources.
