

1 MAR 06. Dear Shappa: Many thanks for your letter of 26 FEB06! I'm sorry to learn of your family's problems, & I wish everyone the best, yourself included. I enclose an official ZOG document referring to religious practices in the gulags. The DTO4 page lists religions which are apparently recognized as such by Washington State Prisons. Apparently, racial religions are permitted, as long as they are non-White. This is an official WSP document, received on AUG 13, 2004, by DCC's OCC Asst. Deputy Secretary's Office, bearing its official date & department stamp, so it should not go 'missing' from this mailing! If so, you have definite grounds for a grievance for theft of mail. Sorry, but I have no particular information in regard to our "A.Ct.", which I gather means "Appeals Court." In my experience, the usual grounds for appeal^{are} based on the error (s) of the trial judge, who is the trier of law, like an umpire who decides if the rules of the game are being followed by the opposing players, i.e. the prosecutor & the defence attorney. In a jury trial, the jurors are the triers of fact, & it is up to them to decide on guilt or innocence, or come forth with no verdict, which means another trial. In some cases, the jury decides that the law is unjust, & they declare that the defendant is innocent because the law is invalid! Been there, seen that. In a trial without a jury, the judge's verdict & sentence may be appealed on grounds of error in law & grounds of unfairness. Without stating specific instances of error on the part of the judge, I do not think one has any grounds for appeal. Let's say that the judge ignored the defence's case & evidence entirely. I've seen that happen in trials with juries present. I have seen witnesses' testimony ignored, as if they never testified, even when their testimony was pertinent to the case. A sentence may be inappropriate to the charge, like 50 years' hard labor for stealing a loaf of bread, but in a state with a "3-strikes" law, this may be considered "appropriate." An appeal depends on the merits of the case, as is said. Black juries are notably reluctant to find Black defendants 'guilty', according to The Wall St. Journal, & Blacks have been able to appeal their sentences on the grounds that they had a non-Black jury at their trials. Unfortunately, 'justice' often depends on who you are, rather than what you did. I have seen trials in which the prosecution was allowed to omit evidence & testimony unfavorable to the defendant, thereby letting the defendant get off free or on a minor charge. I have seen defence attorneys omit evidence & testimony in favor of their alleged client, so the defendant got screwed, or railroaded into prison.

I'll see if I can send you a copy of my Liberty Bell article on "True-jews, Freemasons & the Late United States," but I can sum it up: true-jews call themselves by various names such as British Israel, Israel Identity & Christian Identity, although they may have other aliases. This cult originated prior to World War I, accompanying the British-German trade rivalry following German Unification in 1870. The Idiot Idea included the fable that the Jutes, Angles, Saxons & other German tribes which invaded the British Isles had 'miraculously' changed their race by crossing 22 miles of saltwater, i.e. the English Channel! Shortly before England declared war on Germany in 1914, England's royal house of Hannover became the house of Windsor; Battenberg became Mountbatten, &c. This could not conceal the fact that Kaiser Wilhelm II, King George V & Tsar Nicholas II of Russia were all cousins! One interesting note on the long-standing relationship between Britain, Germany & the USA was that they had similar national anthems: England's was "God Save the King", Germany's was "Heil Dir im Siegerkranz" & the USA's was "My Country 'tis of Thee," all with the same music! Well, it has been argued that the hymn to the monarch was different from the national anthems like "Deutschland Uber Alles", "Rule Britannia" & "The Star-Spangled Banner," but in countries with monarchs, their official songs were on par with the national anthems, for the monarchs were heads of state, & soldiers swore to obey the king, who personified the country. It is also interesting that no U.S. politician or soldier swears to defend the USA, just the Constitution! It would be perfectly legal & Constitutional if the U.S. government gang would sell the USA to China & skedaddle to Israel, bringing along The U.S. Constitution in a plastic baggie, in fulfilment of their oath of office! "To hell with the U.S. people. We've got The U.S. Constitution!" Bush has already cursed it as a "damn piece of paper," so his gang would probably leave^{it} to the new Chinese owners of North America.

Freemasons WANT to be jew-slaves, & jews are giving them every opportunity to be such. Freemasons' H.Q. is in The City of London, their Mother Lodge, so whoever is a Freemason is taking his orders from London's rulers: The Bank of England's jew masters & owners. The Spanish Jesuits were also proponents of race-mixing, for they believed that a mongrel (mestizo) race would oppose the Indian tribes & the Spaniards, in favor of the Jesuits! The main reason for the existence of Whites in the U.S.A. & Canada was that White women accompanied White men to the New World, but not in Latin America! The ready-riches of Latin America & the abundance of slave labor were just what the colonizers wanted, & where they found them, the colonizers were destroyed by race-mixing. Later, White kings used a militant version of the Christ cult so as to centralize their power over their subjects, the better to fleece them & lead them to slaughter! In both versions, the jew promoters of the Jesus-juice racket extended their power & wealth in Europe. Christinsanity has long been dubbed, "Judaism for Goyim", designed for Gentiles to serve their jew masters.
