

3-3-06. Hail John! Many thanks for your letter of 18 FEB06. I'm glad you have questions, so you weren't bored by the reading material I sent you. Yes, I do appreciate any stamps I can get. Every bit helps.

To the best of my knowledge & research, gas chambers were never used for killing humans in Europe. There were fumigation chambers in Europe & in America for killing lice, rats & other vermin, as at Ellis Island, where immigrants were bathed & their clothing deloused in separate rooms. The delousing agent was the same as that used in Europe: Hydrogen cyanide or HCN as its chemical formula reads. This delousing agent was sold under various brand names, according to Dr. Lindsey, former Dupont chemist. "Zyklon-B" was a brand name for the HCN used in Germany in wartime. As I understand, the "B" designation was to indicate that the warning odorant was absent. A warning odorant is what we smell when a gas burner on the stove is turned on, but not ignited. The added odor tells us that flammable, explosive gas is leaking, so we may do something about it, pronto! In the case of HCN, the odorant's aroma came just before the HCN was released, so fumigators would know they were in danger. HCN was & still is used to fumigate entire buildings & ships, now that DDT is banned. In Austria, in World War II, there were huge fumigation chambers which could accommodate entire trains, so that lice from the east could be eliminated. The lice carried the deadly typhus disease that was responsible for most deaths in places where people were crowded together, such as internment & refugee camps. About 90% of deaths at Auschwitz, Bergen-Belsen, Dachau, et al. were due to typhus & malnutrition. All camps had delousing facilities for hygiene & disease-prevention in German jurisdiction, & they all required Zyklon-B. At first, the lying Allies called them all "death camps," but they later changed their lies to put that "death camp" label on the six Polish camps, so Bergen-Belsen, Dachau, Mauthausen & all camps in Germany & Austria were no longer "death camps" officially, as of 1960. That's why the sign was replaced at the Hollywood gas chamber in Dachau, so it now reads: "Never used as a gas chamber!" As I mentioned elsewhere, I saw the official Allied atrocity propaganda film which featured that very "gas chamber", which claimed that "many thousands were gassed" when they thought they were going for a shower! Then, just like that, we are told by the same Allied sources that "no gassings took place." In war, it is natural to lie to the enemy, so how come 'our' governments told the same lies to us as they told the defeated Germans? Fred Leuchter, whom I know personally, arranged executions in the USA prisons. I met him through Warden Armontrout of Missouri State Penitentiary, where executions are done in a gas chamber, as in St. Quentin Prison, California. I understand that Maryland & Nevada also executed inmates by gassing with HCN, before, during & after World War II. The last gassing I studied was of the Jew, Caryl Chessman, in 1958 at St. Quentin, across the bay from my university in Berkeley. The U.S. gassing process for humans is done with HCN pellets which are dropped into acid. The gas then fills the chamber & kills the condemned person. The safety procedures are very numerous, among which guards must be removed from the walls during a gassing, for HCN is lighter than air, so it rises upon being released. It is also deadly & explosive in the proper concentrations. Since the Jews claim that the Germans used the same gas, HCN, to kill "millions of Jews" at the six camps in Poland, we are justified in wondering how the procedures for "gassing millions" could be so different from the procedures to gas one or two people with the same gas in the USA. According to Jews, people were simply herded into rooms above ground or below ground. Any old room seemed o.k. The "gas chamber" at Maidanek, in Poland, was a flimsy wooden building with windows, ordinary windows! In none of the alleged lethal gas chambers for "millions of victims" was there any evidence of gas-seals, which would make the use of HCN inside equally dangerous for people outside! Doors which supposedly resisted the "stampedes of desperate inmates" are so flimsy that they could not withstand being slammed, without falling apart. The "gas chamber" at Auschwitz could not have functioned at all the way the Jews have claimed, for the gas would have entered the crematoria at the same time it was being used on the inmates. The gas & the inmates would have entered the furnace room in time for the resulting explosion as the HCN reached the fires! All the "gas chambers" so called by the Jews are, in fact, quite drafty, so they were not air-tight & certainly not gas-tight. The Germans had much better lethal gasses, such as sarin & tabun, both fast-acting nerve agents, but the Jews insist that the Germans used HCN (Zyklon-B). Of course, HCN is slower, especially to remove from people & places after it has done its lethal work. According to my chemistry, HCN reacts vigorously with iron & oxygen. That is what our red blood carries, so HCN quickly converts our oxygen-carrying blood into a lethal compound. When released into a room, such as one with plaster, cement or brick walls, the HCN reacts

2) with the normally present iron particles & compounds to produce a permanent, dark blue stain. Fred Leuchter discovered that no such use of HCN was present in places where the gassings of people were claimed, but lots of HCN residue was present in delousing facilities, where "no one was gassed." These findings reveal two things: (1) The HCN was really used for delousing clothing & bedding, not people, & (2) No gassings took place where the jews claim "millions were gassed."

The jews also claim that "millions were cremated." The cremation process was invented in 1849, to prevent crowded Europe from becoming a big graveyard. The process produces no smell, nor smoke, & certainly no "flaming chimneys", since flaming chimneys normally collapse if they flame very long. In refineries & sewage treatment plants we can see gas flares which feature flames at the tops of smokestacks. The difference is in the heat: unignited gas rises to the top of the vent, where it is ignited. If ignited gas went up through the stack, it is likely the stack would be damaged! A flame cannot appear unless there is something to be burned. In cremation, there is nothing to be burned in the chimney, nor at the top of the chimney, so where would "flaming chimneys" originate? In the jewish imagination! The jews insist that all the bodies were "cremated." This in itself makes the Holohoax impossible, for it takes 1½ hours to cremate a body under ideal conditions, with modern cremation facilities, not the coal-burners of World War II. If the number of "victims" was as great as the jews claim, the cremations would still be going on! No, you can't cremate more than one body at a time, folks! And, you couldn't do it without coal, so where is all that coal? I've seen none of it in the Allied aerial photos of the Auschwitz camps, where the "gassings" & the "cremations" were supposedly done, for "millions," remember? I've witnessed cremations, & try as I might, I could see only steam coming from the vents, & no smell of "burning flesh. Also, one cannot use a crematory 24-7, so time must be allotted for the extraction of remains & maintenance of the furnaces & their firebrick linings, which spall or flake with use. The use of gasoline would not do the job, even if gasoline had been available in wartime Germany, for gasoline burns at too low a temperature to reduce human remains to the degree required for cremation. Wood would be better, so where was all the wood piled up to dispose of "millions"? None in sight on those wartime photos of alleged "death camps!" I understand that the jew rulers of Russia BURNED bodies of their victims in coal-fired powerplants, trash incinerators & boiler fireboxes of ships. This is quite possible for small numbers of bodies, but since fresh bodies have a large percentage of water, most of the energy is consumed by evaporating the water, before it can be used to cremate, burn or otherwise reduce the body itself, like throwing water-filled balloons on a campfire. No, humans do not burn by themselves. Jews claim the Germans "burned" more "millions" in deep pits at Auschwitz, which is swampy. The Auschwitz water table is around 4 feet below the surface, & jews claim that "the burning pits" were "nine meters deep" or deeper! Since one meter is just over one yard, nine yards would be well below the ground water table, so a "burning pit" would be a water-filled ditch. When bodies are burned outdoors, they must be put on pyres, which are piles of wood or other fuel set on or above ground level! But jews insist on their impossible "burning pits". Blub, blub.

U.S. gassings in U.S. prisons should be no secret. A library reference section or encyclopedia should mention it under "Executions", "Penology" or "Capital punishment." The USA has used hanging, shooting, gassing, electrocution & now, lethal injection methods. With the exception of lethal injection, all other methods were used in the USA before, during & after World War II. California has a two-seater gas chamber in St. Quentin. Ask your zoggies! All U.S. concentration camps alias "internment camps" had crematoria, in case anyone died. So did the Germans'. The U.S.A. had 666 internment camps under Milton Eisenhower, "Ike's" brother, who established the real death camps in Germany after the German surrender on May 8, 1945. These 'camps' were just cattle pens, barbed wire enclosures, in which Germans were herded to die of starvation, cold & disease, under U.S. guards with orders to shoot anyone trying to get out.

The British Foreign Office archives reveal the British scheme to hide the Soviet Jewnion massacre of 15,000 Polish officers in 1940 or even as early as 1939, after the Germans discovered the bodies in the Katyn Forest of the Soviet Union, following their 1941 invasion of Red Russia, just before Red Russia under "Stalin" was planning to attack all of Europe. The jews blamed the Germans, but the Germans were not there when the Poles were murdered en masse.

The jews' vicious murder gangs alias secret police began as The Cheka, whose reputation

became so bad that the name was changed several times. I understand that Cheka became MVD, then OGPU, but was known as NKVD for a longer period, after which it became the KGB. Now it is called the FSB, & is still kosher, as far as I know. A western reporter in Moscow, Peter Worthington, reported that the NKVD or KGB all spoke Yiddish amongst themselves, & Russian to the Goyim or Gentiles. The name changes are helpful in knowing the dates of a Jew atrocity, for the name of the murder gang reveals the date on which it was perpetrating its crimes against humanity. I watched the German film about The Katyn Massacre & the Soviet film, both of which revealed that the Polish victims were shot in the back of the head. This is known as The Lubyanka Breakfast: a cigarette & a gunshot to the back of the head. Lubyanka is the notorious secret police headquarters in Moscow, a nice place NOT to visit.



The British had already deeded Poland to Stalin's USSR, according to treaty, in which Britain would "aid" Poland only if it were attacked from the west, i.e. by Germany, but not if Poland were attacked from the east, i.e. The Soviet Union. That treaty was revealed after the Germans captured Warsaw, as I understand. But in 1943, the British were worried, as they wrote in their Foreign Office Files, that the stupid Poles would join with the Germans in the defence of Poland from the Red invaders, especially after the discovery of the Polish murder victims at Katyn. The Foreign Office writers decided that they would accuse the Germans of planning WORSE things against the Poles than what the Soviets had already done to them. They concocted the "death camp" lie & added "gas chambers" as the means of mass-murder, but the head of British Intelligence, Sir Cavendish Bentinck, objected that "gas chambers" were like the lies they'd told in World War I, so the fictitious "gas chambers" were removed from the official British statement on "German Atrocities in Poland," as of August, 1943. The "gas chamber" lie resurfaced after World War II, when the Germans could no longer defend themselves & Red (kosher) Russia had taken all of Poland, & parts of Central Europe. That's when certain modifications were made at Auschwitz, such as a fake chimney, & signs which indicated "gas chambers".

As I understand, Rommel was not a party to the Hitler Assassination Plot of 1944, but his adjutant, Speidel, may well have been, since the Allies rewarded him after World War II. As I gathered, Speidel was in Normandy in Rommel's absence, & he should have phoned Oberkommando Wehrmacht (OKW) that the Allies were landing in force where Speidel was, but he did not do so! The delayed response by the German forces made Allied invasion possible. Stories arose that Rommel was accused of conspiring against Hitler. One source, which I have not confirmed, stated that Rommel heard about certain officers who questioned Hitler's competence, but Rommel was not informed of any assassination plot. I understand that Rommel had been badly wounded when he drove from Normandy to Germany & his vehicle was attacked by an Allied aircraft. Rommel's widow was, apparently, bribed & threatened to claim that her husband was "anti-Hitler" after the war. Rommel was buried with full military honors, according to pictures I've seen. General Remer, who was in charge of the Berlin garrison during the assassination attempt in 1944, told me that Rommel was innocent of complicity in the plot, according to his knowledge. He was promoted by Hitler over the phone, with Dr. Goebbels as witness!

All I know about Fieldmarshal Milch is what I've read, here & there. Milch earned Hitler's praise when he initiated the aerial reinforcement of German forces in contested Norway, thus giving the British & their Norwegian allies a resounding defeat. Some doubts about Milch's loyalty were raised in connection with the botched bomber program of the Luftwaffe. Air ace Adolf Galland mentions this bungling. Who was in a position to put in the wrong word to Goering, if not Milch? Udet has been suggested. He died under strange circumstances in 1944, I seem to recall.

All I know about the Ritterkreuz is that it is a Knight's Cross, but how it ranks in regard to other Iron Crosses, I am not sure, except that it is high-ranking. I don't know where one can join the NSDAP, since it does not exist, to my knowledge. Adolf Hitler's mistress was Eva Braun, whom he later married. Women were attracted to Hitler because of his power & his personality. They are even attracted to Henry Kissinger, not for his looks or personality, but for the power he represents. At least that's what Kissinger said about himself! Hitler had several secretaries because there were no laptops or photocopiers in his time! If you wanted copies of reports, &c., you needed many typists & lots of carbon paper. Been there. Done that. Alles von die Beste! CRION!

The closing words of the note are interesting in view of the comment by Secretary Lansing upon the German counter demands on the American government. It had declared that one was distinct from the other and could not mutually influence one another.

### ATROCITIES IN SERBIA.

700,000 VICTIMS.

FROM OUR OWN CORRESPONDENT.

ROME, Monday (6.45 p.m.).

The Governments of the Allies have secured evidence and documents, which will shortly be published, proving that Austria and Bulgaria have been guilty of horrible crimes in Serbia, where the massacres committed were worse than those perpetrated by Turkey in Armenia.

The Italian Government has today published the testimony of two Italian prisoners who escaped from Austria through Serbia, and took refuge in Roumania. What these two prisoners saw and learned, however, was nothing compared with the evidence supplied by the Serbians themselves, and communicated by M. Paolich to the Italian Government and to the

Press. According to reliable information, the victims of the Austrians and Bulgarians numbered 700,000. Whole districts, with towns and villages, have been depopulated by massacres. Women, children, and old men were shot up in the churches by the Austrians, and others starved with the bayonet or suffocated by means of asphyxiating gas. In one church in Belgrade 3,000 women, children, and old men were thus suffocated.

Serbian refugees, not on oath, have stated that they were present at a distribution of bombs and machines for producing asphyxiating gas to the Bulgarians by the Germans and Austrians, who instructed the former how to utilize these instruments to exterminate the Serbian population. The Bulgarians used the method at Nish, Pirot, Priazrad, and Negotin, the inhabitants of which places died of suffocation. Similar means were employed by the Austrians in several parts of Montenegro.

## GERMANS MURDER 700,000 JEWS IN POLAND

### TRAVELLING GAS CHAMBERS

More than 700,000 Polish Jews have been slaughtered by the Germans in the greatest massacre in the world's history. In addition, a system of starvation is being carried out in which the number of deaths, on the admission of the Germans themselves, bids fair to be almost as large.

The most gruesome details of mass killing, even to the use of poison gas, are revealed in a report sent secretly to Mr. S. Zygielboim, Jewish representative on the Polish National Council in London, by an active group in Poland. ## Murder at Sea.

During the course of the British attempts to land in Norway, H.M.S. Cossak was heavily bombarded and finally stranded as a total wreck.
