

1 MAY 06. Hail John! Many thanks for your letter<sup>s</sup> of 24 APR 06 & the great enclosure, which is best for photocopying. Christinsanity was invented by the jew, Saul of Tarsus, alias "Saint Paul," for the exploitation of Goyim (Gentiles), just as Marcus Eli Ravage admits.

One jew-scam is the artificial separation of politics from economics. The true subject for study is political economy. The artificial separation of politics from economics is as absurd as it would be for medicine to separate people's right legs from their left legs & treat them as two different items, with no connection to the body from which they protrude! Politics is people-power & government exists in the minds of the governed.

Economics is likewise dependent on people's means of living. The first economic system was hunting & gathering. This economy kept people on the move, in search of fish & game. Then some people realized that they wouldn't need to move around so much if they raised their own food & livestock. This discovery led to the formation of houses & villages. It also produced surplus food, which led to specialization. Iron products were desired as useful, for example, but if the blacksmith had to raise his own food, he wouldn't be as productive on his forge, so other farmers traded food for his ironwork. That is just one example of specialization. Eventually, farmers could support cities in which further specialization occurred. Nowadays, we don't find many people who make their own shoes & clothing or raise their own food, & our food production is so efficient that fewer & fewer people live on farms. Food surpluses are the sign of a rich society, which can afford to feed many non-food producers.

You can imagine that the farmers who paid the blacksmith in pigs, grain & vegetables, &/or meat, fish & baked goods, in exchange for his ironwork would hear the blacksmith complain that he couldn't eat all the food he was getting, & even his family & relatives had more than enough to eat! Even when the food could be preserved & stored, there was still too much for the blacksmith & his family to consume, so he wanted other things, like a new house. If the farmers had skilled craftsmen in their communities, like the blacksmith, they would also be paid in farm products, so what would the blacksmith pay them to build him a new house? This is a limitation of the barter system, for goods exchanged for goods may not be desirable, nor convenient. What is needed is something which is convertible into other goods & services, something which represents value & is a store of value. As I understand, Romans began using grain & cattle as "money." They paid their soldiers in salt, which was another valued commodity, & easily divisible, so salt & grain were the 'small change' & cattle were the big bills. Not only could this money be exchanged for other items, but it could be used for its own sake, as food. Cattle & grain can also be made by anyone who can grow them, so a farmer would be making his own money. As always, there can be inflation & deflation: a drought might make grain scarce, as well as cattle. The result would be less money with which to buy things. Likewise, a year of good harvests would produce so much grain & so many cattle that more would be demanded for relatively scarce goods. Inflation & deflation are determined by prices. Inflation occurs when the money supply increases, relative to the amount of goods & services; deflation occurs when the money supply decreases relative to the amount of goods & services. This is called supply & demand.

Eventually, money took the form of copper, silver & gold, as well as iron. Metals had their own values, for they could be used to make things. I could save up my iron coins & make my own sword out of them. I could make useful & decorative items from my gold & silver coins. Metals were durable & easier to carry around than cattle & grain. Besides, I did not have to feed them! Inflation & deflation occur with metal money, too. As societies became more stable, goldsmiths, silversmiths, coppersmiths, as well as blacksmiths would store metallic money & would issue I.O.U.s to their customers. These I.O.U.s were exchanged by the customers who had metal money stored at such places. Eventually, the smiths learned that few customers called for their metal money, so they began to lend out funds belonging to their depositors. This is called banking. Bakunin said that small criminals rob banks; big criminals start banks. Inflation is theft, in essence, for it devalues money. If I pick your pocket, you find that you no longer have the money, but if I devalue your money, you still have the original amount, but it buys less. Someone has stolen your money's value, which is the same as stealing your money. By lending out the money people put into storage, the moneylenders added money to the overall economy, contributing to, if not causing inflation. My economics professors said that a banking system which holds 20% of the deposits in reserve, but which lends out 80% of deposits increases the money supply five times. In other words, \$1 on deposit in a bank results in \$5 circulating in the economy! This money exists as book

2) entries, not as dollar bills. Conversely, if someone takes a dollar bill & keeps it in a coffee can, he is taking \$5 out of the economy. This is what banksters do if they want to cause deflation, as they did in The Great Depression of the 1930s, & the 'panics' & 'crashes' which preceded The Big One, except that the banksters of the Federal Reserve kept their money in vaults.

Here, we are already in banking, without mentioning interest, that is, usury! I have not concluded with money, so I shall return to that subject. So far, we have looked at commodity money, in which each unit thereof, be it cattle, grain, gold or silver, is a good which has its own market price at all times, no matter what denomination is stamped thereon. I can buy a barrel of oil, another commodity, & stamp \$30 on the barrel, but when the market value climbs to \$70 a barrel, my \$30 a barrel money would disappear. This is what happened in Brazil when inflation made the metal value of Brazilian coins much higher than the denomination stamped on the coins. Suddenly, the coins became worth more as metal than as coins! Commodity money is bad money, for its supply is independent of the availability of goods & services. Money should be representative of the things which give money its value. The more things & services available, the more money should be available to represent them.

An honest society which is self-governing (sovereign) must issue its own money, which should be token money, that is, money which has no value in itself. Money should serve like honest weights & measures. Under ZOG, the value of our money fluctuates. This is like having the length of a yard, the volume of a quart, the weight of a pound, &c. increase & decrease at the whim of speculators & criminals. If I work 8-hour days, inflation can rob me of my work, by making it look as if I only worked 5 or 6-hour days. When Rome was strong, it issued copper coins of little intrinsic value, which served as evidence that the bearer had done something or had provided something pleasing to the Romans, but when Rome adopted gold as money, Rome's rot began. Gold money empowered the goldsmiths & gold merchants, thus depriving Rome of its sovereignty (self-government).

Abraham Lincoln annoyed the banksters by issuing United States Notes (greenbacks) which were paid into existence. Our present money is borrowed into existence at interest. Assume that we were to pay the "national debt," which we owe to the U.S. Federal Reserve, which is a private, jew-owned bank: our money would disappear, for every \$1 bill is an I.O.U. to the Federal Reserve. Worse, we would have paid the principal, but not the interest, which is compounded, so it increases every month that it is not paid! In other words, the "national debt" could continue to increase, even if no money were in circulation! Who gave the jews such power? The politicians. That's why there can be no division between economics & politics. Debt-based, that is, borrowed money, is the WORST form of the 3 types of money.

The Third Reich used Lincoln type money. It was printed by the sovereign government of Germany. Its value was the productivity of the German workers. Economist John Maynard Keynes knew that the cause of The Great Depression was lack of money, so he proposed that governments put money into circulation, in payment for public works projects, such as road-building. This is exactly what Hitler did, with money printed, not borrowed, & paid to the workers who were hired to build needed roads, including the futuristic autobahns in use today. Hitler's policies ended The Great Depression in Germany around 1935, two years after Hitler was elected to office as Chancellor! This was, indeed, Germany's economic miracle. Inflation was prevented by Germany's German-owned, not jew-owned, central bank which withdrew the original amount used to stimulate economic activity, as deposits came in.

But in the rich USA, under Franklin D. Roosevelt, we still wallowed in The Great Depression, which lasted from 1929 to 1939! I knew Col. Curtis B. Dall, Roosevelt's son-in-law. I asked him why FDR had such a hatred of Hitler. Dall said, among other things, that FDR resented the fact that Hitler had ended The Great Depression & its unemployment problem in impoverished Germany, when the jew-banksters of the Federal Reserve would not allow him to use the same "pump-priming" program to get the rich USA out of The Great Depression. Only money was lacking, & FDR had to BORROW every dollar, with interest, thus increasing the U.S. "national debt!" The banksters were waiting for war. Only then would they make money available to end their depression racket.

Interest or usury, is money charged for borrowing money. If I lend you money with which to buy a house at 5% interest, which you must pay me within 20 years, you will discover that you have paid DOUBLE the price of the house. Most sheeple think that 5% interest is a very good deal! Islamic banks do not charge compound interest, which means that you pay interest on the interest every year, or whenever the banksters specify. Instead, you pay a service



3) fee, one time. Then you pay only the principal, that is, the sum lent to you. This difference in banking systems is sufficient to have the jews declare 'holy war' on Islam! In most countries under ZOG, their debts are so huge that their entire tax revenues go only to pay the interest on their debts! That is why interest on money lent is "the one ring to rule them all, & in the darkness bind them." This is the form of money to which all wise men object: the worst form of money, borrowed money, with interest, jew money.

The Werewolves were not SS, as I understand. They were supposed to resist Allied invaders in occupied Germany. Dr. Goebbels thought that this form of guerrilla warfare would be effective, as it had been against the Germans in Russia & the Balkans, but he did not realize that those areas were multi-national countries, so one nationality did not care if German occupiers made reprisals against the local populations where resistance occurred. But Occupied Germany was German! Part-nigger Eisenhower hated Whites in general & Germans in particular, so he issued a declaration that 200 Germans would be shot for every Allied occupier killed or wounded! Thus, the Werewolf movement melted away quickly.

"Krystallnacht" was a jewish ploy to get Germans to riot against jews. Some jew-owned shops had their display windows smashed, which provided the "crystals" that gave the incident its name. German leaders ended the rioting in about 10 hours, maximum. According to the jewish reporter for The New York Times, only one death was recorded in all of Germany: a man who was murdered in the course of a burglary, which had nothing to do with "Krystallnacht!" This Zionist-instigated riot occurred on November 9, 1938, the same year in which the Zionist leaders conferred with German leaders about "The Final Solution" of sending German jews to Palestine. The Zionists saw "Krystallnacht" as a necessary stunt to get jews to leave Germany. This is what the Zionists did to jews living in Kielce, Poland, in 1947, 2 years after Germany's surrender to the Allies. The Kielce Pogrom cannot be blamed on the Nazis! German insurance companies paid the jews substantial sums for any damages they suffered in "Krystallnacht." Hitler denounced the riot as being very damaging to Germany.

Stauffenberg was one of the traitors who plotted to assassinate Hitler in 1944. Hitler tended to trust his officers too much, so the traitors in the Wehrmacht did lots of damage before they were brought to justice, if at all. Men of rank in the Third Reich who were rewarded by the Allies after the war were usually traitors.

The German Army & other armed services did not recognize party membership. Once you were in the army, navy or air force, party membership lapsed. The Wehrmacht consisted of members, that is, former members, of all parties, except for Communists, who were outlawed. The German armed forces took an oath of loyalty to Hitler, & the NSDAP provided facilities to armed forces' personnel.

The Hitler Youth was established with the NSDAP, along with its other youth branches. Baldur von Schirach was their leader. Hitler Youth were the German equivalent of the British & U.S. Boy Scouts, which were established by Baden-Powell as an imperial paramilitary organization for the British Empire. That's why the German nation had no use for Boy Scouts!

The number of all people in German labor camps is known, but it is kept secret. The records of all camp inmates have been kept at The International Tracing Center in Arolsen, Germany, under jewish control.

The Lavon Affair of the 1950s was the first jewish attempt to enlist the USA in a war against Arabs. Lavon was the Israeli minister of "defence," if I recall correctly. He sent jews to set off bombs in U.S. Information Agency libraries in Egypt. The jews got caught, so the scheme flopped. Lavon resigned his post. The next stunt was to sink the USS Liberty during the 1967 Arab-Israeli War. The jews were identified by U.S. naval personnel. Despite considerable loss of life & damage to the ship, it was not sunk. The third stunt which succeeded was 9-11. Former Israeli premier, Benjamin Netanyahu, declared that "it was very good for Israel." The U.S. went to war against Afghanistan & Iraq, just as the jews had wanted, for so many years. "If at first you don't succeed, try & try again."

The ZOG's Waco Massacre was designed to kill off the Koresh Cult, on behalf of jews who objected to Koresh & his followers who were intruding on jewish religious turf. Koresh even flew a huge Israeli flag over his compound, which TV jewsmedia attempted to blot out. Koresh is Hebrew for Cyrus, a Gentile king of Babylon, who was so nice to the jews that they elected him Christ or jew-king. Jews hate to let people know they once had a Gentile king! Bush #1, whose family is jewish, like him, praised the Lubavitcher Hassidic jews' "Rebbe" on his March 26<sup>th</sup> birthday, on which Bush declared it "National Education Day." Bush Sr. said that the basis of "civilization" was the 7 Noahide laws: jew laws for Gentile slaves!

4) The Katyn Forest Massacre of some 15,000 Polish officers by order of Stalin caused the British to start their "gas chamber" hoax, according to their Foreign Office files, as I wrote in my article, "Poland & the Lies of the Allies," which was published in Liberty Bell magazine & The Barnes Review historical publication.

A big Mexican parade is scheduled to occur with a march past my window today, so it appears that the brave U.S. citizen who wanted to prosecute the fatcat felons of Yakima for hiring illegal aliens may get pushed aside by the mestizo invaders & U.S. Congress. I've received no follow up on that first Internet message.

The only way the jews can screw the Chinese is to get them to fight among themselves. This will be a true test of Chinese honor & intelligence. Israel is supplying China with the latest U.S. military technology, as did Bernie Schwartz of Loral, who made sure the Chinese got the latest U.S. missile guidance technology. Once the Eurasian (mestizo) invasion & occupation succeeds, the Asian invasion is even more unlikely to be resisted by the U.S. sheeple under ZOG. Since the Chinese have most of our jew I.O.U.s, they can use them to buy up the USA. By that time, most non-Chinese will probably be unemployed, with no property nor savings, so the Chinese invaders may have us all take a long walk off a short pier. The Chinese already have plans underway to take over Africa & its oil supplies.
