

20 MAY 06. Hail John! Many thanks for your letter of 14 MAY 06! Using the banking system is not the same as going into debt by borrowing money from a bank. I use a bank account for convenience, but I never borrow money. In a White economy, stashing money in one's mattress or in a coffee can is economic sabotage, for it takes money out of circulation. If money represents the goods & services produced in the economy, it makes no sense to remove it, thereby creating deflation, in which money becomes scarce. There must always be a dynamic balance or equilibrium, just as one who breathes must inhale & exhale. Saving allows investment in essential goods & services, including infrastructure, such as roads, powerplants, sewage treatment plants, &c. Without savings, money is usually borrowed because of lack of savings & too much spending. Banking works if it serves the people of a nation. Otherwise, banking is a licence to steal & to enslave. This is why a sovereign or free state must create its own money & run its own banking system. This is not a private matter, any more than military service should be for mercenaries! If a people's army's loyalty is to money, rather than the nation, an enemy can buy the army, & take over the country. Putting money-creation in the hands of alien banksters is no different! Crime or no crime, taking money out of circulation is not good economics. The banksters did that in the 1930s when they wanted to create The Great Depression, & it sure worked! That was a real crime.

As you say, the jewsmedia promote criminal behavior, but we PAY them to indoctrinate us with their propaganda, so we who watch it are just as responsible as the jews who purvey it. Who is responsible for the drug trade? Those who sell & those who buy. Who is the victim? SOCIETY, all of us!

Eisenhower's order that 200 Germans would be killed for every Allied occupier killed or wounded was a matter of public notice. It was not a secret. I saw a photo of his order on a public billboard in occupied Germany, which I will try to find in my archives. Yes, according to several who'd seen him when he had hair, Eisenhower showed definite Black racial traits, & so did J. Edgar Hoover. At West Point, the school magazine referred to Eisenhower as a "Swedish jew." Some claim that was a joke, but Dr. Oliver told me it was no joke, & he was a knowledgeable contemporary of Eisenhower, who was one of the founders of The John Birch Society, (Dr. Oliver was a founder; not Ike!). I do not have a copy of Eisenhower's family background, but no president since Lincoln had been as pro-Black as Ike, who presided over school integration in 1954, as I recall, & who hated Whites in general & Germans in particular, judging by his postwar genocide program in occupied Germany. "Other Losses," by Bacque is good for starters on this matter. Life Magazine ran two full pages which showed German soldiers suffering in open fields enclosed with barbed wire & Allied armed guards to shoot escapees. In these enclosures, unfit for cattle, the German postwar prisoners were systematically starved, without shelter, so millions died of exposure, hunger & thirst in Eisenhower's death camps after the war was officially over. Ike's brother, Milton, ran U.S. concentration camps for civilian detainees, only some of whom were Japanese. Most U.S. concentration camp inmates were White civilians; Germans & Italians whom the U.S. had deported from their homes in Latin America.

From my study of Krystallnacht, I understand that a jew named Grynspan shot a German embassy official in Paris, & it was from Paris that the jew Zionists organized their trick to get Germans to riot, with jews disguised as Party members. According to researchers, the riots occurred within one hour's drive from German borders with France & Belgium. No deaths nor looting occurred in connection with the riots. Jew reporter, Lachner, of The New York Times wrote all about it, & there was not much to write about to his jew editors, but the damage had been done to Germany's reputation, exactly as the Zionists wanted. Krystallnacht occurred in 1938, a year of intense German-Zionist collaboration which followed Krystallnacht. The idea was to scare jews so they would leave Germany, according to Zionist policy, just as the jews did to jews in Kielce, Poland, in 1947, so they would leave for Israel. Pogroms are an old kosher recipe for governing jews, according to Zionism. I never heard of "The Kieke Program." Are you sure of the spelling?

Thanks for the update on Tuolumne County, CA, now part of Mexifornia. It must be pretty bad in terms of White survival. It seems that integrating cells in the ZOG-gulags is a plan for disaster. In L.A. County, jewsmedia report that prisoners are being segregated to prevent racial gang riots.

2) In regard to "hard evidence" that the Holohoax is just that, most sheeple believe only what they want to believe, so there is no way of convincing them. "My mind's made up, so don't confuse me with the facts!" I used to accept the Holohoax, with the "gas chambers" & "the six million victims," until I started checking Allied sources. That's where we can find all the evidence to disprove it, but Holohoax believers must use their minds, as do members of a jury in a criminal trial. I enclose a list of important Allied people who did not see any "Holocaust," so your Mom can start with those sources. A unicorn is a mythical animal, like the Holohoax. If jews claim that unicorns existed all over World War II Europe, it would be strange to find no mention of such critters by people of the time, who would have made note of unicorns as well as Holohoaxes! The first jew-lie about a Holohoax appeared in The American Hebrew of 31 OCT 1919, so your Mom could look that up in a library. No one believed that lie then, any more than we should believe the current Holohoax. The 1919 article specifically mentions "a holocaust" of "six million jews."

The Eisenhower order to kill 200 hostages for each U.S. soldier killed appears in Section 358 d, of the U.S. Basic Field Manual. This would be an official U.S. Army source.

The Federal Reserve Racket manipulates interest rates to control the amount of borrowing in the USA, which threatens to make the U.S.\$ worthless, but unless we reduce our federal spending & our foreign purchases on borrowed money, this policy will only delay the outcome of our economic insanity. It's called spending money you don't have, so you can pass the debt onto your children, grandchildren, great grandchildren, & so on, & on & on. Debt/credit is "the one ring to rule them all, & in the darkness bind them."

"The Minutemen," from what I gather in the jewsmedia, are volunteer U.S. citizens who help the few U.S. Border Patrol people do their jobs, by observing illegal aliens' entry on U.S. territory & reporting them. Some of them spoke out on the jewsmedia in protest of the pro-alien demonstrations.

As you say, there is lots of b.s. about the U.S. use of torture on prisoners. ZOG's techniques include "simulated-drowning." This is kosher crap for real drowning, by placing the victim's head under water, so the victim can actually drown if he is kept under a bit too long. Sexual perversions are designed to give "our" torturers their jollies, while making their prisoners feel dirty & degraded. No wonder the CIA does not want the truth to be revealed! As you say, we now await the outcome of the U.N. hearings.

I haven't heard or read anything about the Mormon leader's prosecution or his intended prosecution. It has long been traditional that men are older than their wives, but this Mormon case likely involves polygamy, having more than one wife. Polygamy is common in Africa, The Middle East & Asia. I don't know how much "force" is required in such polygamous societies, in which most people of the world seem to live. It is interesting that the jewsmedia would attempt to link a Mormon cult with the others you mentioned, since Mormons are race-mixers who believe that American Indians, Polynesians et al. are members of a "lost tribe" of Israel, & are therefore "White."

The Ruby Ridge Incident, from what I read, began when the ZOG tried to draft a fellow named Weaver into their spy program, by blackmail. The zoggies threatened to prosecute him under ATF rules on "illegal gun modifications," such as sawing a short piece off a shotgun muzzle, which the zoggies accused Weaver of doing. Weaver did not appear in zogcourt, so the zoggies mounted a large-scale attack on the Weaver house at Ruby Ridge. In the ensuing shootout, ^{maybe} one zoggie was killed, likely by another fear-crazed zoggie. Weaver's wife & a son were shot dead by a Jap sniper working for the FBI, & ZOG-agent "Bo" Gritz acted as an intermediary to end the truce. Weaver was found "not guilty" in a subsequent trial & he received some monetary award for his tragic loss, as I gathered from jewsmedia reports. Weaver loved Yahweh, just as did the Waco Wackos of Koresh, so Yahweh, like his buddy, Satan, may have demanded that Weaver & Koresh pay some bloody dues.

I saw no anti-immigration protesters in Yakima, only Mexicans, when they had their big parade past my window. I walked around town & saw nothing but more Mexicans in the streets & on the sidewalks. Some Mexicans were Mexo-commies & other Mexo-Nazis. The Mexo-commies belong to La MEChA (Movimiento Estudiantil Chicano de Aztlán or Mexican Student Movement of Aztlán, their name for the conquered U.S. territory they now occupy). The Mexo-Nazis are La Raza Unida (The United Race). Their slogan is Viva la Raza! (Long live the Race!). People who boo them are called "racists!" Go figure. But no one booed them here, to my knowledge.

David Duke is head of The National Association for the Advancement of White People or NAAWP, if I recall correctly. I knew him & Don Black when they were KKK members, on their visit to Toronto.

3) I they may have visited in 1979. Black runs the website, Stormfront, & Duke runs the NAAWP. He puts out some good books, such as "Jewish Supremacism," a good introduction for those who know very little about jews & Zionism. Duke did a stint in the ZOG-gulag on a tax charge, as I understand. He has been to Russia & the Ukraine, where he seems to be a respected speaker & White representative. Shortly after he succeeded there, FEDZOGUSA demanded that he be turned over to U.S. authorities for prosecution on the tax charge, & so he was. I receive no regular news from Duke, so that's all I can say.

Even if one had "hard evidence" about Auschwitz, one would still be facing the World ZOG, its banksters & its puppet government minions. In Soviet Canuckistan alias China-duh, "Truth is no defence," as stated on official thought-crime transcripts. If truth is not a defence for debunking the Holohoax, then what is? The message is clear: "Might makes right!" Nothing less will do. In the meantime, people who are interested in discovering the truth can research the Allies' own lies about the "death camps." First, all German camps were "death camps" with "gas chambers" for inmates. In 1960, all that changed, for the Allies declared that the "death camps" were only in Communist Poland, all six of them! This meant that all of the "gassees" from Dachau, Buchenwald, Bergen-Belsen, Mauthausen et al., outside of Poland, were 'miraculously' transferred to Auschwitz, Belzec, Maidanek, Sobibor, Chelmo & Treblinka! To my knowledge, this transfer was done without explanation. One day, some were "death camps," the next day they were not. As for Auschwitz, the official "death toll" was engraved on concrete tablets. "4.2 million "gassees" were claimed, but when the USSR released the Auschwitz death records, they maxed out at 78,000. Now the tablets are erased, as I last read, by the former Allies! Auschwitz was 3 camps: Auschwitz I was the hospital camp for sick inmates; II was Birkenau, the big internment camp, which also housed workers at Auschwitz III (Monowitz), the big chemical plant which made rubber out of coal. I knew Thies Christophersen who ran the kok sagis plantation at Auschwitz, where Russian dandelions were grown to make the small quantity of natural rubber necessary for the Buna S formula, which is still used today to make rubber from hydrocarbons, which is the rubber all tires are made of! When Japan occupied the British rubber plantations in Malaya, North America had no rubber supplies, so such items as tires were strictly rationed. No ration permit, no tire. People like my parents had to buy an old car, like our 1927 Auburn, for which ordinary civilians, not farmers or doctors, could get tires. Farmers & doctors could get modern tires because of their war work status. Those without status could not get any. After we stole the Buna formula from Germany, we had no problem making rubber! Then there is the Leuna Formula for making oil from coal, which has also worked successfully, as in South Africa & in the USA under the Eisenhower administration, but 'our' oil companies did not like it, so FEDZOGUSA stopped production & dismantled the plant.

"Hard evidence" that Auschwitz was not a "death camp" in which humans were gassed has been revealed by execution expert Fred Leuchter & the Polish head of The Auschwitz Museum, who admitted on videotape to investigator David Cole that the "death camp" exhibits were fabricated AFTER the war by the Polish Communist authorities. My colleague, Josef Ginsburg, told me that he accompanied the kosher Soviet investigation team, including Soviet jew propagandist, Ilya Ehrenberg, which found no evidence whatsoever that Germans intended "gassing" or otherwise "exterminating" any camp inmates. Executions occurred & they were recorded as such. Most deaths occurred because of typhus epidemics, due to LACK of Zyklon B louse-killer. The quantities of Zyklon B received by all German camps is also recorded, so one can calculate the amount of gas required for "gassing" so many victims. In jewspeak, "death camps" were not where people died, but where they were "gassed." Nor were the alleged "gas chambers" the places where the Zyklon B was used. Ample evidence exists today in Auschwitz that the Zyklon B was used in delousing areas, where lots of Zyklon B was used to kill lice, not humans. The residue bonds permanently with any iron present in bricks & concrete, leaving a dark blue stain, which I've seen in color slides taken at Auschwitz, as well as from eyewitness testimony in court.

Thanks for the organizational chart with Third Reich leaders listed thereon. Again, I'm surprised that you would have a list of names with no biographical information, such as the brief biographies in my dictionary, so I must rely upon my memory. Many names I have no information on, so I'll state what I remember about those whom I've heard of or read about.

4) Foreign Minister Ribbentrop attended the signing of the Hitler-Stalin Peace Pact in 1939.

Rudolf Hess was Hitler's trusted deputy & served as ombudsman for The Party. In 1941, he flew to Britain with Hitler's peace offer to Churchill, who rejected it, & kept Hess in prison. The British murdered Hess in Spandau Prison, Berlin, after Zionist Occupied Germany told the British that the USSR would release Hess during their watch at Spandau. Hess helped Hitler write "Mein Kampf" when they were serving their sentences in Landsberg Prison. Bormann was a top assistant to Hitler, & some sources claim that he escaped from Berlin with Hitler in 1945.

Himmler, who headed the SS, allegedly offered his services & his Waffen SS troops to help the Allies against the Soviet Union, but his offer was rejected & he committed suicide. I recall seeing the photo of his body on the floor of the Allied military office.

Heydrich headed the Reichssicherheitshauptamt or RSHA, as I recall. He was murdered in Czechoslovakia. He worked with Eichmann to smuggle Jews into British-occupied Palestine.

Dr. Goebbels joined the Party after hearing Hitler speak. He proved his loyalty in 1944 when he burst into the office of my friend, General Remer, with a machinepistol. Remer had no idea that traitors had tried to kill Hitler with a briefcase bomb, until Goebbels told him. When Remer asked how Hitler was, Goebbels rang him on the phone & said, "The Chief will talk to you," & handed Remer the phone. Remer said that Hitler promoted him over the phone. Todt was a brilliant logistics expert, as well as military engineer. His Todt Organization constructed many of the fortifications of The Atlantic Wall. He was killed in a plane crash, & replaced by Albert Speer, if I recall correctly.

Frank was governor of occupied Poland. As I recall he was charged as a criminal at Nuremberg after the German surrender of May 8th, 1945.

Terboven was the Third Reich contact in Norway with the Quisling government. When Germany surrendered, I read that he committed suicide by sitting on a landmine.

Warlimount (sp?) was mentioned in connection with Elint & radar installations in France.

Canaris alias Meyerbeer was a Jew & a traitor who informed the Allies of German war plans & who kept Allied war plans, such as the Normandy Invasion, secret from the Germans. He was tried for treason & executed in 1944, after the assassination attempt against Hitler.

Halder was personally responsible for sabotaging the German attack on Red Russia, by halting German forces for 2 crucial weeks at Smolensk, which allowed the Reds to regroup their forces, & may have been the foremost cause of Germany's defeat in the East.

Sperrle commanded the Condor Legion in The Spanish Civil War.

Doenitz was appointed Hitler's successor as leader of The Third Reich. I seem to recall that he moved the German government to Flensburg, in Northern Germany, until the surrender on May 8th, 1945. The Allies treated him & his members of government as if they were rowdy thugs. In terms of the present constitution of the German Federal Republic, a national referendum was to take place, following German reunification. As I understand, that did not occur, & there has been no peace treaty signed with a German government to this day!

I don't know why other important people were omitted from your list, such as General Wolf & Feldmarschal Kesselring, who commanded forces in Italy.

Thanks for the trip down Memory Lane, but I suggest you check up on the things I've mentioned. If you find any errors, please let me know.

I was in a local diner devouring a hamburger. The TV was on, showing the torture chamber at Guantanamo.
