Others have noted ulterior motives in both sexes: the male seeing the female as a means of getting sex, & the female seeing the male as a means for getting children. Prostitutes use sex as a means of getting money, which males & females call 'short-term prostitution', whereas marriage is called 'long-term prostitution'. There are positive & negative factors in all sexual arrangements. On the other hand, life must often be sacrificed to gain freedom for oneself & for one's people, & if freedom were so desirable, why would anybody put up with slavery? I think it was Nikita Khruschev who said, "None are so enslaved as those who THINK they are 'free.' I believe he said that in reference to the people of the USA.

All our activities & purposes have their price, so as thinking beings, we should consider if the price we pay in time, labor & money is worth what we are getting in return. tured servants were transported across the Atlantic in some of the same ships and under equally uncomfortable conditions as the Africans, conditions which he asserts should be seen today "not as something unusual or inhuman but as part of the age."

Ship's captain James Boswell echoed the opinions of many 17th century sea captains and planters when he said that slavery saved the Africans from "massacre or intolerable bondage in their own country, and introduced them to a happier state of life." During the early 18th century, Britain's Lord St. Vincent stated that "life on the plantations was for the Negro a veritable paradise as compared with his existence in Africa."

If the European buyer, not the African seller, is to take the full burden of this trade, who exactly were the European buyers who profited? According to Susanne Everett, the most prominent among them were the Spanish, Portuguese and British royalty, the French Huguenots, the investors in the Dutch East India Company, and to a lesser degree, the pope and other leaders of the Catholic Church.

Toward the end of the medieval period of Europe's history, late in the 15th century, Europeans of the aristocratic classes were accustomed to the practice of enslavement, particularly of Negroes and of Moors. From the Arabs, British royalty occasionally purchased Africans. Susanne Everett, a British subject, writes that long before Africans were brought to the Americas they were a common sight in the royal houses of Europe. By 1492, when Christopher Columbus set foot in the West Indies, black indentured servants (not slaves) were being imported to serve European royalty at the rate of 1,000 a year.

In England, small black boys were fashionable as pets until the 18th century. Upon growing up, they were discarded, thus swelling the ranks of the poor and destitute in London, Bristol and Liverpool.

Servitude in the New World began almost as soon as Columbus arrived there. The impetus for it was an extraordinary arrangement arrived at by Spain and Portugal. In 1493, the pope responded to an appeal for arbitration between these two contenders for colonial possessions. Eager to see the world safely divided between Catholic powers whose influence would both enrich the Church and convert heathens, Rome allocated the eastern territories of the world outside Europe to Portugal and the western ones to Spain.

The line of demarcation ran down the

Atlantic. The Portuguese, however, were dissatisfied with the decision, which denied them Brazil. A year later, they managed to obtain an amendment, moving the demarcation line west, to intersect the mouth of the Amazon. By this the Portuguese were granted full territorial rights in much of Brazil.

On November 27, 1492, Columbus recorded in his journal: "After they [the Indian natives] understand the advantages, I shall labor to make all these people Christians." A year later, in a speech before Ferdinand and Isabella of Spain, Columbus said: "God has reserved for the Spanish monarch, not only all the treasures of the New World, but a still greater treasure of inestimable value, in the infinite number of souls destined to be brought over into the bosom of the Christian Church."

However, the mass of this Indian aboriginal population had been turned to forced labor, and had died in great numbers. Bartolome de Las Casas, bishop of Chiapas, returned to Spain in 1537 to petition the then-monarch, Charles V, on their behalf. He suggested supplementing this flagging labor force with black Africans. Charles granted authorization to ship 4,000 blacks a year to Hispaniola, Cuba, Jamaica and Puerto Rico. The courtier to whom Spain's king granted



English industrial accident boys (circa 1890) are pictured at Dr. Bernardo's Home in London. Those in the "Afrocentric" business as well as dominant elements in education, media and entertainment bave drummed away at black slavery in America as an unrelieved purgatory. In fact a large proportion of slaves lived rather pleasant lives, and slave punishment was largely confined to the incorrigible. In contrast, many millions of white people of the 16th through 19th centuries were exposed to battlefield death and maining, the dangers and borrors of American frontier life, unconscionable industrial exploitation and extremely vile mass bousing conditions. While generations of black slave children played and performed chores, tens of thousands of white children were worked mercilessly, were crippled, and died in workplace accidents or from lung congestion, and other diseases associated with work conditions.
