

19 AUG 06. Dear Michael: Many thanks for your letter of 14 AUG & enclosures, which I shall copy & **pass** on, as appropriate. Thanks, also, for the current information on the outbreak of the resistant & infectious "staph" bacteria. Our abuse of antibiotics is bearing fruit of a noxious variety, for reliance on antibiotics coupled with lax sanitary practices have made hospitals & similar institutions virulent centers for disease-transmission, rather than treatment, at the same time that countries are flooded with infected Turd Worlders & their filthy habits. I wrote, back in the 1970s, that we live in the age of Biopolitics, not Geopolitics. Geopolitics applies to the same people living in different areas, whereas Biopolitics applies when different people live in the same areas. Biopolitics applies to organisms other than people, which affect people, so my emphasis of the term is appropriate. Our biopolitical behavior will determine whether we shall survive or not, as we are beset by alien & antagonistic life forms. So far, we have done a poor job of defending ourselves biopolitically, as is obvious to those of us who can see.

I appreciate your letters to zoggies Lee & Goebel. You are wise in dealing with Lee in writing, only, for the stated security reasons, & I look forward to specific information about the RIP indoctrination course which replaced the former "Victim Awareness Education Program," which violated the U.S. Genocide Convention in regard to mistreatment of Whites. Your work is much appreciated, & I'm glad that it has generated favorable responses in so many areas. It's good to know that we have activists, rather than apathetic ZOG-zombies, in our society. As for Covington's "Migration Handbook," I do not recall if I ever received a copy, for none of its contents comes to mind. I do recall reading a page of Covingtonia which heaps fulsome praise on The Order & pledges undying loyalty thereto. This is totally inappropriate. Imagine putting out a brochure promoting western migration which includes praise & undying loyalty to Jesse James' gang during its members' lifetimes! What do you suppose that would achieve? Migration is legal, not secession, now, as it was then. Advocating armed rebellion is illegal now, as it was then, so we might ask where Covington has been since 1861. What is pathetic has become dangerous, thanks be to ZOG, at precisely the time HAC has labelled his advocacy as illegal, all by himself, thereby doing ZOG's job of unmasking his fiction. ZOG is emphasizing 'guilt by association', 'co-conspiracy', &c. in a context of "terrorism." According to a correspondent, the NSA is establishing a data base which links groups & individuals in contact with one another, as other secret police apparatus have done over centuries, without computers. Suppose that one of my correspondents was in contact with a CIA Al Qaeda member. ZOG could accuse me of "being in contact with Al Qaeda," even if I did not know about it. HAC feigns ignorance about postal procedures which have been in effect since the Post Office was established in Europe & North America. I recall his accusation that Metzger "gave" the FBI his mailinglist. Any government agency is entitled to record the addresses of senders & receivers in the mail, without opening the mail itself. This means that apparatchiks of the FBI, et al. can obtain anyone's mailing list without the permission of those using the mails. The same procedures apply to E-mail as to snail-mail. How much & what sort of contact is required to incur a charge of 'conspiracy'? Everyone who receives HAC's mailings has been informed in writing that HAC knows he is advocating illegalities. Does a 'comrade' unnecessarily endanger his 'comrades'? If so, why? This has been HAC's M.O. ever since I met him in Rhodesia. I must say that he is resourceful in his use of the mails to endanger those like myself who wish to maintain their distance from him & his activities! I do follow HAC's advice: I keep nothing of his on my premises to prevent a ZOG-seizure thereof. Hence, I no longer have his writings for reference purposes. What HAC does to himself is his business, but what he may do to others is their business.

Current photocopier technology is a KGB dream: for these 'smart' machines have memories. I discovered this when I removed my master from the machine after a paper-jam. When the jam was cleared, the machine made the number of copies I had punched in, WITHOUT the master! This means that authorities may access ALL material which people photocopy, possibly while copies are being made. For those of us who have no secrets, such technology does not matter, as it does for those who do wish to keep secrets. I guess this is what is meant by "an open society." Ha!

In many respects, this era is a 'parancia paradise', with myriad means of covert surveillance & miniaturized mischief-makers, combined with violent brutality. As one writer

2) feared: Imagine Genghis Khan with a telephone! That was his 'worst nightmare.' Yes, his forebodings are a bit dated. I asked a psychology major if a person who did not think he was important could be paranoid. He never got back to me on that. One professor of International Relations described how a person might become paranoid: Imagine that you are walking on a street in an unfamiliar city. It is getting dark, & the street is deserted. As you walk past a payphone, it begins to ring. Out of idle curiosity, you pick up the receiver, & discover that the call is for you! An Iranian acquaintance told me of the abundance of "spies" in Iran under the Shah & his Israeli-directed Savak (secret police). He said that all waiters & taxi-drivers were "ja sus," or spies. I understood what he was saying when I realized he meant "informers", rather than foreign agents. That's when I learned to say: "Amerikani ja sus nistam." ("I am not an American spy.") My Iranian acquaintance said: "Now that you can say it, no one will believe you!" I discovered that no one believes me when I say that in any language. Stating that one is not a spy is a no-win tactic, like proclaiming that "I am not a crook!" It didn't work for Nixon, either, & it didn't work for me as my train pulled away from the platform of the Bahnhoffriedrichstrasse in East Berlin, where my compulsory companions of The Interior Ministry waved at me. I waved back & shouted: "Ich bin kein Spion!" They just laughed. As I pulled my head back, out of the train window, a fellow passenger cautioned me: "Schluss mit diesem Spion Sache!" ("Cut out this spy business!") as our heavy 'east-locomotive' puffed into the night, as in a Grade B World War II spy drama. Warm-fuzzy feelings are made of such things (I guess!). It was 1969, & Mischa Wolf ran the Stasi or East German version of the Gestapo. As I understand, Mischa works with his kosher crony, Michael Chertoff, in our "Homeland Security" apparatus, where he should feel right at home, along with former KGB chief Primakov, as in a synagogue. FEDZOGUSA deemed the Stasi "a terrorist organization." Does this mean that it takes terrorists to catch terrorists? ZOG's logic surpasseth understanding, at least for dumb Goyim! No, Mischa, my camera which you could not find did not exist, & I am not a spy! Give my regards to Dr. Joswig, in any case, who I met in California.

ZOG pursues its 'equality' myth by seeking to punish Whites on a quota basis, so its Security Threat Group statistics match. Only then would the proportion of Hispanics jailed in Yakima be the same as for other counties. ZOG is sick unto death, so we should prepare for its inevitable demise. Conveying any respects is optional! One who attended the meeting of Olympian zoggies & Yakima County Commissioners suggested that the Hispanics could be divided into "Whites" & non-Whites for statistical purposes, since that's what FEDZOGUSA does, & the zoggie commissars from Olympia were feds, whose message was: "Equalize your offender population, or else!"
