

4 OCT 06. Dear Michael: Thanks for your letter of 28 SEP 06 & enclosures! Great pictures! You are wise to opt for formal proceedings, since the matter on which your grievance is based is on record. This would be no time in which to address the matter off the record. As you know, the ZOG is out of bounds when they deem an expression of love for one's own race to equate with 'hate' for other races. That is why they should be challenged to say, officially, if the use of Black, Yellow or Jew in place of White in The 14 Words would be 'kosher' with them.
