

22 NOV 06. Hail Daniel! Many thanks for your cogent letter of 8 NOV 06. Thanks for noting that I have not spent my life smoking rope, for I have tried to keep my mind alert, rather than inert. When Bush I checked himself into a hospital because he felt light-headed, I remarked to some acquaintances that 75% of the denizens of Brownest Yakima would PAY to feel light-headed. If you lack intelligent conversation with your gulag residents, then Yakima is no different from your place. This is why I enjoy corresponding with those who do think, & who have something to say.

Steve lives in Australia, so 'snail-mail' is functioning quite well, ZOG willing. I've conducted an international correspondence for decades, so as to break the jewsmedia information blockade, to some extent. Zoglines of news censorship run NS through the Atlantic & EW in North America. This means that 'news' in Europe does not get to North America & vice versa, & 'news' does not travel unimpeded between Canada alias China-duh & the Jewnited States. Some 'news', such as Yakima's TB epidemic, can't make it across the USA. I had to read The New York Times to find out that we had a TB epidemic here. In Soviet Canuckistan alias "Canada" I had to watch a Chinese TV news program to discover that demonstrators in Germany were trying to stop a trainload of radioactive milk en route to Holland for use as cattlefeed, after the Chernobyl Nuclear Disaster. The commentary was in German, so I could understand what was being said before the Chinese voice-over. This item did not appear on any other news service in Canada, to my knowledge. When I worked as a freelance journalist for OIGA Magazine in Lima, Peru, I had access to Reuters wire service, so I could read incoming & outgoing news in Spanish, my second language. I noted the relationship between financial news & political news right off. The jewsmedia in the USA routinely censor what comes over the wire services such as Reuters, Associated Press, et al. Important local news which has importance for other parts of the country is usually reported locally, & nowhere else, whereas, health news, such as our TB epidemic, is not reported in the locality most affected. This is why it took us normal Goyim 50 years to discover what happened in regard to Pearl Harbor. Thanks to the Internet, we have been able to learn the truth about our 2nd Pearl Harbor conspiracy of 9-11. The "Dancing Jew" article refers. Now we shall see what informed Goyim can do with knowledge, once it is thrust into their faces, but this window of informational opportunity may not be open very long, as other 'net sources & print media warn of B'nai B'rith (pronounced Ba'ad B'reath) machinations to censor the Internet. In all Zionist Occupied Countries, with the exception of the USA, thought-crime laws now apply. Thought-crime is specified as "hate speech," which, in practice, is anything jews hate for people to hear, even if jews are not mentioned. B'nai B'rith is the master Freemasonic lodge for jews only. It means "Sons of the Covenant." The Anti-Defamation League, which is the jews' version of the KGB in America, complete with hit-teams, works actively with the Mossad, or Israeli CIA. The ADL is a branch of B'nai B'rith, which should give you an idea of the hierarchy. This relationship was confirmed by Victor Ostrovsky, former Mossadnik, in his second book, "The Other Side of Deception."

Israel Identity, &c. was founded by British government propagandists to split Whites so we would go to war against our fellow Whites in Germany, just prior to World War I. As I gather, Angles & Saxons in Germany are dubbed "Judah," while Angles & Saxons in England are called "Israel," so by crossing 22 miles of saltwater, Germans changed their 'jewish' tribal origin! The first "British Israel" propaganda I encountered in Africa, from His Majesty's Printing Office, i.e. official Britzog propaganda. The late Pastor Miles also confirmed the origin of "Idiot Identity."

Politics is correctly deemed "the art of the possible," so form should follow function. Both sides of my family fought on both sides of the genocidal conflict known as The Civil War, & neither side was worth one drop of White blood. Most slaves, before, during & after The Civil War were White, not Black, & the first Black troops wore Confederate uniforms, according to Michael Hoffman's research from publicly-available sources, including Civil War era newspapers, & early reports on White slavery in America. His book, "They Were White & They Were Slaves" is merely the tip of the iceberg of White Slavery in America & Britain. Both slaves & masters were Christian, I should add. Nowhere is slavery condemned in The Bible. Jesus tells slaves to be loyal to their masters.

The KKK had 3 eras. The first, post-Civil War era was one in which Freemasonic discipline applied, under Union occupation. The KKK was called The Invisible Empire, for all its members were under cover, literally & figuratively. The robes were to conceal the identities

2) of the members of this underground terrorist organization, as well as to scare Blacks, especially at night. This KKK was officially disbanded by its founders after the withdrawal of Union occupation forces in the South. The 2nd era KKK was numerous & less disciplined. I recall seeing photos of a great KKK march in Washington, DC, in the 1920s, which should be still on record, somewhere. Lacking discipline, KKK members or those purporting to be members, pretty much did their own things, although their main objective remained White Supremacy over Blacks. World War II ended the 2nd KKK era. The third KKK era, as with the Communist Party, USA, was one of FBI infiltration. In Louisville, KY, during the housing integration/school integration program of the mid-1970s, locals told me how ZOG neutralized the KKK on the first days: all members were known, since most of them openly wore KKK robes going in & out of their homes, in broad daylight. The FBI intimidated members at work, as they intimidated their wives at home. Score: Non-Whites 100%, KKK zero. Infiltration also meant sabotage by agent-provocateurs, as happened to Pastor Miles' KKK-niks when a ZOG agent set fire to school buses. Do KKK jargon & costumes follow function as a White Separatist program? My answer is flatly, NO! Even David Duke abandoned the KKK in favor of his NAAWP, or some such, since KKK baggage of secession & White Supremacy failed to attract support from Whites who were not supremacists, nor secessionists.

Then there are the "Neo-Nazis" who like to dress up as German 1930 Stormtroopers. Once again, we see signs of another time & place. Would Hitler have adopted KKK robes in 1930 Germany? Would he have displayed the Confederate flag? What relevance would those symbols have for Germans suffering under jew-rule? As we say in Brownest Yakima: NADA!

When I promoted The White Power Movement in the mid-1970s, I suggested we use the White Race's symbol, The Swastika, on a red, white & blue background; that our uniforms be blue jeans, so we looked like workers or cowboys; that we wear white cowboy hats or construction helmets with the Party Emblem, plus armbands; that our footwear be workboots or cowboy boots. The blightwing reaction was negative. We looked "too American" in America, of all places! Moreover, we did not have delicatessen-accented accents like those jews who played Hollywood Nazis.

Blightwingers are fond of time-travel, but not of relevance in terms of people-power, that is politics. The jewsmedia were expressing concern with "The Star & the Swastika," but not the blightwing proponents of irrelevant regalia. Since Form Follows Function, our symbols must not only reflect reality, but enhance it. This is why Hitler adopted so much red in the banner he designed, as he wrote in "Mein Kampf": to infuriate the Reds. Did it work? It sure did! Why not have a U.S. flag with a big red Swastika in the square with all the stars? That would replace the Death Star or Star of David, which is most appropriate today, under ZOG. Things & concepts of the Past have validity, but what worked then is unlikely to work now, in this time & place. Time & place are important, as you know where you are, & as I know where I am, here in Northern Mexico, alias Washington State, whose White founders have always sought to deny fellow Whites a living wage. These are the traitors who hire the illegal aliens, & who brought in Black strikebreakers to replace White miners who sought a living wage for themselves & their families. These are not "elite," but scum, which also rises to the top. The moneyed class is also the criminal class in our society. As one professor of sociology said: "The dumb crooks go to prison. The smart crooks run the prisons." As Bakunin said: "Small crooks rob banks. Big crooks run banks." The USA is an example of the old British adage: "Why does treason never prosper? If Treason prospers, none dare call it treason!"

Life in Southern Africa was not one of racial separation, but one of racial intimacy. White Supremacy does not work. Whites must do their own work. As Cox wrote in "White America," a White civilization cannot be maintained without a White workingclass, & a White workingclass can only be maintained by paying wages sufficient for the White worker to support himself & his family. The USA was founded on the myth of 'cheap labor', which the tax-payers fund, instead of the employers. Our local 'cheap labor' has bankrupted Yakima County, in terms of welfare & criminal justice. This latter consumes some 90% of the county budget. As a White farmer told me upon my arrival in Rhodesia (now Zimbabwe): "There is no such thing as cheap labor." He was right, all over the world. As one local bumpersticker read: "If I'd known the trouble it'd cause, I'd have picked the cotton myself!"

Thanks for providing us with a forum for discussion. I hope it survives beyond January 2007, when the thought-crime laws are alleged to be enacted in this part of ZOG's empire. All the best & ORION!
