

9 DEC 06. W.N. Greetings, Daniel! Many thanks for your letters of 27 & 30 NOV 06, & the outstanding enclosures, including Separate Living. On the back page is a good likeness of my relative, Robert E. Lee, who revealed his true motive for engaging in anti-White genocide: his "dearest rights" (of property, power & profit). This was the basis for the founding of the USA, as well as the Confederacy. You note not one word about race. Whites must ask if the creation of the Bankster entity, the Judeo-American Empire, was ever good for Whites. Cornwallis prophesied to the Freemason, Washington, that "You will be back under the British Empire before you know it; (via Hamilton); you will destroy your nation in a holy war (the Civil War); & your religion will be Judaism, but you will not know it (the kosher tax on goods in interstate commerce)." Cornwallis was right, because the founders of the USA were minions of the jew banksters, all along.

Our ancestors survived, despite their mistakes, but many Whites were victims of our racial renegade policies, so they did not survive. Our ancestors were no wiser & no more honorable than we are today; we who have inherited their mistakes & the obligations which go with them. There was nothing noble nor wise in our behavior in America. There was only the great natural abundance of the land which allowed our follies & our mistakes, for we have been like a spoiled rich kid who plays with matches. When he sets one room on fire, he can just move to another room in his great mansion. The rich kid can despise the poor who have only one room in which to live, but he is too dumb or ignorant to know that his great number of rooms is due only to his wealth, not to his wisdom, & his stupidity will cause his entire mansion to burn down in due course.

Imagine that we could time-travel back to antebellum America: In the North we would see White wage-slaves; in the South we would see White slaves who lived worse than Black slaves. In both areas, we would see a rich minority of exploiters, many of them non-Whites. This is what we would see at the outbreak of The Civil War, predicted by Cornwallis. Were either of these areas' rulers pro-White? No more then than now. Why would we seek to romanticize such eras? It is certain that Lee's fellow Black & Indian slave-owners cherished those same dearest rights as he did, but why would we lie that Lee was pro-White? Lincoln was willing to kill all southern Whites in order to send the Blacks back to Africa, & the jews made sure he only accomplished the first step in his program: killing Whites. The jews still had use for their Black slaves in Judeo-America, so the banksters won the American Revolution & The Civil War, as well as all subsequent wars. The Whites lost, both in numbers & in territory, as the Judeo-American Empire expanded. I cannot romanticize wars in which Whites ardently & bravely killed their fellow Whites, for I am a White man & a White Nationalist. Those who do hark back to the Confederacy or The Continental Congress are not White Nationalists, but are the servants of anti-White powers.

As you & I have both said: If the past had been so good, why did it lead to the present?

Commander Rockwell accomplished with Third Reich regalia & uniforms what he set out to do in Phase One: Get the sheeple's attention. Phase Two was the establishment of a pro-White party. That was when he was assassinated.

I also agree that the public are thoroughly brainwashed in Pavlovian fashion by the jews-media. They are well-trained to switch off their minds on signals like "KKK", "Nazis," "conspiracy-theories," &c. It's much easier to judge a book by its cover, than to read the contents. Above all, Goyim fear the intense pain of THINKING, so they pay the jews to do that for them. Such a deal!

2) P.S.: Re the suppression of free speech in "Soviet Canuckistan" alias Canada alias "China-duh": Canadian Zionists got Canada's thoughtcrime laws passed in the late 1970s, as I recall, in terms of the so-called Genocide Convention, which is now the law of the USA in terms of the U.S. Constitution, for The Genocide Convention is a treaty, ratified by Congress. The same Zionist pressure group which suppressed freedom of speech & press in Canada (The Anti-Defamation League of B'nai B'rith) wants to do the same in the USA. In addition to criminal proceedings, Canada also has "Human Rights (Wrongs) Tribunals" for persecuting free speech, & civil suits for bankrupting free-speakers. One Canadian publication has shut down because of costly civil suits conducted against them by Zionists. In the USA, Tom Metzger was successfully bankrupted by the jew, Morris Dees, for publishing cartoons deemed as "incitements" to violence. Canadian Goyim said, "It can't happen here," in regard to loss of their freedom of inquiry & expression. When it did happen, they shut up. U.S. sheeple who manage to learn anything about suppression of the 1st Amendment in the USA say the same as did the Canadian sheeple. The majority are wrong, as usual, although I'd like to hope not. I am one fellow who hates to be right.

The sheenies choose to call "thoughtcrime" "hate." In Canada, Europe & Australia "hate", in practice, means anything Zionists hate, & "truth is no defence," as the law says in regard to "hate." All communications may be monitored & intercepted to detect "hate." The hebes are using kosher salami tactics with "hate" in the USA, by connecting "hate" with previous crimes, like assault, robbery, arson, murder. If a racial, ethnic or religious motivation may be construed against a White involved in a crime, (not a non-White!), then additional penalties are added to the crime itself, since it is now a "hate-crime." The Zionists want to make the thought itself the crime. This is typical Judaism, in which the thought is equated with the deed in Old & New Testaments. White men have a robust sense of freedom: think what you want; say what you want, but behave yourself! Frederick the Great said that he "refused to rule over slaves." He wanted free men in his kingdom. Not so with Zionists.

FEDZOGUSA has no definition for "Terrorism." It means whatever ZOG says it means, even if no overt act takes place. Words are equated with "terrorism," according to FBI Director Mueller. In the case of The Liberty City 7, their failure to denounce a ZOG agent to the ZOG, after he made "terror-related statements", which they heard, means that they face imprisonment for "terrorism" & "conspiracy." The NPA fulfills Mueller's definition of advocating "terror," so ZOG is biding its time to rope in those it deems to be NPA "terrorists" & "conspirators."

ZOG-P.O.W.s are already inside, but they are not exempt from being charged with "hate" & "terrorism". The Fort Smith "Sedition Trial" put members of The Order on trial, who were already inmates of the gulags. The latest jewsmedia report says that he is being 'tried' for undefined "Terrorism," without witnesses nor evidence. Bush II promised that would never happen to a U.S. citizen! Padilla was tortured, drugged & confined under cruel & unusual circumstances for over 3 years, as I understand. He is no saint, but nothing he could say or do, since his abduction & confinement, would justify his mistreatment under the U.S. Constitution. So much for 'our' "government of laws!" Like the Weimar money which inflated & just as suddenly deflated, words in the USA, which previously went unheeded, are now receiving an exaggerated value by ZOG.
