I read that Gapon was a police informer before the March on the Winter Palace, after which he fled Russia & became a Red. The account I read stated that Gapon was captured by Tsarist troops while returning to Russia with weapons for anti-Tsarists. E.T.

Political police have always used informers. Sometimes these become agent provocateurs, i.e. they incite others to crime then report them for it.

A.Ievno was one such agent of provocation.

While a.p.'s may exist in all parties the search for them can be equally destructive. E.g. ex-Confederate Action Party member Tony Pitt, on joining One Nation, wrote a 'How to Spot Infiltrators' report. Within 12 months he was expelled - on the false accusation of being an infiltrator.

Azev, Ievno (1869-1918) Russian-Jewish Social Revolutionary terrorist and police informer, b. Lyskovo, Nizhny Novgorod, father a tailor. Primary education only. In 1887 while working as a commercial traveller, he was distributing revolutionary pamphlets. Denounced by an informer he robbed his employer of 800 roubles and escaped to Germany and for a year attended Karlsruhe University among other Russian socialist emigrés. Soon destitute he was approached by an Okhrana agent and agreed to act as an informer on revolutionary exile activities. At the Okhrana's suggestion he later joined the \diamond Social Revolutionary Party. He won the confidence of his comrades in Germany, France and Switzerland and was so successful in enabling the Okhrana to make arrests by supplying them with information about SR activities inside Russia that he was called to Moscow and given the task of penetrating the top ranks of the Party. He did so, learned of a plot to assassinate Spyagin, Minister of the Interior, and to move the Party's secret press to Tomsk in Siberia. He informed the Okhrana of this move, thus causing the arrest of the militant SR leaders who headed 'Organization' (originally 'Organization for Combat'), the Party's terrorist wing. As a result Azev was entrusted with command of 'Organization' and successfully organized the \diamond assassination of Spyagin and of Prince Obolensky, Governor of Kharkov. At the same time his information was enabling the Okhrana to make numerous arrests of SR militants and Azev was made directly responsible to the new Minister of the Interior, Plehve, whose assassination he master-minded successfully. He was instructed by the SR Party's 1904 Congress (Paris) to organize the assassination of the Tsar's uncles, the Grand Dukes Sergei and Vladimir. He succeeded in the case of Sergei, Governor of Moscow, but failed in that of Vladimir. In April 1905 he defeated an attempt by the Party's leading ideologist, Chernov, to persuade the SR Party to abandon the policy of \diamond terrorism. He also talked his way out of an anonymous denunciation of himself, 'Comrade Valentine', as a police spy, and when arrested as a terrorist by a new Chief of Police in St Petersburg, talked his way out of that by invoking his record as a successful counter-revolutionary agent and by revealing the names of the assassins of Father Gapon who, following the Winter Palace massacre of demonstrators on 9 January 1905, had turned police informer. Azev himself had organized that assassination. **

When called on to procure the assassination of the Prime Minister, Stolypin (1905) Azev informed the Okhrana of the plot and had all the conspirators ostentatiously 'tailed'. He used this state of affairs to suspend terrorist activities for the time being but when the Social-Democratic 'Maximalists' blew up Stolypin's house, Azev was relieved of his job as head of 'Organization'. His successor, Zilberberg, however, consulted him as an expert, on a plan to assassinate both Stolypin and the St Petersburg Chief of Police, von der Launitz. Azev warned the Okhrana; Stolypin changed his plans and was saved; von der Launitz ignored the warning and was killed. Azev received a bonus of 9000 roubles from the Okhrana in the same week as his election to the Central Committee of the SR Party.

In 1908 Azev fell in love with a young dancer, and deserted his wife and children to live with her. This lost him the confidence of both the SR Party and the Okhrana. For years he had had control of the Organization's very considerable funds and as he had always managed his assassinations and other terrorist activities economically, he had a large amount in hand. With this and his savings from his Okhrana salary and bonuses, he took his mistress abroad. They lived a hunted life, moving from one country to another, for the SR Party had discovered his treachery and were bent on assassinating him. His money ran out, his mistress deserted him and he died, destitute, of a kidney disease in a Berlin hospital (April 1918).

The Liberty City (FL) Seven were Black Moslems who listened to a zoggie who claimed to be an Al Qaida agent. By not denouncing the zoggie to the ZOG, they have been charged as "terrorists" & "co-conspirators." ZOG refuses to define "terrorist" & "illegal combatant." The lack of definition enables ZOG to zap anyone they want to, regardless of what a person says or does; or doesn't say & doesn't do. You're condemned if you do & condemned if you don't. In the ongoing case of U.S. Citizen Padilla, the zoggies grabbed him in Chicago & leaked various accusations to the jewsmedia, which were dropped from Padilla's charges & now are denied by ZOG. Padilla was locked up in solitary for 3 years & was tortured, so it now appears he is unfit to stand trial. So far, the zoggies have laid no charges against him, which makes for a most peculiar trial, if one occurs. So here we have a U.S. citizen who is accused of nothing, but has been abducted, confined & tortured for 3 years without being charged nor tried for anything. The Padilla Case proves that The Bill of Rights has been abolished by the ZOG, without notice. So much for the lie that "we are a government of law, not of men." This case is a very dangerous precedent, for what has been done to Padilla can be done to any U.S. citizen.

So, at present, we have in the USA Arab "terrorists," & Black Moslem "terrorists." But ZOG needs White Nationalist "terrorists." I believe, on the evidence, that Covington's job is to supply ZOG with White victims who may be accused of being "terrorists," "illegal combatants" & "co-conspirators." Since he sought to implicate me in terms of ZOG's precedents, I have denounced him to the ZOG. Their reactions were quite revealing. Here is a fellow who advocates armed rebellion & secession from the USA. FBI Director Mueller declared that such advocacy is "terrorism", as occurred with The Liberty City 7, who listened to such advocacy & did nothing. The local FBI zoggies actually hid out from me on my 2nd visit with more evidence for them & Homeland Security behaves as if to say, "So, what else is new?" This indicates to me that I have discovered a ZOG plot designed to rope in anyone connected with Covington. Can I prove that I have done my ZOG-required duty in regard to Covington? I have just done so with this letter, which is now a matter of public record.

Covington pulled a similar stunt in Rhodesia, for which I was brought into court, but I intend to foil him this time. As they say, "Fool me once; shame on you. Fool me twice, shame on me!" I recommend you turn over all Jeff Hughes' items to your zoggies & disavow any & all connections, affiliations & sympathies for his group for your own protection. The same applies to contacts with Covington. Now is the time to go on record that you reject "terrorism," "co-conspiracy" & the status of being an "illegal combatant." Publicity is our best protection in this matter.
