- * Gives the Secretary of Defense authority to deviate from time-tested military justice standards for fair trials "

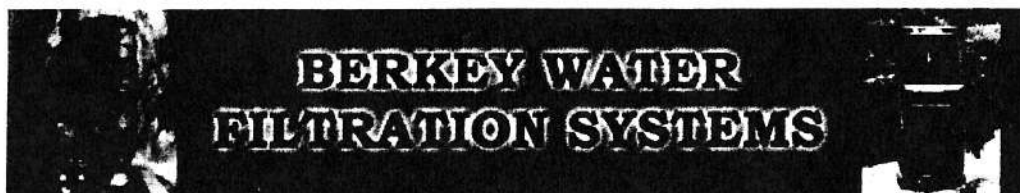

13 FEB 07. Dear Michael: Many thanks for your mailing of 10 FEB 07! If I ever need to submit legal brief, I shall hire you. Laymen think that legalese is too wordy, but it is an art to cover all the bases in as few words as possible, as when we "swear to tell the truth, the whole truth & nothing but the truth," unless our previous Kol Nidre jew oath frees us from that obligation. Then the rule is "catch me if you can." I have seen jews caught when lying under oath in cross-examination, so jews must learn to keep their lies straight, as one defence attorney said in the testimony of "Rudolf Vrba" alias Rosenberg alias whoever he may have been, for his I.D. appeared to be the product of a big kosher lie-factory. Had I not witnessed the proceedings, I'd not have believed that such a travesty of justice was possible. Vrba testified that no one who'd seen Auschwitz ever left alive, unless they escaped, as he alleged. But what about the other 4 jew witnesses who said that they'd been there & were transferred out, usually to war production plants in Germany, as was Sabina Citron, formerly Winter, head of The Canadian Holocaust Remembrance Association? Her testimony, alone, would have debunked the Holohoax, so she only testified in the preliminary hearings. The 4 jews who had testified before Vrba were obviously alive & well, but they hadn't escaped the clammy clutches of the Nazis, so they were really all dead, if we believed Vrba. The dumb Goy jurors believed all jews in the court. As such, they proved that they were mental defectives, so a retrial should have been ordered. Our defence attorney should have called for an adjournment to put this fact on record: that the jury must be able to decide who is dead or alive & therefore, who is lying under oath, for it was so blatant.

The Holohoax reminds me of your Brian Maguire, who seems to be an O'Brien wannabe. As I recall, O'Brien was Winston Smith's torturer in Orwell's "1984." In my years of Holohoax research, I discovered that LACK of evidence is deemed 'proof.' The Katyn Forest Massacre by jews of 10,000 to 15,000 Polish officers, under Stalin's orders, in 1940, was proved by the number of corpses buried in Katyn Forest, on Soviet territory, NOT by allegations of thousands of 'survivors'. I have seen both documentaries on the exhumation of the NKVD victims: the first which was made by the Germans, with Red Cross witnesses & the second by the Soviets, who blamed the massacre on the Germans, their 'proof' being that there were no German forces in the area when the massacre occurred. The official International Committee of the Red Cross ignored all massacres on Soviet soil, since the USSR did not recognize the Red Cross. I was amazed that the Red Cross would deem all inmates of the Soviet Jewnion to be "non-persons", but that was their position. When lying Red Cross witnesses were caught on the witness stand, they immediately retracted their previous lies. Their head honcho in Toronto claimed, under oath, that "the Red Cross kept no statistics." Our defence attorney, Doug Christie, showed him an official Red Cross report & asked him what those numbers were. The Red Cross liar admitted that they were indeed statistics. Since the Red Cross sold contaminated blood, thus infecting hospital patients with HIV, & since it lied viciously about the Germans & the Holohoax, I would not donate a drop of sweat to their racket, let alone a drop of blood.

These contradictions apply equally to Mr. Maguire who believes that "good behavior" is the sign of a prisoner's evil powers & machinations. Let's use White man's logic: If good behavior indicates criminal activities, then it would be best to lock up all people who are not already in prison, since they must be big crooks! But if Maguire believes his own allegations, he should kow-tow to you in abject servitude, since you are allegedly empowered to rule the prison with your advice, favors & punishments. My suspicion is that Maguire does not believe his own statements. I asked one Holohoax 'survivor' why he was alive if the Nazis killed "all jews" in their custody. I asked him what he had done FOR the Nazis to be a 'survivor' of 4 years of Auschwitz living, while others were allegedly "gassed on the spot" as soon as they arrived, & the others were "worked to death as they starved to death." One jew accused that jew of being a Kapo or jew overseer of camp inmates. I left before the jews started fighting amongst themselves. Kapos received better rations & accommodations than did regular inmates, who most often did not justify their upkeep under any regime. The jew, Lenin, called such people "useless eaters," shortly after he put Marxism into reverse, by declaring: "Those who do not work shall not eat!" His reversal of Marxist doctrine was on par with the New Testament reversal of Old Testament tribal predation & exclusivity, but like the Goy jury members, Russian Goyim swallowed "Marxism-Leninism" along with Old/New Testament idiocracy.
