

24 FEB 07. Dear Michael: Many thanks for your letter of 18 FEB 07! I see you are doing the ZOG-samba alias diesel-therapy, so you have a new address. It appears that I am receiving your mail, but you have not been receiving mine. I received one notice on pink paper with extremely faint entries to the effect that I had sent you "too many copies of something," but the zoggies have not returned the material. Apparently, a number of news items on a single page is forbidden, as "too many newsclippings." ZOG-gulags all have different & arbitrary policies in my experience, for some things are permitted & others not. The only consistency is meanness, for I try to abide by ZOG rules, for everyone's benefit, but I get regular surprises. I understand that thought-cops don't like to read lots of material, so I try to keep my mailing quantities to a minimum. One zoggie complained that my envelope was "too big." It was a #10 business envelope with 3 oz. of contents. Another refused to approve a photo of WW I soldiers as "portraying gang activities!" I was prompted to insert a note to all gulag correspondents: "Avoid gang activities. Don't enlist!"

I received your PRP work in good condition & I replied that I would retain it for you, until you otherwise instruct. I guess you did not receive that letter, either. I have mentioned to correspondents that you must have outside back up documents to preclude ZOG-thefts of your legal documents. Bad zoggies!

Yesterday I received your excellent letter to Brian Maguire dated 9 FEB 07 re Records & Paperwork. It appears that they blamed you for 'persecuting' them with their own red tape. Zoggies can dish it out, but they can't take it. My impression throughout these tedious proceedings is that you are as true to your principles as you stated. You have nothing to hide, & you have conducted yourself honestly & honorably, as distinct from the behavior of your zoggies. It seems that you have learned, but the zoggies have not, as I gather from their attempt to intimidate you in your new location. Bad play, zoggies!

I am prepared to send single-sided copies of your documents to all those listed, but I advise to wait until you are more or less settled, for a new location may resolve all the grievances stemming from your previous location in Gulagland. It may become a matter of addressing past injuries, rather than present ones, which were ongoing in your previous location.

"Forced Integration" is really cultural persecution, alienation by association, &c. which definitely is a form of cruel & unusual punishment. ZOG knows! Apparently, ZOG panders to the 'fashion needs' of non-Whites, rather than their actual body sizes, as you've discovered. I hope the U.S. Armed Forces do likewise, to assist their enemies to catch their thugs more efficiently. Another aspect of "forced integration" is the imposition of Turd World living standards. Apparently, it's up to Whitey to clean up after the Turd Worlders. It's also informative that zoggies punish Whites for not doing janitorial jobs created by non-Whites' filth. The ZOG rule appears to be: Muds crap & Whites clean up, or else. The more I hear of ZOG practices, the less I would be willing to defend ZOG interests in Iraq or anywhere else. The idea of punishing one for another's infractions is quite Jewish: punish the innocent; not the guilty.
