26 June O2. During the absence of Ernst and "Anne Burton", his jewish dominatrix, I got a telephone call from Eileen Pressler who was present at the series of meetings. It was she who told me that Ernst was going to 'fire' me upon his return, but that I could work on Eileen's Christian farm as a Goy serf, so there would be a place for me. I therefore caught a ride back to the U.S.A. Not being a Canadian citizen put me at the mercy of any informer who would tell CANZOG that I was working 'illegally', so there was no security in merely leaving Toronto for B.C. This letter was on top of the mess on Ernst's work table, and I suspect he found it before he or "Anne Burton" wrote a newsletter accusing me of being an "infiltrator". It is my considered opinion that Ernst is now under the domination of Rimland (er), and that all indications point to her as another jewess. That's why I do my duty as a White man, and I say to other pro-White Whites, Bewere of Goy frontmen who pose as White leaders. Such creatures wasted the White man's time in Southern Africa, and we have no time to waste anywhere on Earth. ORION!

Dear Mrs. Miller:

Cur mutual friend, Günter Wild, sent me a copy of your justifiable observations on Ingrid Rimland-Zündel. I worked closely with Ernst from May 1976 until May 1991, so I probably know him better than his wives, in terms of his stated goals and his projects toward achieving those goals, if any. I admired Ernst for his creativity, but the negative side was his changeability in regard to his real values. I worked with him because I believed he was pro-White. I said at the beginning that the Lie of the Holohoax being used against Germans today will be used against all Whites tomorrow. To this end we made a video film entitled "Genocide by Propaganda," 'starring' the jew, Ditlieb Felderer, myself and the possible jew, Zündel, who was very much under the influence of his jewish mistress and dominatrix "Anne Burton."

Over the years, I saw Ernst change directions. Instead of thinking in terms of 'we,' he began to think in terms of 'me.' Toward the end of our collaboration, he announced to witnesses, "I am the Cause!" He would tell his activists and supporters that the great amount of donations made to him, on behalf of the Cause of Truth, Freedom & Justice, did not belong to the Cause, but only to him: "It's mine, all mine!" he would boast. This negative change became more obvious after we won the second Holohoax Trial in The Canadian Supreme Court, which abolished the law under which he was tried.

Since I was loyal to the Cause, I was 'exiled' internally. I no longer was allowed to use my talents as a writer, but only as a wrapper and shipper of books which had come from Europe, to be sent to addresses in Europe, where the book shipments were often refused and sent back. Thus I was condemned to wrap and ship the same books once, twice and even 3 times. My letter of resignation refers.

Ernst quickly alienated his most active supporters in favor of "Erbschleichen," in which he appealed to aged donors to include Ernst in their wills. When Mr. Cotter willed him a substantial sum of at least \$100,000, he decided to take the money and run. By that time he had his relationship with "Ingrid Rimland." I use quotes, for no one seems to know her real name, exactly as in the case of "Anne Burton," who used her husband's name, and most likely, another name than the one she used during World War II, when she allegedly worked in the British Imperial Typing Pool, as supervisor. Her wartime name was "Mitzie." The present Mrs. Zündel has used several different first names: Sarah, Ina, Angrid and now Ingrid. As I understand, Rimland was her first husband's name. It appears that The Zündels wish to define "German" in terms of Count Coudenhove-Kalergi: mongrels all living in "German-Culture."

Although I wrote "The Hitler We Loved & Why," E<sub>r</sub>nst got the money. Ingrid calls it a "dirty little book," according to a correspondent. Rimland's claim to fame is her "Demon Doctor," her Nazi-hunting story describing the South American antics of "Dr. Mengele," in her eyes or imagination. According to INSIGHT, Ernst renounced all his pro-White views when the FBI interviewed him, when he applied for admission into the USA.

I have noted over the years that the U.S. Government was diligent in its enforcement of Canadian thought-crime laws, which were illegal in the USA, at the time. Ernst was not allowed into the USA, even as a visitor, but suddenly he was, for a time, until his surprise deportation. I believe Ernst was set up by Rimland, who enticed him into a Zionist trap, from which she profited as his wife and heiress. What a waste of supporters' funds!
