

12 MAR 07. Dear Mrs. Miller: Many thanks for your letter of 6 MAR 07 & your generous enclosures! I read the article on "capping," which you indicated. It reminded me of earlier movies like "They Live" & "Clockwork Orange." Ernst resembled a subject of capping when his jewish dominatrix, "Anne Burton", was hovering over him. I understand that she approved his marriage to Irene, whom I never met. Irene denounced him in her testimony at a Zionist "human rights tribunal" in Toronto. I read from various correspondents who attended the tribunal proceedings that Irene claimed Ernst was affiliated with Timothy McVeigh, through a fellow named Mahon. To the best of my knowledge, Ernst would never assist nor conspire to blow up buildings. I wonder why Irene would be so malicious.

I appreciate your information that Ernst wanted to quit the Holohoax business, not knowing that he could not quit, for the reasons you state: the jews. I don't capitalize "jew" for the same reason I don't capitalize "criminal." Jews are not a race, not a religious group, not an ethnic group (since they come from everywhere, so they are ^{not} an identifiable group in terms of the Genocide Convention. That argument won us back our Canadian postal privileges in 1982. When the jew attorney at the postal tribunal, Mr. Greenspoon, objected, he said: "Jews are certainly identifiable!" A delegation from the postal tribunal marched into a typist's office next door & borrowed her dictionary. Greenspoon brought it into the hearing room in triumph & read the definition of "jew": (1) Noun, A creeping plant; (2) Verb: To cheat. Greenspoon let out a shriek like a vampire threatened by a wooden stake, & threw the dictionary across the table. The Freemasonic members of the postal tribunal could hardly keep from laughing, but we did not. A good laugh was had by all Goyim present, although there weren't many of us, because Goyim have to work, & jews do not. After helping to win back our postal privileges I was thrown in the Toronto Don Jail for 2 weeks on immigration charges, which I won without difficulty. My female attorney, Lynn McCaw, suffered consequences: her son was kidnapped, & she was forced to leave Canada, to live in Scotland. An Interpol contact informed me that I could return to the USA whenever I liked, because "They are all dead." He meant Nixon, Nelson Rockefeller & FBI Director Hoover.

I am a long-time student of International Relations, as well as a practitioner. I've participated in 2 civil wars, one in South America; one in Africa. I have been deported from a present total of 5 countries: USA, Peru, Sweden, East Germany & Rhodesia, because of my journalistic activities. When I was in Toronto, fresh from Africa, in 1976, I met Ernst who told me of his political ambitions, which were considerable, having run against Pierre Trudeau for Prime Minister of Canada, &c. He told me of his pro-White, anti-Zionist views, & invited me to collaborate with him, which I was happy to do, for those were my own views. I warned him in 1976 that if he were to embark upon this course of action, there were certain risks: the least risk would be death; the greater risk the loss of one's loved ones. I said to Ernst that neither of us had solid legal status in Canada: I was a visitor. He was a legal resident & landed immigrant. Both of us could be turfed out of the country on the whim of its Zionist Occupation Government or ZOG. I spoke from experience. Ernst ran to his jewish 'mama', "Anne Burton," & told her what that awful Eric had said. According to Ernst, she said: "Eric wants everyone to live out of a suitcase," for I had told Ernst that, if the authorities were nice, they might let you take a suitcase of your belongings with you into exile. This was an example of "Anne Burton's" jew-jitsu with Ernst's brain. She could reprogram his memory of events he'd witnessed & participated in. I told Ernst that I would respect his wishes if he decided to quit, but he never told me he wanted to quit. Instead, he sought to obtain more & more donations on behalf of a cause he, apparently, had already betrayed. That is dishonest & dishonorable. Ernst made lots of money as a photo-retoucher, so he didn't need to look for a different career. His attraction to politics (people-power) was like the attraction of a moth to a flame, I suppose. As you say, he is a martyr by default, so he can still serve the cause he fled from. Ingrid will exploit the hopes of those who believe in The Cause of Truth, Freedom & Justice, as I predicted, so she can line her own pockets & decorate her bosom with gaudy baubles, much like any jewess on the make.

Your letter-writing idea sounds worthwhile, but local politicians tend to ignore letters outside their jurisdictions. As you say, keep the message short & simple!
