Re: Reminder about unanswered PDA requests

Dear Ms. Wilson-Kirby,

Below please see PDA file numbers of five unfulfilled requests for the Public Disclosure of documents. I am treating the lack of response as a refusal and hereby appeal.

KWK.CLA06-125A, last correspondence from you, dated Nov. 16th, 2006, requests the documentation surrounding the establishment and implementation of the RIP program at Washington State Penitentiary.

KWK.CLA06-126A, last correspondence from you, dated Dec. 29th, 2006, requests a copy of my Major Infraction hearing appeal in hearing #10087 at WSP.

KWK.CLA06-126B, last correspondence from you, dated Dec. 29th, 2006, requests documents that show which "recognized security threat group" is symbolized by "photograph of Adolph [sic] Hitler with a swastika and [...] Nazi soldiers with banners and swastika symbols..."

KWK.CLA06-126C, last correspondence from you, dated Dec. 29th, 2006, requested "all documents WSP [was] using to classify me as STG affiliated."

WSP PD 634, last correspondence from Joni Aiyeku, dated Dec. 29th, 2006, requested policy protocols and records pertaining to (1) inclusion in and removal of documents from my central file; (2) the document that records each time my central file has been reviewed by someone other than myself and by whom, (3) documents describing the identity of persons removing documents from my central file, and the subject matter of those removed documents; (4) the list of documents in my central file unavailable for my inspection; and (5) the document describing the protocol for how I may contest the veracity of information in my central file, and thereby amend any inaccuracies.

The first four file numbers cited above were the subjects of feigned loss by Joni Aiyeku and therefore not treated as appeals. To date, I still have received no response on the subject matter of any of the above requests. I therefore appeal (again?), because none have been denied, just ignored.

\*\*I would like to add that I was threatened by WSP's CPM Brian Maguire (with placement in solitary confinement) regarding my being the source of inordinate requests for records. Because of those threats, I have delayed appealing until now, after having secured a de-facto separatee from the administration at WSP.
