

4 April 2007 Dear Eric, Received yours of 28 March, postmarked 30 March, on 3 April. Enclosed was cover b/w 'solitary confinement;' 26 March to Jason b/w 'Adios, White Argentina'...; 3/9/07 from David Lane on England..; 2/18/07 from BBC re "John Frum" (ha!); 8 March to Douglas b/w 8 March to Jason; 9 Jan.'04 from NYTI on 'Gringos and old Grudges'; 3/8/07 from Henry Makow b/w 'Alice in Lampshade Land'; and the TBR blurb on Masonry. Thanks again!

A different legal standard embraces the outgoing mail of US prisoners, known as *Procurier v. Martinez*. The incoming mail or property standard is *Turner v. Safley*, which is slightly stricter, but less so when the material bears religious significance (then it falls under the "strict scrutiny" standard of the RLUIPA, which John, et al, won from the Sixth Circuit). The Memorandum on Religion and Literature in DOC refers. Re favored groups and religious expression, I wear a Thor's Hammer, as an honorarium for my service for White rights in DOC, and because 'Two Seedline,' my faith when forced to identify it, embraces all homogeneous elements of White culture. We believe portions of the Danite quadrant of Israel, represented by Asher, Dan and Naphtali, settled Scandinavia circa 1600 BC. Okay, when the judeos wear their crucifii exposed, they are left unmolested by staff, as would be the kikes, had they the courage to wear their jew stars of Moloch (some niggers wear these as BGD "Black Gangster Disciple" gang indicia). However, Whites in prison must not wear their Thor's Hammers exposed. I point out we have 'freedom of religion,' not 'freedom from religion.' If pressed I will lobby for swastika medallions (which we believe represent Christ and natural order), as the equal opposite to jew stars. Go ahead and send the PRP documents, hopefully reducing all the double sided exhibits to single-sided. I hope you can distinguish between exhibits and work product, which is basically research notes and such. Go ahead and retain the Hardebeck appeal, forwarding it to John would be a good idea. Eventually, we're going to need a stamp in red ink stating "PUBLIC RECORD" so that these items can be sent back in. It's necessary to point out to zoglins that these are public documents disclosable under RCW 42.17. They will feign concern over other prisoners' privacy, while intending to stifle the free exchange of information designed to enable prisoners to overturn frivolous STG allegations. If it ever becomes convenient for you to get an estimate of the cost for having such a stamp made, please do so. I will forward the proceeds from another legal contract in your direction to recoup the costs. For now, I'm going to send a few of these John's way, and see if we can liven up LibRA with some financial contributions.

I remember the brief to-do about the racial inequity in hispano mestizo jail population, in Yakima or Benton / Franklin counties. Brought to light around January 2003.

I believe you have received my new and final PDA request perfecting the factual base for the forced integration essay. I enclose another if I neglected to send one. Please forward it to John. Also see the enclosed 'Official Misconduct' complaint form I made from perusing the statute. Another arrow in the quiver of oppressed Washington prisoners. The only two remaining ethics commissions, Executive and Legislative, are reflected in the "To" list on the Official Misconduct form. They are legally obligated to investigate complaints of misconduct against DOC employees. They may delegate downward to Clarke or Cedeno, but they remain liable for claims. See also the crescendo reached in the appeal to Kay Wilson-Kirby regarding records they're loath to give me which establish there's no link whatsoever, per se, of connection between STG and swastikas or Hitler. They'll also be busted for fiddling with my central file, and will be responsible for identifying a means for correcting the maliciously false information included in my central file by the kike, Donald Holvevinski. I will also develop a dummy PDA suit format and lodge it with you.

I need legal representation to recover damages for malfeasance by DOC and/or Dr. Sung re my eye care. It boils down to: (1) did Sung give orders in writing to DOC requiring weekly TOP monitoring; (2) did Sung order ongoing continuation of eye drop prescriptions past the date when the prescriptions expired? I was left without meds for about three months, thinking they were unnecessary. New Doctor says much of the current damage is the result of that lapse. Presently, there is silicone smeared all over the lens implant and a buildup of residue is on my retina, resembling scar tissue, but removable in the doctor's opinion. Trouble is, field has closed due to pressure spikes, and any operation will likely cause more pressure spikes, possibly resulting in total blindness. So, I'm going blind because they're afraid of making me blind. I'm going to ask for a second opinion from the University of Washington School of Medicine. Why do I feel like saying 'Yeah, right!'

Asatru prisoners have already made the link to Odin and my eye problems, and not necessarily jokingly.

Boy Scouts of America v. Dale, a US Supreme Court decision, rules the right of cultural expression necessarily included the right to exclusivity as part and parcel of the right of expression. Society will collapse before the kike judiciary will allow pro-White case law to develop along those lines. Nonetheless, we will advance those interests.

Re Jason, I'm fascinated to know there are still Creators after the Benny Buttfuck debacle. Truly, the message is more important than the messenger, and not dependent on the messenger's character.

David Lane seems back to sanity with the essay against internecine strife. I think he went temporarily nuts over his breakup with Katya.

The BBC cargo cult gives one the Heebie-jeebies, doesn't it? Is it all just wishful thinking and the application of 'engines-of-state?'

8 March to Douglas is another one of those great primers I'll have to send out to supporters. Its reverse to Jason clears up some misconceptions about WWII, but may be a little convoluted for beginners to follow.

The 'Gringo' whine is as relevant today, or more so, than in 2004. Will let people know why what's happening is happening, from one angle anyway.

On to Makow the 'change agent.' Hitler displayed evidences of far too much altruism to be a knowing pawn in the rise of the Reich. His photo in Jan/Feb '99 Barnes Review, page 69, says it all. Rapt in enthusiasm and projecting an aura of cooperative, encouraging leadership, while mulling over parade plans for Reich Day 1935. Nostalgia for Hitler isn't dimmed by the possibility that he was allowed to rise to power as some counterpoint in Zionist machinations. It is, and will continue to be, the result of his open and obvious and consistent altruism and enthusiasm in promoting the welfare of Whites at the expense of no one else.
