Penitentiary officials have an affirmative obligation to get my legal work back: "Affirmative obligations are imposed on the state to assure all inmates access to courts and assistance in preparing and filing legal papers." Petrick v. Maynard, 11 F.3d 991 (10th Circuit 1993).

Prison officials are not entitled to 'qualified immunity' from liability for failure to return a prisoner's legal papers: "Reasonable officer would have known that siezing [..] papers prepared on benalf of another inmate from prisoner's cell was unlawful, so that prison officials were not entitled to qualified immunity." Newell v. Sauser, 79 F.3d 115 (9th Circuit 1996).

An avenue must be made available to me to retrieve my legal work, this is clearly established law!: "Penitentiary's failure to provide for return of inmate's legal documents when jailhouse lawyers were transferred to another unit, violated inmates' right of access to the courts." Goff v. Nix, 113 F.3d 887 (8th Circuit 1997).

Despite internal rules and regulations, my legal work must be returned to me: "Internal agency regulations cannot legitimize the violation of Constitutional or statutory rights. <u>U.S. v. Morole</u>, 173 F.3d 1213 (9th Cir. 1999).
