

13 April 2007; Dear Eric, received yours of 8 April, postmarked 09 April, on 12 April, containing cover b/w form which has secured legal work for WSP prisoners 3 times, after passing scrutiny of their Legal Liaison Lori Scamahorn; 30 March to HQ re PDA appeal b/w new request; our new Official Misconduct form; Impeach George Bush b/w CIA torture graphic; 4-4-07 to Tom b/w your excellent Profits Versus People; Ace of Spades article b/w Jefferson Jewish? article; Ota on "jews" and Israelism b/w Renewal p. 3; and Rense's US Visa blurb b/w the Excellent AZA query. Delayed sending response on reverse -- dwindling resources.

Re religious emblems, I don't even like calling them "religions", but enthusiasms for periods in history, and our allegiances to participants therein. WTL on Odinism, enclosed, refers. Please read, copy for anyone interested, and return. There are no P.O.W.s in WSP that I know of, and we draw a very specific distinction between (1) Political Prisoners, (2) Prisoners of War, and (3) Student/Enthusiasts of WN. A P.O.W. is someone whose crime of conviction was in the process of furthering the White Cause. Not even I qualify as a P.O.W., even though I co-founded the White Student Union at the University of Minnesota, engaged in meetings, demonstrations and one riot there, was the chief officer of the largest Invisible Empire Klavern in the state of Minnesota, ran an autodialer project there, ran a separate Aryan Hotline there, and was subsequently a resident congregant at CJCC Hayden Lake, then subsequently Security Chief there from the '93 AWC until Halloween '93. Don't call people P.O.W.s unless they provide paperwork about their crime of conviction confirming it was in furtherance of White Rights! Cc: John on this! If that's who I think it is calling himself a P.O.W., he approached me in the Spring of 2003 with the proposal that he sell dope in prison 'for the cause.' I told him specifically that no good could come of it, that any funds accrued thereby would be 'blood money,' and that we didn't need that kind of reputation. If he persists in calling himself a P.O.W., he's going to have problems with me. My charge of first degree murder (on an armed victim) and a weapon enhancement, sans any consideration of my political and religious views, would probably have been manslaughter for seven years (with zero prior sentencing points) and maybe an enhancement for five. I'd be nine into a twelve now instead of nine into 25. And again, I am not a P.O.W.!

Re the rubber stamp, have you experienced any problems sending exemplar documents to other prisoners on how to do PDA requests, how to appeal them, and such? I would like to see all WN prisoners working toward proving ZOG gulag administrators are lying about what is and isn't STG. For this reason, I think my documentation may be helpful to others. If there have been any hinderances, it would be both helpful and appropriate to remind gulag mailroom zogstituents that these are PUBLIC RECORD and not inmate-to-inmate correspondences. If we have experienced no problems thus far, then it's unnecessary. And using only the reminder of its being public record will both keep costs down and prevent any accusation that we're defrauding or misleading prison mailrooms. Let no allusions be made that we're misrepresenting ourselves. That's the last thing we need ZOG pointing to.

My treatment probably falls short of torture, and I doubt it was deliberate. More likely it was just astonishing incompetence over and over again with respect to medical procedures and follow-up. I consider myself paranoid at times, but even I would have trouble thinking all this was orchestrated by some unseen hand -- although I am notoriously proficient with firearms, and am right-handed.

I think the current Angela Davis situation is the perfect opportunity for us to point out the double standards re inclusivity / exclusivity and substitution of terms (which I intend to make the standard of review) re White, Black, jew. I'm the first one signed up on the Angela Davis speech here in my unit, so they'd be hard pressed to justify denying me attendance. Most likely, they'll schedule some frivolous (?) call-out for me at the same time as the speech. Just watch!

COTC didn't draw more than 30 members to its regional shinding in Montana in '93. Anna M. sent me photos (with Jason and Melody?) In one of the photos was a nigger seig heiling! Story was that his White mother was either raped by or submitted to a black man who he hates for causing his (the COTC member's) mongrelization. Maybe 10-15% of WA prisoners look like David Matthews. Would love to see statistical analysis of the behavioral impact of mongrelization. From direct reliable and repeatable observation, I can state that behavior-genetic racial behavior tendencies increase and decrease in direct proportion to one's ancestry. The prison microcosm is the perfect place for such observation. I'm sure your observations over the years coincide with mine. Our detractors will claim we're bringing our prejudices to the observation. 'Postjudices,' more likely. Another formal entry into the lexicon: postjudiced. Even Ota cites Israelism as being a religion of racial purity. Any religion which requires racial purity for Whites is not at cross-purposes with our aims. What everyone knows for sure is that today's self-styled jews are mongrels containing black, White and yellow admixture. DOWZ & ORION!
