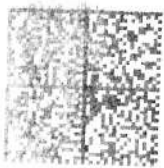

14 APR 07. Dear Michael: Many thanks for your mailings of 6, 9 & 11 APR 07! I am impressed to learn that the Black Racist-Marxist leftover from the sick sixties will be deemed kosher to purvey her Black Stalinist Wisdom to the benighted inmates of your ZOG-gulag. I wonder why your zoggies have restricted similar information from La Raza, which I received from you in your latest mailings. If I were to send you Black Nationalist propaganda, would that be acceptable, or is any such information coming via me the grounds for restriction? This is a new ZOG-gulag game, so I need to know the rules, which appear to pertain to content, rather than format, as at your previous gulag. Apparently, your censor will reject a letter which contains one thought which he, she, it deems un-p.c. I need to know the criteria for censorship/seizure/restriction, for it appears to restrict information, as well as opinion.

In the latest restriction, your zoggie, "IM10", used a garbled listing: "racial-ethnic inferior," as the basis or pretext for restricting ideas & information. As I wrote in my letter 2 APR 07, a statement of difference for identification purposes does not equal "inferior," nor does a statement expressing dislike of the difference. Zoggies appear to dislike 'offenders,' so they lock them up. This shows their utmost respect for 'offenders,' rather than any alleged "inferiority," since who can deem "inferiors" as a threat? ZOG deals with 'offenders' as one would deal with enemies whom one respects. I do not deem rattlesnakes to be "inferior," for example, nasty, yes, but not inferior. Rattlesnakes are different, & if I find their behavior dangerous to my health, my statements about this difference & this danger do not constitute categorizing rattlesnakes as "inferior." Your zoggies should be more specific, & they need to use better English to express their rules. If "IM10" has individual criteria for mail restrictions, I need to know them. I pretty well know Angela Davis, for example, so I could conform to her racist-Marxist criteria, which would strongly resemble Canadian postal restrictions, under which I've existed. It's no secret that might makes 'right,' at least until the tables turn, as history teaches those who will heed it.

From your mailings, I get the Gestalt that Stafford Creek is a Feminist-Communist gulag. In this case, I would understand their criteria for restricting information & opinions that they find offensive, but does this behavior conform to the rules of Washington State Prisons? If so, then we know, but there is a definite difference in WSP censorship from one gulag to another. The material which I now receive in Mail Restriction envelopes from you is material which was permitted in your previous gulag. So, now what? ZOG works in mysterious ways, its wonders to perform. If we go to war against Iran, as appears likely, will your IM10 zoggie restrict such nasty news? I think we'd all agree that such news would be nasty, but should such information be hidden from gulagniks? Is a strict diet of Walt Disney now your sole intellectual fare? ZOG forbid! That would make offenders inferior, indeed.

Thanks for your cogent assessment of sexual behavior in your gulag. People, including myself, have heard of it & suspected it, but your report sets out the true dimensions of such behavior. In his book, "Destroy the Accuser," investigative reporter Frederick Seelig noted that homosexuality was deemed a vice by prisoners, but that ZOG was not only protecting homosexuals, it was encouraging such behavior. Homos were becoming the new 'elite' in the prison hierarchy, which may also be the case in ZOG-forces. I served in ZOG-forces in the early sixties, when homosexuality was deemed a "security-risk," so things were quite different then. If human behavior can be changed so radically, there is a likelihood that the pendulum can swing back to previous behavior patterns, especially as sexually-transmitted diseases become more virulent & drug-resistant. Back in the sick sixties, people said, "If it feels good, do it." I doubt that Angela Davis would govern her behavior by that pre-AIDS standard, since she has survived, apparently in good health. A recent report on NPR jewsradio indicates that the use of antibiotics in animal husbandry, on behalf of profit, has entered the food chain, thus affecting the immune systems of human consumers, & creating highly-resistant strains of diseases which were previously treated by antibiotics. Oh, brave new world! Perhaps the American Medical Association should update its publication by calling it "The Journal of the Plague Years." Hey, bring out your dead! as they used to say, & likely will in the near future. ZOG-quacks have been researching the deadly 1918 "Spanish Flu" Epidemic in regard to its virology & its history, in terms of preventing its transmission. The conclusion seems to be that our society cannot & will not impose any necessary quarantine procedures in time, if at all, & the time-lag between discovery & vaccine preparation & distribution will be a case of "too little, too late." This knowledge constitutes the good news & the bad news, so, what, me worry?
