Guest Speaker Angela Davis

I used some information I pulled off of the internet and only used a small bit of it to peak your interest. Angela Davis is internationally recognized scholar, writer and activist. She will be visiting the gentleman at Stafford Creek Corrections Center followed by an appearance at the Bishop Center whereas tickets are currently being sold. This is Ms. Davis's first appearance in this coastal Washington community although during the past twenty-five years she has lectured in all fifty states as well as in Africa, Europe, the Caribbean, and the former Soviet Union.

Professor Davis, who currently teaches at University of Califirnia Santa Cruz, began her political activism as a youngster in Birmingham, Alabama. Active in the civil rights movement while still in high school in New York City, she came to national attention in 1969 when UCLA officials removed her from her teaching position in the Philosophy Department because of her political activism and her membership in the Communist Party, USA. Driven underground when the FBI put her on the Ten Most Wanted List in 1970 after a shoot-out in an Oakland Courtroom, Davis eventually resurfaced and supported by an international movement to "Free Angela Davis," gained acquittal in 1972 after one of the most famous trials in recent U. S. history. Former California Governor Ronald Reagan once vowed that Professor Davis would never again teach in the California system but today she is a tenured professor in the History of Consciousness Department and in 1994 she was appointed to the University of California Presidential Chair in African American and Feminist Studies.

Davis has long advocated for prisoners' rights, first expressed with her involvement in the campaign to free the Soledad Brothers which led to her own arrest and imprisonment. Her visit to the prison in Aberdeen is the continuation of that work in which she has developed a powerful critique of racism in the police, court and prison systems in the United States. She is a member of the Advisory Board of the Prison Activist Resource Center and writes frequently on prisoner's issues.

Professor Davis's articles and essays have appeared in numerous journals and anthologies, and she is the author of several books including, Are Prisons Obsolete?; Women, Race, and Class; Angela Davis: An Autobiography; and The Angela Y. Davis Reader.

I shall also send copies of your April 10th & 13th letters to JWG, to keep him up to date. I should address the items on your 10 APR letter first.

(1) I do not correspond with Jason Ludwig.

(2) I enclose the 2 Miller letters as you requested.

(3) I addressed the issues raised by your mail restrictions & request guidelines re content: are "IM10's" content restrictions Stalinist, Feminist, Anti-White Racist or just

personal & arbitrary? My letter of 14 APR 07 refers.

(4) I think that the more who know about your case, the better. I have none of the concerns you mentioned. I do not object to photocopying, nor the use of my return address. In regard to the Maguire calumny, it's entirely up to you. As you say, it is like a landmine which may hinder your progress in the future, as you have experienced. On the other hand, Maguire's snide remarks may have been his parting shot, in view of your transfer out of his jurisdiction. As I say, it's your judgement call.

(5) I agree with your initial instinct to reveal the homo activities in your gulag. I do not believe such information is 'snitching,' & if it is, Whites certainly need to know

about it!

(6) I enclose copies of correspondence relevant to the "Victim Awareness" course which has, apparently, risen like a vampire from its first, official, burial & replacement by the "RIP" course.

(7) Brushfires #6 enclosed.

(8) What a good idea: David Duke would be a great foil for Angela Davis. What would be wrong with allowing ZOG-gulagniks "equal time?" Oy veh! One could rightfully ask why Angela is not incarcerated for her alleged role in a Black Panther murder. Apparently,

she enjoys protection from Hillary Clinton & Company.

(9) Thanks for the distinction between P.C.W.s & non-P.O.W.s. You are more scrupulous in the use of that term. I think it applies to you, since ZOG seems to have stomped on you extra hard for your pro-White background, in addition to your alleged offence: of self-defence! ZOG likes to use criminal charges to cover up its political reasons for punishing dissenters. Basically, you are being punished for surviving the murderous intentions of your assailant. I wonder what ZOG would have done, had he killed you, rather than vice versa. When criminal charges are the pretext for political punishment, I'd deem the ZOG-victim a P.C.W. Of course, as you noted, there are many who claim to be "F.C.W.s" when they are just criminals.

(10) I've had no need for the rubberstamp, since I receive no legal work from other prisoners, but I shall send a copy of this letter & yours to JWG. When I need it, I'll get it.

(11) Your visual-victimization at the hands of ZOG would entitle you to war crimes repara-

tions, were you jewish.

(12) According to current COTC-niks, no Black would be allowed at a COTC convention. They accuse me of spreading "lies." I watched an S.S. film entitled "Erbkrank" (Hereditary Illness) which had footage & statistics from pre-Nazi Weimar. Although jews were a small minority in Germany, they were heavily-represented in the insane asylums, mainly because of schizophrenia. Everyone should resume checking into the family backgrounds of their intended mates, as they used to do, according to a jovial insane asylum attendant whom I met in Brownest Yakima. Our current rage of "find a hole & fill it," or "find a pole & stuff it" insures that he will enjoy increasing job-security as we produce a bumper crop of nuts for him to store, at tax-payers' expense, of course. In jewspeak, "prejudice" = disliking anything deemed "politically-correct," even after you are injured by him, her or it. If it happens again, that proves you are "prejudiced!" In fact, we would be "postjudiced," as you say. I'd recommend that p.c. zoggies take long walks off short piers, to show us they are not prejudiced.
