Dear Mr. Thompson:

Your request for a appeal of Mail Rejection No. 12784 has been received by my office. I have had all pertinent policies and operational memorandums reviewed and referenced. In my review, I have determined that Mail Rejection No. 12784 was imposed due to policy violations.

There are no exceptions for this requirement and no change in the original determination. Please refer to Department of Corrections (DOC) Policy Directive 450.100, Mail for Offenders, Attachment 1, Page 2, Number 15, wherein it states: *"Mail that advocates that any group is inferior based on national origin, race, color, religion, age, gender, marital status, sexual orientation, status as a Vietnam Era Veteran, Wartime Veteran, or Disabled Veteran, or the presence of a physical, mental, or sensory impairment, and makes such a group the object of ridicule and scorn, and may reasonably be thought to precipitate a violent confrontation between the recipient and a member(s) of the target group."* This policy directive serves as the Operational Memorandum (OM) at SCCC.

This correspondence is not in compliance with facility policy. Your appeal is denied and Mail Rejection No. 12784 is upheld. 16 MAY 07. Hail Michael! Many thanks for your 2 mailings of 14 MAY 07. I received what may be the reply from IM10 via Capt. Charles Jones, which sustains IM10's Mail Rejection (formerly Restriction) criteria in terms of Policy Directive 450.100.
