A lot of newspapers do not print letters to the editor from prisoners, but I set up a website called

FROMJAIL.COM

where prisoners (jail, prison or mental institution) can express to the public. If you are not interested maybe you know of some people who are.

I have a scanner. I will scan the letter up to three pages, and the envelope and post images of them on the site. Letters more than 3 pages will be discarded since I wouldn't have time to edit them. I also won't be able to handle any request expressed in the letter since I won't necessarily read them all. Write legibly.

Topics can include stuff like facility conditions, and the politics of the writer's incarceration. **(It's up to the writers to be careful not to write anything self-incriminating.)** About the only thing I might do is blot out a postage stamp if it didn't get canceled, to avoid the counterfeiting laws.

4 JUN 07. Hail Michael! Many thanks for your letter of 31 MAY 07 & enclosures. The day before your letter arrived, I received Mail Restriction 13679 which contained a letter from RNPA, NY. The envelope was still sealed, & was apparently unopened by Commissar IMLO. The Mail Rejection notice stated: "No return address!" The contents were pretty kosher, according to previous ZOG-gulag standards of acceptance: A book ad for Waddell's books on Race & Civilization + a flier announcing the website for www.rnpaheadquarters.org. I have started a file on "IMLO" censorship policies for future reference & pending legal actions. It may be of interest to note that Soviet censors called their rulebook "The Talmud."

I shall circulate your information & requests to all my correspondents in hopes of assistance, for your intelligent & determined legal battles are on behalf of every ZOG-gulag inmate, not only yourself. Of course, justice denied to one is usually justice denied to all. An ancient Aryan observed that "a corrupt society is known by the number of its laws." I have noted that a tyranny is known by the numbers of laws its agents break. One example was when Zionist Occupied Germany broke its own privacy laws to persecute Germans who dared to write to Samisdat Publishers Ltd. in Toronto, Soviet Canuckistan. Orwell noted that tyrannies deem some 'more equal' than others for law enforcement purposes. Thanks for the letter to that effect from Sr. Cedeño, whose bureaucratic prose is a sign of presidential potential. His great letter of obfuscation is outstanding, & I shall give it maximum circulation.
