YOM KIPPUR — What Is It?

On the evening of October 12, Jews around the world gathered to celebrate the most holy day on the Jewish calendar. It is called *Yom Kippur*, or Day of Atonement. At synagogues everywhere worshippers recited the so-called *Kol Nidre* prayer. Taken from the first two Hebrew words of the prayer, "Kol Nidre," it means "all vows."

The *goyim** are told that Yom Kippur is an occasion when pious, saintly Jews approach their Maker in a penitential rite to beg his forgiveness for wrongs they have committed during the past year.

RUBBISH! The occasion is nothing less than a time when Jews ask for and receive absolution for all the sins and wrongs they are about to commit—IN THE COMING YEAR! In so doing, they cut a lawyer's deal with their god (whom they call YHWH, or Yahweh) which gives them an exemption in advance from all wrongdoing.

Here is the actual text of this outrageous "prayer":

"All vows, bonds, devotions, promises, obligations, penalties and oaths wherewith we may vow, swear, devote or bind ourselves: From this Day of Atonement until the next Day of Atonement, may it come unto us for good,—lo, all these—we repent us in them. They shall all be absolved, released, annulled, and made void and of no effect; they shall not be binding, nor shall they have any power. Our vows shall not be vows; our bonds shall not be bonds; and our oaths shall not be oaths."

That's pretty clear, unambiguous language. What we have here, in fact, is nothing less than a one-year, renewable license to lie, cheat and steal with impunity, all based on a decree from the Jews' so-called holy book, which says:

"And he who desires that none of his vows made during the year shall be valid, let him stand at the beginning of the year and declare, 'Every vow which I make in the future shall be null. ""

(Babylonian Talmud, Tractate Nedarim 23a & 23b)

Among those who will be reciting the Kol Nidre oath are the many Jewish politicians, judges, lawyers, corporate executives, businessmen, journalists, commentators and spokespersons disproportionately represented in public life today. It should be noted that any oaths they may take to uphold and defend the Constitution or otherwise tell the truth are, as of this occasion, "abandoned, cancelled, null and void" and rendered "without power and without standing."

Isn't that nice?

Lost Tribe found in India

More than 2,000 years after they claim to have first set foot in India, the mystery of the world's most obscure Jewish community—the Marathi-speaking *Bene Israel*—may finally have been solved with genetic carbon-dating revealing they carry the unusual Moses gene that would make them, literally the original children of Israel.

Four years of DNA tests on the 4,000-strong Bene Israel—now mainly based in Mumbai, Pune, Thane and Ahmedabad—indicates they are probable descendants of a small group of hereditary Israelite priests, or *Cohanim*, according to results of a new study.

The priests are scattered worldwide but genetically related in a distinctive fashion that leaves just a billion-to-one chance of a mistake in identifying who the Bene Israel really are, says Tudor Parfitt, Jewish Studies professor at London's School of Oriental and African Studies.

Parfitt, who initiated and led the research, says this is the first concrete proof that "exiles from Palestine made it as far as India and managed to maintain Judaism in the sea of Hinduism and Islam."

In the early '50s, 30,000 Bene Israelis returned to the socalled Promised Land, soon after the state of Israel was created. Their Indian appearance, cricket-playing, sari-wearing, curryeating and Marathi-speaking habits led to a bitter battle for recognition as "real Jews."

The name Bene Israel literally means "Children of Israel," and their legend of origin holds their ancestors to be Jews fleeing persecution in Palestine in 175 BC.

According to the legend, seven men and seven women survived a shipwreck near Navgaon village on the Konkan coast. Their descendants became thoroughly Indian, except for observing Saturday, the Jewish sabbath, as a weekly holiday. The practice led them to be known as Shanwar Teli, Marathi for "Saturday oil-pressers."

It was only 1964, that the Israeli prime minister declared they were genuinely Jewish and should be allowed to return to Israel and intermarry.

But now, the new study goes one better. By studying certain genetic markers in the DNA chain, found only in male descendants of Aaron, Moses' elder brother, who founded the line of Jewish priests, the Bene Israel could well claim to be the purest of the pure.

The new research has also found preliminary genetic evidence to show the declining community of Black Jews of Cochin left Israel in remote historical times.

The new data, which has been featured in leading Western scientific journals, comes after painstaking efforts to genetically source the origins of India's other, self-professed "lost" Jewish tribes, including the Manipuri Jews and the Teluguspeaking Jews of Guntur.
