Hail Joseph! Thanks for yours of 16 NOV 07. I believe that you have put the proverbial cart before the horse in regard to nation & territory. First must come Nation, then Land. You can see examples throughout history where people hold land, without being conscious of their Nationhood, so they lost their lands to alien invaders, as we see in all former White countries. I have mentioned examples of nations without land, such as Jews & Gypsies. These nations invade & occupy the lands of their host peoples. Our local Yakama Nation has its territory, but wherever a Yakama goes, he remains a Yakama, unless he loses his nationality by out-breeding with non-Yakamas. Whites must develop their Nationhood first, then they can get land & hold onto it.

All the programs you mention are worthwhile, but they need the concept of White Nationhood to make them possible. As with communities, Nations depend on the quality of the members. Since my return to the Jewnited States empire of ZOG in 1992, I have met not one Ostensible White who has the makings required to participate in a community nor a nation. To survive, a nation must be exclusive as well as inclusive. Those who are deemed fit should be included, & those deemed to be unfit must be excluded, for the good of the whole. I've seen groups destroyed by a single defective member, including bad leaders, so due care must be exercised in recruiting members. It only took one or two bad apples to destroy Pastor Butler's little settlement, & deprive him of his land. In this case, a security chain is only as strong as its weakest link.

Karl Hand of RNPA has a White relief program of the sort you mentioned.

Perhaps the best example of what can be done is the Mormons, who are pretty much a nation under a church label. They believe in "communitarianism," in which each member looks out for the others & vice versa: "All for one & one for all." That credo is necessary for the creation & survival of any nation. Duties also must come before rights, so as to avoid parasites. Members must be willing to give of themselves before they are entitled to take. Need is infinite, but the ability to feed is finite. After finding that out, "Lenin" dumped Marxism's "From each according to his ability, to each according to his need," by declaring "Those who do not work shall not eat!" No, he did not put babies to work, but their parents.

A community can only begin as a concept agreed upon by its members. It cannot begin as a place. Few towns, if any, are communities in this land of ZOG. If you can name even one, I'd appreciate it. Communities must be inclusive, according to standards, & they must also be exclusive toward undesirables; otherwise they cease to be communities, if they can ever begin as such.

Literature in this day of the Internet is inefficient. Why would I want to leaflet Brownest Yakima? Most of the people are non-Whites & anti-White Whites. Local zoggies remove the leaflets & trash them, while other zoggies file lawsuits against the distributors. New Jew 'hate laws' have come into effect, which expose pamphleteers to prosecution, so the risks are great, as compared with the possible benefits. If I thought the general passing out of information were practical, I'd do it, as I did in Toronto's Whiter districts, before such material was subject to strict ZOG censorship, as at present.

I used to know a few skinheads who were out of prison. Now, all who tell me they are skinheads are in prison. Then they get out, only to return. If that is not "prison-prep", what is? How does one live his life for White Survival if he is unable to stay outside the ZOG-gulags? How do we realize The 14 Words behind bars? It makes no sense to me.

Your zoggies have forbidden Hitler pictures, so please ask if it's 'kosher' for me to send you one. Then I'll be glad to do so.

I pointed out to one skinhead that his tattoos tend to make him unemployable outside, just as if I would go to job interviews wearing an SS uniform. It was hard enough to find work as a plain White man, now that we have so many "affirmative action" categories. My ace in the hole used to be that I'd take the most menial jobs available, but those are now taken by illegal aliens, so I was very lucky to obtain the minimum-wage, part-time job I did here. My former location, Louisville, KY, was also part-time, minimum-wage, & the job was seasonal, as a groundskeeper on a rich man's 30-acre estate, so I'd be unemployed for 3-4 months per year. The costs of rent & car expenses required me to dip into my meager savings, so I had to find an all-year 'round job. Here, I no longer needed a car, & the job was not seasonal, so I was able to eat & sleep under a roof, until the employer went out of business, as did two others. No, they didn't overpay me! My last job went to India. Friends' jobs have gone to China or they are lost to illegal aliens.
