## **Claim Tomorrow!**


Are you tired of your rights, the rights of our people being ignored or trampled upon--of being treated as if you or any of our people have no rights worth honoring or respecting? Are you tired of so-called civil rights or civil liberties spokesman who seem to feel that civil or constitutional rights are for everyone but our Eurofolk people? Are you tired of politicians, religious spokesmen, business leaders or others, some of whom like to occasionally talk as if they are for at least some of our people, but who seem unable to comprehend that the Constitution and Bill of Rights should and do apply to our Eurofolk, especially when our people are the ones who wrote it? Are you tired of "organizations" or "leaders" who are unwilling or unable to even begin to think about effectively standing up for the rights of our people? You need no longer be made to feel weak, frustrated, defeated or hopeless! You now have a voice and a means to begin to seriously, genuinely and effectively stand up for your rights and the rights of all our Eurofolk. You now have Liberty Rights Advocates (LibRA), a Eurofolk, patriotic, civil rights association.

LibRA is already emerging as the voice for our political prisoners, a voice they have long needed but never had before. Members of our association already have been involved in civil rights litigation, and have already won some victories, including the Supreme Court decision upholding the Religious Land Use & Institutionalized Persons Act (RLUIPA), a law designed to protect and defend the religious rights of not just prisoners, but of every citizen. We have engaged in several lobbying, public education and other activities, and are planning to actively participate in various political efforts, such as voters initiatives. So far we have had more successes than failures, more wins than losses. We are establishing a track record of success.

Whether you are confronted with anti-Eurofolk discrimination, infringement upon your right to the free exercise of your religion, deprivation of First Amendment rights, or other constitutional rights issues, methods and strategies we are successfully using to stand up for the rights of prisoners we can, should—and will—use to effectively stand up for the rights of our people who are not in prison.

If you intend to be a serious pro-Eurofolk, patriotic or nationalist activist, or to be actively involved in advocacy for issues self-appointed thought police arrogantly deem "politically incorrect," or even if you just realize that the oppressive squeeze of growing dispossession of our people and of an ever encroaching tyranny will only become increasingly more unbearable unless something is done about it, you need LibRA. If you are now finally serious about wanting to effectively stand up for your rights and the rights of all of our people, and realize that to achieve that purpose you must finally become involved in a serious-minded effort with positive direction and real purpose, then you can and should–indeed, you'd be a fool not to–join and support Liberty Rights Advocates.

Hail Daniel! Many thanks for your letter of 23 FEB C8 & Issue #14 of Separate Living. Our task is much simpler & more difficult than it is complex: We must teach Whites to stop hating themselves, then we must teach them to think in terms of who they are, as a biological community, as do the jews, who always ask, "Is this good for jews?" The lesson of history is clear: Nation first; homeland second.

Will our people wake up in time? Probably not, although some will. Who knows if our people will heed them. Events have a way of out-pacing Whites' ability to think. ZOG knows!

You'd be best advised to keep our potential leaders out of universities, which are ZOG centers of disinformation, in my own experience. People I know who have been in the 'news' business tell me that graduates of journalism & mass-communication are most unqualified to be journalists of print or electronic media. They are merely readers of what is put before them. A journalist must be informed, so he can inform others. Apparently, "journalism schools" in this Land of ZOG do anything but teach things of relevance to personal or public information. 'News' for Goyim is just show-biz for the ZOG. My own journalistic experience goes back to print media in old-fashioned newspaper offices with typewriters, telephones, & later, teletypes for international news. Journalism dovetailled with my academic research, in which one had to learn facts & present them coherently to readers. This career has so far got me kicked out of 5 countries, but I live, so far, to tell about it.

As a journalist, I have waged a lengthy war against ZOG's censorship, at home & abroad. I participated in numerous thought-crime trials in Soviet Canuckistan alias Canada alias China-duh. I co-operate with victims of Zionist censorship in our gulags, so as to restore their alleged First Amendment Rights, & I recommend Liberty Rights Advocates in this regard. My Canadian contacts inform me that the ZOG's ADL has succeeded in enforcing their thought-crime laws according to the censors' kosher tastes. "Hate" is therefore anything their ZOG hates, even if no zoggies are mentioned.

ZOG is well-practiced at using gradualism or 'salami tactics' on Goyim. First, they pass a law, but nothing much happens. The Goyim go back to sleep. Then, the law is gradually enforced, tighter & tighter. Resistance was possible in the beginning, but the Goyim did nothing. After legal precedents have been established, it is too late. Goyim generally wait until it is too late. The ADL has pushed through their thought-crime laws in various states of the USA, according to their ADL website, but they really want a federal "hate law". FEDZOGUSA has already imposed its "hate-crimes law," which, to my knowledge, has never been enforced against non-Whites. What is "hate?" Hate is thought. Our ZOG currently equates words with "terrorism", so it is logical that expressions deemed as "hate" will be crimes in themselves. The Goyim sleep on. They prefer to pay their taxes & die in Iraq, for THINKING is too painful for them.

The Internet has become the Medium of the Masses, so it is logical that ZOG will impose censorship restrictions on it in the USA, as it has in China, Canada, Europe, Australia & New Zealand. The USA is, to my knowledge, the only place where there is freedom of expression on the Internet, so guess which will be ZOG's big target. There are numerous ways of imposing censorship, including over-charging users; sabotage; emergency laws, & finally, neutralizing the few who have anything worth saying. No one is anonymous, for all communication is a two-way street: Whatever one puts out, another can send in, via the same avenue. This is why I do not participate nor advocate criminal activities, so if the Goyim sleep on & ZOG deems my expressions illegal, I shall cease forthwith. Why go to ZOG's gulag for saying what nobody wants to hear? In the jewbook, this is known as "casting pearls before swine." So far, all I hear from the Goyim is "Oink!" But until ZOG's ax falls, I shall continue to do what is possible, on behalf of CRION!
