LEAST RESTRICTIVE MEANS

The RLUIPA requires you use the "least restrictive means" in abridging my religious freedoms to accomplish your penological objectives. Complete rejection of the materials in question is not the "least restrictive means" of furthering your interest in preventing violence. Firstly, 18943's rejection was probably for material that this publisher asks that I proofread. I provide editing / emendation service for Mr. Emahiser. Chances are, it is requested I proofread it and send it immediately back out. Secondly, the least restrictive means of protecting your management concerns - with both rejections - would be to redact words or phrases you have good reason to believe will cause violence. This wouldn't take any more time than your initial review of the material and in fact could be done simultaneously.

EXAGGERATED RESPONSE

Given a long pattern of exaggerated fears about my mail causing violence, and Olympia's having frequently to overrule decisions to withhold my mail, it's much more than likely this is what courts are calling an "exaggerated response" to your concerns. If you've pulled up my above-referenced essay at fromjail.com, look at page 4's summary of the RLUIPA: "Inadequately formulated prison regulations and policies grounded on mere speculation, exaggerated fears, or post hoc rationalizations will not suffice to meet the act's requirements" (145 Congressional Record, S7774-75). Would you censor Mark Twain's Adventures of Tom Sawyer and Huckleberry Finn for its frequent use of the word "nigger"? Do you block out Carlos Mencia's frequent use of the terms 'nigger' or 'spic' on television? Of course not. I can speak or write these words with impunity. Accordingly, there's no reason why I can't have mail referencing them - especially religious mail.

THE LAW OF THE CONTRARY

'The Law of the Contrary,' which I cited in the above-referenced essay at its page 9, holds that your policies on race relations and censorship will have the opposite of the intended effect. Forced integration in its several manifestations in prison - whether in foolish cell assignments, or assigned seating in chowhalls - is the number one cause of violence in prison. SCCC's Diversity Committee, which 'celebrates' every race as a race except the White race, causes immense resentment among White prisoners while cultivating a sense of grievance and entitlement among non-Whites. And censorship like this creates a psychological affect of fascination among White prisoners with the 'forbidden' subject matter, and contributes to a climate of hypersensitivity to offense among non-White prisoners, who are the only ones 'protected' against the slightest insult. Bad ideas on all fronts - think about it!

I'm filing all the formal appeal and notice paperwork along with this letter. Please reconsider your position and reverse the rejections.
