In this connection I would also like to convey the following facts: On 17 September 1945, Major Emery, an interrogator from England, whom I already knew as he was known in England, or "Englishman", as he was known in Germany, sought me in my quarters in the Kaufbeuren Interrogation Compound. I suppose that his real name is different. He was, as he had once told me, a New York banker. He commanded the American interrogation group to which Capt. Tracy (also a cover name, most likely) also belonged. The American interrogation group was located in the English interrogation compound of Camp 7. Mr. Emery asked me about my ancestry, meaning that if I were of Jewish ancestry, he would be able to remove me from all further prosecution. As I informed him that his supposition was not pertinent, he thought that he could not change things. The same gentleman visited me in Nuremberg on 5 November 1945, as I was just being questioned by an American interrogator. By chance I heard that it was a Major Mohagan (?). After a short conference, Emery Mohagan asked that we be left alone. Emery then said to me that if I were to make more favorable statements on behalf of Goering, Speer and the other accused in the International Military Tribunal, I must myself reckon with a war crimes trial against me. I replied that I took part in no war crimes and I could not see how I could be tried. Emery answered: "That is a small matter. If we wish, we could try every German, regardless if he committed crimes or not. Why do you want to stand up for Goering, Speer et al.? They would not do it for you, and I shall give you some good advice: It is in your own interests to testify against these people." I replied that I could only tell the truth and that my person played no role in this matter, and that I did not fear a trial. Emery answered: "You must consider that you are still young, that you can again play a role, and that you must think of your family."

Naturally I refused his offer, even if it were well-intended. With that he concluded that he could no longer be of any assistance. In this instant I knew that they would attempt to start a war crimes trial against me. I have also brought this matter to the attention of several comrades in Nuremberg as well as in Dachau, and also to the Swiss representative of The International Red Cross in Geneva, at that time.

Dear Phil: Many thanks for the Irving book on The Luftwaffe. I almost felt as if I were reading about old comrades, since I've corresponded with & interviewed several Luftwaffe heroes. In my book, they are all heroes, & if we consider Milch, he withstood the temptations only attributed to Jesus. All he had to tell the jew at Nuremberg was that he was a jew, & all things would be given him. But Milch refused to use his jewishness as a key to freedom. Almost casually, he stood firm, & he refused to denounce his comrades, thereby incurring life in the ZOG-gulag. Rudolf Hess did no less, for he was apparently offered such Judeo-Satanic perks if he would renounce his loyalty to National Socialism & become the Soviet puppet governor of the DDR or East Germany. Hess refused the offer. Apparently, Speer was more pliable. Dr. Rudolph, a Nazi rocket scientist who worked with von Braun, sold out by denouncing his people & their government. I worked with him in Toronto, on his immigration case. The jews used his own statements of 1947 to prevent him from even visiting North America. I told him that "You joined the enemy in time of war, & you betrayed your people. For that you should be hanged, but you are being punished by the wrong people for the wrong reason. In any case, you are being punished." Rudolph turned pale & began to co-operate in his own defense, but CANZOG used his 1947 statements against him: A traitor betrayed by his own treason. How fitting! This was a man with lots of technical knowledge, but hardly any morals & less wisdom. In some respects, I felt sorry for him, but I could see justice, of a sort, being done in his case, as it was in the case of Zündel. "Time wounds all heels," as some say.

I don't consider myself a 'superman' of virtue, but I am committed to the Cause for which I stand, & I shall support that Cause as long as I can, with every means available, on behalf of the children I never had, & The Race who gave me birth: When they are bad, they are very very bad, but when they are good, they are truly wonderful.

Thanks, as always, for the latest International Forecaster. I agree that economic disaster is coming, soon, but I'm reminded of a mathematical proposition in which an oncoming object approaches collision with another object in infinity, by halving the distance between them at high speed. The teacher said that no matter how close the two objects came to collision, they would never collide, for the halving of the distance separating them would be infinite. Ha! I think that we live on a finite planet, with a finite economy & finite stupidity, so our economic collision with reality will occur, or has already begun to occur in many cases.
