Hail Chris! Many thanks for your letter of 22 MAY 08 & the Dachau photos, copies of which I return herewith. I'm favorably impressed by the good housing which the Germans provided their prisoners. I've stayed in much worse-looking motels in the USA!

Zyklon B was a brand name for HCN (hydrogen cyanide). I understand that Zyklon A had an odorant which gave off a warning scent to let people know the gas was being released from the absorbent crystals, so they could evacuate the premises or take other precautions. Zyklon B had no such warning substance, as I understand. My source was Dr. Lindsey of Du Pont Chemical Co. which made HCN for fumigation in the USA. Unlike European countries, the USA was the only country which used HCN for executions as well as delousing, before, during & after World War II. The only jew I know who was gassed for sure was Caryl Chessman, who was killed with HCN at St. Quentin Prison in California in 1958 or 1959, to my recollection.

Poison gases were used in World War I, such as chlorine, mustard gas, lewisite, phosgene & nerve gas, but not hydrogen cyanide, for the simple reason that HCN is lighter than air. "War gases" must be heavier than air, so they can kill troops in foxholes & trenches. HCN is also flammable, so it should not be used in the presence of sparks or flames. If the jews were not lying about the alleged use of HCN for "gassing" people, the Germans would've blown up their "gas chamber" as soon as the HCN reached the crematory ovens at Auschwitz I, plus killing the crematory staff! Such a deal, it never was. I understand that HCN is very active in combining with iron upon contact. Blood (hemoglobin) contains iron, so cyanide quickly forms a ferrocyanide bond which prevents blood from carrying oxygen, causing the organism to die of suffocation. HCN is absorbed through the skin, as well as through the lungs. I'm not sure what the writer meant by HCN's ability to "stun", unless he means the reaction to sudden choking & inability to get air.

Poor Commander Hoess! He was tortured by Allied interrogators into inventing all sorts of lies, & even a fictitious "death camp" named "Wolzec." The statistics he claimed were impossible, as anyone can confirm by asking how many corpses may be cremated in the most modern facilities, under ideal conditions. A cremation expert, Ivan Lagace, testified at the Toronto Holohoax Trial just because the jew cremation statistics were so outrageous. I understand that Hoess' "confession" was written in pencil, in English, which Hoess did not speak. Isn't it miraculous what torture can do? The entire Holohoax was a 'miracle', according to the jew-liars: millions of 'survivors' of alleged 'extermination camps.' Miraculous cremations & burning millions of bodies under water, with invisible coal, &c. Then the miraculously disappearing bodies of millions of victims.' The miraculous Nazis routinely defied known laws of physics, chemistry & logic. They had to, if the jew stories could be true. Let's try putting 250 jews into a two-axle standard European boxcar, with their pianos & steamer trunks, for starters, without the necessary assistance of a 'miracle.' The French could only put 40 infantry or 8 horses into such a boxcar, 'cause they couldn't work'normal'Nazi miracles.

The jews insult our alleged intelligence in many ways with their Holohoax, because they rule over us with their money power. They allege that Nazis ran "secret trains" which carried uncounted 'millions' to the 'death camps.' They should have lied that the Nazis used trucks or flying saucers, for trains are recorded, with their cars & cargo, & train movements are recorded to avoid collisions. You can have a secret railroad, but no secret trains, for they would collide with regular trains, causing a big mess, which would be no secret. Jews claim that Germans used 100-car trains. Not in Europe, according to locomotive engineers I've interviewed, because the locomotives weighed ½ as much as an American locomotive; the couplings were too weak & the sidings too short to allow for two-way traffic on the single-track lines on which the alleged jewish "millions" were carried. Nor could the numbers of arrivals in camps be "secret," so as to permit the infinite increase of alleged 'holocaust victims.' The British claim that they monitored all camp arrivals & departures from intercepted German radio transmissions, so the Germans had few secrets indeed.
