Hail Daniel: Thanks for your letter of 23 SEP 08. You may remember from reading history that the jew banksters wanted to break up the USA, because it was a threat to their empire. That's why they got us to fight the so-called American Revolution, which divided the British colonies into Canada & the USA. Then they wanted to divide the USA into the South & North. When that failed, they bought the whole lot, so the USA fell under their rule, as effectively as if we were in The British Empire (which we were, anyway). Since the banksters rule the West & East, with some questions about The Middle East, it matters little if their empire is divided into large geopolitical states or mini-statelets. The USA was a political/economic threat to jew rule because it had a large, fairly homogeneous population of Euro-Americans, with land & resources sufficient to supply their needs, & a large domestic market to absorb their production. Thus, we approached the jewish nightmare of self-sufficiency, which could have eliminated the jew middlemen of money & commerce. Cornwallis predicted to Washington, at the signing of the surrender at Yorktown: (1) You will be back under the British (Bank of England) Empire before you know it. (2) You will destroy your nation in a 'holy war.' (3) Your religion will be Judaism, but you will not know it. All those predictions came to pass: (1) With the incorporation of the 1st U.S. Bank (of Usury); (2) With the Civil War & its Battle Hymn of the Republic; (3) With the kosher tax on goods in interstate commerce.

With population diversity comes diversity of interests, so geographical separation of individual U.S. states is not relevant to solving the problems of demographic diversity nor of creating self-sufficiency. The British Isles were not economically viable by themselves, for their population had to rely on trade, that is, foreigners, for their economic survival. The same conditions applied to Athens prior to The Peloponnesian Wars, for the jews controlled the gold which Athens required for its trade.

Consider how any legally independent statelet could achieve de facto economic independence with (1) Its large welfare population of unskilled, "useless eaters," as the jew Lenin called them; (2) Its lack of industrial &/or agricultural resources sufficient to supply its population; (3) Its diversity of races, loyalties, identities, values, priorities & behavior.

Consider that the USA was no more. How would each statelet defend its territory from unwanted occupants, who presently move right in with their baby carriages? Such territorial defense requires a territorial government with the political wisdom, will & resources to defend the territory from invaders. To have such a government requires a political ideology beyond that of individual homesteaders, i.e. the White Flight crowd. This is why Separate Living is no solution capable of ensuring White Survival. If you doubt me, go live in South Africa. Your program was tried in all Black African countries, so it is doomed to suffer the same fate in Mestizo/Afro-America. In other words, we must have White Nationalism, not just White property ownership, under ZOG.

The role of government is to Direct, Protect & Collect, on behalf of the general welfare & common defense, so individual anarchists need not apply. They would be incapable of establishing an independent territory or of defending it.

We do not work in a ZOGless vacuum today, nor will we tomorrow, as long as jewish nationalism (Zionism) remains intact via their Empire of Usury. As long as jews can "hire ½ to shoot the other ½", we will need a pro-active anti-Zionist policy, whether we live in big geopolitical states or in little ones.

History shows us how the jews solve their problems, at our expense. If a state is large, they co-opt & corrupt its rulers; if the state is small, they play it off against other statelets. Hence, mere separation is no solution to OUR problem, as long as the jew has access to our economy. A purely agricultural economy is no solution, nor is a purely industrial economy, but a healthy combination of both, sufficient for the needs of the population which makes up that economy within its geopolitical state. If not, then we're in hock to the jew middlemen, & no better off than we were before. Then we have jews like the arms merchant Zaharoff who instigated wars in the Balkans, at a profit, by selling the latest weapons to one mini-state or the other. Then he'd visit the next mini-state & show their rulers what their enemy had in his arsenal. Can Separatists comprehend such doings, & could they defend themselves against such people? Not without knowledge & Nationalism.

ZOG has options, as it likes: It can combine Canada, USA & Mexico into its North American Union, thereby dissolving the USA, or it can promote secession throughout the USA & the rest of North America into "patrias chicas" or small homelands. Either way ZOG wins & rules.
