Hail Leif! Thanks for your letter of 2 NOV 08 & the S.S. enclosure, which I return via photocopy. It's a useful chronicle. A very dear friend of mine, Frau Rost van Tonningen, was married to the Dutch finance minister who was in the Dutch Waffen SS, as distinguished from the Allgemeine SS. The Waffen SS was, in effect, German allies who believed in National Socialism for their peoples. It was a display of unity against Communism & Capitalism. Herr van Tonningen fought the Zionist invaders of Holland. Whether he was taken alive or not is a mystery, as well as hisplace of burial. With Mrs. van Tonningen I perused the Canadian archives in Ottawa, since Canadian units were engaged in the invasion of Holland in 1944-45, & I hoped there might be a record of her husband's capture, or mention of his unit. But, as they say in Brownest Yakima: Nada. Her children were taken away from her & taught to hate their parents, & Our Race. The van Tonningens spent a social evening with Heinrich Himmler, so I shook the hand of the great lady who shook the hand of the Reichsführer SS. I've also known, personally, men who shook hands with Adolf Hitler, so when you shake hands with me, you are two handshakes away from the hand of Adolf Hitler.

So far, I've received no replies from any darkies in the South African media or government.

I enclose some information in regard to prisoners' rights, which you may already know about. If so, pass them on.

The information on the fighting capabilities of German troops tallies with other Allied sources. If I recall correctly, British historian Max Hastings even said that the Germans were formidable in retreat, as they were in attack & defense. The Allied propaganda that the Germans won because they had the numerical advantage in men & materiel was just that: propaganda, which turned Allied defeats into "victories," as at Dunkirk. Such a deal!

I didn't understand why the French were so unfriendly to English-speakers until I read Max Hastings' "Operation Overlord," which describes U.S. & British carpet-bombing of French territory before, during & after the Normandy Invasion. We Anglos killed more French <u>civil-</u> <u>ians</u> in those bombardments than the Germans did in 3 wars against France. That's why I had to order my train ticket to Copenhagen from Paris in German! That was in 1964.

I've never heard of Action T-4, since I don't yet know everything. Ha!

ZOG willing, I enclose a copy of The White Genocide Manifesto, which includes the 14 Words.

Let's hope President Obama is better than Zimbabwe President Robert Mugabe, whose inflation must top the world record @ 1 million + %! When I was there, under White Rule, the Rhodesian dollar was worth 2 U.S. dollars. Local jews say that Obama will be assassinated in office, since he lived through the campaign for president. Blacks may be prepared for RaHoWa, but Whites sure aren't, since they love the ZOG way too much.

I mentioned to a local Yakimoron that Obama's situation is almost as bad as Hitler's, when he was elected to office as Chancellor of Germany. Weimar Germany was heir to the privations & debts of World War I, then the bankster inflation, which <sup>W</sup>iped out wages, savings & pensions, plus a jew-Bolshevik attempt at takeover, which nearly succeeded. The fatheads of the USA have never had such a nasty situation, but Obama will need to combat kosher inflation, or see the U.S. economy go Weimar, which also suffered from the banksters'contrived "depression," which inflicted severe unemployment in Germany. Hitler overcame the German depression by kicking the jew banksters out; by taking over Germany's 'national' bank, & by issuing Lincoln-style money, which was pent into existence, not borrowed from jew banksters.

Franklin Roosevelt's son in law, Col. Curtis B. Dall, told me that FDR hated Hitler, because he got Germany, small, impoverished Germany, out of the bankster depression by 1935, with money paid for useful public works projects that provided instant employment & gave instant buying power to the workers. FDR was not allowed to BORROW sufficient money to get the USA out of the 1929-1939 Depression, for the banksters wanted another jewish harvest, i.e. a war, which they'd planned to follow World War I, on behalf of more power & profits from the Goyim: Us. As we know, they succeeded. Goyim bleat that "We needed the war to get out of the Depression. Well, actually, the banksters did, in the course of their kosher business cycles.

So, do you prefer traitors with pale faces, or traitors with dark ones? I don't care. Obama could stop the bankster 'recession' by seizing their ill-gotten assets, by abolishing the kosher Federal Reserve & seizing its assets, along with the Fed-felons' salaries, &c. He could also get our troops out of their Zionist-bankster wars in The Middle East. He could also print United States Notes, as did Lincoln & Kennedy, which would be debt-free. Now, Goyim face an inflationary depression, with worthless money & no jobs.

World War II got bankster zogbucks into circulation, but our present debt-based economy is already spending way beyond its means, & U.3. creditors may soon find our mountain of jew I.O.U.s to be incredible, so they won't continue to 'buy' them. So who would lend us more money to fight our Zionist imperial wars? And who would ever be able to pay the debts incurred by our ZOG in The District of Corruption? Nobody I can think of. The Chinese want to be paid in commodities & in real estate, not more zogbucks. I understand that they are funding the ZOG's bankster-bailout of \$700 billion +. By buying this huge private debt & making it U.S. property, the Chinese investors who bought U.S. Treasury bonds have bought a major part of the USA, & they will want reimbursement. Would you blame them? I wouldn't, but I'd certainly blame our traitors-in-office. Both McCain & Obama voted in favor of the banksterbailout, so will they hand over U.S. realestate to Chinese occupiers? Stay tuned. The above partially answers your 1st question on what I presently think of Obama. As we know, he is ½ Black & ½ White, so who might he favor? (3) To secure one's existence requires one to know who he is. Then he can know what is good or bad for him. Whites are unconscious, at present, so they must first wake up & stop being

Goyim (sheeple & jew-slaves). (4) "Great" people can be good or bad, so I think in terms of their greatness on behalf of Our Race. I can think of none as great as Hitler. Lack of such great men is why Our Race is in its present dire straits.

5) The future of Our Race is in its hands, as well as its hearts & minds. Right now, only a radical change of mind can save Our Kind. We must develop a total commitment to Our Race, as parents should have for their children. Before we take any action, we must ask: "Is it good for Whites?" The solutions are simple, but it is their achievement which is hard.
