Hail Leif! Thanks for your letter of 5 Jewlie 09 & the great enclosures. I'll check to see if my local Internet contact can log onto Tina's website. He said that Tom Metzger's place was raided by zoggies, possibly in connection with the von Brunn matter, which provided a pretext for intrusion. You may already know that Hal Turner & Bill White, both of whom are said to be jews, are in ZOG's gulags for advocating violence against judges & congressmen. I have long known that such advocacy is illegal in Judeo-America, going back to the 1950s. Goyim need to know, for "ignorance of the law is no excuse."

Race-traitors do their adultery out of ignorance or bogus, jew-instilled righteousness. This does not excuse them of guilt for genocide, but we must strive to address the genocidal propaganda of the jewsmedia on behalf of racial survival. Race-mixing, like homosexuality, is promoted in all 'our' media of edjewcation, information & entertainment, which includes churches which also promote "White guilt." When we consider a "shiksa," (Goy meat) already influenced by sheeplike parents amid the context of genocidal media messages, who comes into contact with drugs & muds, the logical outcome of miscegenation is not surprising. Jews who pass themselves off as Whites also do much mischief to Our Folk. That's how Christinsanity plagues us, for we are made to identify ourselves with anti-White interests. If a "Christian" is pro-White, it is only by accident, for he has missed the cult-message of guilt & race-mixing, which is now increasingly potent in multi-racial societies like ours.

In Latin America, I learned of ZOG's phony combat cells, which I reported in the November 1976 edition of White Power Report. "The Turner Diaries" was totally phony in regard to its target-selection, for example, for all its targets are non-strategic & therefore non-revolutionary, as those were which The Order selected. I did learn a few things from living in civil wars as well as interviewing Spanish & German civil war vets. The German civil war occurred between 1918 & 1933. The Spanish Civil War was fought from 1936 to 1939. The Colombian civil war has gone on for almost 400 years, with pauses for reloading weapons, as Colombians told me. The civil war in former Rhodesia was ended with 'our' Prime Minister Ian Smith's betrayal of Whites, in favor of the jews' pro-Black Marxist policy, not that it did Blacks any good! I also attended lectures by the jew, Kurbis, alias Alexander Kerensky, who ruled Russia between Tsar Nicholas II & the advent of the jew, Lenin, alias Ulyanov, who described how he got kicked out of Judeo-Russia.

My view of The Order & its incarcerated members is that they are victims of a typical ZOG phony combat op. It's too bad David Lane could not write his great works outside the gulag, for "propaganda of the deed" is only effective if it is understood by those whom it is in-

tended to help. The Goyim did not, & do not understand, thanks be to ZOG.

As you say, ZOG makes 'hay' from the von Brunn story by tarring those who don't believe the hebes' Holohoax into "terrorists" &, now, Kiddie Porn Perverts. Such a deal! Von Brunn

was just what ZOG needed.

I'm trying to keep track of the developments on "Hate Speech," i.e. thoughtcrime here in the Jewnited States. The jews have pretty much what they want in Canada alias "China-duh," where "hate" is what jews hate, regardless of how hateful they are to Goyim alias Gentiles. Here, they have created a class of 'protected critters,' including fruits, nuts & cripples, both mental & physical, to which they are adding more of same. If an unprotected critter is attacked by one who is protected, he has no right to physical self-defense. Thus, one may offend & the victim may not defend, for defense would constitute "hate." As we'd expect, ZOG is pushing "hate speech" on all fronts, which criminalizes words in addition to deeds, as in Soviet Canuckistan, where "Truth is no defense."

The Prophet, George Orwell, described current reality in his novel, "1984:" Surveillance, privation,& mind-manipulation via the media, amid endless war by the government against the governed in which a foreigner, like Osama bin Laden, is blamed for all ills inflicted by the government. Unlike Hitler, who is past his prime, Osama is digitalized into virtual reality, so he may be made to appear at any time, to say anything ZOG wants, for ZOG's purposes. As in "1984," the "proles" alias Goyim have a figure whom they may hate publicly, ZOG love him.

"J Ehre heisst Treue" should be Meine Ehre heisst Treue: My Honor is my Loyalty, the mot-

to of the SS. I don't know what "J" is supposed to mean in that quote.

The legal basis of "hate speech" laws is The Genocide Convention, which I understand was ratified as a treaty by the U.S. CONgress. According to the U.S. CONstitution, Article VI, Section (2), "all Treaties... shall be the supreme Law of the Land..."

Thus, The Genocide Convention (Treaty), which defines "genocide" broadly, as ZOG does "terrorism," includes prohibitions on speech which may target some "identifiable group" for criticism, possibly including members of the group! Hence, Old Testament prophets could be "hate criminals" under this law, as well as Jesus. In Soviet Canuckistan alias Canada, one who cites biblical text condemning homosexuality is guilty of "disseminating hate." Homos are a 'protected group.' For some reason, known only to ZOG, jews & Moslems are permitted to spew 'hate' against infidels, without punishment, including fines & incarceration. As Orwell said: "Some are 'more equal' than others."

The last Bush made an unconstitutional ex post facto (retroactive) law by permitting telephone companies to disclose phonecalls & conversations to ZOG, even though such disclosure was illegal at the time. By the same token, ZOG could make illegal what was legal at the time, like prosecuting someone who'd had a drink before Prohibition was law. Since The Genocide Convention has the same weight in law as the CONstitution, First Amendment 'rights' of free speech may go down the Talmudic Toilet of History, legally & constitutionally! The Supreme Court may decide on this matter.

Private communications which are not published, that is, made available for public access were allegedly permitted in Soviet Canuckistan when I was there, but CANZOG is increasing its snooping by means of the pretext of "terrorism," as in the Jew Ass Cy Veh, so no communications are deemed private, between 2 correspondents, or between 2 people chatting at home or outside. The Internet is rife with ZOG agents provocateurs whose statements entrap Goyim into "association with word-criminals," i.e. "terrorists," so "1984" lives, stronger

than ever, when Orwell wrote it, as I understand, back in the 1940s.

I've lived under various dictatorships, including those in Judeo-America, but the main difference I've noted is FEDZOGUSA's penchant for entrapment, by conning Goyim into thinking that they have a right to do something. That's how I got kicked out of this Land of ZOG in 1969, after its confiscation of my doctoral dissertation on Peru. Had I received even a hint that my research would displease "the powers that be," I'd have taken such a hint seriously. Instead, I received encouragement to research the Peruvian situation from my faculty members, all of whom had worked in some capacity for FEDZOGUSA. In Fascist Spain or Communist Germany, I'd be advised what NOT to do in regard to inquiries & public statements. In the Jewnited States I was INVITED to do my "rights & duties" of informing myself & others, "on behalf of an enlightened electorate." I walked right into ZOG's trap. I certainly learned thereby, & I have even lived to tell about it, so far. In present circumstances, if ZOG tells me to shut up, I'd do so, but ZOG, being jewish, would likely prefer to shoot me instead, for "The best of the Goyim should be killed," as it says in The Babylonian Talmud. Jews want freedom to exercise their religion, after all.

I think Tina's interview would be great reading. I've been in contact with her for several years, & I understand that she's led an active life in White Nationalist circles. I do believe in the First Amendment, so people are free to criticise me to their hearts' content, as many do, when I tread on their perceived interests. One thing I have never done is compete with others who Live OFF the Cause. I just live FOR Our Race, & work with the means available on its behalf. My message is never "me-me-me" & "gimme-gimme-gimme," like too many others who claim loyalty to White Nationalism. In this battle for the minds of Our Folk, information is the real currency, rather than ZOG's money, as ZOG knows. That's why it is striving to cut off the flow of ideas, out of fear that some Goyim might be able to learn, think, & take logical steps on behalf of Our White Nation, individually & collectively. For ZOG, this is a "fate worse than death," which would eventually result in the death of ZOG, whose main power consists of lies & illusions, of "Force & Make Believe," as stated in The Protocols of Zion.

Imagine if you did not know you were in prison. That's the state of most Goyim, inside or outside ZOG's gulags. Our job is to wake them up & to inform them. What they do after that is up to them. We can do nothing, except behave as ZOG's slaves & suckers, if we don't know who we are, where we are, & in what circumstances we are. We can only arrive where we want to be if we know where we are at present. ZOG's job is to keep us in the dark, amid a darkening population. That's why "No change of place can save Our Race.
