Turia - second thoughts on immigration

When the Maori Party was established a few years ago, party co-leader Tariana Turia had a grand vision of Polynesian and Asian immigrants uniting with Maoris into

a voting bloc to dispossess the whites. Now that the Government campaign to enrol sufficient Maoris on the Maori electoral roll to justify the creation of another Maori MP has failed, this vision has soured. Turia has lambasted successive immigration policies as a deliberate plot to further reduce the number of Maoris to minimise their influence, and has demanded that Maoris be consulted on immigration levels. "I think that it's quite deliberate to ensure that Maori numbers don't grow at a faster rate than the rest of the NZ-population", she said. (Dom. Post, Feb. 3, 07).

Yet in 2004 Turia was optimistically saying that Maoris combined with Polynesians and Asians would comprise up to 60% of the voters by 2050. (Kapiti Observer, June 28, 04).

Scientist affirms "race"

Dr Bob Brockie, Dominion Post science columnist and research associate at the School of Biology, Victoria University, Wellington, has questioned the dismissal of the concept of "race" in favour of "ethnicity". Stating that "race" is a reality based on gene clusters, he contends that despite the PC trend even among scientists to claim that "race" has no validity, he questions whether the 1% DNA difference among races is of no consequence. Citing the prestigious New England Journal of Medicine, Prof. Neil

Risch, head of a 'high powered medical research team' at Stanford, writes that 'the scientific journals have got it wrong'. Brockie explains:

"Prof. Risch's team concur on the genetic conformity of the human race. We can all interbreed with each other, and we all share about 99% of our genes. But whether typing by proteins, chromosomes or dna, the genetic features cluster round and the deepest genetic differences lie between the five continental races – the Africans, Caucasians, Asian, Pacific Islanders and Native Americans."

Brockie states that Risch et al say "It's misleading to assume that the only genetic differences between races are genes for skin colour..." Risch thinks that these racial categories are scientifically meaningful and "medically very useful." He points out that some diseases are race specific, as are some treatments, ordinary anaesthetics being dangerous to Black S. Africans, for e.g. "Prof. Risch and co say that it's important that doctors, epidemiologists, drug companies and public policy-makers acknowledge these genetic racial differences. The Stanford researchers think that race blind or race neutral medical approaches are neither equitable nor advantageous and that ignoring racial differences will ultimately lead to disservice to racial minorities."

"Call me old fashioned but I think we are muddying the English language by supplanting the precise scientifically justified word race with the woolly polysyllabic euphemism ethnicity," Brockie writes. (Dominion Post, Jan 29, 07).
