Worst of the Worst

I was first introduced to administrative segregation (Ad-Seg) in 2001, after only three months of being in prison for the first time. One might say I was a bit of a knucklehead when I first fell, but no more so than most 22 year olds fresh to the joint. Right from the beginning though, I was labeled as a part of a "Security Threat Group" (STG). I was given this label due to my racial, political and religious beliefs. The bald head and tattoos were justification enough, I guess. This STG label put me in the "ZOG trooper" spotlight and under the proverbial microscope. However, since I was only serving a four year bit, and non-violent, I was sent to a medium security prison. To me, the prison seemed to be overflowing with lowlifes, degenerates, and all around frauds. There were only a handful of Euro-Folk prisoners worthy

I'm glad you are in contact with John Gerhardt & LibRA, for 'sheeple' need to know what goes on in ZOG's war against Whites, inside the Soviet-style "gulags." Obviously^{ly}, any White is a target for victimization, & pro-White Whites are targets of "the worst of the worst mistreatment" under ZOG's so-called 'justice system.'

You did not choose your battlefield, but you are fighting on for justice, truth & freedom like the brave Aryan warrior you are. I wish you Strength through **Joy** in your struggle, for yourself & Our Folk.

If you were a non-White, I could expect lots of 'liberal' argu^{ments} in your favor, such as equating opinions with criminal acts, which is merely a first step in deeming every White a "racist," as is occurring in various ZOGLands, including Britain, where "racism" is a crime if one is White, but not otherwise. Our jew rulers declare that "only Whites can be racist," so non-Whites can be as racist as they like. That's how ZOG sees things in practice.

I'm not sure how either of us could have learned from others' mistakes, since we had been led to believe we were guilty of something we did, rather than who we were. Neither of^{us} knew the depth of corruption in our court system, with its phony 'adversarial' justice wherein judges, prosecutors & defense counsel are often in cahoots, as I've witnessed in courtrooms.

In Soviet Canuckistan alias Canada alias China-duh, I witnessed a judge stepping into the prosecutor's role with more vigor than the actual prosecutor had summoned for the jury to consider. On the other hand, I've seen Commie thugs avoid conviction as judge & prosecutor fumbled the case & failed to call evidence. Canada uses the same sort of 'justice' system as exists in the USA, & both countries cite each other's case law, when it suits them, so "the fix is in."

I attended the first "thoughtcrime" trials in which statements of opinion were equated with crimes of physical violence of the most vicious sort, so Canada was a sample of things to come in the USA, bit by bit, as we see happening now. The USA has its "hatecrimes," which supposedly punish a crime of physical violence more if it is accompanied by "hate!" This procedure is being extended to criminalizing the alleged thoughts of a person, rather than a physical deed. Thus do we now have Orwellian "thoughtcrime," for which colleagues of mine are in the ZOG-gulags in Zionist Occupied Germany, Britain, Canada, Austria & Australia, right now. One of them gets out this month, so we shall see what freedoms he has left, outside the gulag. As I understand, the terms of his release place him under a lifelong gag order in regard to his own lifestory! Defense attorneys are gagged to stop them from defending their clients, &/or imprisoned for themselves violating ZOG thoughtcrime laws. "Such a deal!" say the jews. I asked a local FBI agent if "hatecrimes" would apply to non-Whites, as well as to Whites. He grinned & said: "Don't hold your breath." As I see in the jewsmedia, when Blacks kill Whites, "it ain't hate nor racism." We sure live in a hypocrisy, not a democracy!

As you say, hard experience may serve to teach us what sort of people we are, & it may even strengthen us, to our benefit. On the other hand, I know combat veterans whose hard experience has made them worse off, physically & mentally. To them I try to be kind & understanding, for most of them could not choose their wars, as I've done. Nor can I say that I fought for lies which I learned later were just scams to mislead me. So far, I've avoided being shot or blown up, although I've been where such things were 'par for the course,' & I knew it. I've seen enough bodies to satisfy any curiosity I may have had, along with the vile stench of decay which accompanied them, when they were not removed soon enough.

Unlike yourself, I've enjoyed a pretty easy life, despite being kicked out of 5 countries, & being involved in two civil wars, one in Colombia, the other in Africa. "Anything for the quiet life," as my Brit colleagues would say.

This I do know: Our Struggle for Our Folk is only just beginning, as we slowly begin to awaken to the reality of our situation. Keep up the good work. ORION!
