Three Zimbabwe fertiliser firms close

Zimbabwe was facing another year of food shortages as three major fertiliser manufacturers had closed due to power cuts and a lack of raw materials, state media reported yesterday.

Eben Makonese, chief executive of Chemplex Corporation, which runs the three semi-governmental firms, said Dorowa minerals, Iron Duke and Zimphos had not been able to operate since last month.

"We have sent people on forced leave and on half pay because of these operational challenges," the Herald quoted Makonese as saying.

The Dorowa mine, which produces phosphate rock concentrate, a key component

in making fertiliser, had ceased operations due to persistent power cuts and lack of foreign exchange to import mining materials, said Makonese.

Fertiliser firms have so far produced 160 000 tons against a target of 600 000 tons for the forthcoming season.

Misheck Kachere, another senior company official, said fertiliser had been sold at a fifth of the cost of production as a result of government price controls imposed two months ago.

He said a 50kg bag of fertiliser was selling at Z\$88 000 (R2 530 at the official rate), while packaging alone cost Z\$79 000. - *AFP, Harare*

China plans to send jobless to live in Africa

Beijing - China is preparing to send more farmers to Africa as rural labourers find it increasingly difficult to find jobs in the nation's urban centres.

At a meeting in southwest China's Chongqing city on Tuesday the head of China's Export-Import Bank, Li Ruogu, pledged to help finance African emigration as part of the city's urbanisation scheme.

"With the establishment of the [rapid urbanisation] project, several million farmers will have to move," the People's Daily quoted Li saying.

China's Commerce Ministry refused to say how many contracted Chinese workers have been sent to Africa, but according to state press reports up to two-hundred thousand Chinese-born mainlanders live in South Africa alone.

A Swift Squint at the Jew World Order by E. Thomson

If politics is the art of the possible, then control of money via usury & central banks makes a policy desired by a vested interest group much more possible. As Meyer Amschel Rothschild declared: "Give me the power to issue money & I care not who makes the laws." At this stage of jew-bankster power, the laws are made by the banksters' employees in government, who will do anything for money, like typical prostitutes.
