I, Eric Thomson, hereby swear as true and correct

1. OPINIONS EXPRESSED AND THE REASONS THEREFOR

A. This case confronts overclassification of Whites  
to project an illusion of equal outcomes in Washington State  
Penitentiary's disciplinary process, and custody level,  
racial demographic.

B. My expert opinion is offered as an author, pub-  
lisher and freelance journalist on race relations, 'cultural  
diversity' and White Nationalist political, religious, and  
cultural perspectives.

C. The reasons for expressing these expert opinions  
are to lay the foundation for a jury to find that Whites  
in WSP are being treated arbitrarily and unfairly with respect  
to their Nationalist political, religious and cultural per-  
spectives being deemed "Security Threat Group" (STG)

activity when these activities are encouraged, lauded, and financed for other WSP prisoners of other races.

D. I am also qualified to testify about "Cultural Diversity" programs, and the content of Nelson's essay, 'War Against Whites.' My testimony will support a jury finding that cultural diversity programs are inimical to correctional interests as they encourage non-Whites to adopt perspectives of victimhood and entitlement, and animosity toward Whites.

E. The data considered in forming these opinions will be the exhibits in this case, the WSP cultural diversity textbook "A Different Mirror" by Takaki, my first hand experiences in various governments around the world, my career as a researcher and freelance journalist, in the context of this case.

# The Truth About Income Taxation

**Taxes have been imposed on people for hundreds of years but Income Tax was thought up in 1913, the same year as the Federal Reserve Bank, by a member of the American elite.**

Right from its inception it was **designed** for the poor and middle class to pay and for the rich not to pay. The rich created "foundations" to evade tax (i.e. the Rockefeller Foundation, Ford Foundation). Income tax came to Australia in 1936 as a *temporary* measure.

Countries borrow from the International Monetary Fund and World Bank and taxes are used to make the repayments. Debts are not allowed to be paid back in full and countries borrow more and more from the IMF. Countries borrow much more during wars.

When countries borrow money, the IMF puts "conditions" on these loans such as: more immigration; more foreign investment; higher taxes; lower social welfare; introduction of a GST.

In 1953 the Government introduced the Double Taxation Act, allowing a company paying tax in another country to avoid tax in Australia. The upside is supposed to be that Australian companies operating overseas will benefit. One effect of this was that Australian-owned Impulse Airlines had to pay about 30% tax while Virgin, being foreign, paid only about 2%. Impulse went out of business. This situation is pervasive around Australia.

The Deputy Commissioner has admitted that since 1953 multinationals have paid little or no tax. The result today is the takeover of Australian companies by foreign ones. State governments give tax bonuses and incentives to foreign companies.

In the 99/2000 financial year the Federal Government raised a revenue of \$168B. \$1B came from foreign enterprise even though they took \$640B out of the country. According to BRW the top 1000 Australian companies made \$937B between them paying \$18B in tax so the other \$150B came largely from Australian wage earners, and small and medium business.

One alternative to this is the debit tax proposed by some organisations whereby 1% of all bank withdrawals go in tax. This as the only tax would raise more money than the current system. Almost as importantly there would be no paperwork. Another proposed single tax is one on all property.

A start to taxation reform is having a proper tax burden applied to foreign firms. The Australian takeover of such firms and their redistribution into locally-owned smaller corporations will see wealth stay in this country.

Some courageous people are already **not paying taxes** they would otherwise have to pay. For example some people don't pay income tax, the GST, car registration, council rates, fines etc. They're doing this because they know the system is very unfair and they're courageous enough to take a stand against it.

**Then there's the GST.** In 1995 Howard said it was *completely off the Liberal Agenda*. As soon as the Howard Government was elected he was instructed to attend an international bankers meeting where he was informed by bankers' representative Corsene that he would be implementing a GST to which Howard said Yes. This tax could never have been implemented without the collusion of both the Democrat and Labour parties, or that of the entirely Labour state governments.

Labor says removing GST would be like unscrambling an egg but Switzerland did it in 1978. In that year a Citizen Initiated Referendum was held on the tax which had been introduced in 1977 and it was voted out never to return.

There have been seven petitions against the GST that I am aware of. The biggest one was One Nation's which got over 2 million signatures (about 25% of Australian voters). Another was to the Governor General, as he can stop a law from being enacted, but he asked his security to burn the petition.

GST administration costs are about 18% for small business and 1% for big business. Not surprisingly the biggest cause of bankruptcy is the ATO. After the GST was introduced in Canada and NZ, 37% of businesses went under as a direct result. The ATO had "factored in" 25% of businesses collapsing here because of the GST. The ATO called this "getting rid of the riff raff". There was also a huge increase in divorces and suicides. 21,000 work for the ATO and consume a huge cut of revenue.

Some people have questioned the legality of paying income tax because the ATO is not a legal entity. In response to a letter objecting to the payment of tax for this reason, the ATO replied that its lack of status as a legal entity did not exempt people from paying tax. Those objecting to taxation on these grounds have cited breaches of the Australian Constitution at Sections 51, 55 and 99.

The provision of tax revenues has always been

something which has ultimately been decided by the people. The levying of GST in Australia has clearly been against the wishes of the majority, clever party politics notwithstanding. This makes it an arbitrary and oppressive tax which people should use every device to combat.

## LET'S GET THIS RIGHT: JEWS AREN'T WHITE! by E. Thomson

From time to time a correspondent or writer will blithely state his unresearched opinion that jews are "White". This is not only a fallacy, but it is an impossibility. Here's why: the jews are the only people who are not qualified for protection under their own Genocide Treaty. (1) They are not a race. This is proven from jewish sources in regard to Falashim or Black jews; Benai Israel or Indian jews; Chinese jews, who look Chinese to a foreigner, but who are not real Chinese; the Sephardim or semitic jews; and the Ashkenazim or "Russian" jews, who are most likely to have White genes. These people converted to Judaism in 700 A.D. Many of them resemble White people, but all of them, according to "The Genetics of the Jews" have Afro-Asian genes, including the blondest of them. Blond, blue-eyed people with Afro-Asian genes are not White, but mongrels.

(2) Jews are not a religious group, for they include atheists. Two thirds of the "jewish" population of Israel are not religious, but claim to be "jewish" through their mothers, which is how Orthodox rabbis define "jewishness". A White person who 'converts' to Judaism will not be deemed a jew by Orthodox rabbis.

(3) Jews are not an ethnic group because they reside in all parts of the world and resemble their host peoples in looks, language, and often, in religion. Yet, they consider themselves jews. What can be their common bond? Not religion, not race, not ethnicity, but economy! It's their rackets which bind them together as jews, exactly as the "Patels" are bound together by their caste-determined role as merchants. Such disparate groups maintain cohesion with their common interests, and behave like a nation among nations. Yet, they are not a nation, which is comprised of people with a common genetic origin.

It is extremely dangerous to admit jews into White Nationalist groups, for I have had firsthand experience of their sudden betrayal of White interests in Rhodesia and South Africa. One day they were "White". Next day they were sneering at us as "you White people". Jews officially declared themselves non-White in 1972, as quoted in The Rand Daily Mail of May 15<sup>th</sup>, 1972.

Some Goyim go by FEDZOGUSA's definition of jews as "White", but if we were to accept ZOG definitions of "White", which includes hispanic mestizos and other Eurasian mongrels, Arabs, et al., we would cease being White Nationalists in fact and in effect. Foolish Whites may overlook racial differences, out of love for the ZOG, but mestizos, Arabs and other mongrels do not see Whites as their people, although they enjoy White women as trophy sex partners, like any Black or Asian pimp. I notice that a non-White 'stud' with a beautiful White female will enter premises, with his eye on the Ostensible White males, to amuse himself at their reactions, as if to say, "See what I took from you honkey muthas!" When an Ostensible White enters with a Black female, all eyes look at him with the unspoken question: "Are you blind or nuts?" I have seen this pattern almost daily in my work for a full decade, and there are many such places in this town, where the same things occur.

A genuinely righteous jew belongs not with us, but with his own people, who sorely need him. "THE GENETICS OF THE JEWS" by A.E. Mourant et al., Oxford University Press, 1978, reports the findings of jew hematologists, whose work was originally published in The Lancet, the official journal of the British Medical Association. They report that "even the blondest jew has Negro marker genes... which are due to concubinage (prostitution) and slavery."

Blacks were introduced in the Black Sea region, and along the Silk Route, as 'trade goods'. # THE NEW FOR WHOM "RACE DOES NOT EXIST" **Ashley Montagu, 94, Anthropologist and Popular Author** CAN HIS ARGUMENTS REFUTE THE GENOCIDE CONVENTION?

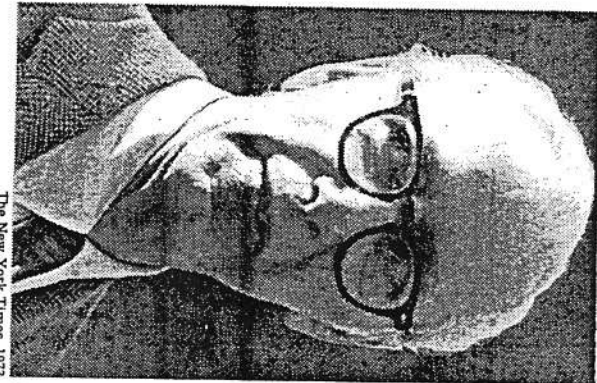
Ashley Montagu, the London-born anthropologist and popular author whose energy, erudition and showmanship brought genetics, paleontology and other topics in the life sciences to a wide American audience, died on Friday in Princeton, N.J. He was 94.

The author of more than 60 books, Mr. Montagu recently completed a substantial revision, published this year, of his influential 1953 book, "The Natural Superiority of Women," and was collaborating with his biographer, Susan Sperling, when he was hospitalized in March. He died of cardiovascular disease, Ms. Sperling said in an interview.

Mr. Montagu's wide-ranging career as a freelance commentator on nearly everything human, along with his white hair, owl glasses and pipe, made him the public picture of the professor in the 1950's and 1960's. But despite a voluminous production of scholarly works, he was unable to achieve tenure at any of the universities at which he taught, Ms. Sperling said. That slight was due, in part, to his ideas about the equality of the races and the sexes, which were startling for their day, she said.

Mr. Montagu wrote books on anthropology, human anatomy, intelligence, marriage, why people cry, the history of swearing, as well as an account of John Merrick, the severely disfigured Victorian Englishman known as the Elephant Man. His commentary extended even to the prehistoric. He bristled at the cartoon depiction of Neanderthal men as brutes who clubbed their women over the head, and would dash off a scathing letter to the editor whenever he read such a depiction, which he said ignored evidence of the essential gentleness of Neanderthals.

Henrika Kuklick, a University of Pennsylvania professor of the sociology of science, said Mr. Montagu was "someone who bridged the academic and the popular. His works were both accessible and academically respectable." Ms. Kuklick, author of "The Savage Within: The Social History of British Anthropology, 1885-1945" (Cambridge University Press, 1991), added that "as a public intel-

lectual, he ranks below Margaret Mead, but far above many others who I won't name."

Jonathan Marks, who teaches biological anthropology at the University of California, noted that Mr. Montagu's interests included genetics and anatomy, a range that would be nearly impossible in today's academia.

"He and Max Levitan wrote a standard textbook on human genetics that was used into the late 1970's, even though Montagu's original training was in anatomy," Mr. Marks said. "It's as if you could write equally well about architecture and the detailed mixing of concrete."

Montagu Francis Ashley Montagu was born Israel Ehrenberg on June 28, 1905, in the East End, a largely working-class section of London. In previous biographical articles, Mr. Montagu apparently said or made it known that he was the son of a stockbroker in the City of London, the financial district, but his father, Charles, was really a tailor, a Polish-born Jew, and his mother, Mary, a Russian-born Jew, according to Ms. Sperling. Although an agnostic, Mr. Montagu later acknowledged his Jewish heritage. He took his last

name from Lady Mary Montagu, an 18th-century woman of letters and feminist, and the other parts of his name from other writers he admired, Ms. Sperling said. "I don't know why exactly he changed his name," Ms. Sperling said. "He was ambitious to do great things and as Israel, well, that would have been an impediment in British academia."

The classic autodidact, Mr. Montagu as a teenager puzzled his parents by visiting London's used book stores and buying secondhand copies of challenging authors like Thomas Henry Huxley, the British biologist who championed Darwin. At 15, he won a literary contest and selected William McDougall's "Introduction to Social Psychology" as his prize. He was perhaps the first undergraduate to study physical anthropology at the University of London.

He pursued his graduate studies at Columbia University in 1927, interrupting his studies there to work in ethnology and anthropology in Florence and physical anthropology at a medical museum in London. He got his Ph.D. from Columbia in 1937 after studying under pioneers of anthropology like Franz Boas.

In 1953, he told an interviewer that the United States had a profound effect on him: "I was brought up a stuffed-shirt Englishman. I wasn't very human. What America did for me was to humanize me. Democratize me, beginning with the man who examined my luggage on the dock in 1927. He didn't call me sir and I resented it."

Mr. Montagu won his first fame in the 1940's by arguing that race was a social construct, a product of perceptions about race, rather than a biological fact. He was a principal drafter of a United Nations "Statement on Race" in 1949 that incorporated these ideas.

His most noticed work, however, was his 1953 book, "The Natural Superiority of Women," in which he argued that men were a form of "incomplete" woman and that women were in many ways biologically superior. The attention and the sales from the book allowed him to resign his teaching position at Rutgers Uni-

versity in 1955.

The controversy, in those pre-minist days, was enormous, but non-threatening. With his willingness to return reporters' telephone calls, Mr. Montagu was widely quoted and therefore influential. His professorial manner and dry wit made him a frequent guest on "The Tonight Show" with Johnny Carson.

A television producer of the day captured his appeal. "All he does is play himself — a professor," Bob Heridge, a WCB-TV producer, told an interviewer. "He talks about stuff like early paleolithic culture and stone artifacts of the upper Mesozoic period and you should see the fan mail! It's fantastic!"

In later years, he expanded his commentary to things like Ivy League dress. "The Ivy League look in men's fashions is to be deplored on a number of grounds, if not on the

ground of taste itself," he wrote in 1958.

Although an occasional pipe smoker at one point in his life, he opposed tobacco in public places. If smoking cannot be banned on airplanes, smokers should at least be segregated to the back of the plane, he wrote in 1971. "It would be a simple act of civility and serve to increase the pleasure of both nonsmokers and smokers — the nonsmokers breathing relatively unpolluted air and the smokers enjoying the pollution of others as well as their own."

Mr. Montagu is survived by his wife, the former Marjorie Peakes, and three children, Audrey Murphy of Sutton, Mass.; Barbara Johnstone of Princeton, and Geoffrey Montagu of Los Angeles. He also had four grandchildren and two great-grandchildren.
