

Observations on "World War III" by Jack B. Otto

The author dances around the definition of "jew" by distinguishing "fake jews" (Khazar converts) with "real Old Testament Hebrews." The former, the Khazars, use The Babylonian Talmud AS WELL AS THE RACIST, TRIBALIST Old Testament as their religious guidebooks. The Old Testament is just as violent, blood-thirsty & rapacious as The Talmud, but is a tribal mythology, rather than a tribal recipe for behavior in the present. The Old Testament was rabbinical accounts of jewish myth; The Talmud is rabbinical interpretations of Old Testament doctrines illustrated by those myths. The author appears to identify with the evil Old Testament Hebrews & their demonic deity, as if that will save us from the disciples of Zionism, which is the political expression of the Old Testament & Talmud.

History tells us that all religions have members who emphasize certain aspects thereof, such as Buddhists, Christians, Moslems & jews. From different interpretations stem different sects, as those of Hinduism; Catholics & Protestant Christians; Sunni & Shia Moslems. Jews emphasize certain aspects of Old Testament & Talmud, but they do not deny that those believers are "fake jews," necessarily. Most people think that Catholics & Protestants are Christians, albeit distinctive in detail. Some, however, denounce Catholics or Protestants as "fake Christians," just as Sunnis denounce Shias & vice versa as "fake Moslems."

In final analysis, how do we distinguish Yahweh from Satan? Since Yahweh created Lucifer, knowing in advance what he would become, logic suggests that Satan is one more aspect of Yahweh, who is depicted as vengeful & mischievous, like Lucifer, when mankind are concerned.

The author shows the various manifestations of "The Illuminati" which follow Yahweh's commandment to wage war by deception, hence the Illuminati (Rothschild bankster) minions' infiltration & direction of Christianity, politics & economics. The initial goals of The Illuminati (jews & their agents) or Zionists (jew supremacists) is described in The Protocols of the Learned Elders of Zion as being first revolutionary, against Gentile regimes, & then creating their New (Jew) World Order.

The author correctly reveals the role of the "American," the "French" & the "Russian" Revolutions in this forced march to the Jew World Ordure. But the author appears confused in regard to the bankster origins of The British Empire, which was merely another servant of jewry. The jews have a long history of betraying their servants, as written in the Old Testament, as well as current history. Wellington was as much a Rothschild minion as was Napoleon. The author seems not to grasp the fact that jew banksters lend money to all sides in conflicts instigated by jew banksters & their Goy agents, so whoever 'wins' provides more money & power to the banksters. That is why "wars are the jews' harvests."

The author points out the infiltration of French revolutionary activists in the USA. This is ironic, for the French financed the so-called "American Revolution." Similarly, the USA jew banksters financed the Red Revolution in Russia, & the Goyim wondered at the infiltration of Communist agents into the USA. This is a form of political recycling, it appears.

The author makes much of the fact that Ashkenazim are not Arabs, i.e. Semites. If converts are "fake" cultists, then so are the non-Semitic Christians who adopted the Semitic religion called Christianity, & so are the majority non-Semitic believers of Islam. Hence, only Arabs can be "real" Christians, Moslems or jews. This is silly on the part of the author.

He correctly identifies Freemasonry & its offspring, the Ku Klux Klan, as agents of the jew banksters, thereby revealing that many so-called opponents are merely different hands of the same personage. Goyim need to wake up to this fact, but his emphasis on "fake jews" tends to distract <sup>from</sup> the grim purpose of "real" Judaism: The enslavement & extinction of Goyim, in terms of the Old Testament, in addition to The Talmud.

The author gives proper attention to the role of usury, inflation & deflation as tools of our jew bankster rulers. He cites The Communist Manifesto's goal of abolishing private property, the family & religion, without mentioning that these goals applied only to Goyim, just as do The Noahide Laws of the Old Testament. The jews who took over Russia became "the state," which was entitled to steal the fruits of Goy labor, so it is not important what is said, but who benefits from the transition of words into deeds.

The author reveals the collaboration of jew capitalism with jew communism, i.e. The Cold War Hoax. How confused the Goyim be when "opposites" combine against the Goy masses. This is only because they do not see The Kosher Connection.

He correctly identifies Zionism with Communism, both being jewish in origin & execution, but, for some reason, the author does not mention the identity of Zionism with capitalism. Why would that be? Could the author make some distinction, in his own mind, that jew banksterism is "different" from capitalism? Economist Werner Sombart identified capitalism with Judaism, as did Karl Marx. Sombart wrote that "The USA is the distilled essence of Judaism!"

The author reveals the bankster role in bringing about World War I, via The Federal Reserve. All major names involved in this crime are jewish, but the author claims they are "fake jews." Apparently, he believes that our only salvation from these "fake jews" is to throw ourselves into the service of Old Testament Hebrews, whose god commands them to slay Goyim: Us! This 'choice' is like being on the sinking Titanic: We can choose to drown in the water which fills the ship, or we can choose to drown in the water that fills the ocean. Such a deal! as jews would say.

As always, the jew harvest of World War I enhanced the jew-banksters' power & profits. The postwar creation of The League of Nations worked to continue this harvest, in addition to preparing for the next war. The author also points out how the bankster interests use the mass media (jewsmedia) to herd us, the Goyim, who are indoctrinated with "political correctness." The author mentions the anti-Zionist role of former bankster jew, Benjamin Freedman. Yes, Freedman was protegee of Henry Morgenthau Sr., a top-kick bankster kike, but it was his son, Henry Morgenthau Jr., who became Secretary of the Treasury under FDR. Jr. wrote "Germany is Our Problem," in which he detailed the jews' genocide program to be used against Germany. The Morgenthau Plan was the ONLY genocide program of World War II.

The author's grasp of history is muddled by his specious "fake jew"-"true Hebrew" distinction. Apparently, the author believes that ALL religious converts are "fakes." He does us the favor of quoting Benjamin Freedman's astute observation that "most of those six million" (alleged jew gassees of the Holohoax)"are walking the streets of the USA today, happy & prosperous." Freedman also revealed the hoax of "jewish suffering" under Soviet (jewish) Communism, & he points out the fact that jew is deemed a nationality, not only a religion. Indeed, Israel is more Communist than the USSR.

The author is most revealing of the Communist affiliations of big names in Hebrewood alias Hollywood. Since he claims that "fake jews" serve the bankster-Illuminati, we may conclude that these "Red stars of Hollywood" were also "fake" commies.

Since the U.S. CONstitution was written by Illuminist Freemasons on behalf of the "fake" jew banksters, the author's apparent concern for this "fake" document is indeed mysterious.

The author falls for the "Mark of the Beast" hoax in the form of the injectable microchip, made popular after the Y2K fizzle. The microchip will govern one's ability, allegedly, to buy & sell, as per the Old Testament. Such a chip can be ruined by electromagnetic radiation. The information thereon may be erased &/or copied for duplication by electronic means. The real Mark of the Beast is the six-pointed Death Star of jewry. Being able to wear the Death Star entitles one to buy & sell, especially in jew-monopolized commerce. It also allows one to put a kosher tax on goods sold to Goyim, as evident in the U or K kosher symbols alias hechschers or hex marks.

The Zionist Occupation Government's (ZOG's) holocaust at Waco was motivated by the "true Judaism" of Koresh, which is Hebrew for Cyrus. King Cyrus of Babylon was elected christ or jew-king by the "real jews" of Babylon. This means that jews chose a Goy as their king, & that is something such jews as the Lubavitchers of Brooklyn positively hate. Koresh rubbed it in by flying a big Israeli flag over his compound. "Holocaust" means "burnt offering." The Noahide Laws of the Old Testament prescribe death for Goyim who worship "abominations" like Jesus or other beliefs displeasing to the jews. The author consistently repeats the error of using "it's" in place of the possessive, "its." Such ungrammatical usage labels the writer as a semi-educated person, which unsympathetic readers may construe as indications that his thesis is invalid.

He criticises Red China's One Child Policy. Does he want the Chinese to multiply so they can crowd everyone else off the planet? In the end, world conflict is a battle of being, of biology. Some Christians believe that "live" is just "evil" spelt backwards. I say to them that God is really Dog, & they shut up. The Judeo-Christian message is: "Be fruitful & multiply," so we can all be "born in sin." Such a deal!
